20A/B	DMH has been in a process of closing state hospitals since 2012. We still serve committed patients but have shrunk the amount of state beds in the state for Civil/Non-Forensic commitments. We still maintain the number of state hospital beds for Forensic commitments and are actually adding approximately 25 beds this calendar year. Since 2011, DMH has been in a process of transformation which has included a more direct interact with transitions of individuals into community care and resources and coordinating care between our community mental health system and the state hospitals. This has led to a UR process that works more closely to analyze needs in the community to better assist in reducing readmissions. The data seems to support that our efforts may be providing more effective outcomes.
