The decrease in SED/SMI served reflects a number of challenges faced by agencies, including difficulty recruiting and retaining an effective behavioral health workforce (both clinical and psychiatric staff) and funding issues (frozen Medicaid rates) impacting clinical capacity. In addition, the decrease in SED/SMI and corresponding increase in general mental health might reflect impacts from the simultaneous roll out of the DSM V and the new ICD 10 codes that complicated clinical practice. Starting in SFY16, all ISM client counts generally reflect unduplicated client counts for each agency (note: there may be duplication across agencies). Over time, from SFY12 to SFY16, the agencies that report ISM client counts implemented improvements in their reporting methodology; the reported client counts reflect these changes in addition to changes in service delivery. The increase from SFY15 to SFY16 in the number of ISM clients served largely reflects two agencies that reported an increase in ISM clients due to increased outreach and service capacity (also, one of these agencies improved their methodology in obtaining unduplicated client counts, which resulted in a higher count). Another agency's reported ISM client count decreased significantly from SFY15 to SFY16; this decrease reflected improvements in their methodology to obtain an unduplicated client count. This particular agency's ISM clients are co-occurring clients, and this decrease in co-occurring clients is reflected in Table 12 Percent Treated for Co-Occurring Disorders.
