4	The increase in the number of consumers that were unemployed and not in labor force between 2009 and 2010 is due to the fact that this data comes from a survey, and more surveys were completed in 2010 than 2009.
6	Tennessee experienced bed closures between 2009 and 2010 resulting in a decline in the total number of consumers served in state hospitals at the beginning of the year.
6	The total number of consumers served in community programs, other psychiatric inpatient settings, and residential treatment centers are Medicaid-only data that come from the Bureau of TennCare. TennCare changed the way it calculated this data from "Total Served at the Beginning of the year" in 2009 to "Total Served During the First Month Based on Initial Service Received" in 2010.
6	Total Admissions to Community Programs, Other Psychiatric Inpatient, and Residential Treatment Centers During the Year are Medicaid-only data that come from the Bureau of TennCare. The decline in admissions in these settings (from 2009) is likely due to the elimination of a TennCare category, between 2009 and 2010, that covered certain SPMI individuals.
6	As of 2010, Tennessee no longer has children's beds in state hospitals. All children's beds in state hospitals have been closed, therefore, the Average Length of Stay for children is no longer applicable.
8	The percent of MHBG expenditures for non-direct service activities declined in 2010 (from 2009) because of the need to increase the percent of expenditures devoted to direct services.
