20A	The increase in readmission rates is likely the result of expected year-to-year variation. While these numbers are not as small as the numbers in Table 20B, we are still dealing with rather small numbers. As such, adding or subtracting even a handful of readmissions results in what appears to be large increases or decreases in readmissions if looking at only the percentage. A decrease in the number of patients from 30 to 10 for the 30-day readmissions and 35 to 13, is likely part of normal variation. While this decrease is a bit more than prior years, it isn't outside the realm of statistical reliability. We will continue to monitor these numbers in the following years.
20B	There is a slight bump in readmissions from 7 to 18 patients, which raises the readmissions rate from 2.4% in 2017 to 5.8% in 2018. This increase can likely be attributed to year-to-year variation. In review of data from the past 5 years, we would expect to see readmissions counts in the 15 to 25 patient range, with some years being slightly higher other years being slightly lower.
