16	When comparing FY17 to FY16, there is a marked decrease in persons served by EBPs according to table 16 (especially ACT). However, the state has other data records and programmatic records to indicate the overall admission to ACT and other EBPs have not decreased this dramatically. Rather, the EBP data set does not have any data validation and quality activities throughout the year. The following ACT report example illustrates the conflicting data system efforts and priorities. Specific ACT reports are collected each quarter from all 17 community mental health systems. This data collection is separate from the primary mental health record (CCAR) and the EBP data systems. The programs staff and data staff focus energies on the outcomes and data quality of the ACT specific reports to tie these to performance incentive contracting and fidelity monitoring. This specialty report is reconciled with the primary mental health data reporting (CCAR), but not with the EBP data system. Therefore, it is not appropriate to compare those reports to this table.
