5A/B	Medicaid expansion has enabled many more clients to qualify for Medicaid. The level of 'unknown' funding status has increased. CT is working on cleaning up the insurance data field and many of the unknowns may actually be Medicaid funded clients. While the SMHA bills Medicaid for state operated facilities, they don't for private non-profit providers. It is possible that the SMHA is not getting the most current insurance information.
6	State Hospital – adult – forensic units of Connecticut Valley Hospital became its own separate hospital (Whiting Forensic Hospital) in spring 2018. Consequently, this has affected admission and discharge numbers. Increase in RTC use - moving clients from closed secure correctional facility to community beds. Additionally, we had an issue with children beds being incorrectly reported as RTFs in the past instead of Other Psychiatric Inpatient. These were recoded as Other Psychiatric Inpatient for 2018 reporting accounting for the vast majority of the increase in total admissions to Other Psychiatric Inpatient During the Year when compared to 2017.
7	In Other 24 Hour Care – we had been receiving funds related to the Dept. of Veteran Affairs Patriot's Landing in FY17, but in FY18, the appropriation was moved directly to that department and no longer passed through DMHAS. For the decrease in Ambulatory/Community Non- 24 Hour Care- department spent significantly less in FY18 on capital expenses and bond funds- contributed to about \$3M decrease; also, shifts between different funding types for some programs based on the available appropriation. Finally, in FY18, all of our contracts with private non-profits took a 5% across the board reduction, so DMHAS had to make adjustments.
8	This table pertains only to DCF (child system). The bulk of the increase is in Training and Education.
