16 & 17	<p>Michigan Fidelity Assistance Support Team (MIFAST) - Overall Purpose of MIFAST: To ascertain the degree to which an evidence based program has been implemented and functioning for both fidelity and efficacy. As the result of a MIFAST visit, agencies/teams will be able to have an outside perspective of how their EBP is being implemented, and where internal focus can be prioritized for improvement activities. In addition, cumulative information from visits provides a way for the state to see where needs may be in terms of support for improving practices and providing technical assistance across the system. No state staff are part of the initial MIFAST visit, however are the primary person to directly provide post-visit technical assistance, materials, training or further development, consultation, or coaching depending on needs identified during the visit itself. Generally, MIFAST visits are conducted every two years. Depending on available capacity, number of projects within each evidence-based program, and the number of teams available, prioritization may occur where exemplary reviews may result in a re-visit in three years and poor reviews may result in a re-visit in one year. Process for Developing MIFAST: 1. Announcement made at Performance Improvement Steering Committee (PISC) to members noting specific EBP focus area needing MIFAST team established. 2. Develop Workgroup from interested members. a. Workgroup will develop process for evaluating fidelity to the EBP based on the model b. Select and invite other people from network who are known experts in EBP and will be able to assist the process as reviewers, consultants and trainers (be inclusive of peers when possible). 3. Conduct training on the instrument that will guide the MIFAST review visit. a. Use of a standardized tool, for example SAMHSA Self-Assessment toolkits; Fidelity Rating tools developed by the EBP authors; or tool developed by workgroup. b. Conduct Inter-rater reliability between reviewers as part of training. c. Test tool through pilot reviews; revise as necessary. d. Use of a work plan format for reporting results of visit. e. Outline process for follow up to review site and offer of assistance for areas of improvement. 4. Select MIFAST reviewers from those who complete this process. a. Develop contract for reviewers. b. Complete contract process. 5. Announce availability of MIFAST process to the network; 6. Begin case finding for MIFAST visits. Note: The heart of the MIFAST process is to provide “outside eyes” to providers implementing specific EBPs as a way to improve. It is reiterated this is a completely separate process from formal site visits/reviews and/or technical assistance visits from the department. Once initial teams are developed, to add additional reviewers in the future they will spend one year participating in reviews as an “observer” and then as a “secondary reviewer” where their comments/review documents will be compared to lead reviewer - Current MIFASTs (FY18). To date, the MIFAST process has been predominately implemented as part of adult mental health block grant providers although there have been recent efforts to expand this process to substance abuse funded efforts as well.
