4	More data was available in 2018 than in 2017 due to improvements in the data collection system.
5A	In 2017 individuals with Medicaid funding only were included with the non-Medicaid funding. OMHSAS fixed that logic for 2018.
6	In 2017 OMHSAS just reported any that received services in the year which was correct for anyone who received the services during the year, not the beginning of the year. In 2018 we included new logic to only include those people who received services on the beginning of the year. 2018 are the correct numbers. OMHSAS identified a need to ensure individuals that have a medically necessary service in the Pennsylvania Mental Health State Hospital System. This process had begun during a part of the 2017 reporting year and the entire 2018 reporting year. The process included evaluating competency of individuals in the Pennsylvania Mental Health State Hospital System and discharging individuals that can be better served in other services. Therefore individuals may have a shorter length of stay than in previous reporting years.
7, 8	Data for 2017 are actual expenditures. Data reported in year 2018 is the total budget. We will not have actual expenditures for 2018 until later in 2019 when Income and Expenditure reports are due, changes are made, and they are reported as final.
7A	The changes in fiscal reporting for Early Serious Mental Illness (ESMI) between 2017 and 2018 reflect both the increase in Community Mental Health Services Block Grant Funding (CMHSBG) overall and a change in the federal requirements for EMSI set-aside amounts (from 5% to 10% set-aside in December of 2015). The Pennsylvania Office of Mental Health and Substance Abuse Services utilized the increased ESMI funding to expand First Episode Psychosis Services to additional program sites, doubling services from four to eight program sites. In addition, OMHSAS funded new statewide FEP training that is now held on an annual basis.
9	In 2017 OMHSAS included 5,000 surveys to consumers that received peer support services. Due to the requirements to determine satisfaction regarding the CCBHC Demonstration, the methodology was changed for 2018 which included not sending out the peer support survey to 5,000 individuals. These individuals have received a similar survey that is connected directly with the CCBHC.
12	ICD 10 became effective in October 2015, replacing ICD 9 diagnosis codes. Additionally, OMHSAS has been working with entities involved to improve reporting by reporting all diagnosis codes.
