All	Historically, we have employed our IT data warehouse vendor to design and maintain reports and data files that generate the CLD/URS data. While these standardized reports were helpful for the consistency of our data, we found it difficult to work with our vendor to make adjustments to the reports when federal requirements changes or when we found errors to fix. While we explained the requirements to them for federal reporting, we did not have access to their programming and found ourselves too distant from the process. In addition, the standardized data warehouse reports cannot clean the data as needed in preparation for analysis. For example, we have duplicate hospital admissions to clean up that our vendor was not able to do. With a new staff member on board in 2017, we brought the federal reporting "in-house" and now two of us generate all the data and statistics. We have noticed some changes in the multi-year trends due to this change, but we believe our post-2016 data is more accurate because we can directly verify it.
All	Due to increased data quality checks and communication with all counties about improving their data submissions, the 2017 consumers reported is 9% greater than the number of 2016 consumers. Approximately half of this increase is from Wisconsin's three most populated counties which we have worked with. 65% of the increase is for clients with an SMI/SED which is the only group for whom functional status (NOM) measures are required in Wisconsin. Thus, this increase may be seen throughout many of the data tables that use client-level data reported by county behavioral health agencies to the State DHS agency, but will be even more pronounced in data tables with functional measures like employment and living arrangement.
6	To check the variations in table 6 for state hospital residents at the beginning of the year, we checked our 2016 vs. 2018 data. We verified the 2018 figure (171) and found that the 2016 figure should have been very similar (173). The total number of State hospital residents across the year was similar in 2016 vs. 2018, but it appears our vendor may have mis-categorized some admissions during the year as residents at the beginning of the year. So, the 2018 figures should be accepted as is. However, we found that the 2017 figure of 70 residents at the beginning of the year is too low due to clients we erroneously excluded from the analysis file who had no discharge.
7/7A	A 49% increase in funding for Wisconsin's First Episode Psychosis program occurred from 2016 to 2017. This is an accurate increase which reflects the Wisconsin DHS's decision to increase its investment into the ESMI programs. This increase is reflected in Table 7 under "EBP for ESMI" expenditures and in Table 7a under "First Episode Psychosis" expenditures. In Table 7, "Administration" expenditures have decreased from 2016 to 2017 and this is likely due to fluctuation in overall administrative needs.
14A/B	State definition of SMI/SED is similar to federal definition, but worded differently: "Persons in Need of Ongoing, High Intensity, Comprehensive Services - have a primary diagnosis of a major mental illness or severe emotional disturbance, and they have substantial needs for psychiatric and medical treatment, including substance abuse, daily living skills, budgeting, job training, family support and support at school. Some may have a history of trauma, such as physical or sexual abuse or neglect, which contributes to the mental health problem. Persons in this category may need help to access community resources, such as safe, affordable housing, benefits and entitlements, and legal assistance. They need support and assistance in combating stigma and discrimination. Without ongoing, comprehensive services, these persons will be at the highest risk for increased psychiatric hospitalizations or extensive reliance on placement in nursing homes, child-caring institutions, and other supervised settings; confinement in jail; homelessness; and increased harm to self. These persons will sometimes experience acute psychiatric crises as a result of increases in symptoms of mental illness or environmental stresses. Because some may be reluctant to access mental health or other services, extensive outreach may be needed to engage them into services. The person and family need ongoing, comprehensive treatment and intensive community support and wraparound services to help them achieve and maintain a more stable level of functioning and a lifestyle relying more on natural supports and less on formal mental health services." State definition also includes this group: "Persons in Need of Ongoing Low Intensity Services - have a diagnosed mental disorder. They function in a fairly stable manner but may occasionally experience acute psychiatric crises. Some may have a history of trauma, such as physical or sexual abuse or neglect, which contributes to the mental health problem. These persons need services such as ongoing medication management (prescription, evaluation, and monitoring), case management, and/or periodic support contacts. With the benefit of such services, they are usually able to live relatively independently and have good potential for recovery and increasing success in community living. Without ongoing supports and services, however, they can be at a serious risk for relapse and for much more costly treatment, including intensive crisis intervention and psychiatric hospitalization."
14A	The increase in African Americans and multi-racial clients is real. The three largest counties contributed heavily to our increase in clients reported and they also are the more racially diverse than other counties in the state which explains this specific increase.
