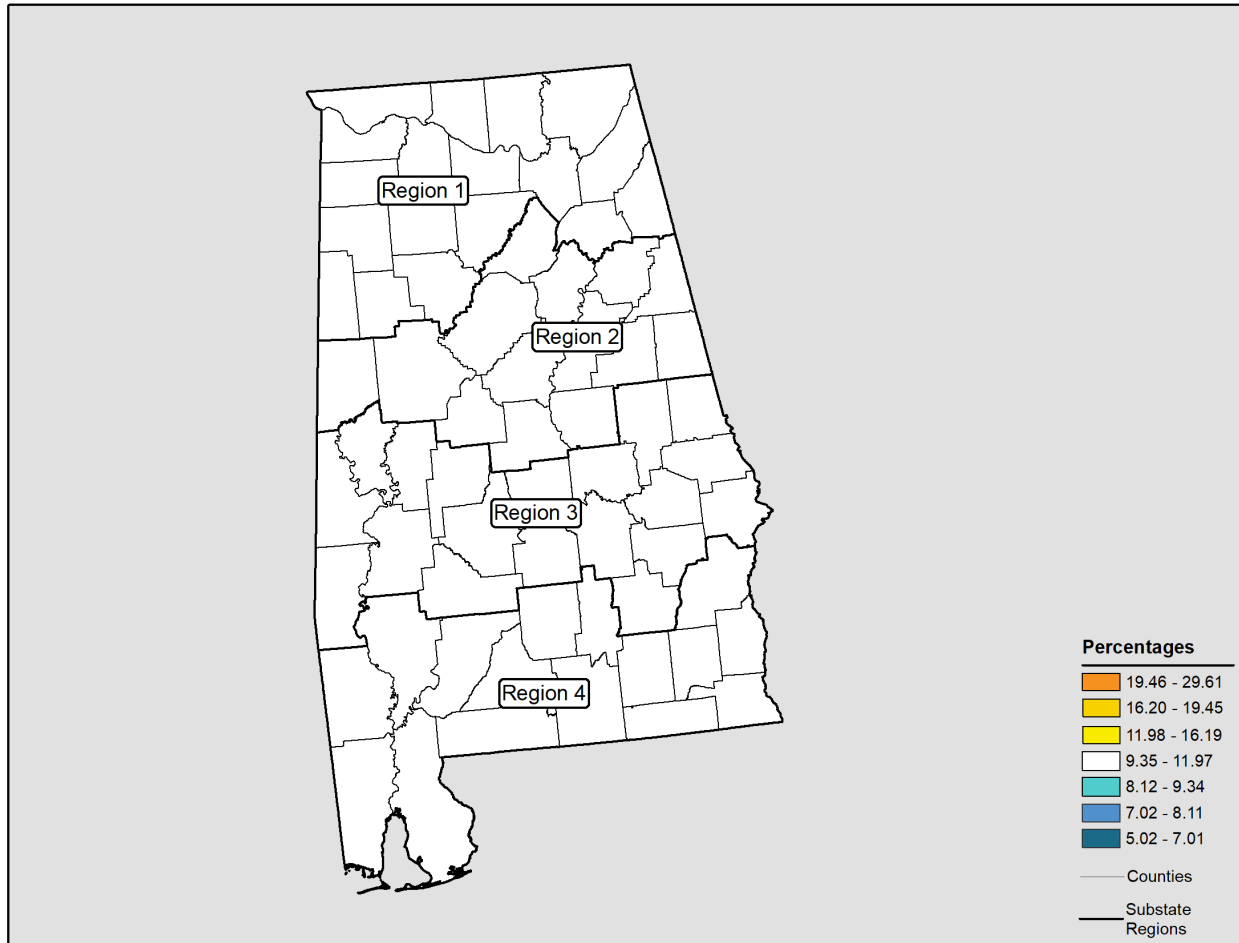

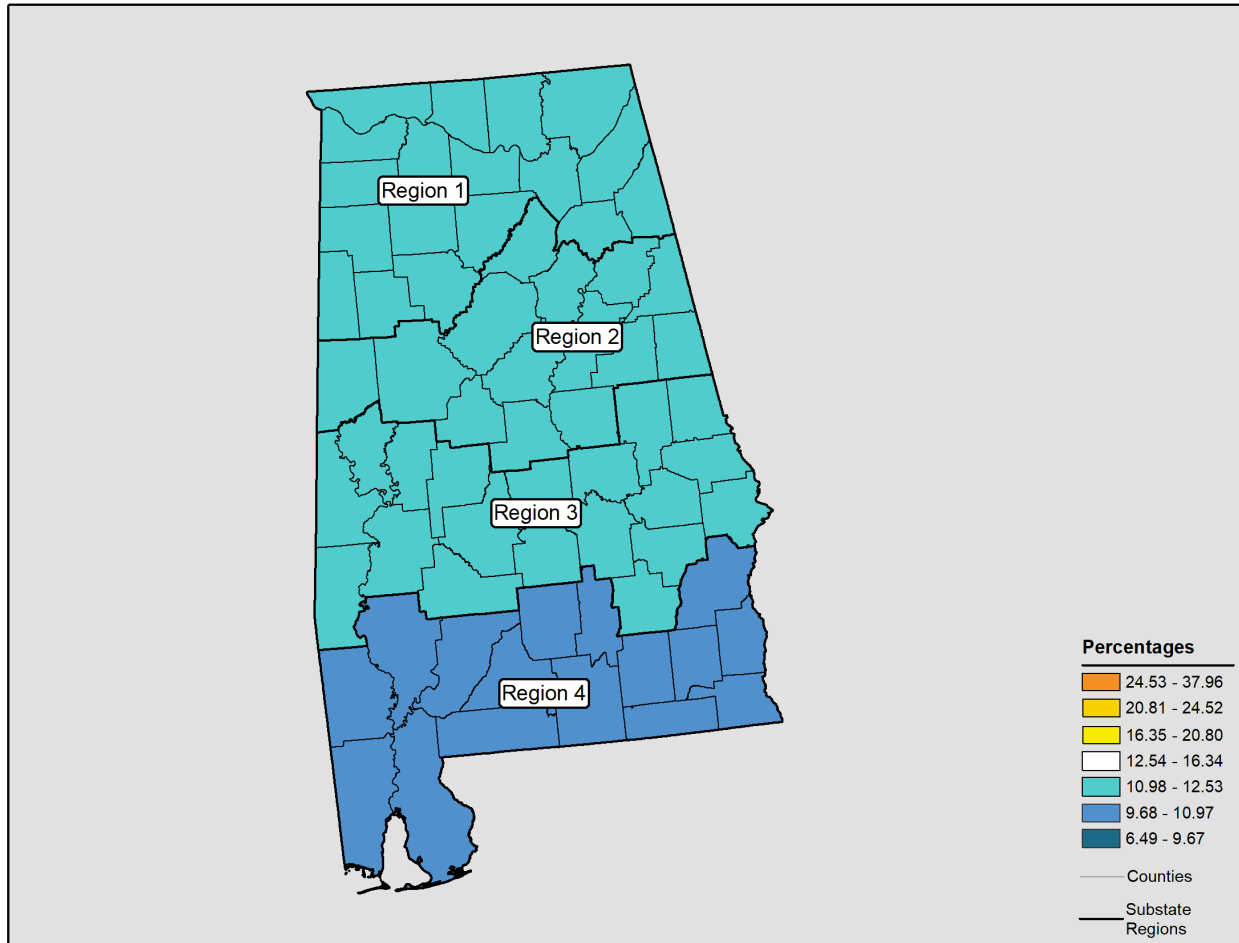
Figure 1.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

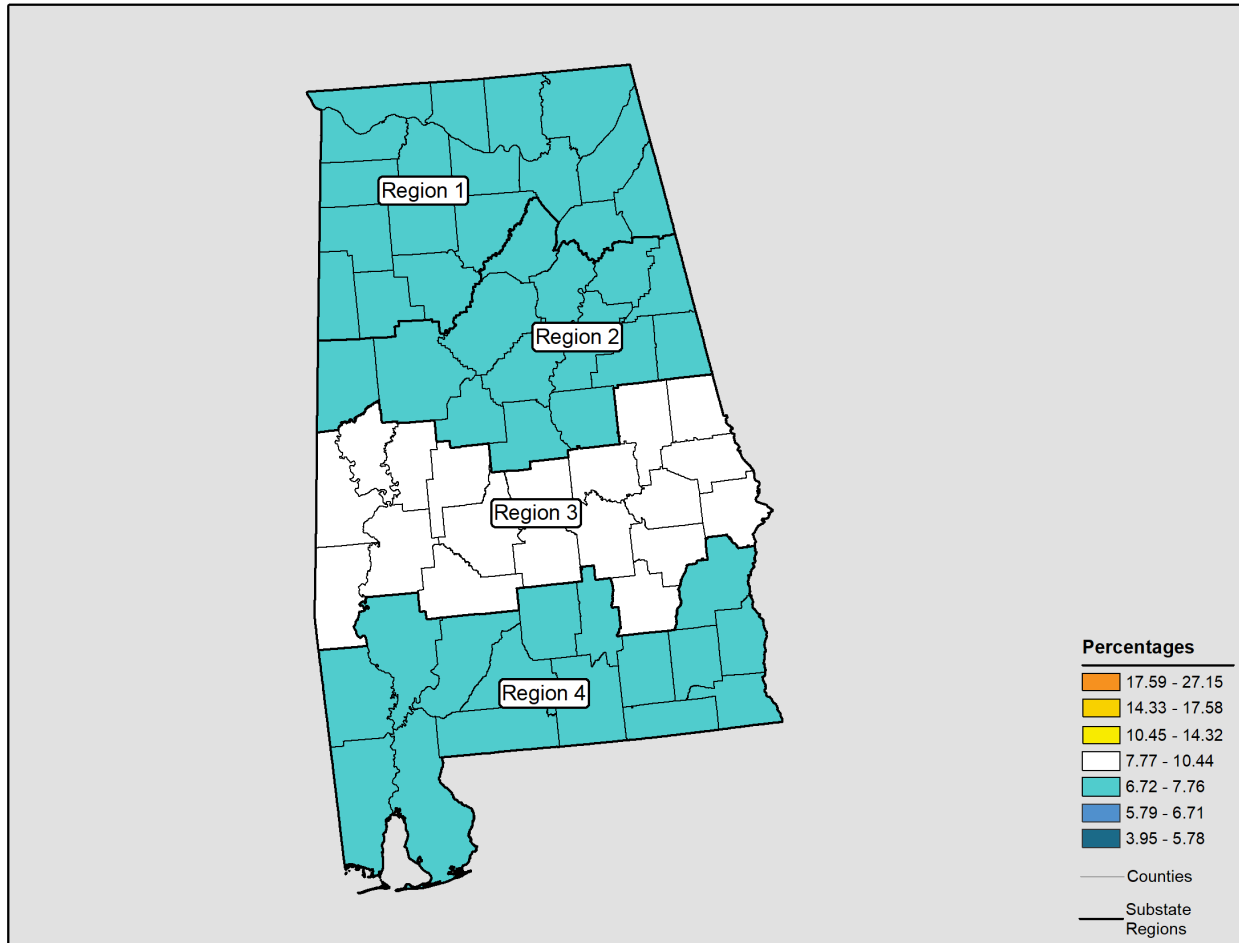
Figure 1.2 *Marijuana Use in the Past Year* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

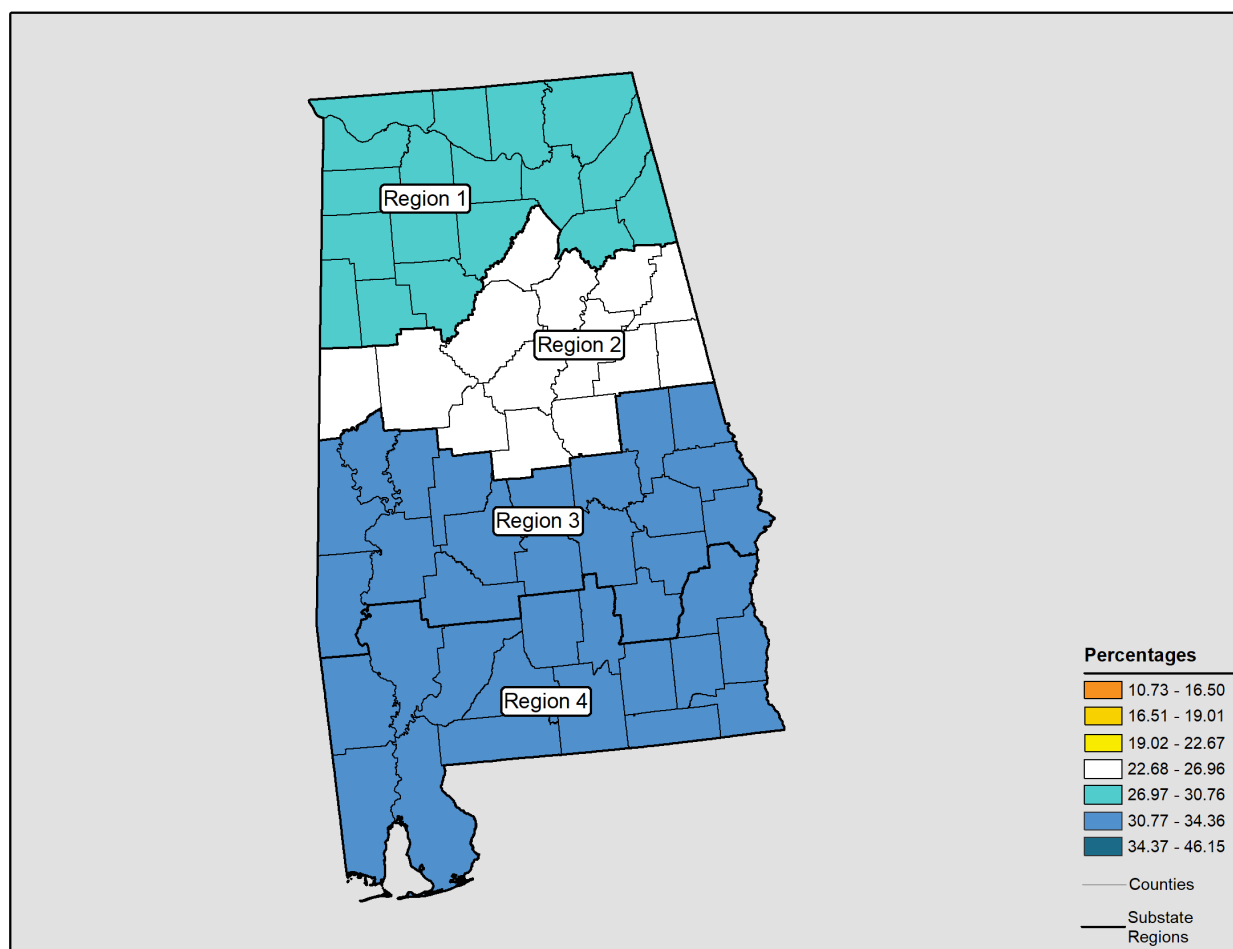
Figure 1.3 *Marijuana Use in the Past Month* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

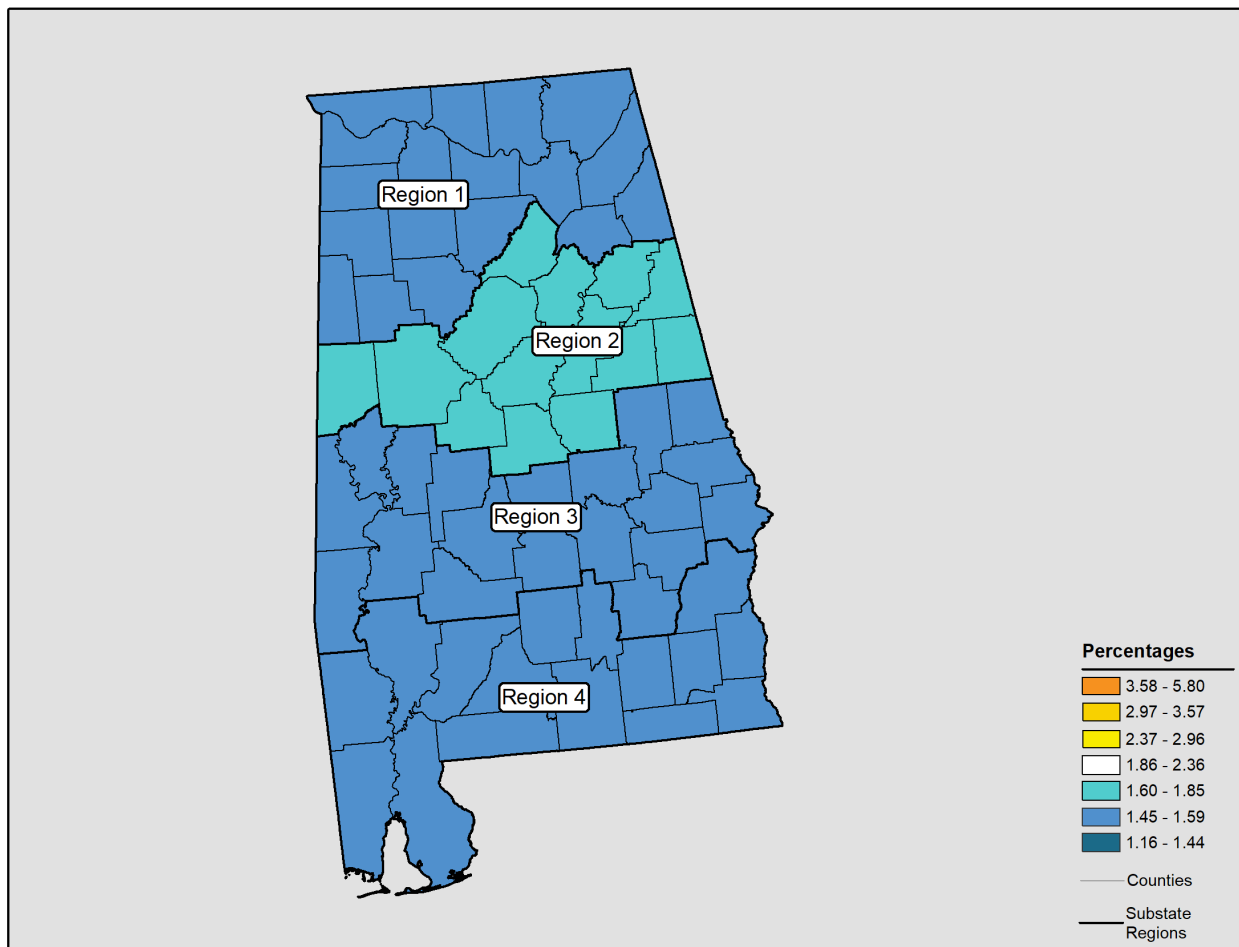
Figure 1.4 *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

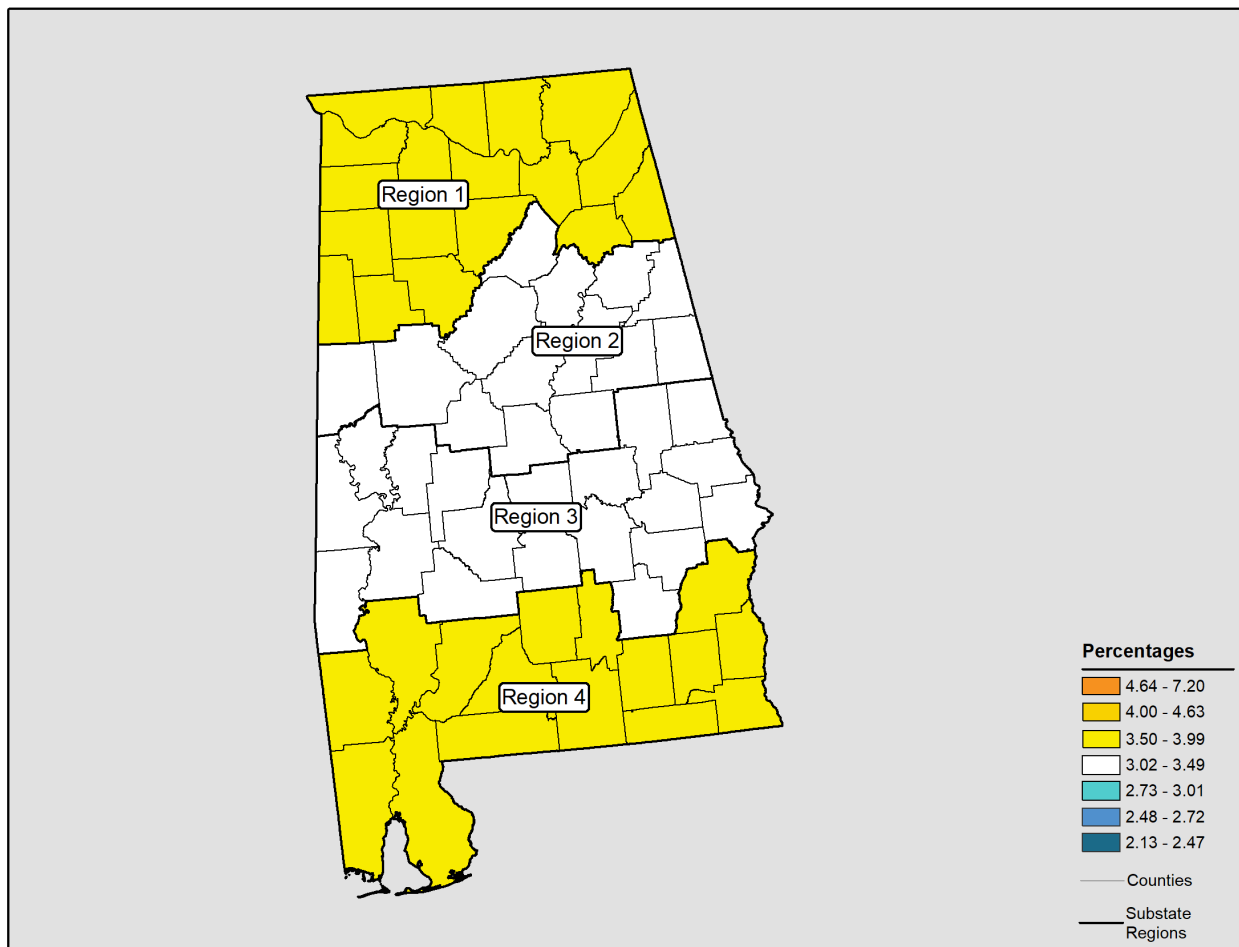
**Figure 1.5 *First Use of Marijuana* among Individuals Aged 12 or Older in Alabama, by Substate Region:

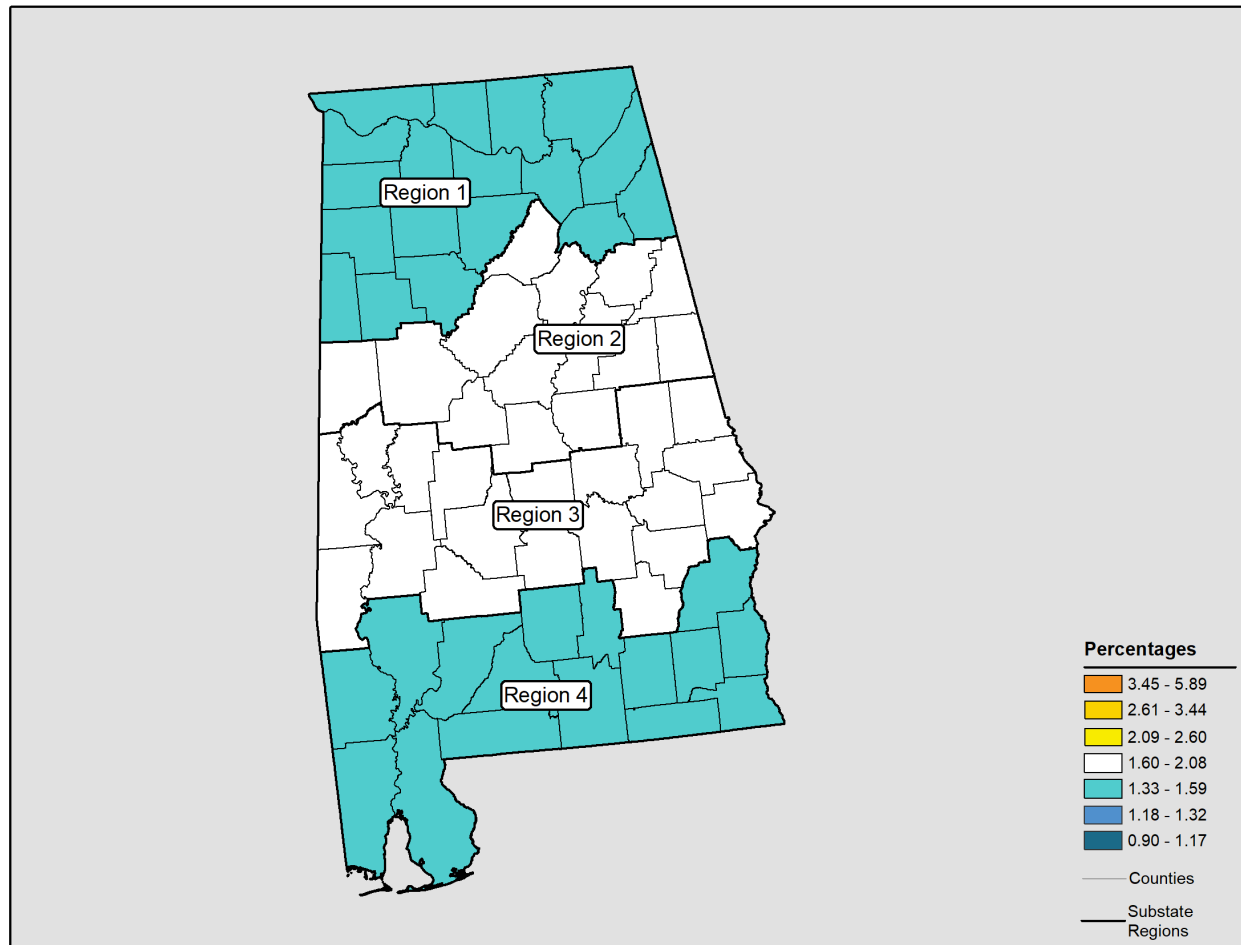
Figure 1.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

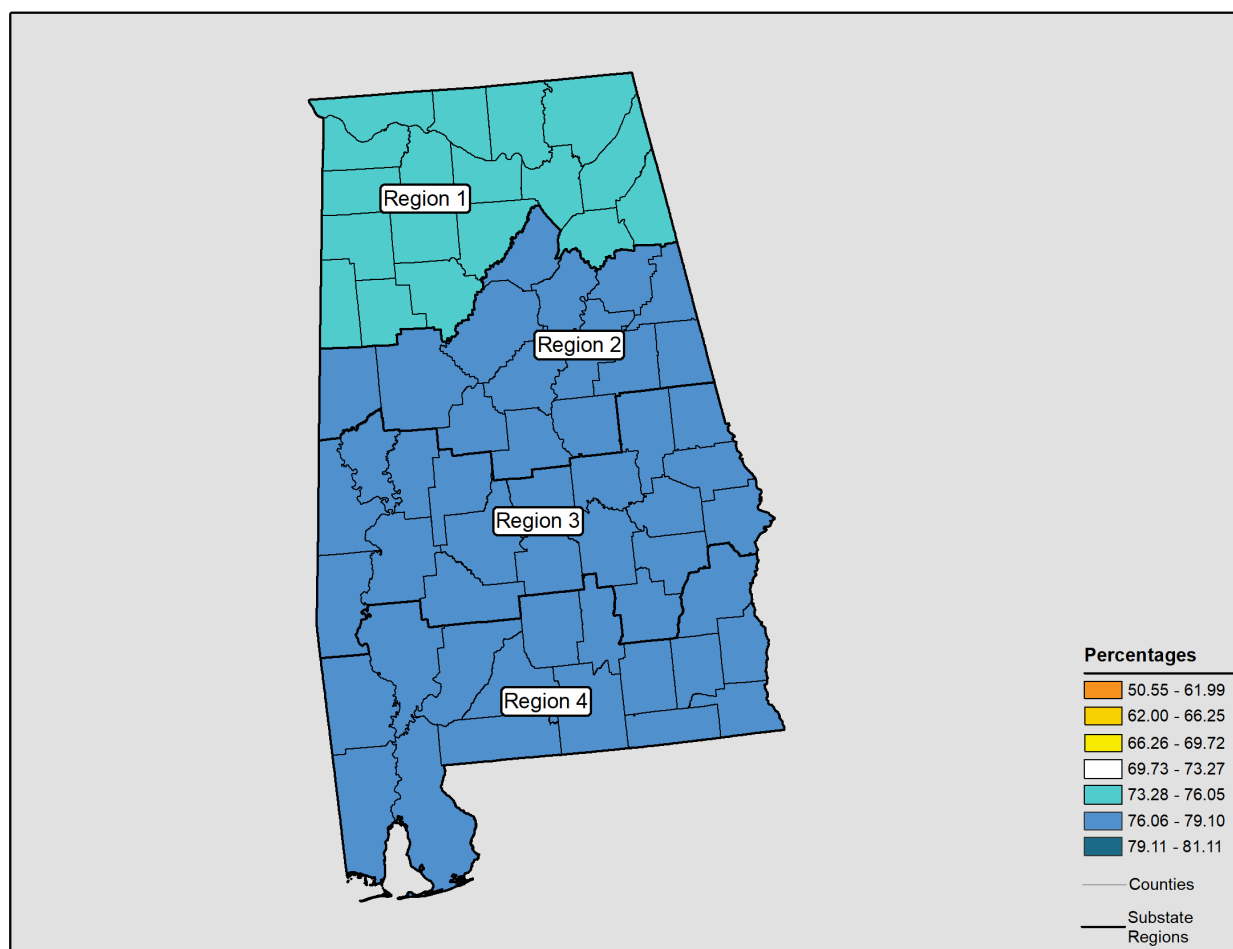
Figure 1.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

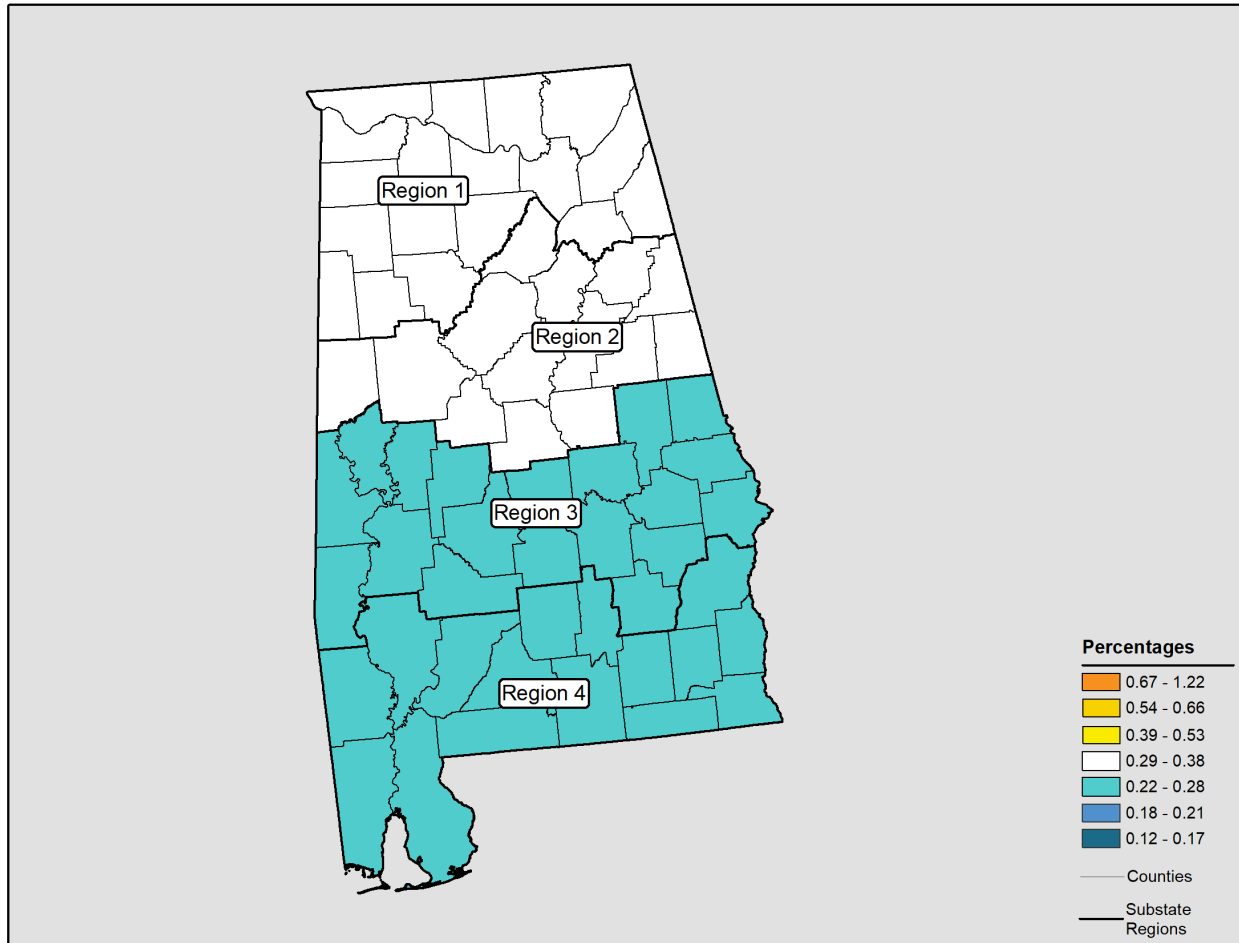
Figure 1.8 *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

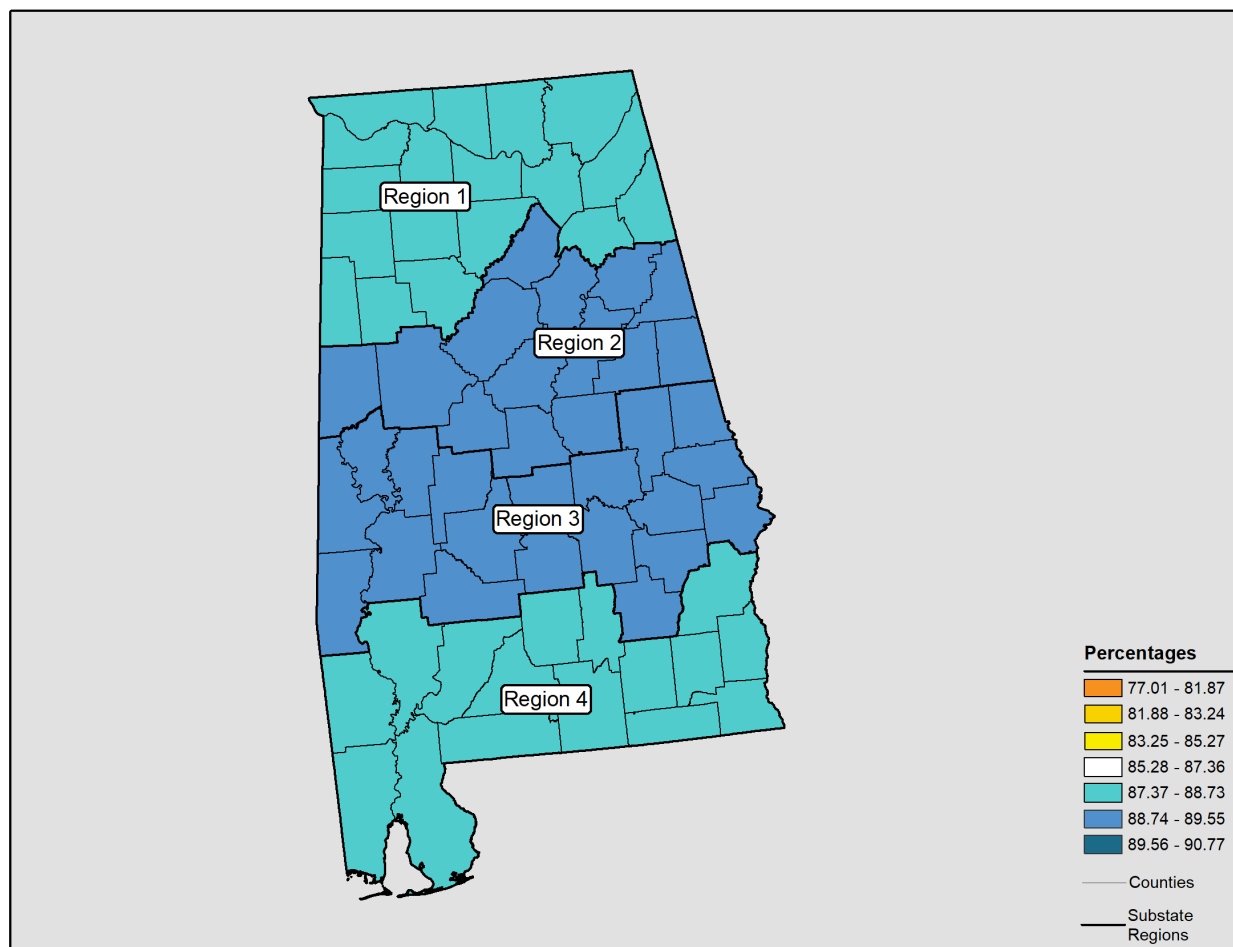
Figure 1.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

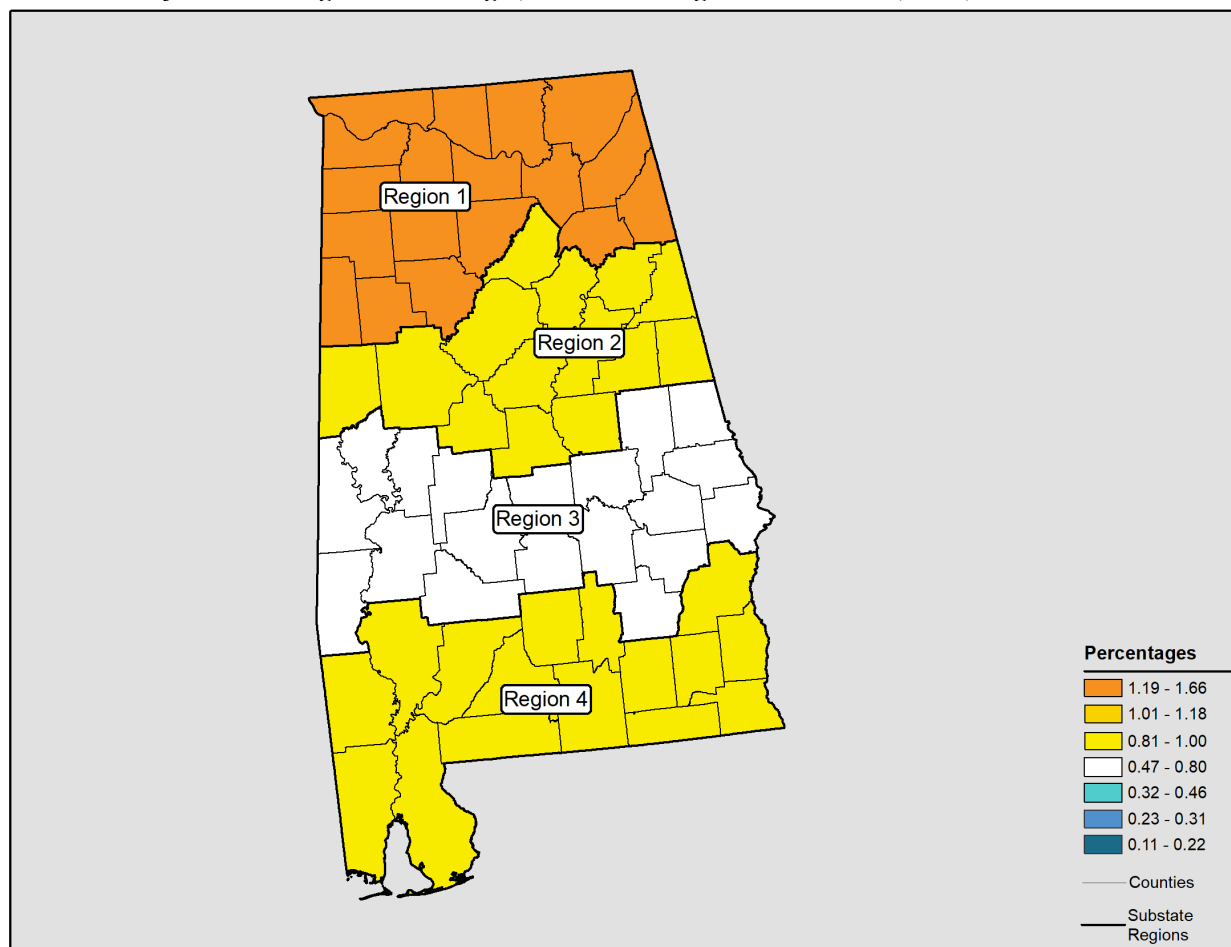
Figure 1.10 *Perceptions of Great Risk from Trying Heroin Once or Twice* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

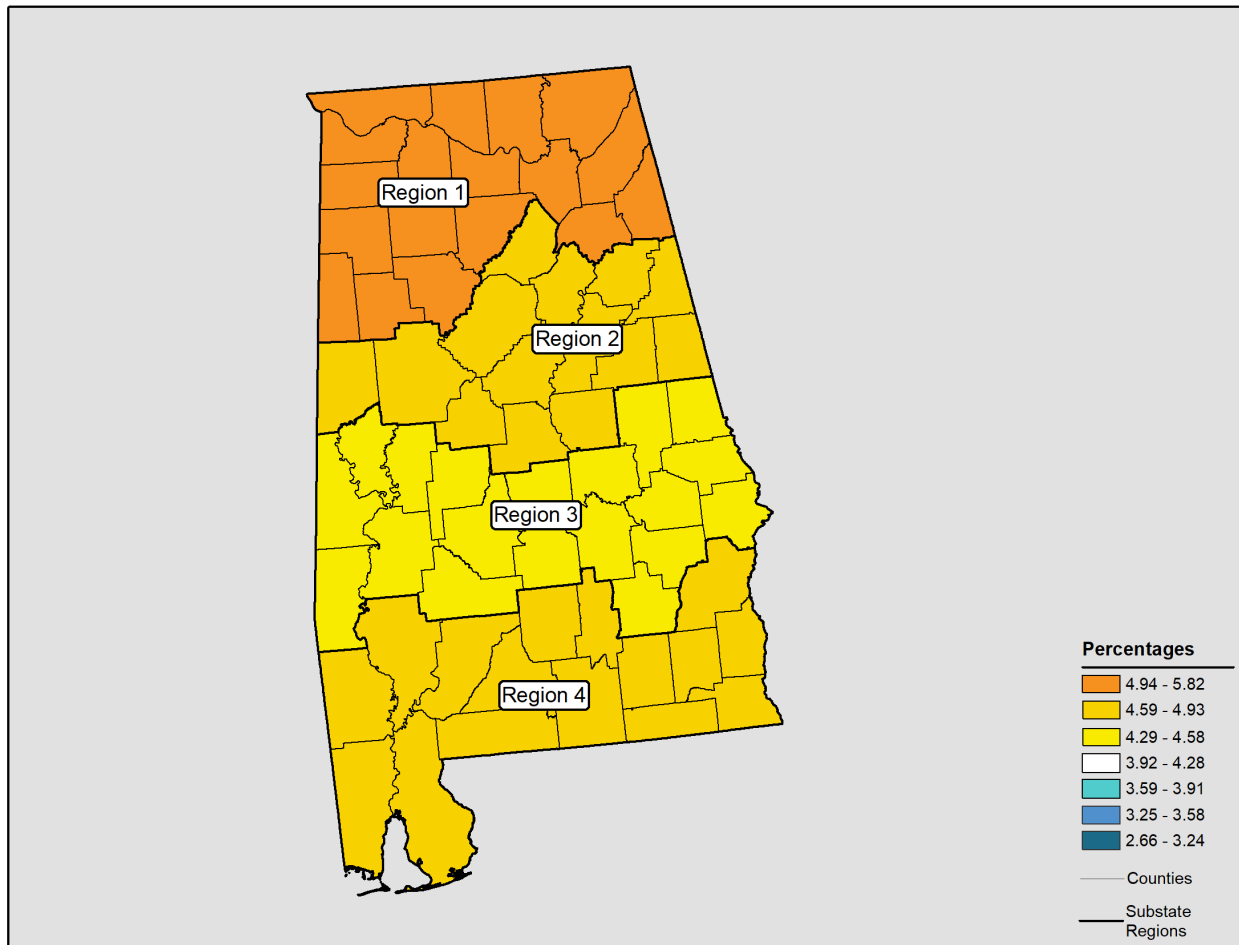
Figure 1.11 *Methamphetamine Use in the Past Year* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

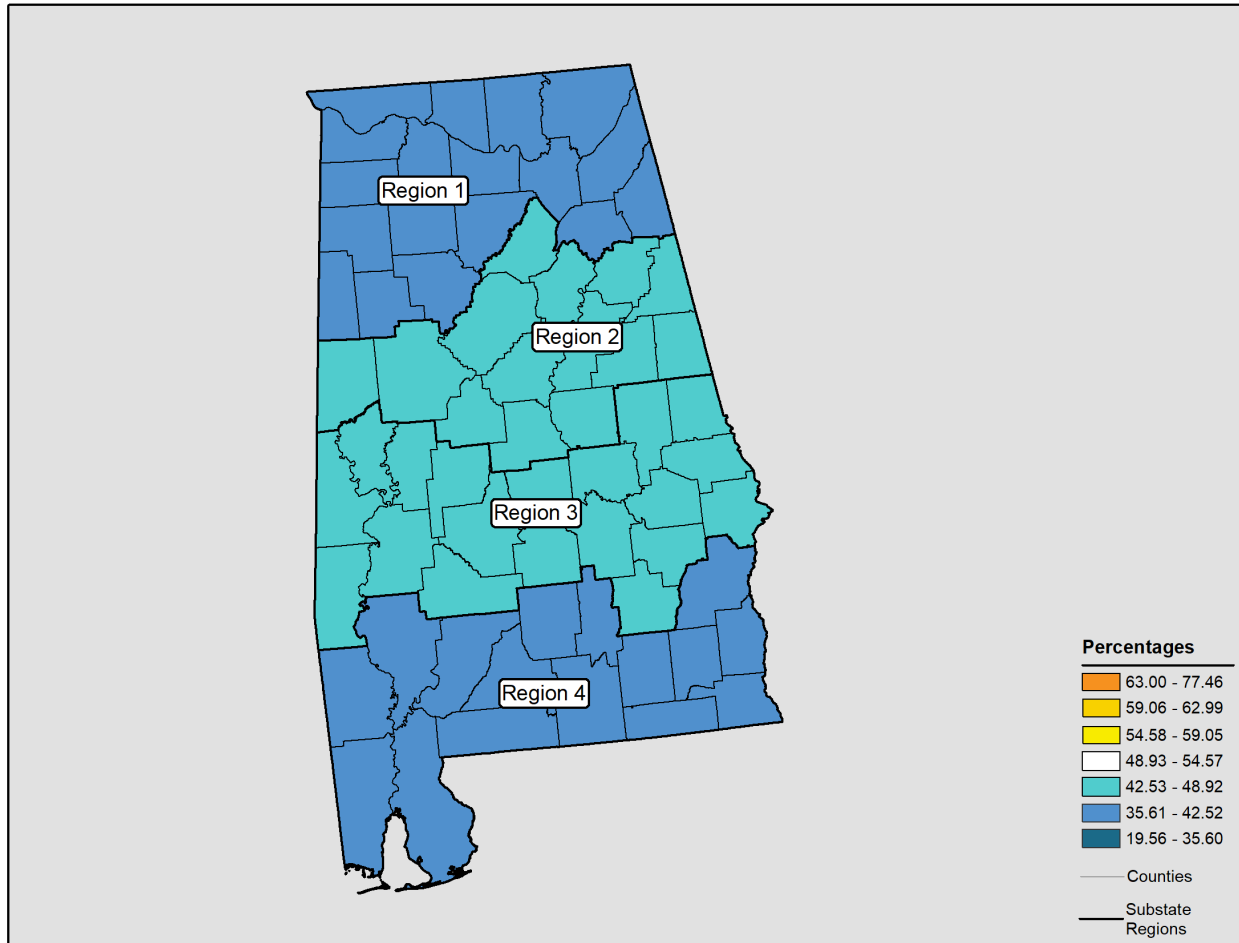
Figure 1.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

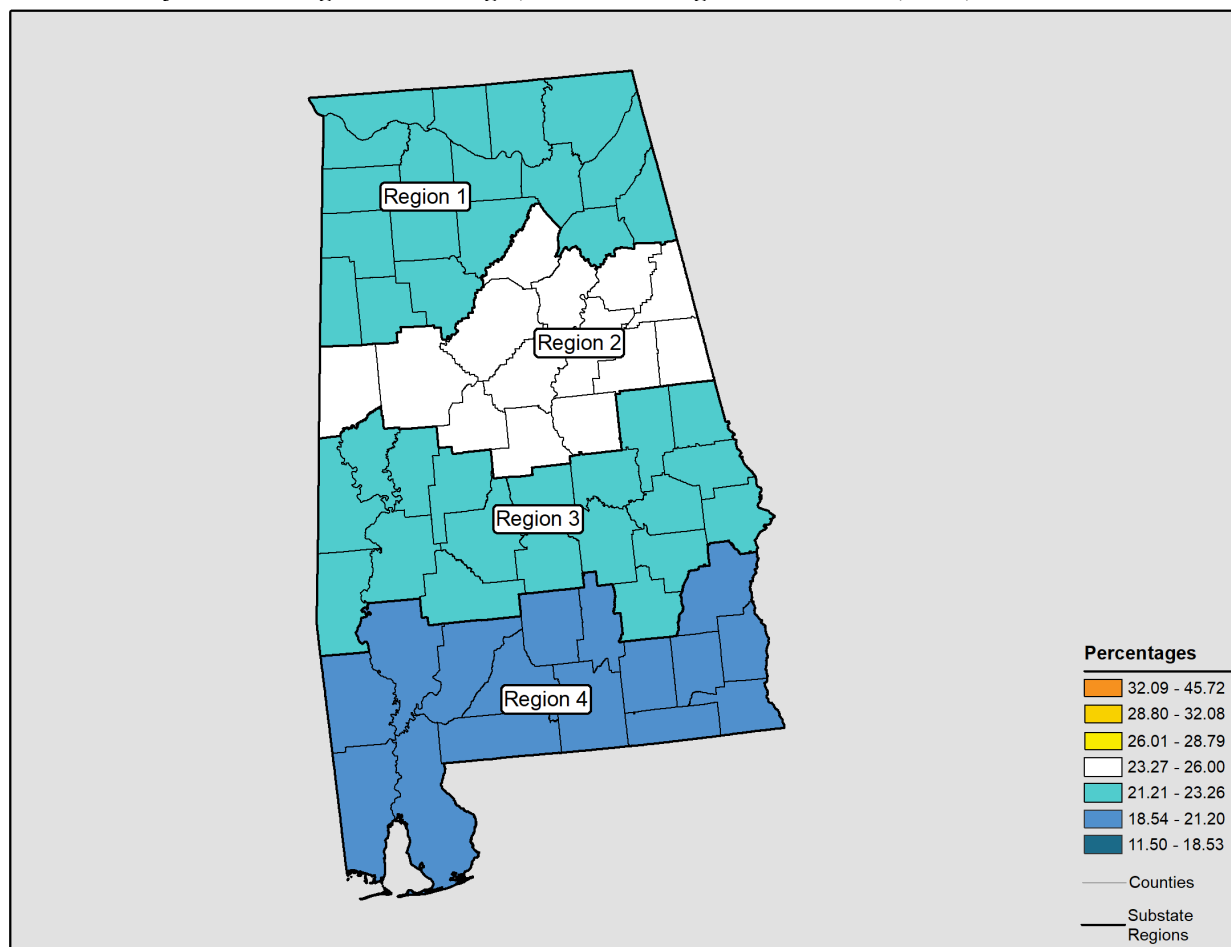
Figure 1.13 *Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

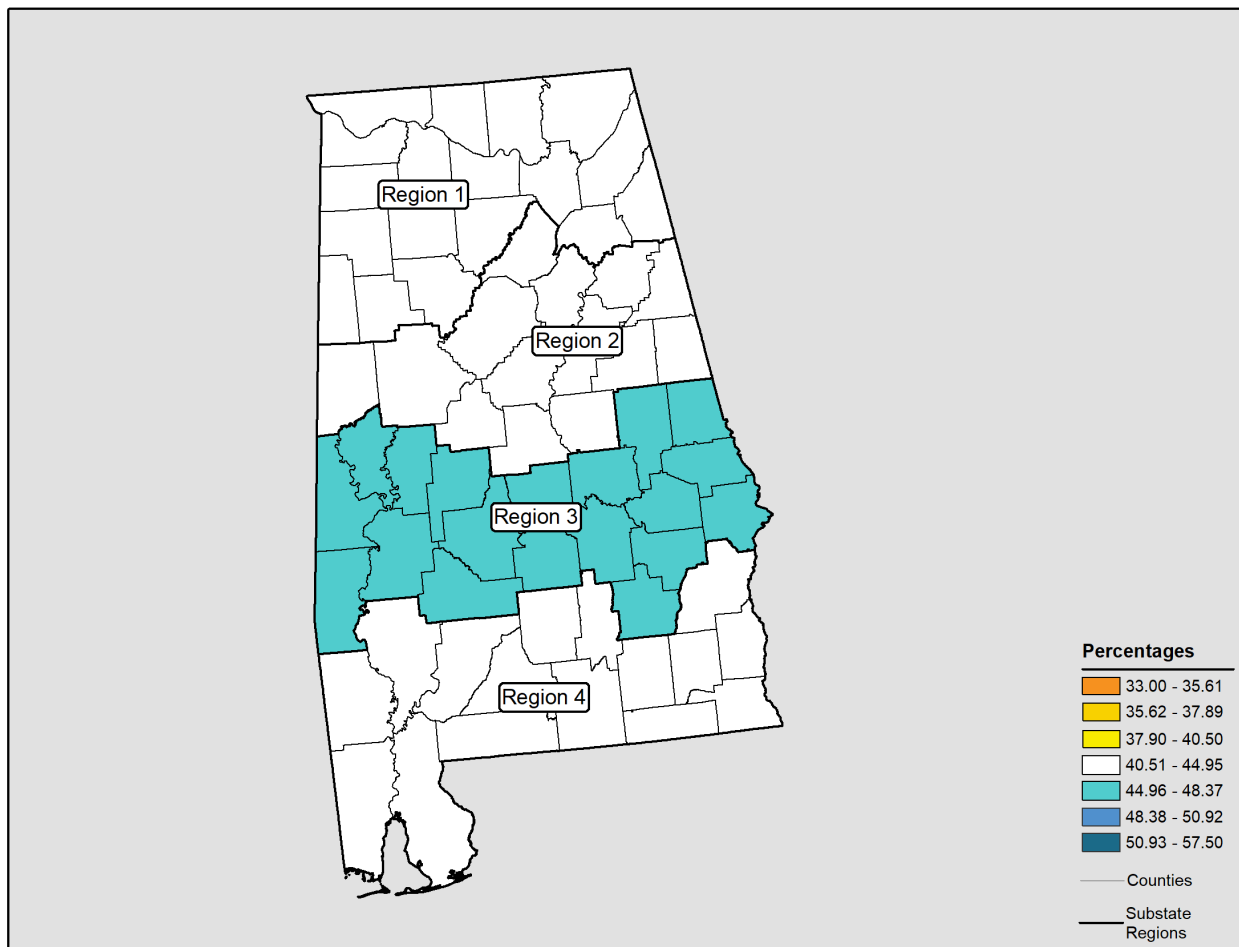
Figure 1.14 *Binge Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

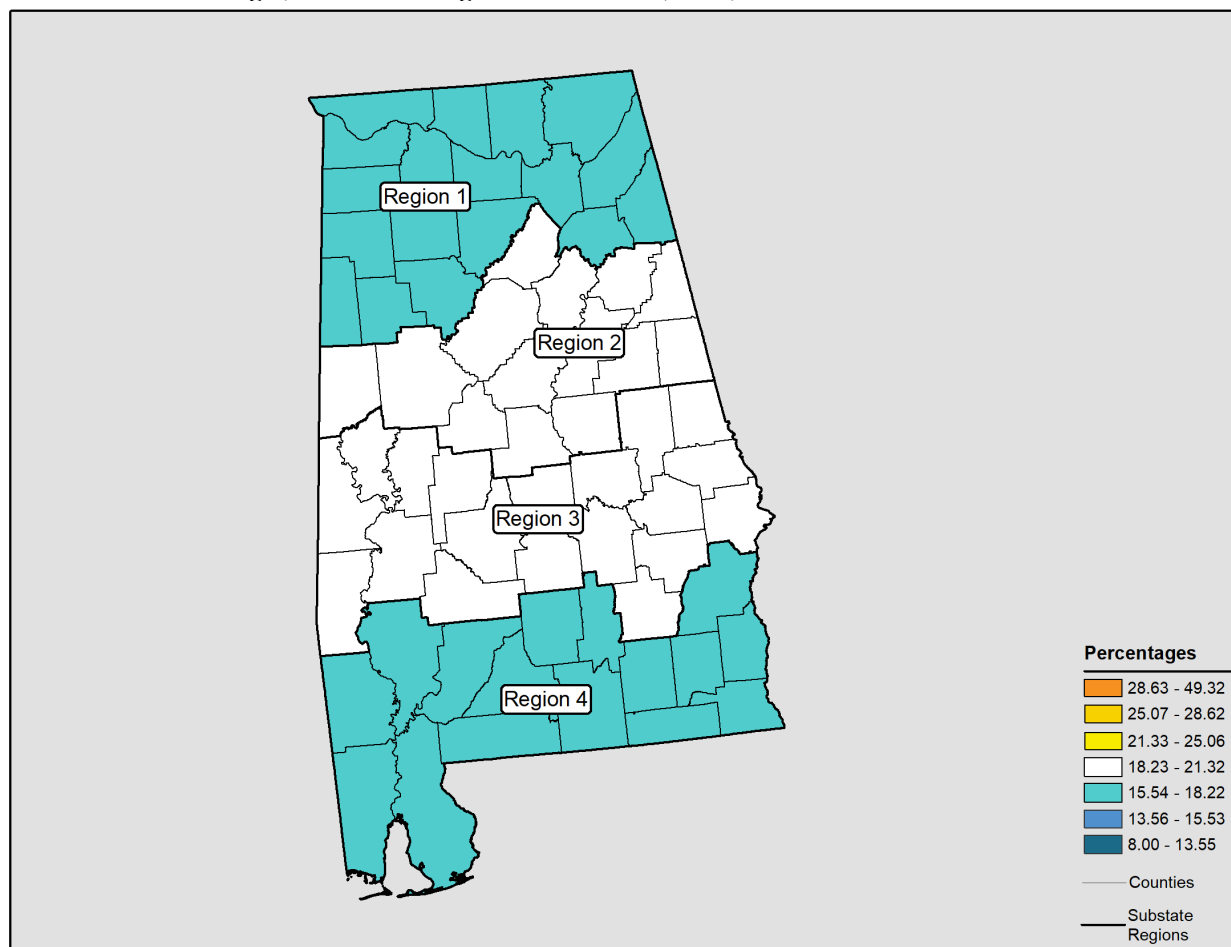
Figure 1.15 *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

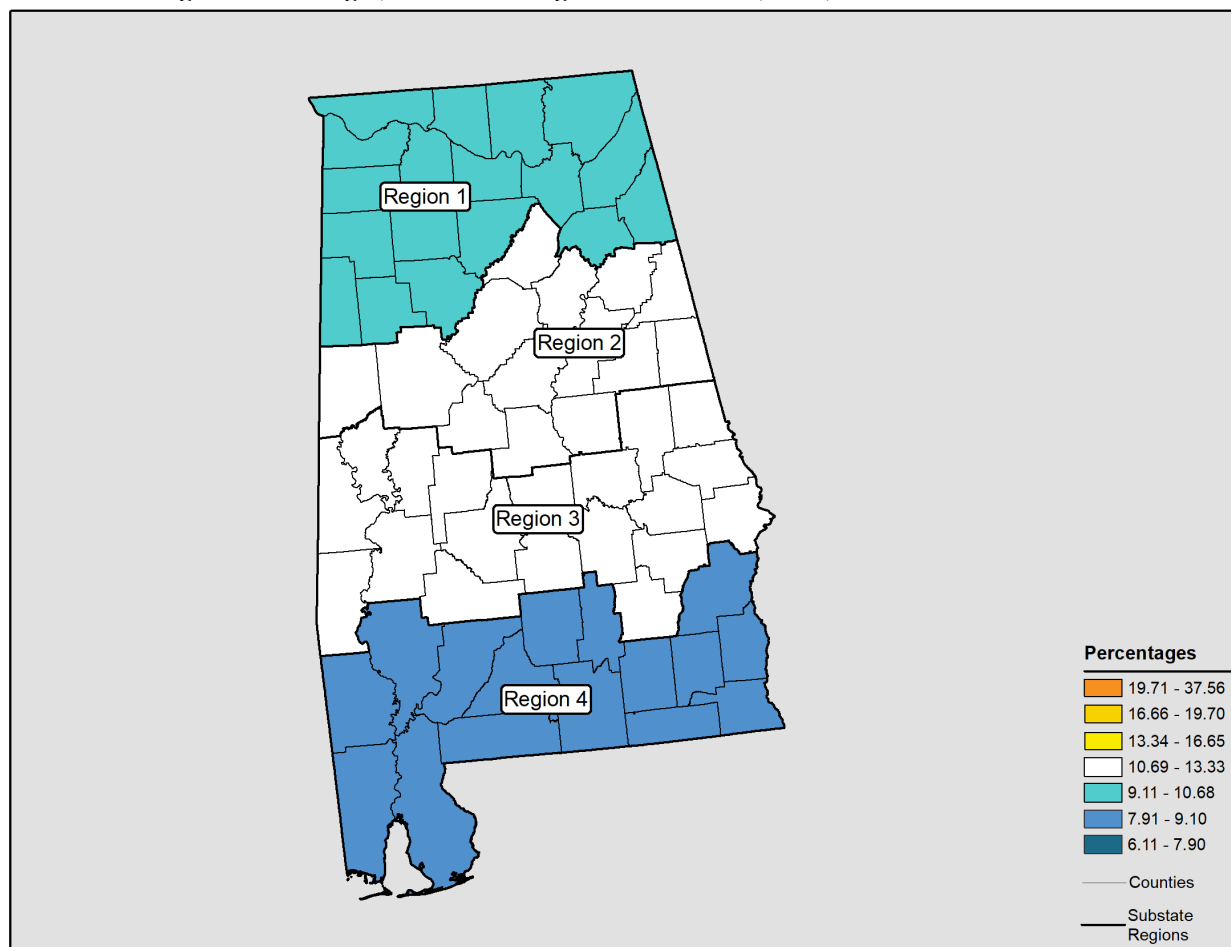
Figure 1.16 *Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

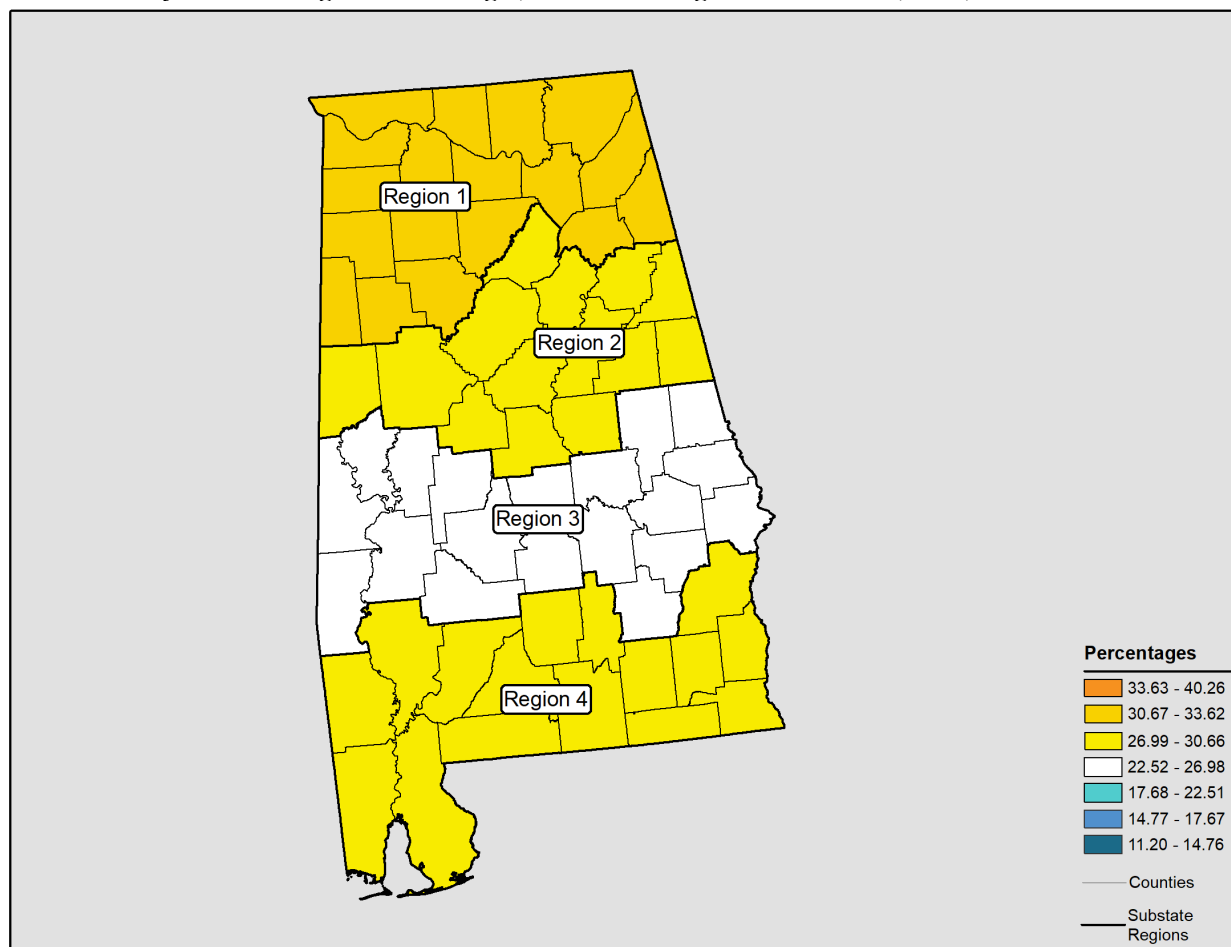
Figure 1.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

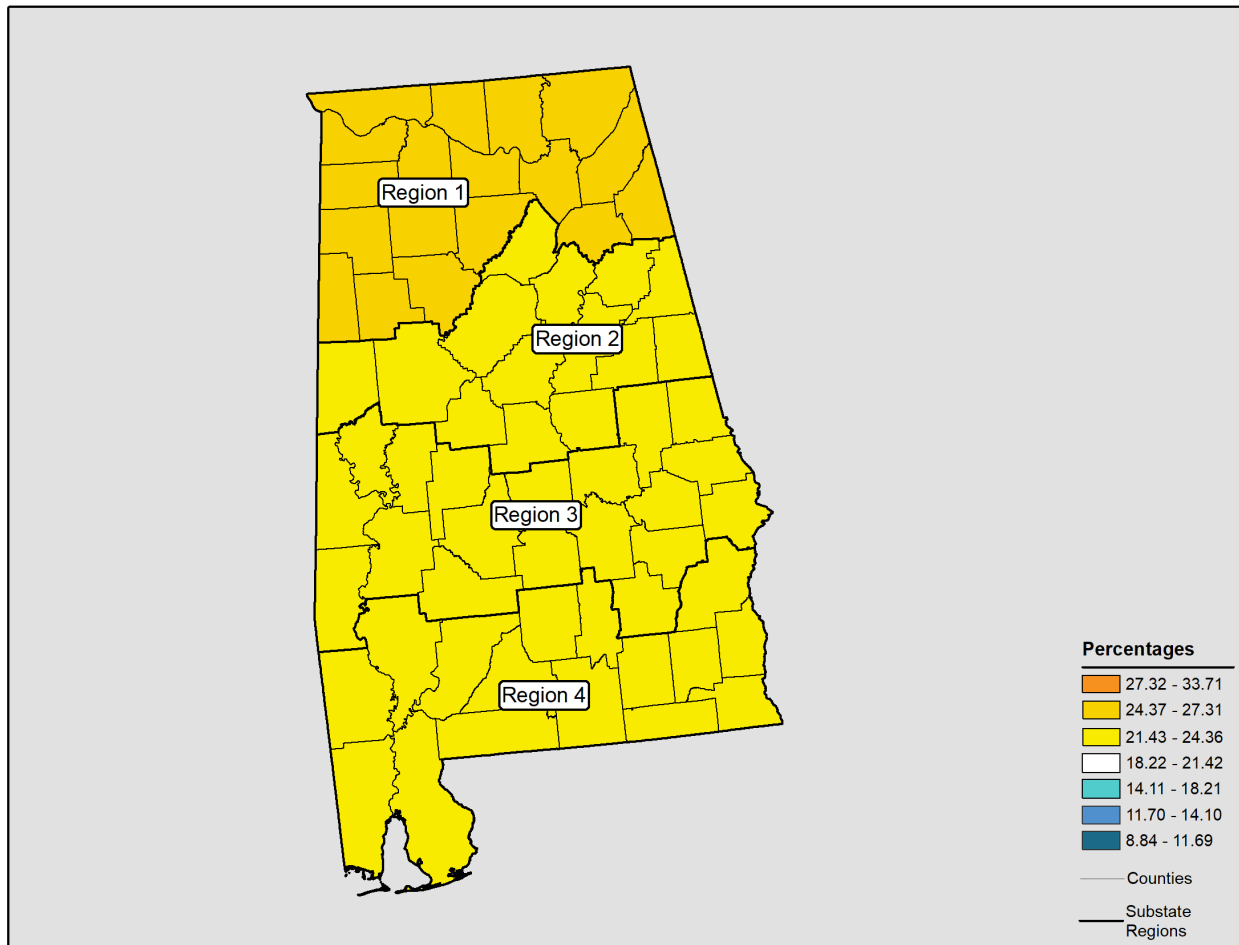
Figure 1.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

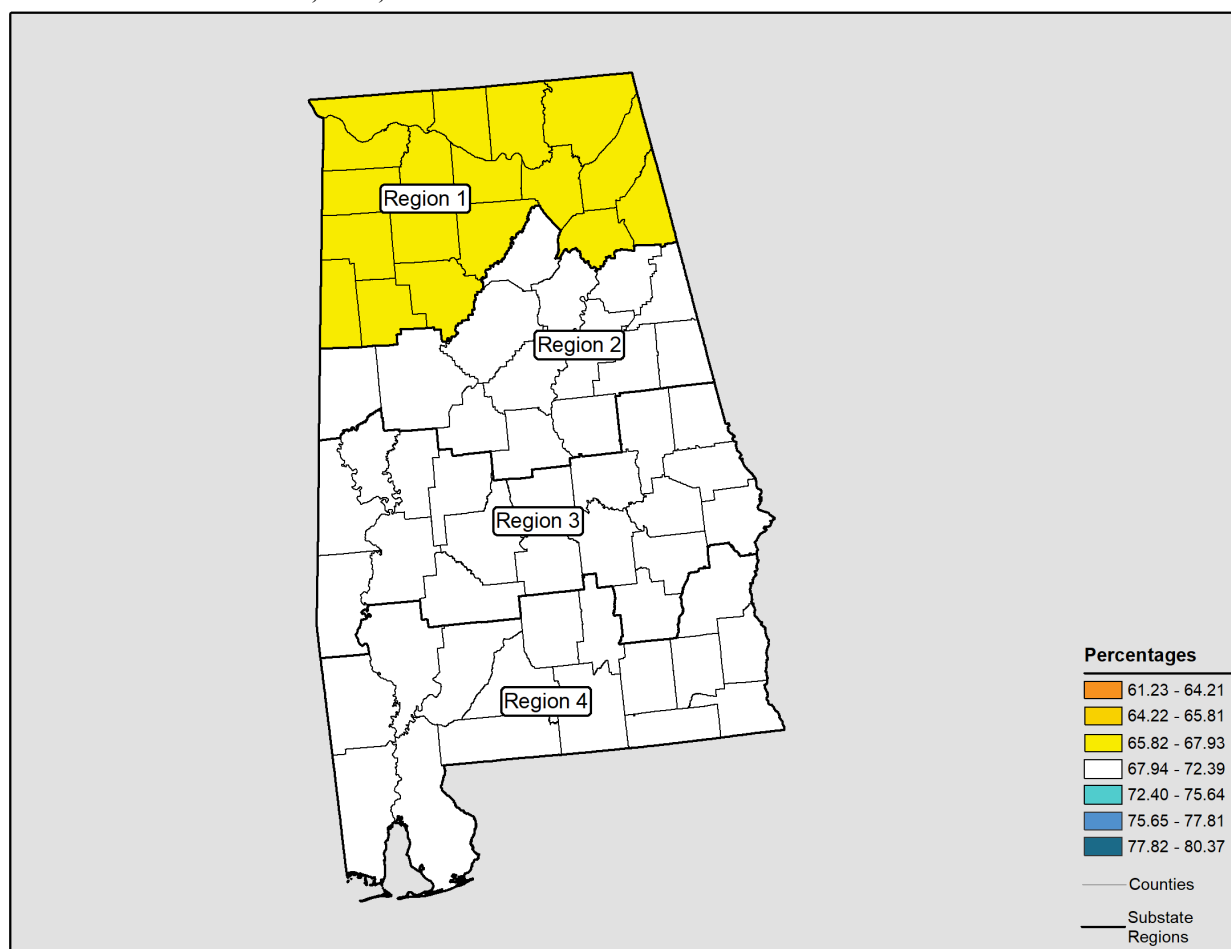
Figure 1.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

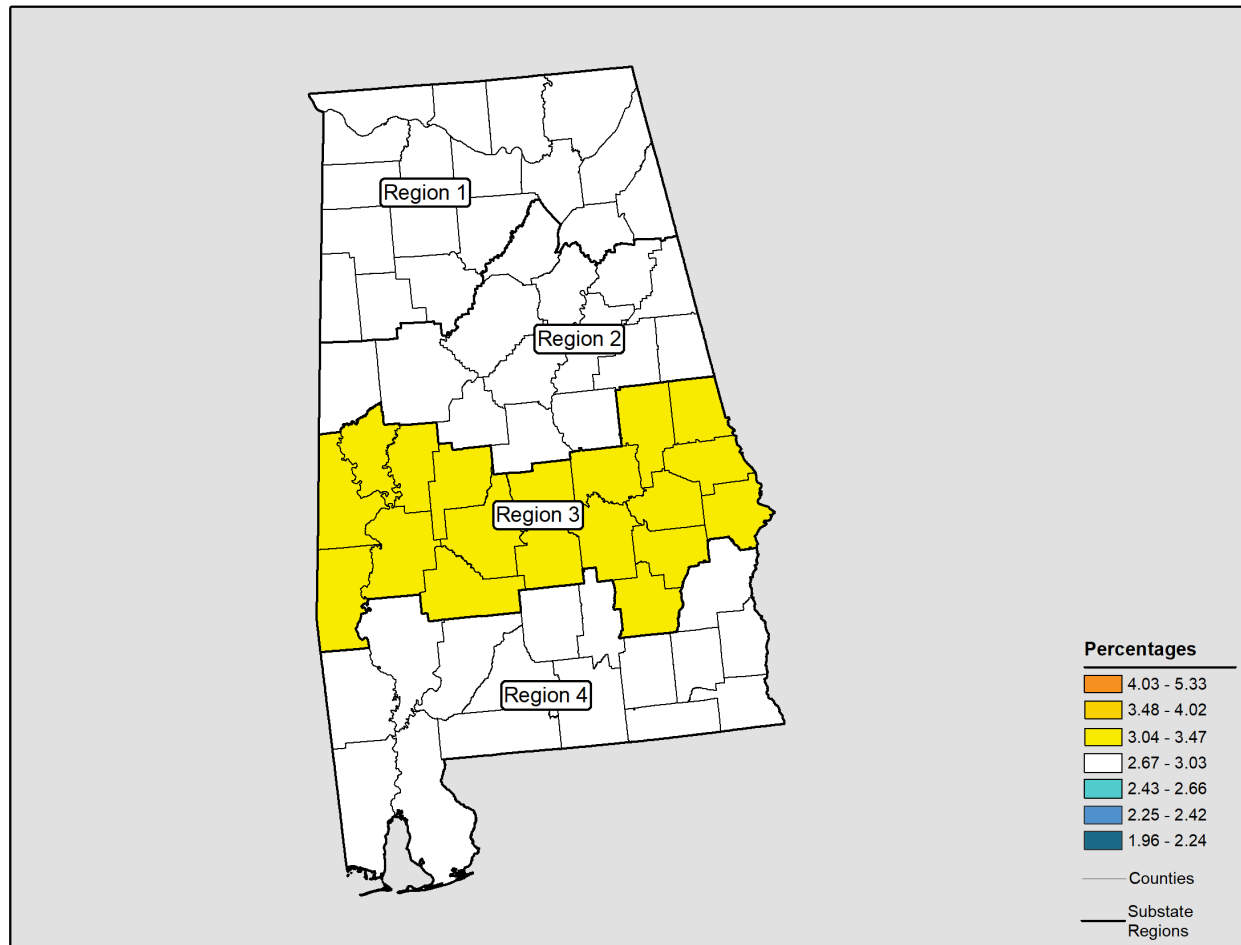
Figure 1.20 *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

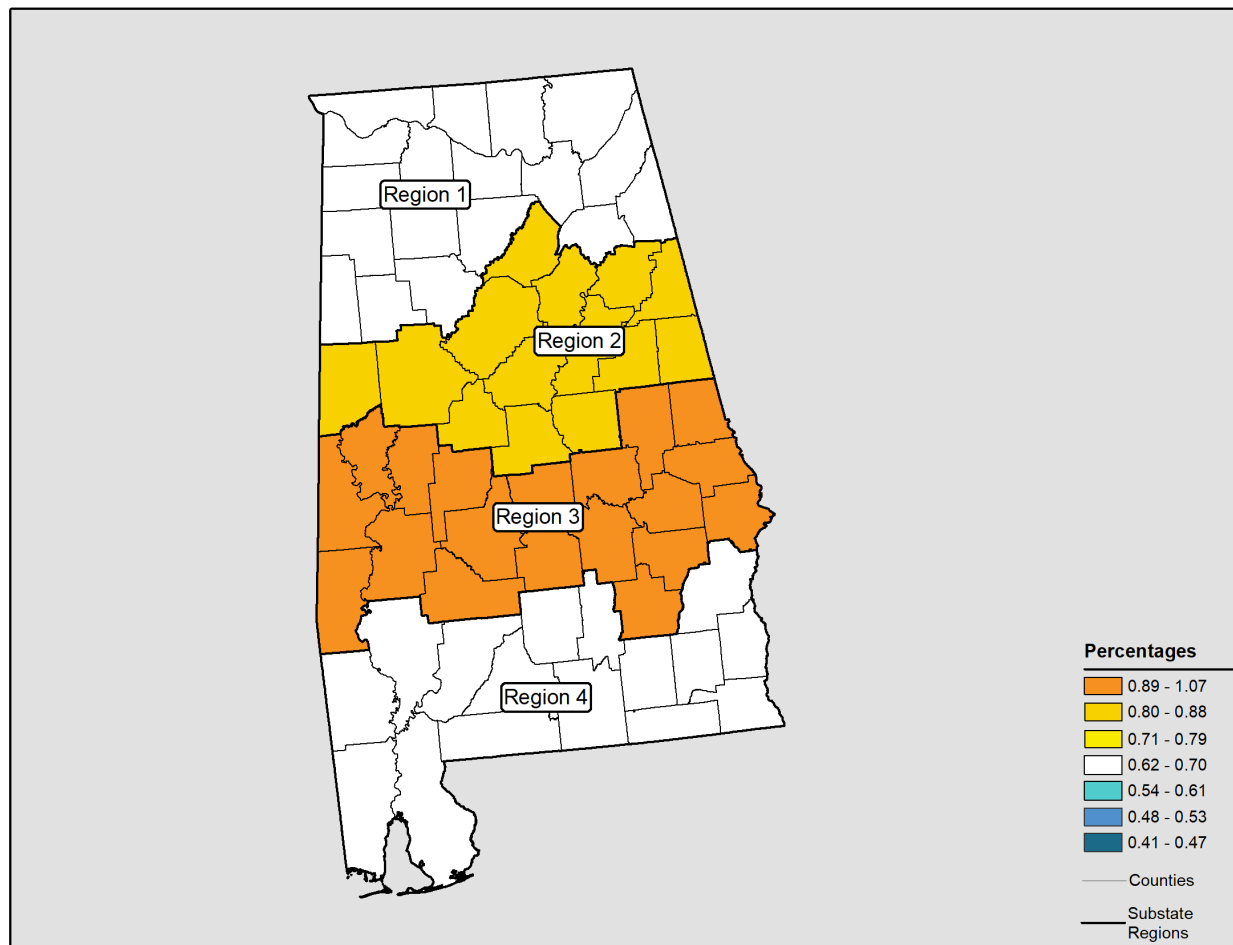
Figure 1.21 *Illicit Drug Use Disorder in the Past Year* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

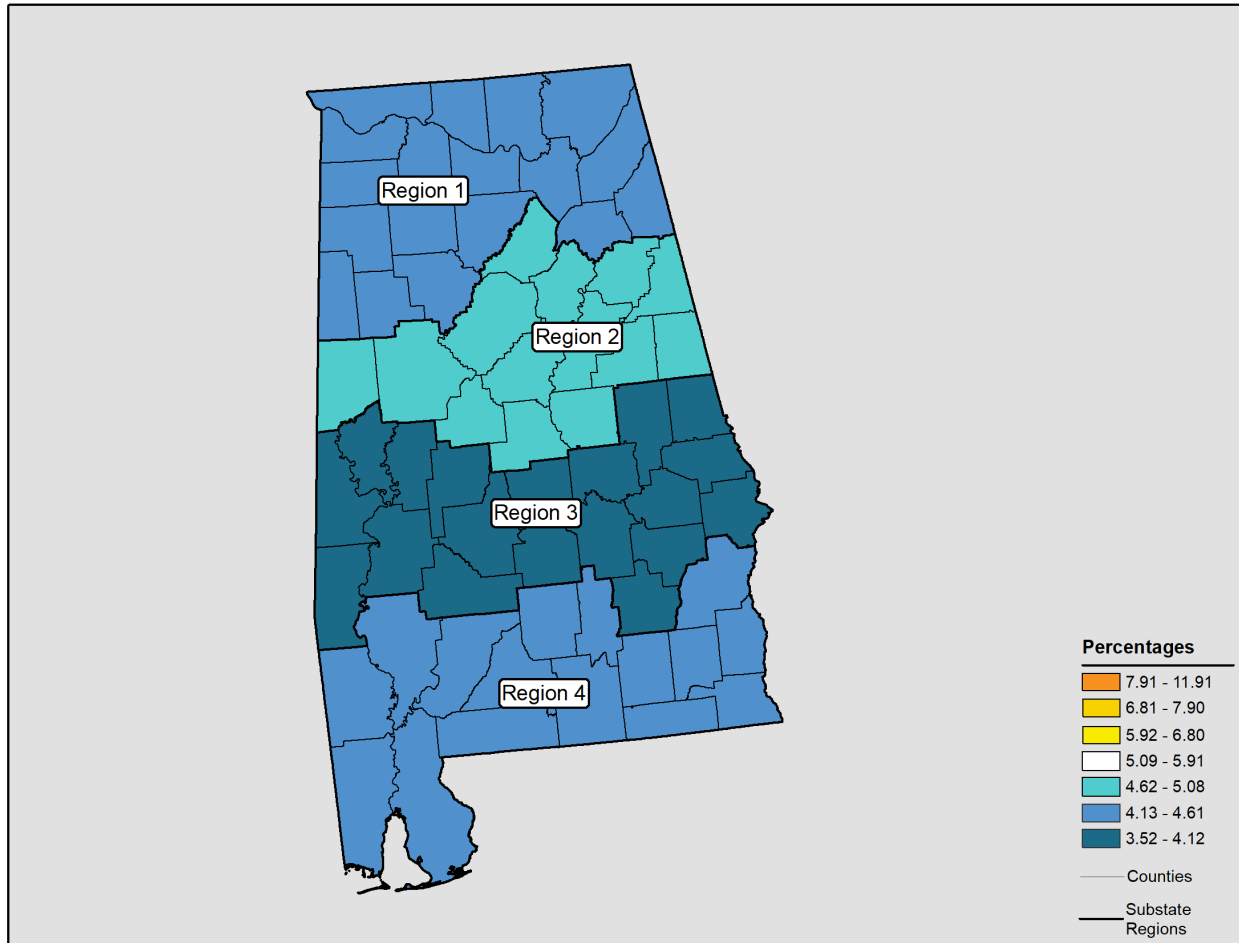
Figure 1.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

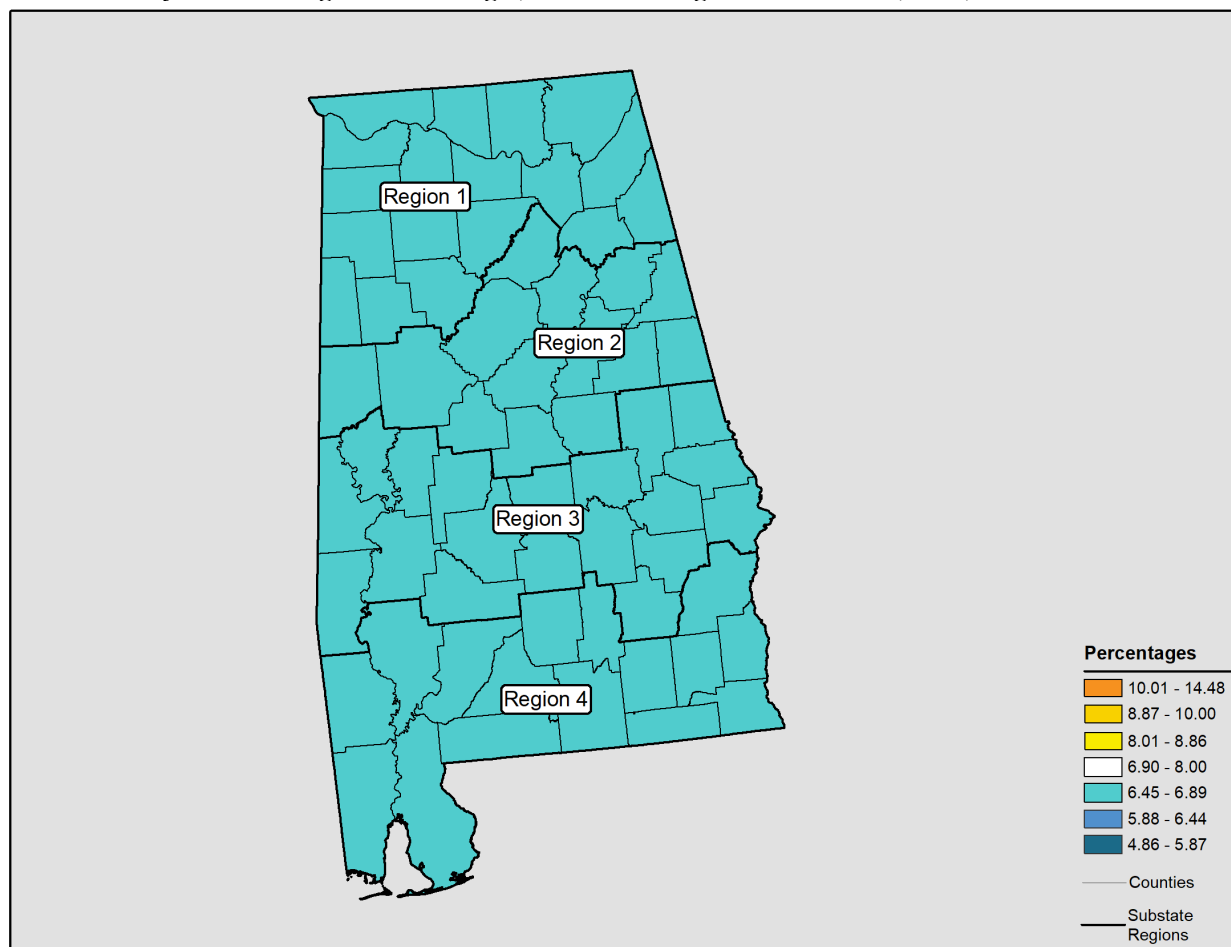
Figure 1.23 *Alcohol Use Disorder in the Past Year* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

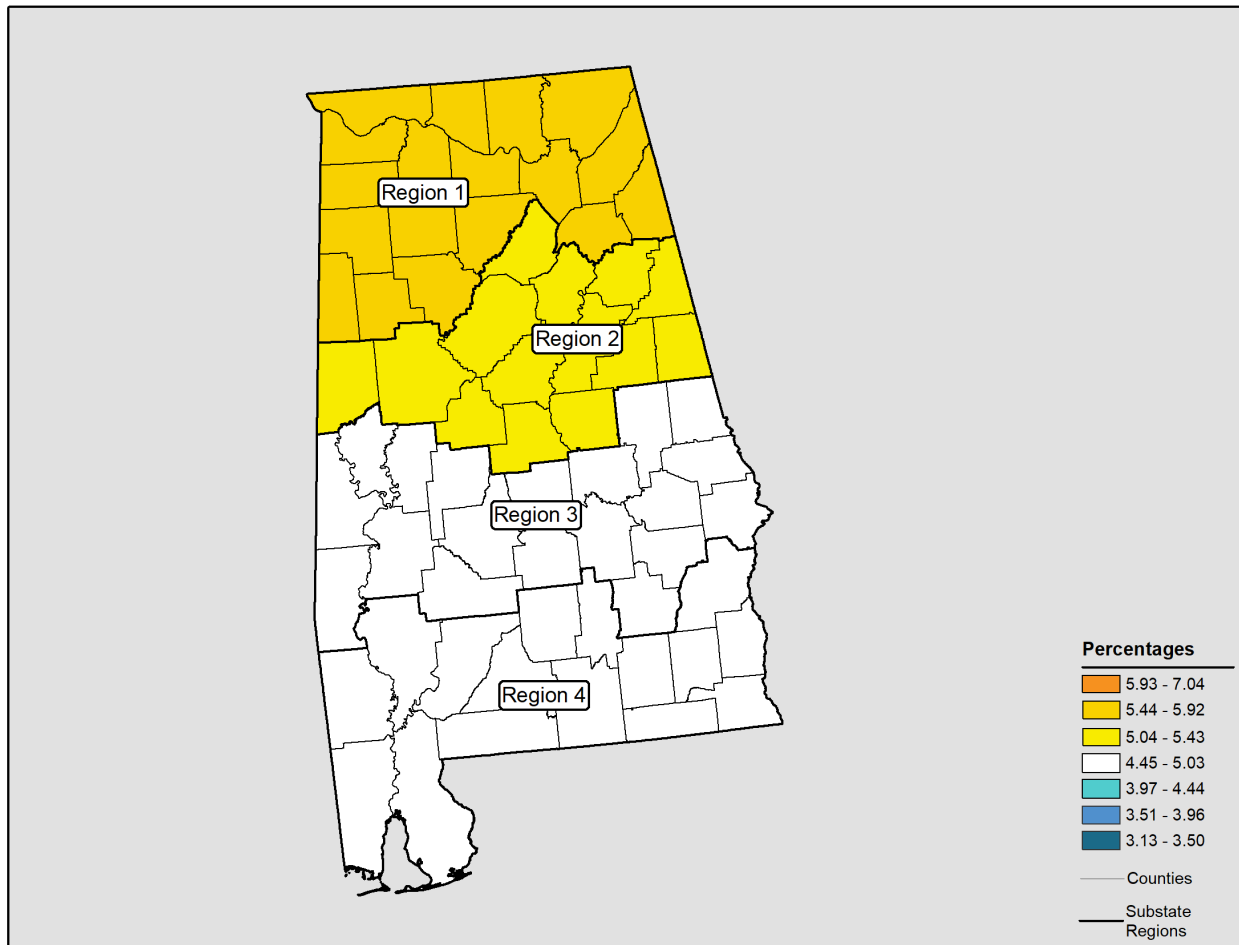
Figure 1.24 *Substance Use Disorder in the Past Year* among Individuals Aged 12 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

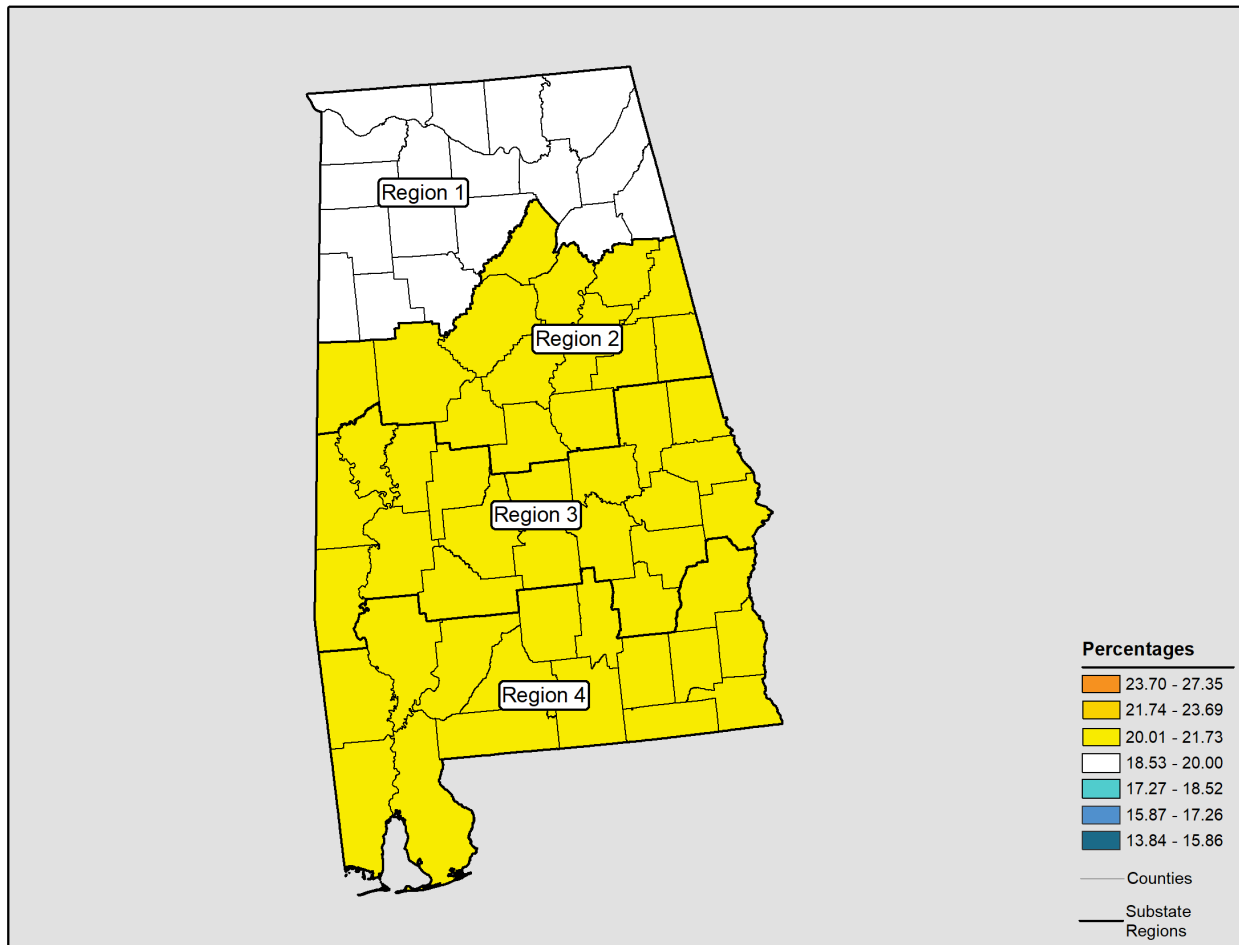
Figure 1.25 *Serious Mental Illness in the Past Year* among Adults Aged 18 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

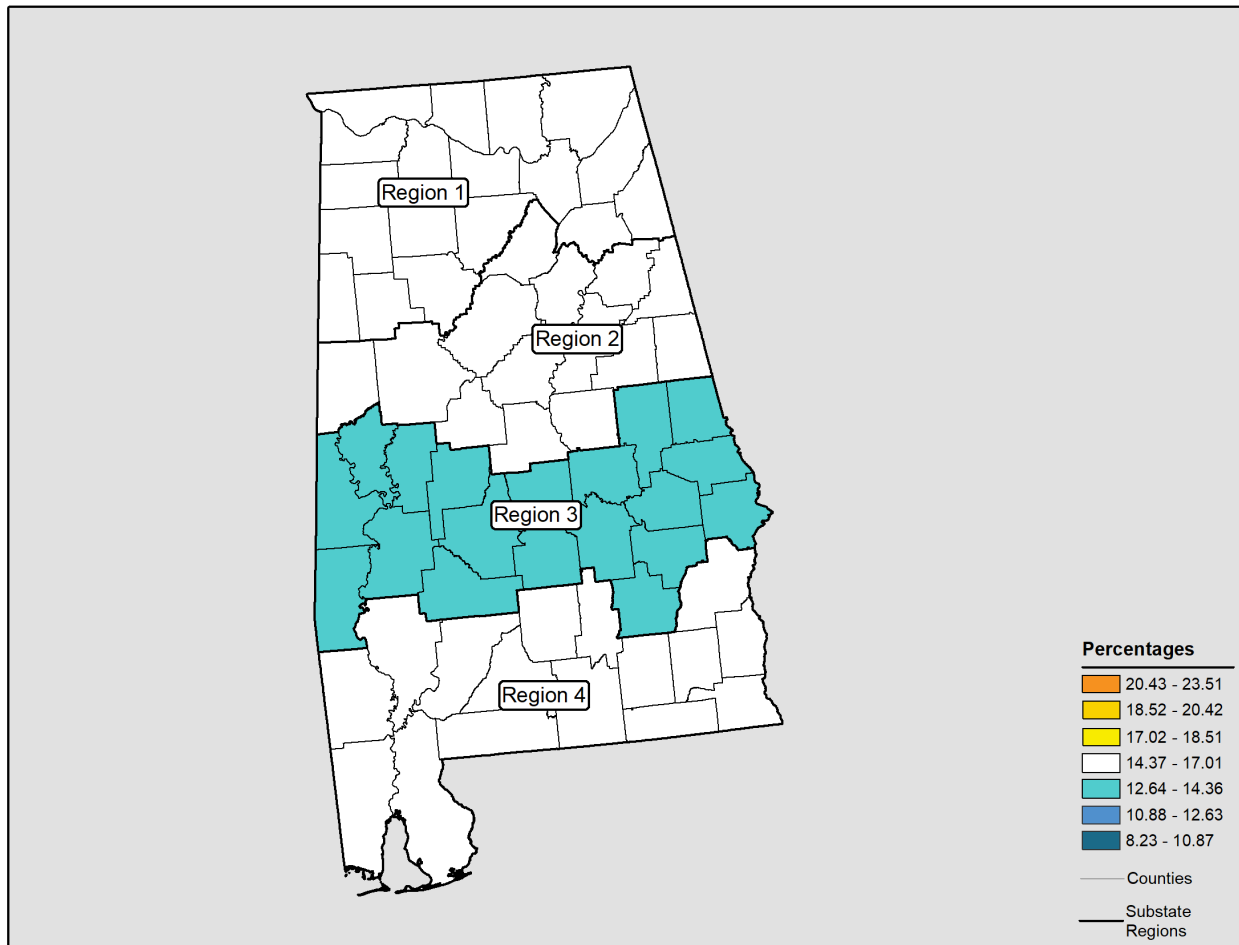
Figure 1.26 *Any Mental Illness in the Past Year* among Adults Aged 18 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

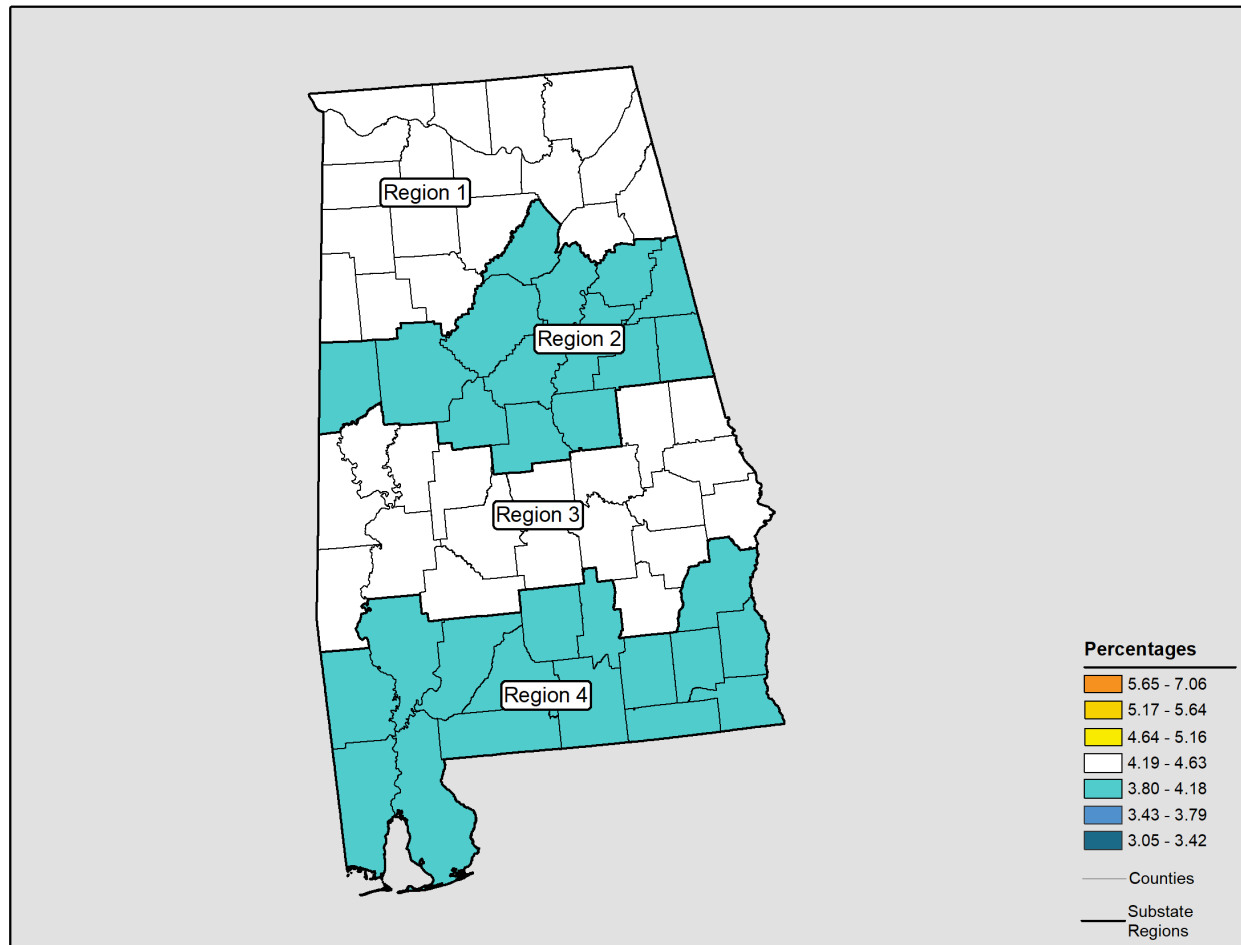
Figure 1.27 *Received Mental Health Services in the Past Year* among Adults Aged 18 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

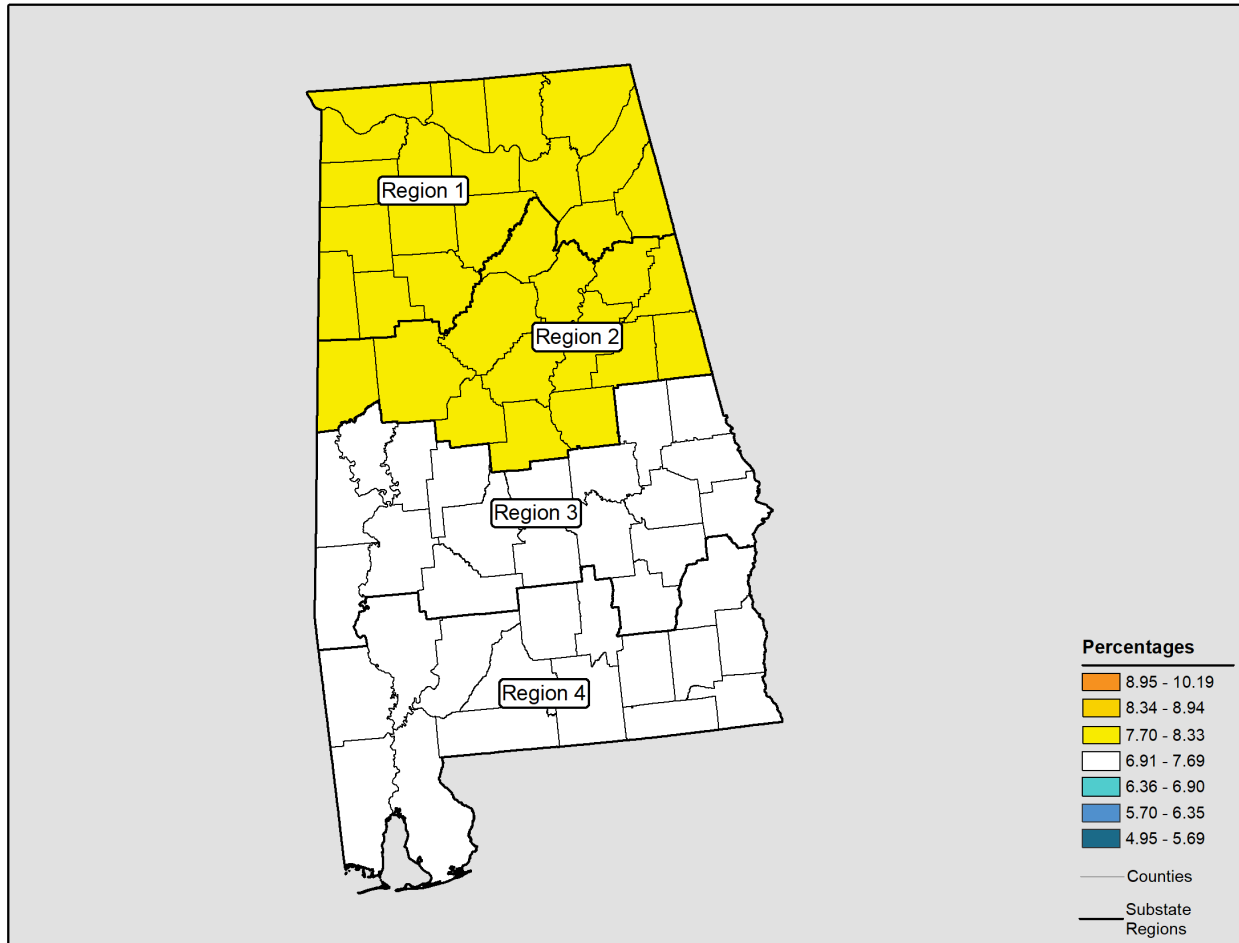
Figure 1.28 *Had Serious Thoughts of Suicide in the Past Year* among Adults Aged 18 or Older in Alabama, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs
