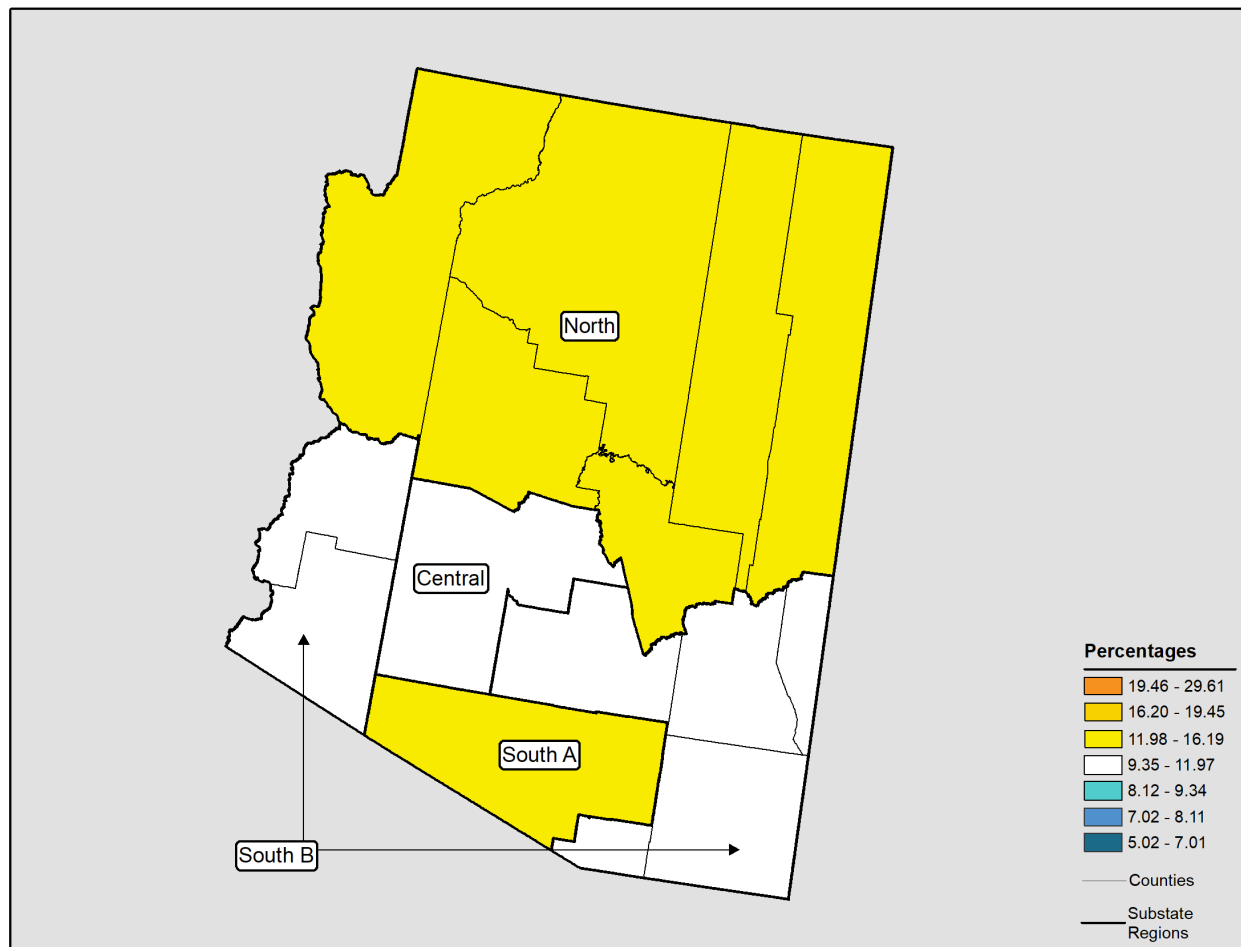

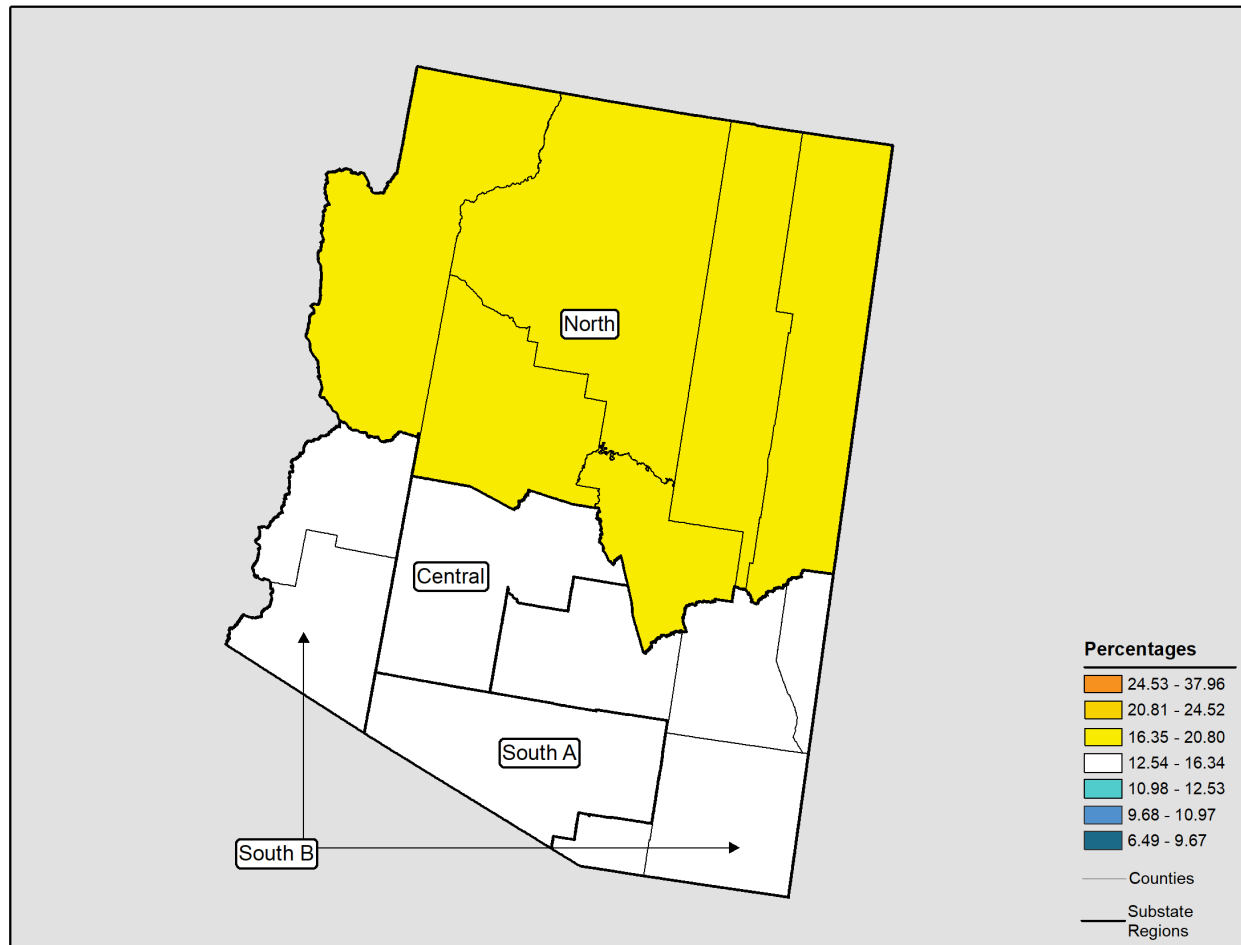
Figure 3.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

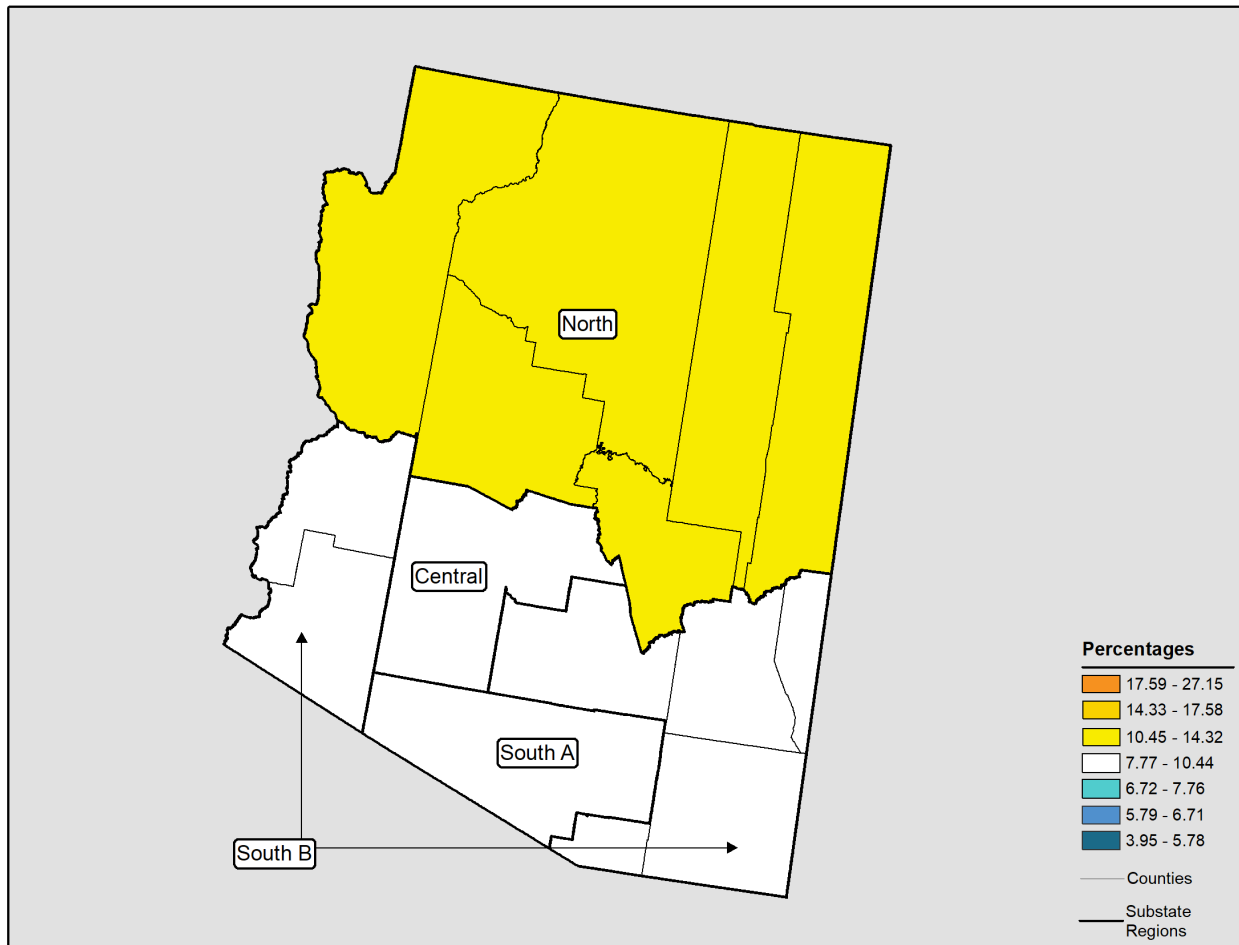
Figure 3.2 *Marijuana Use in the Past Year* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

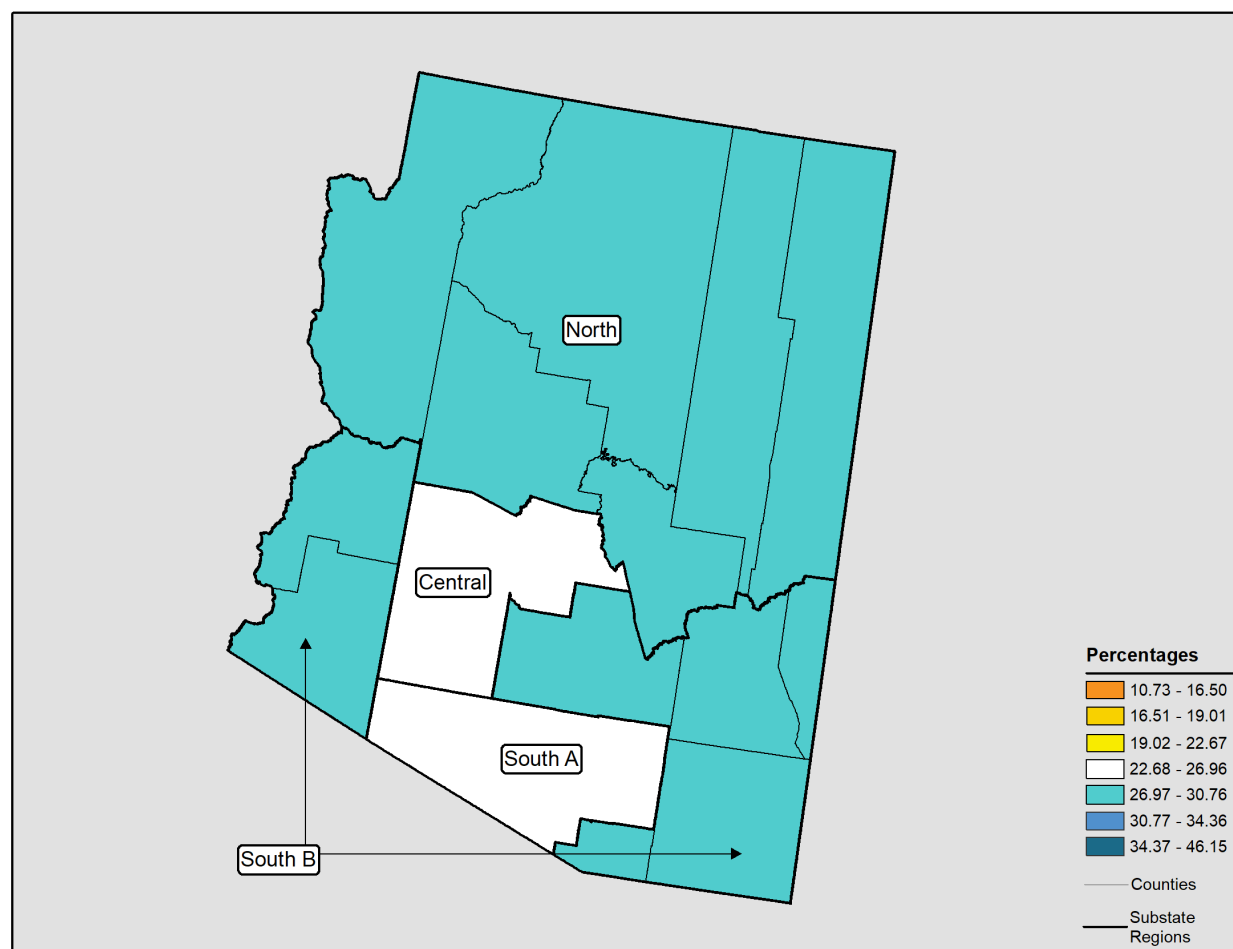
Figure 3.3 *Marijuana Use in the Past Month* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

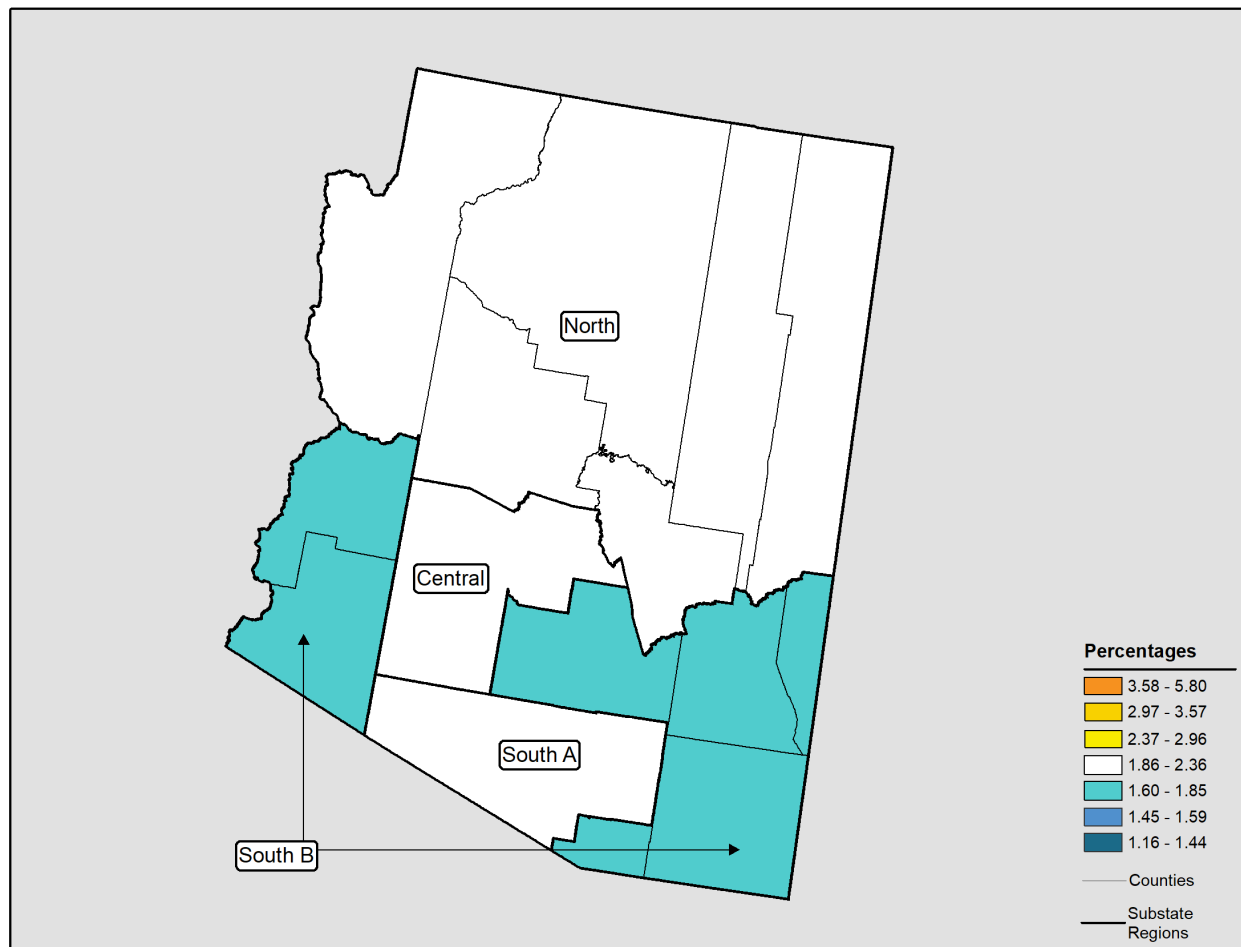
Figure 3.4 *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

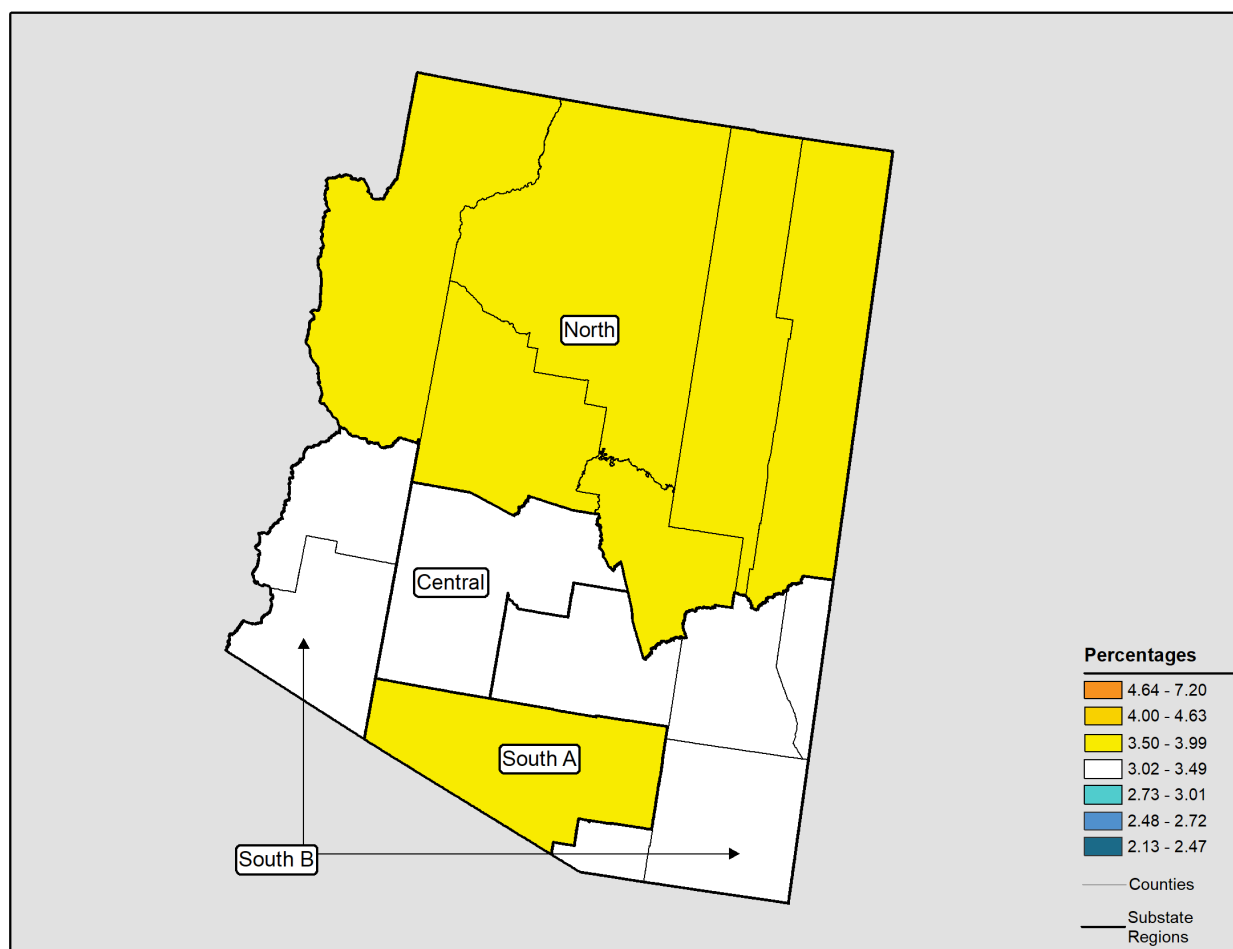
**Figure 3.5 *First Use of Marijuana* among Individuals Aged 12 or Older in Arizona, by Substate Region:

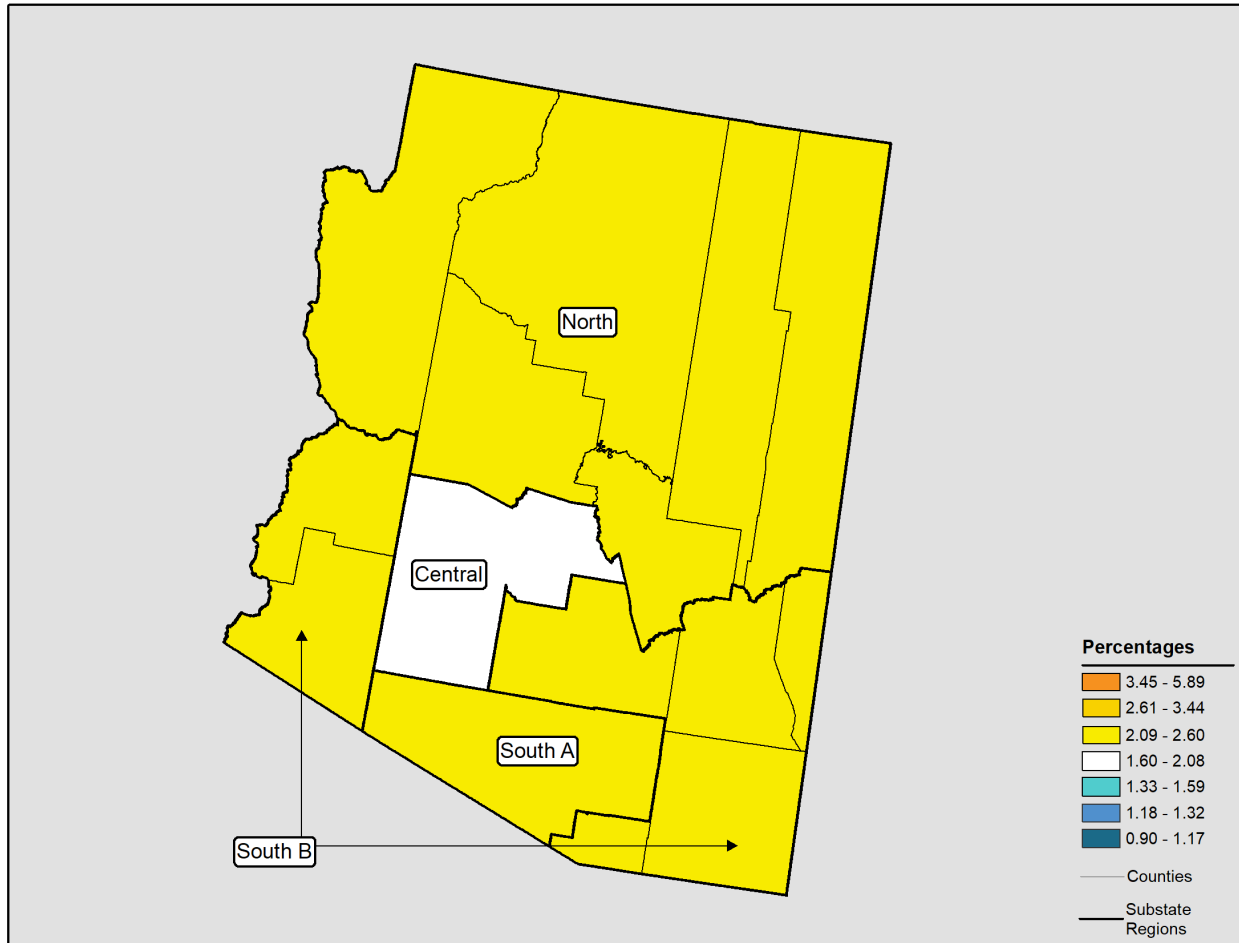
Figure 3.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

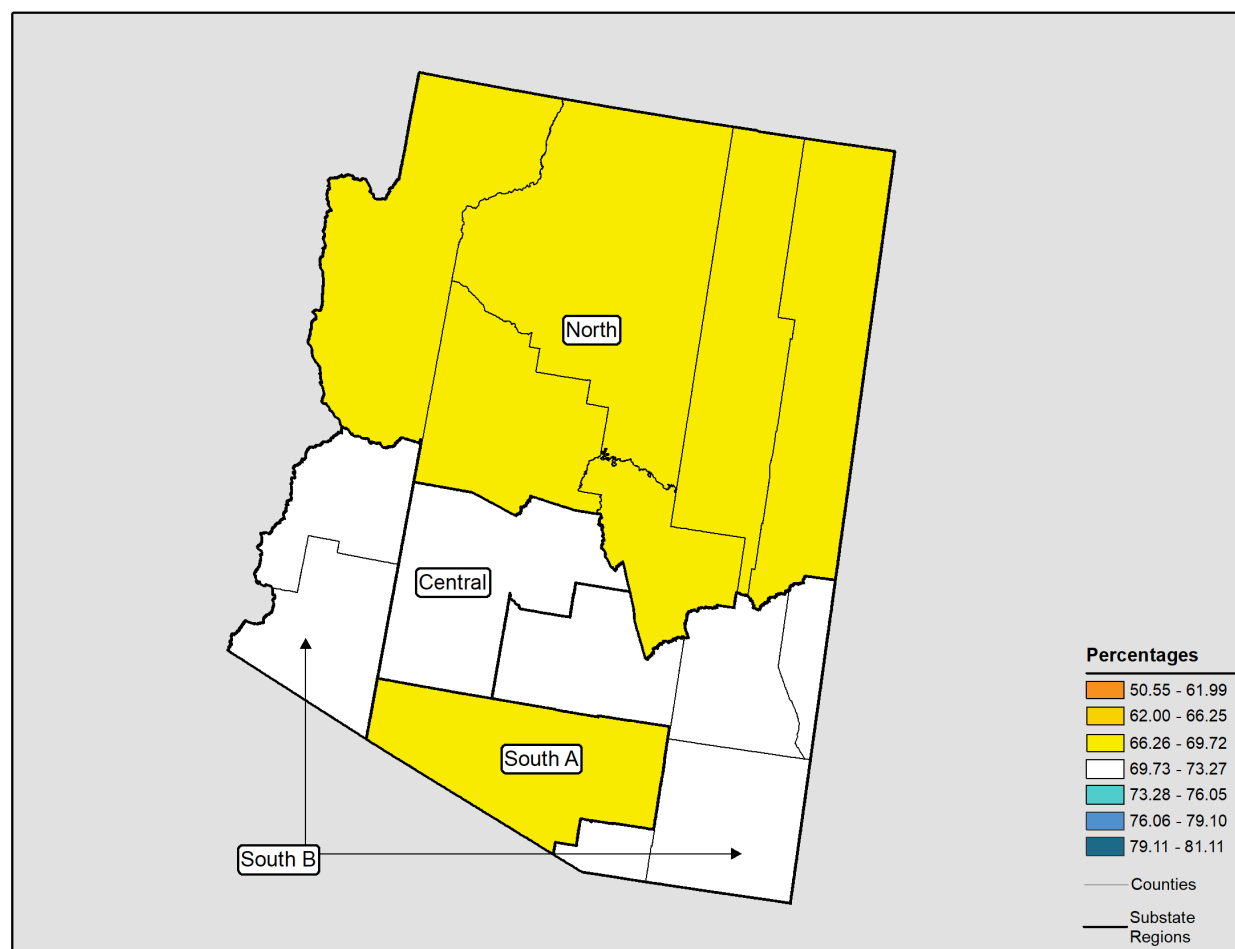
Figure 3.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

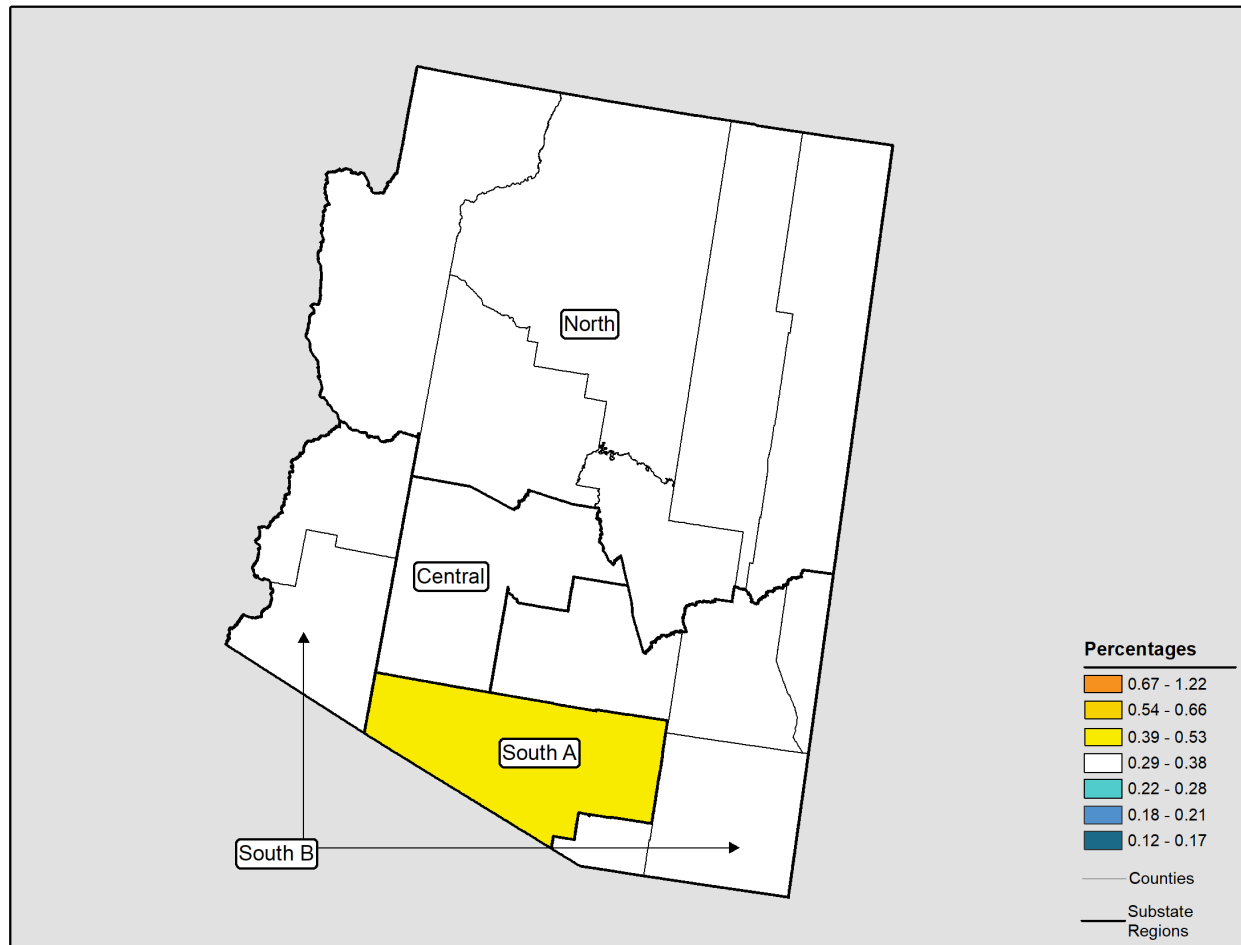
Figure 3.8 *Perceptions of Great Risk from Using Cocaine Once a Month* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

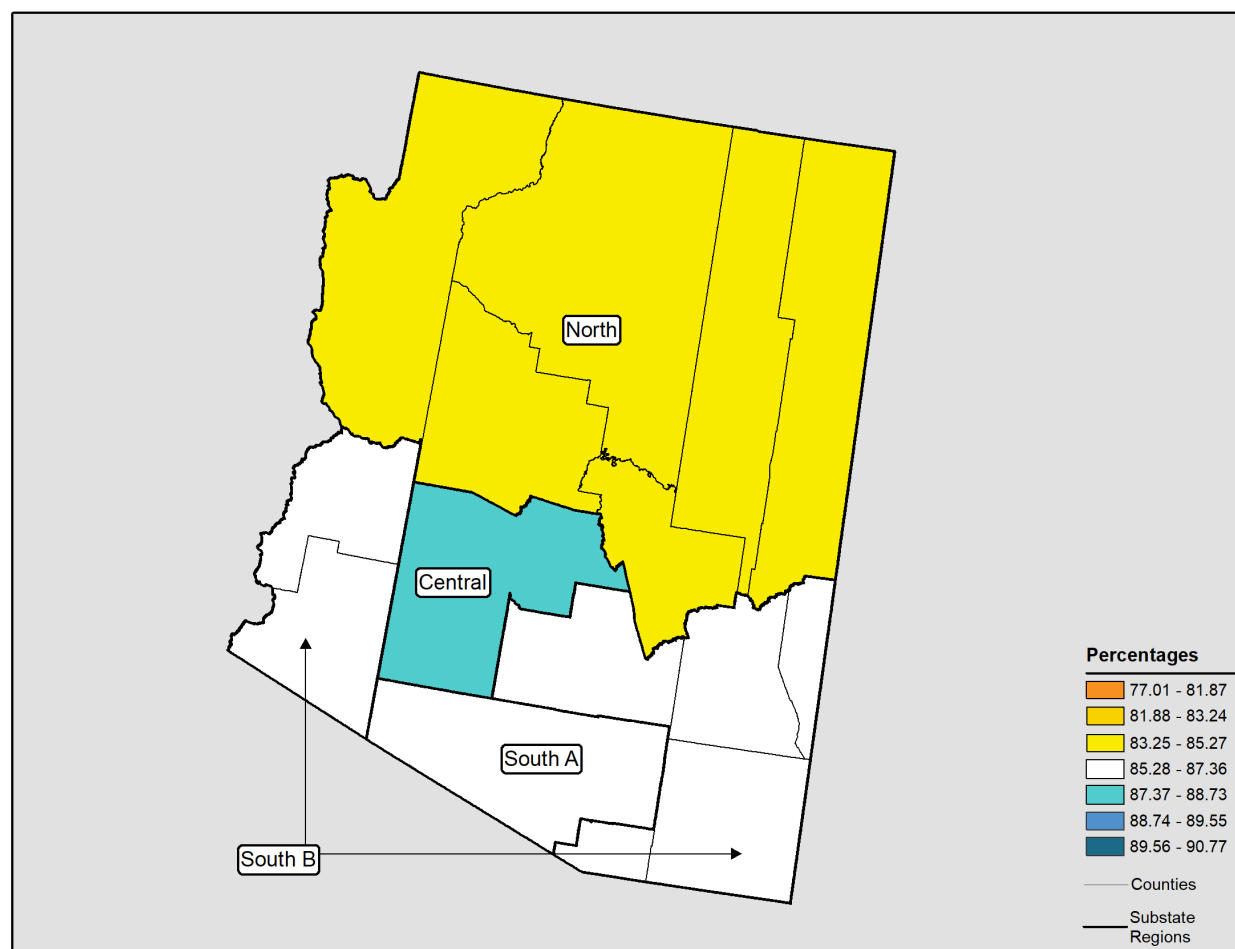
Figure 3.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

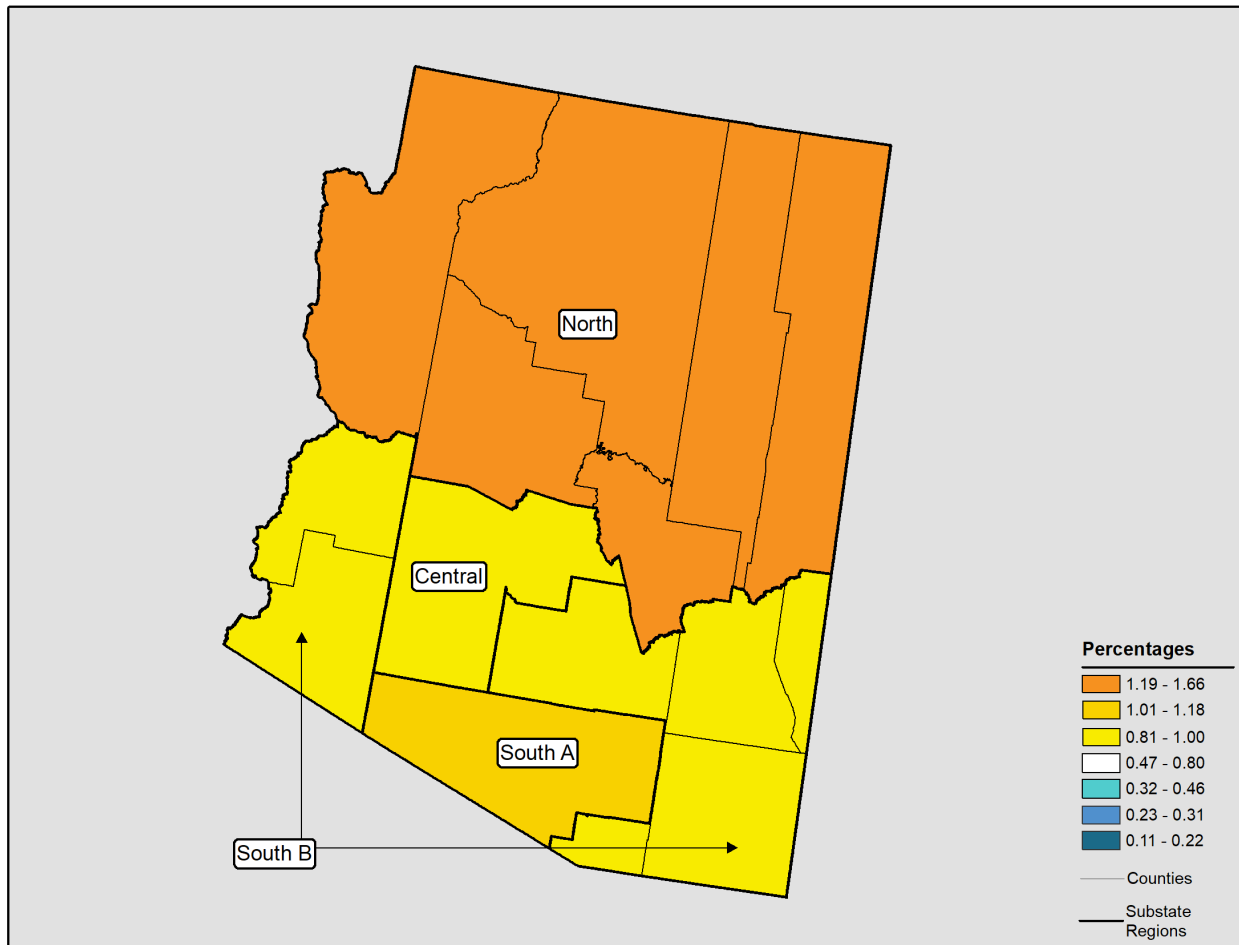
Figure 3.10 *Perceptions of Great Risk from Trying Heroin Once or Twice among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

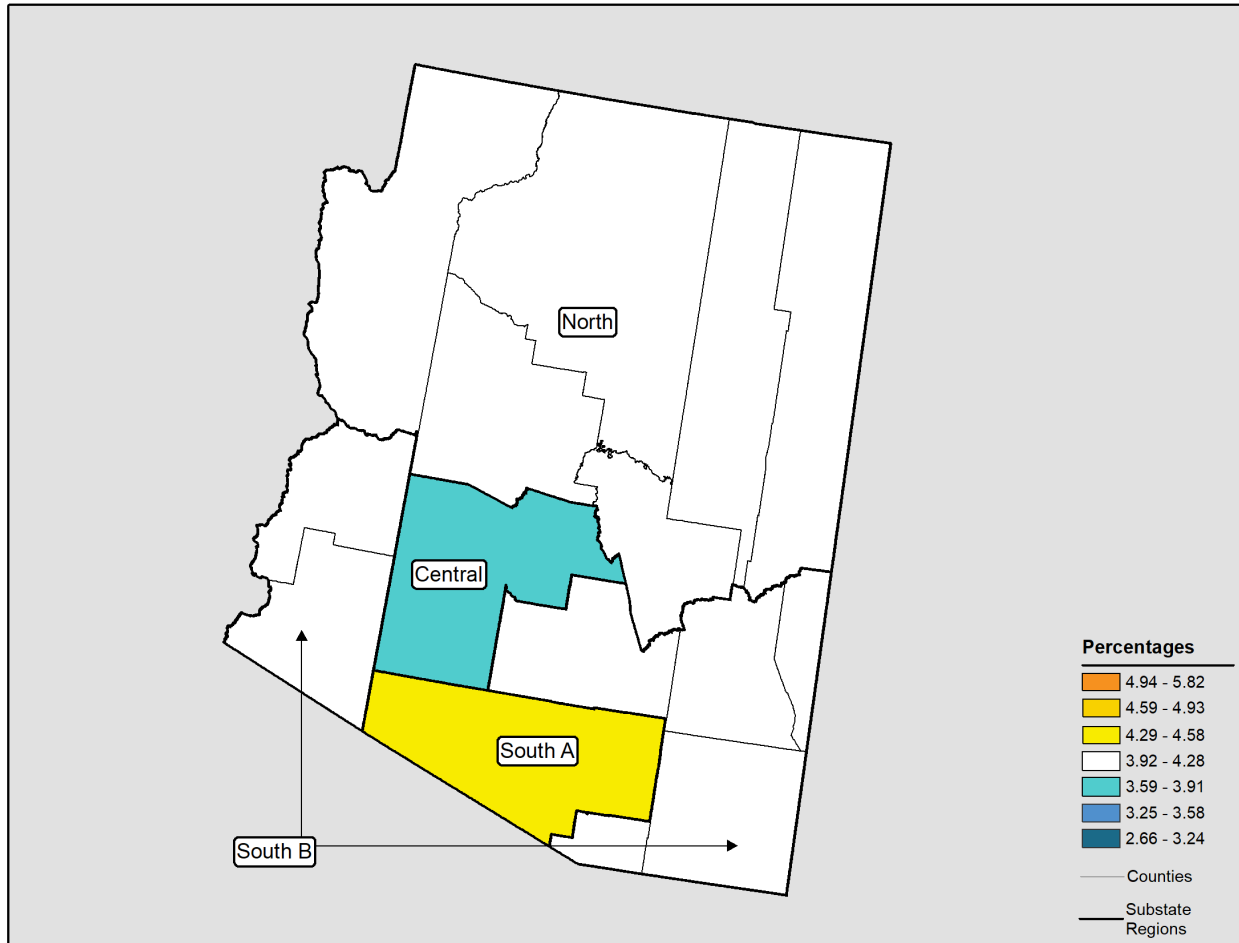
Figure 3.11 *Methamphetamine Use in the Past Year among Individuals Aged 12 or Older in Arizona,*

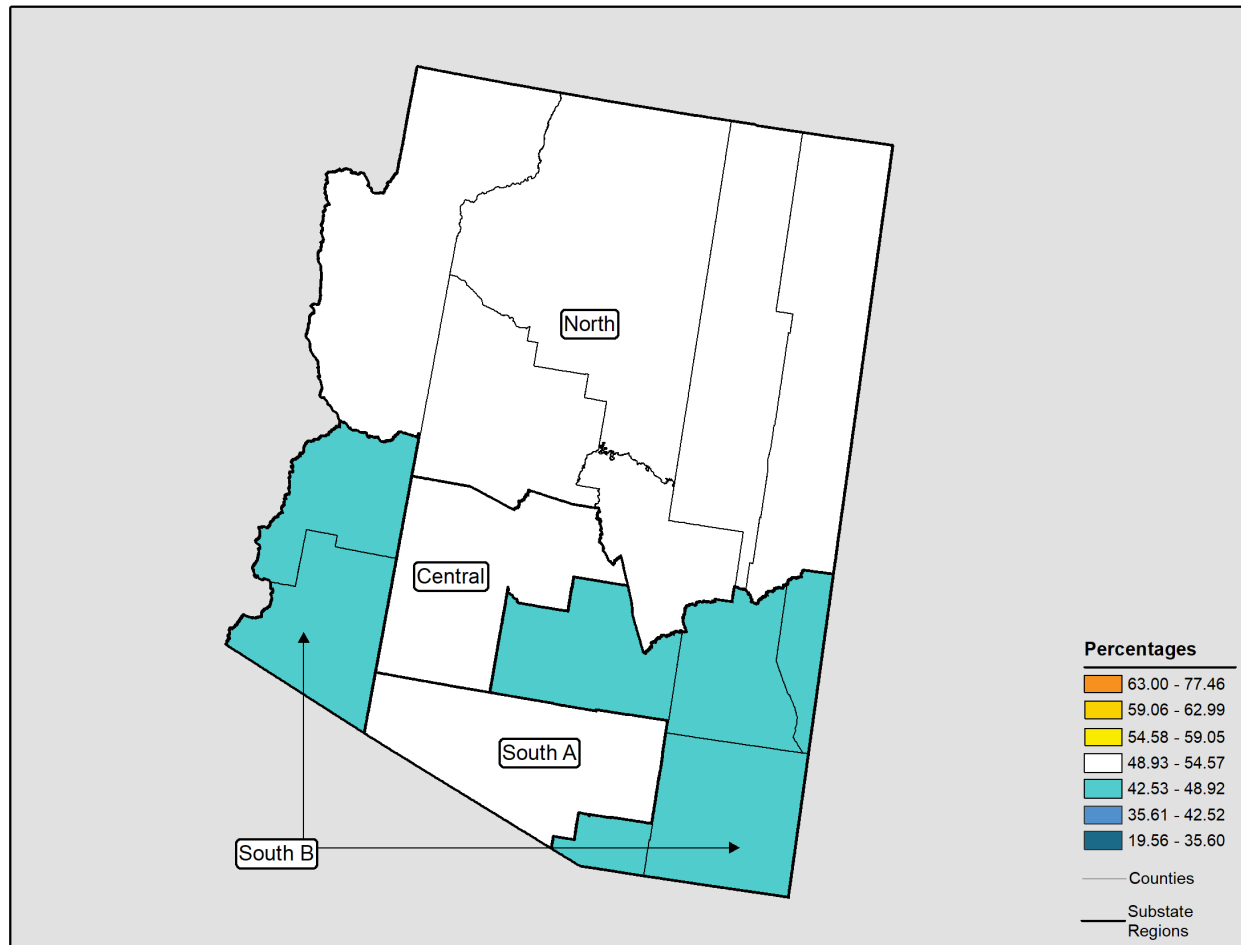
**Figure 3.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Arizona,

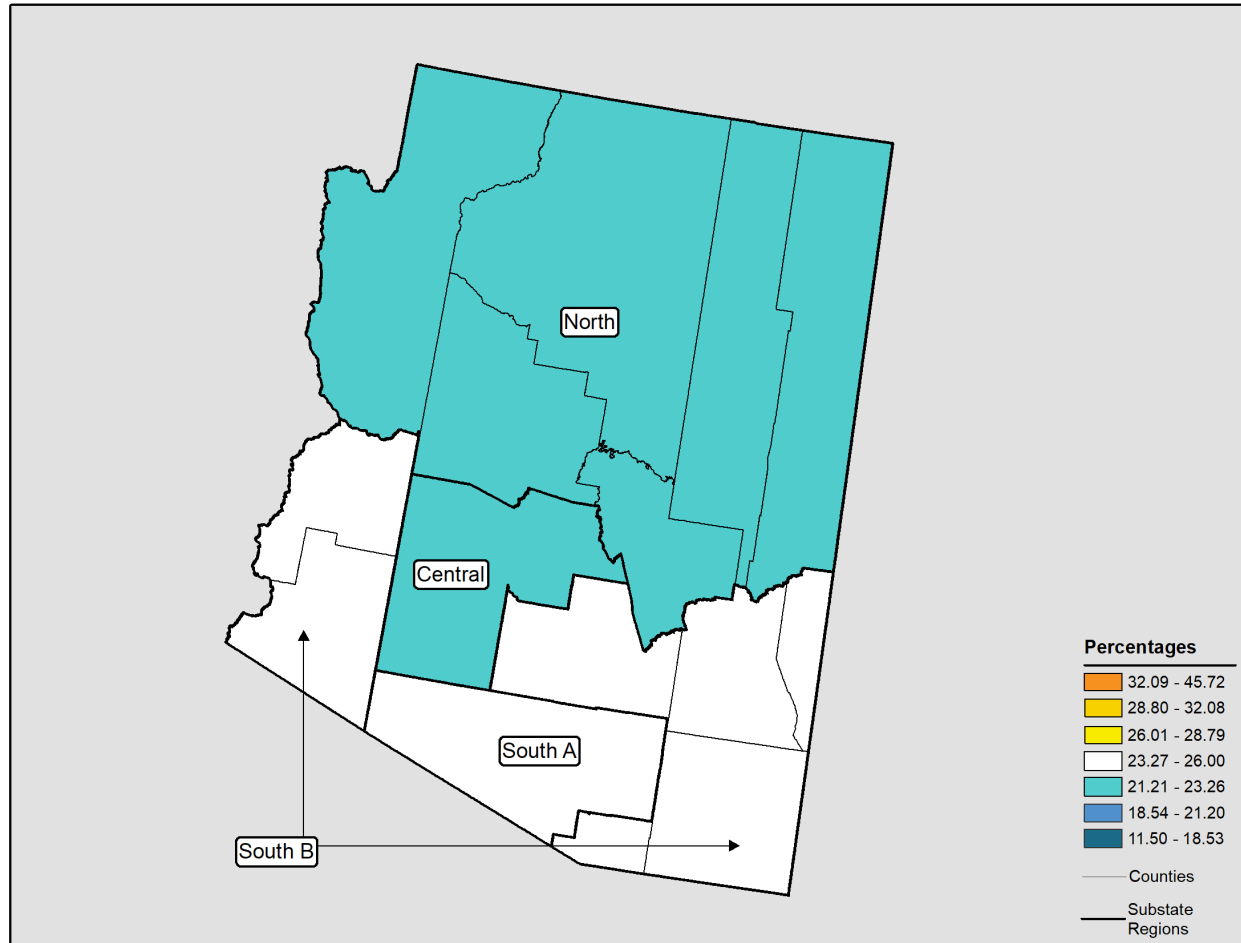
Figure 3.13 *Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

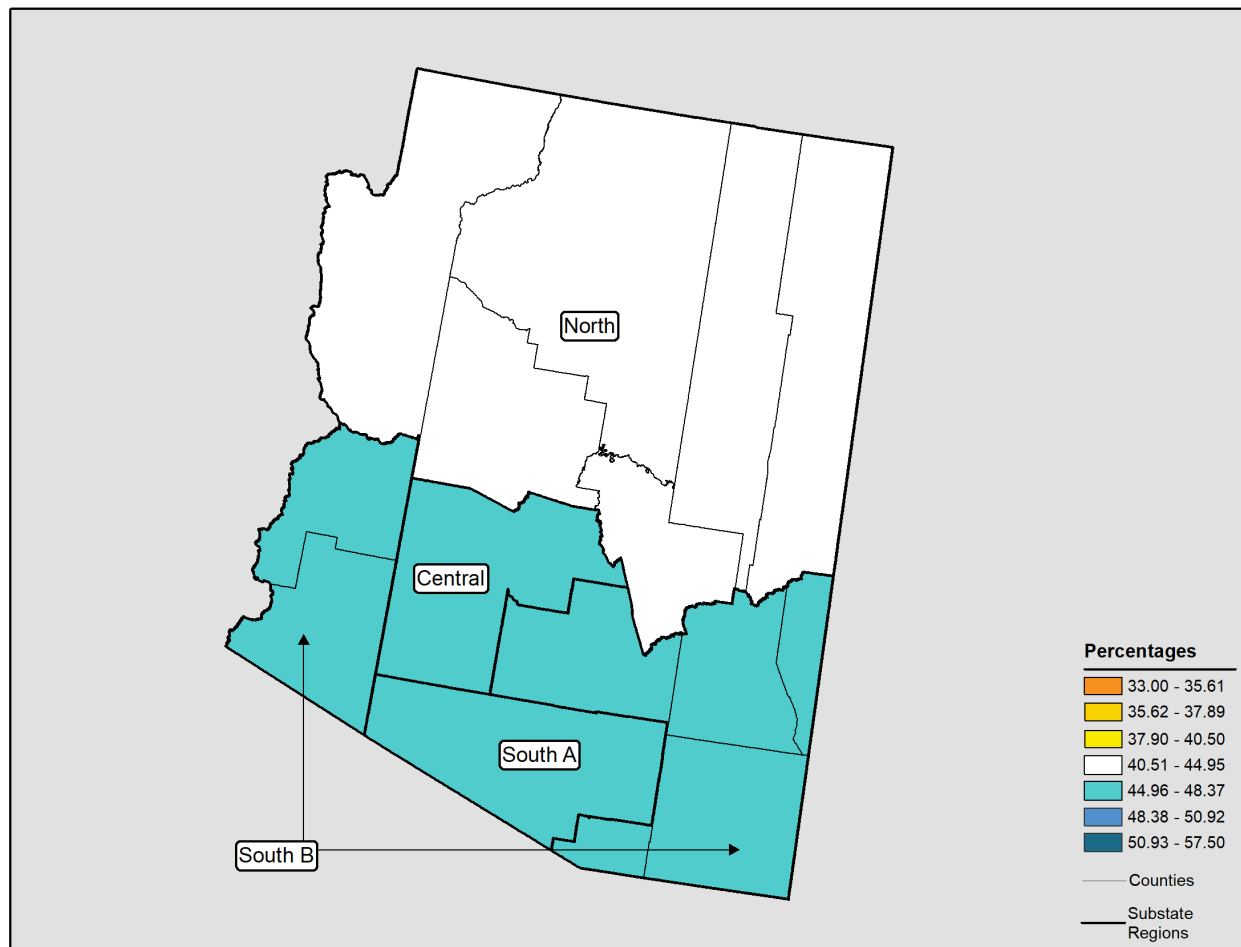
**Figure 3.14 *Binge Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Arizona,

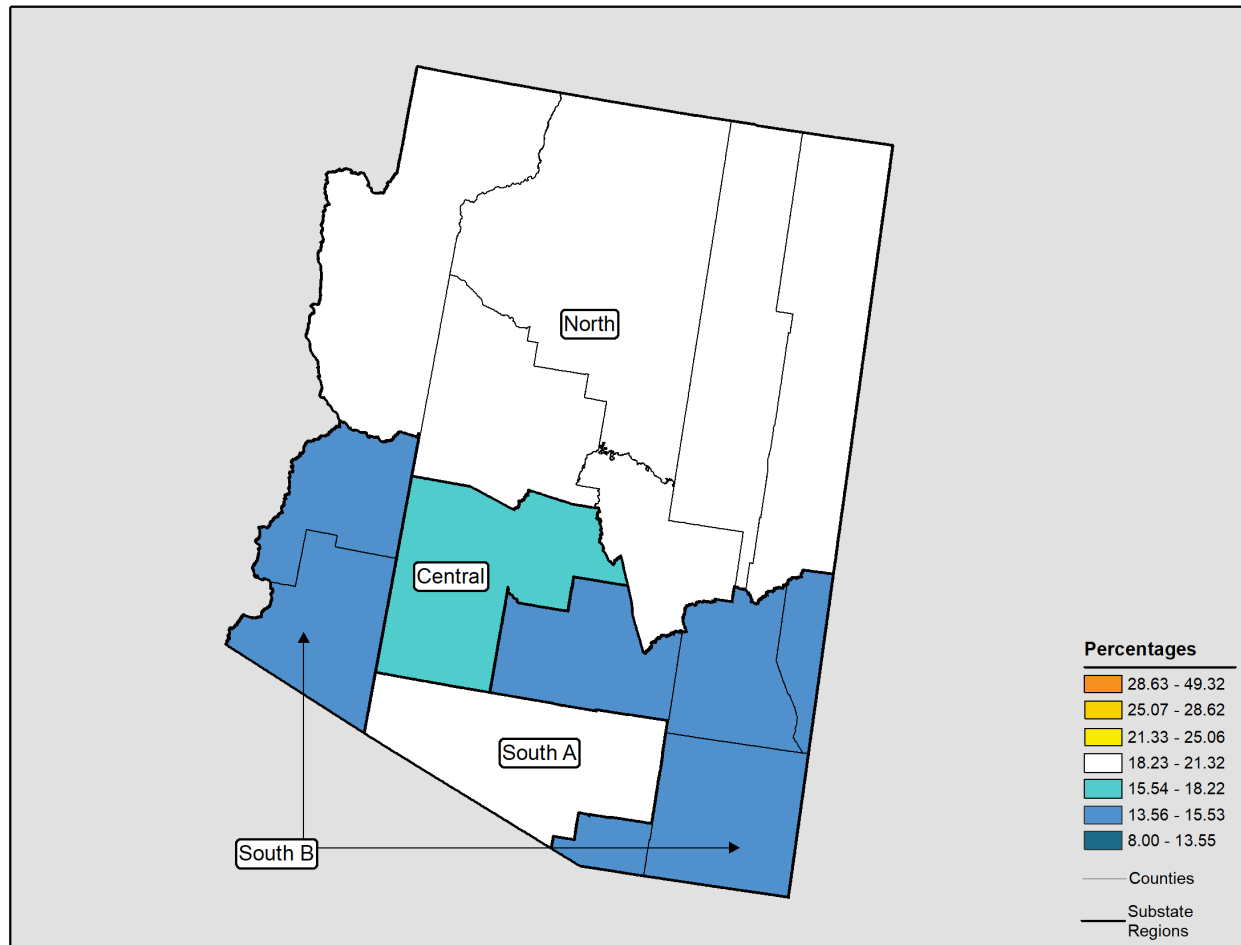
Figure 3.15 *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

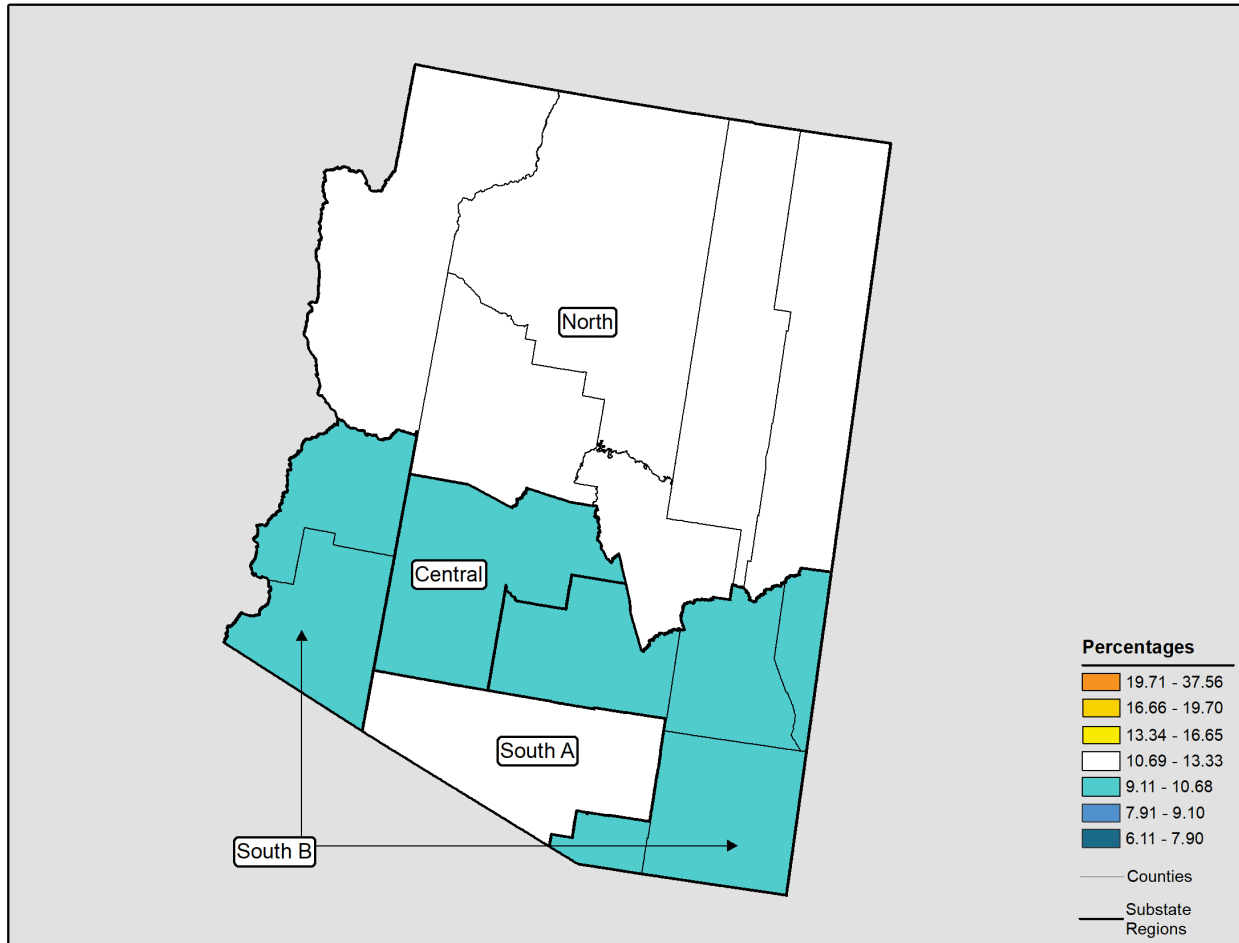
Figure 3.16 *Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

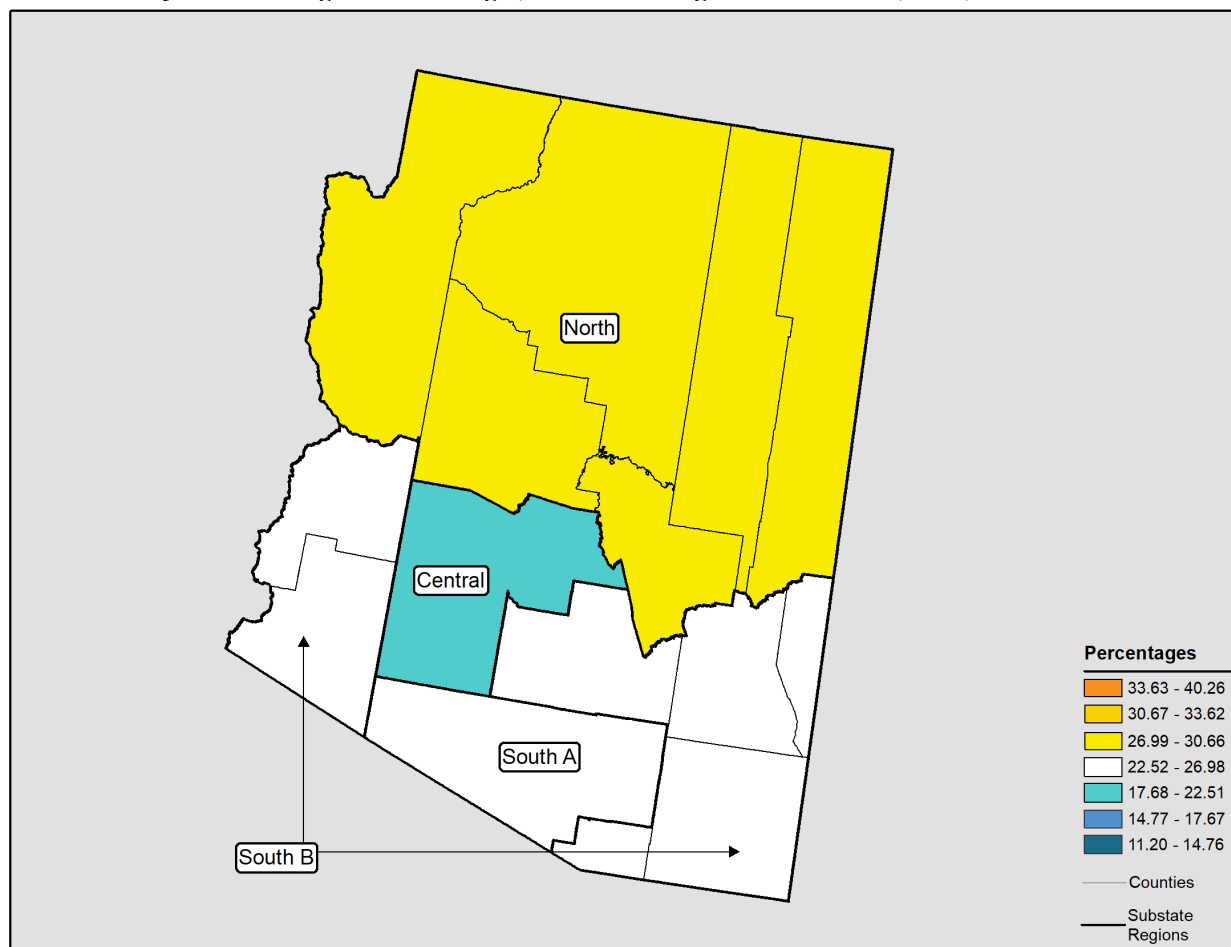
Figure 3.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

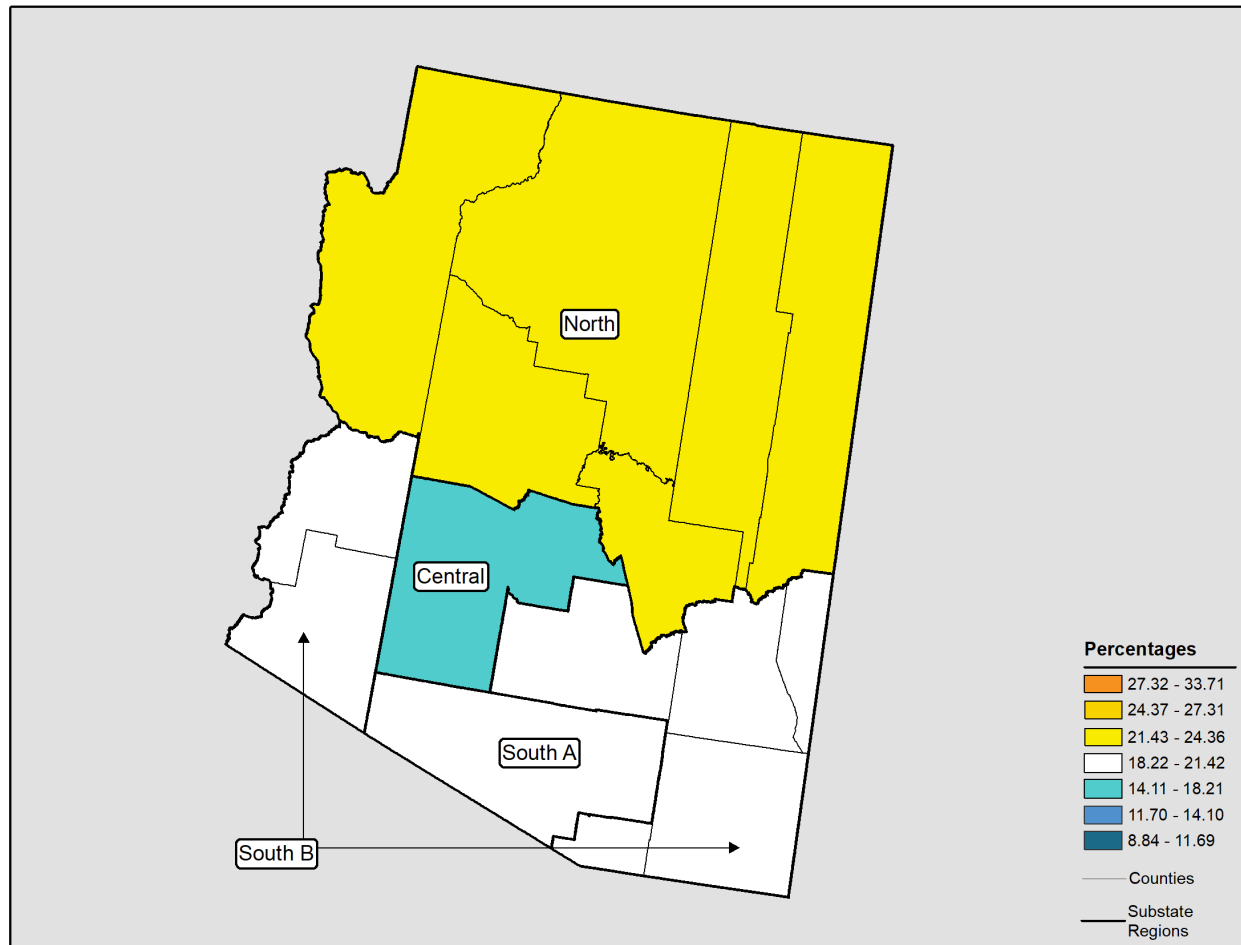
Figure 3.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

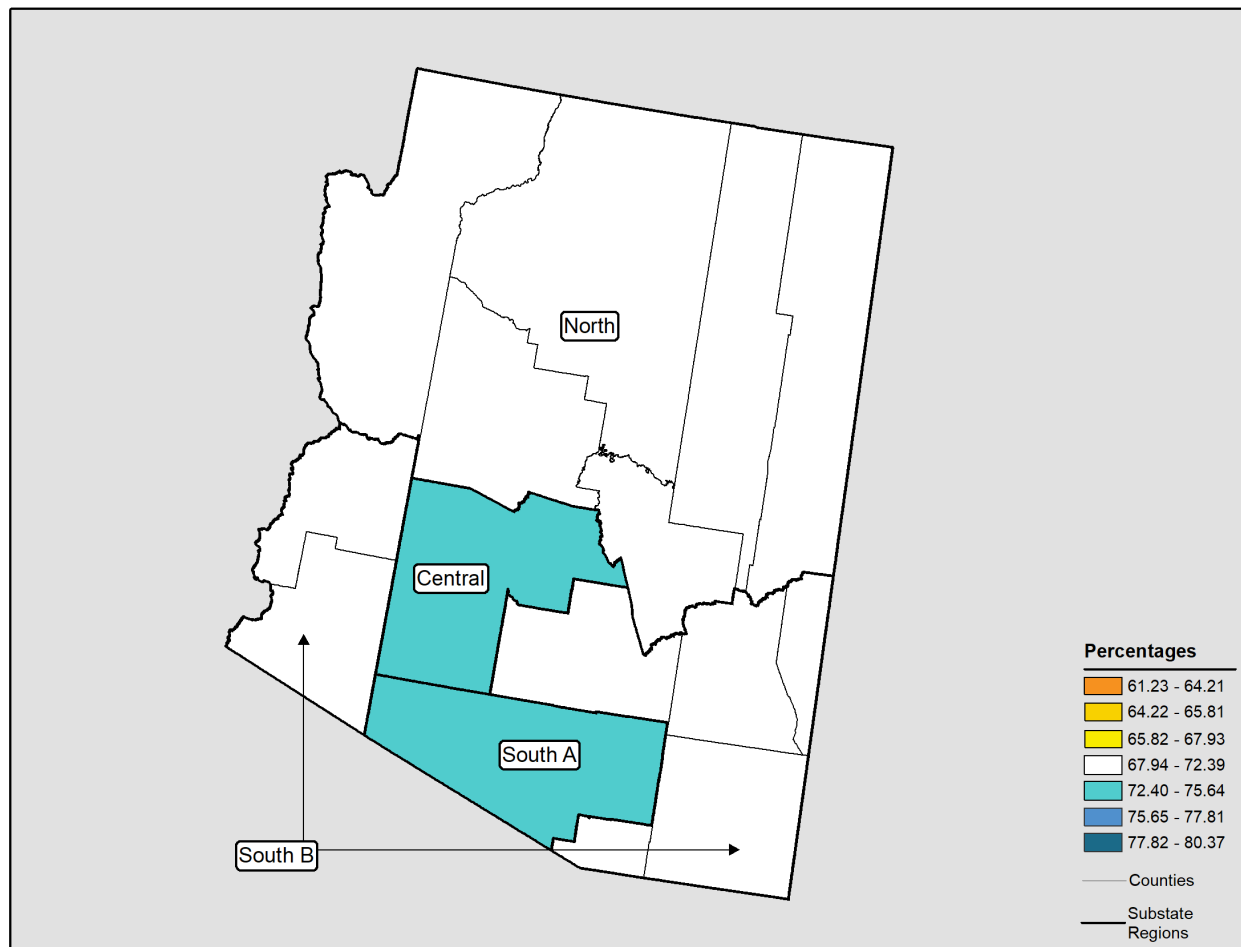
Figure 3.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

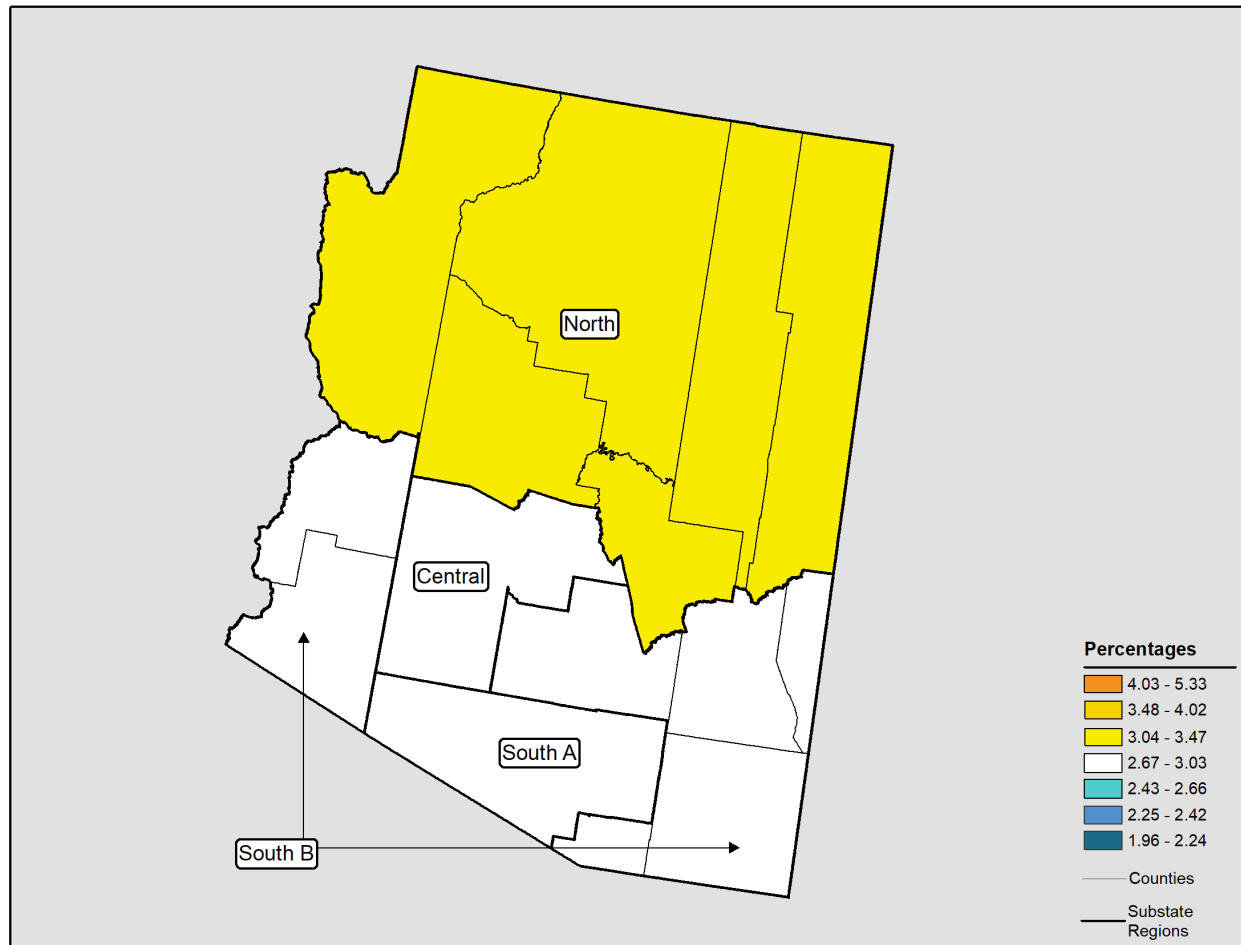
Figure 3.20 *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

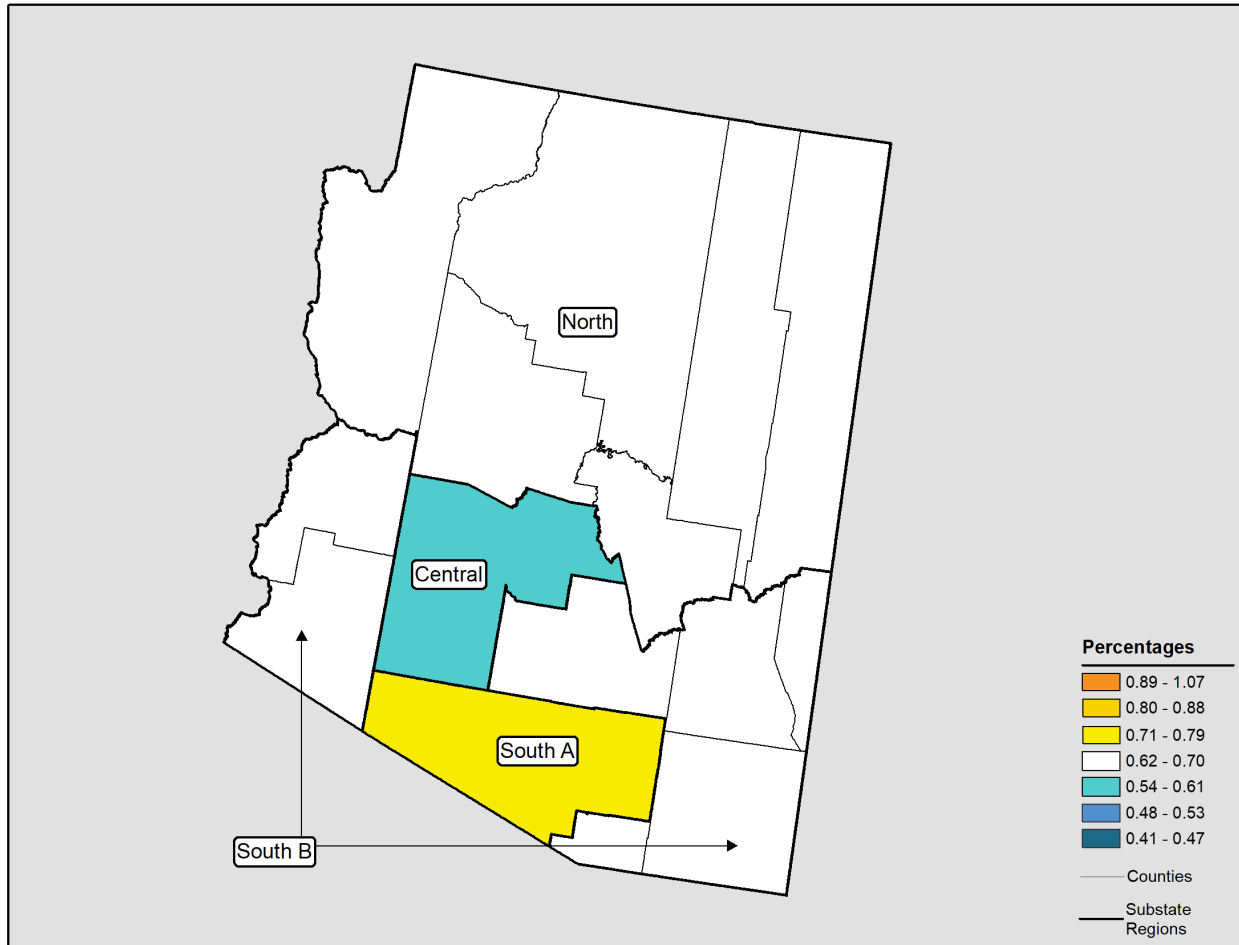
Figure 3.21 *Illicit Drug Use Disorder in the Past Year* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

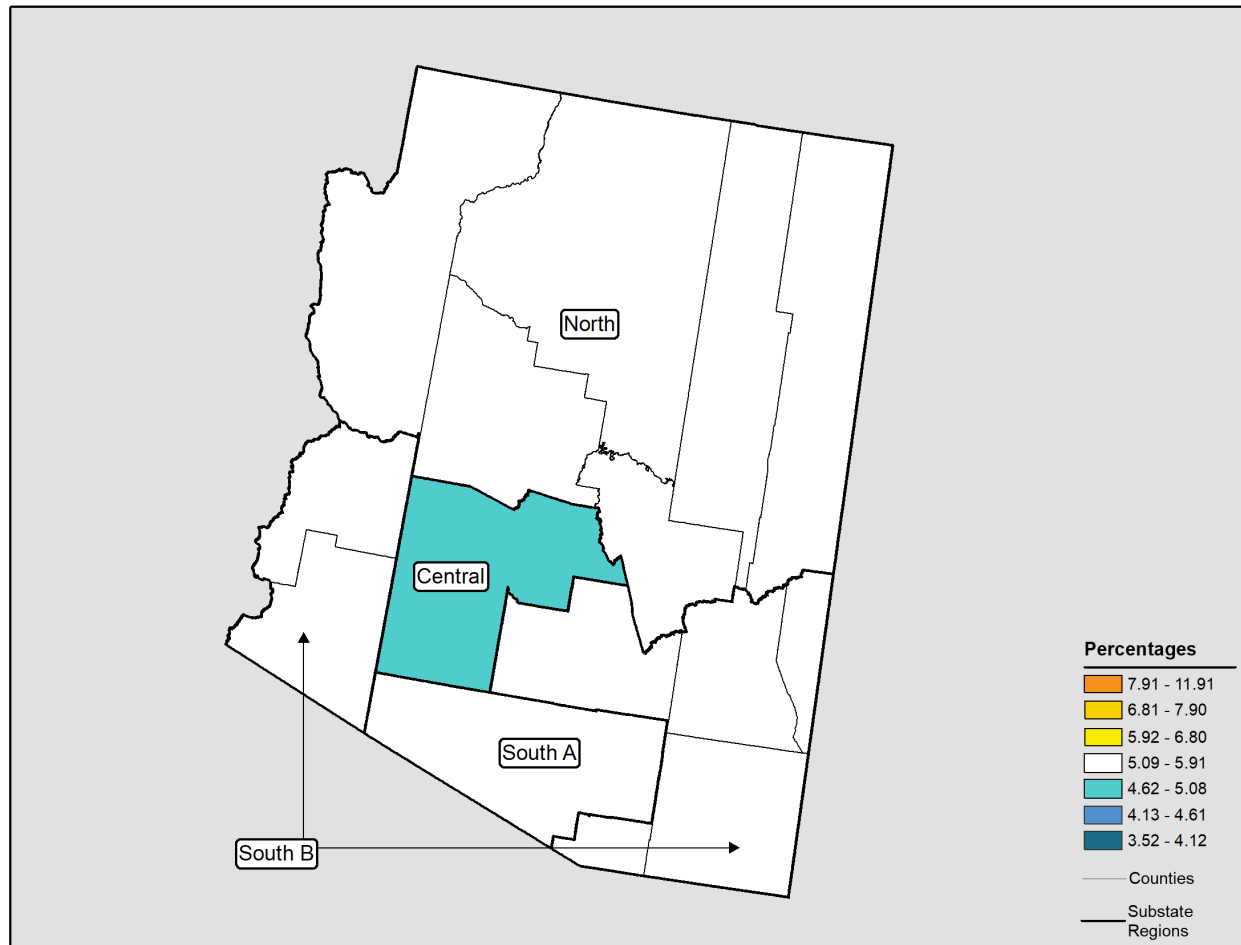
Figure 3.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

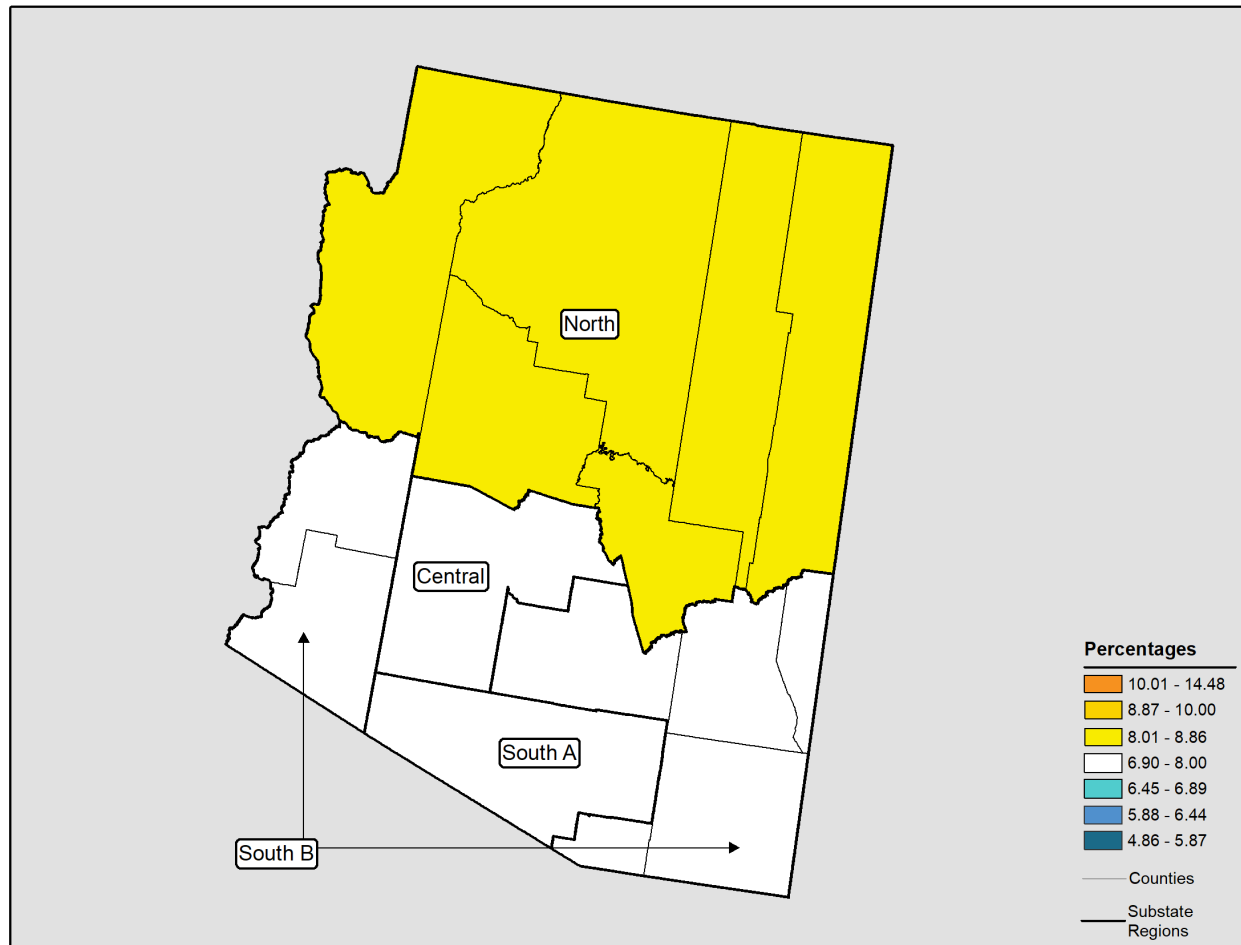
Figure 3.23 *Alcohol Use Disorder in the Past Year among Individuals Aged 12 or Older in Arizona,*

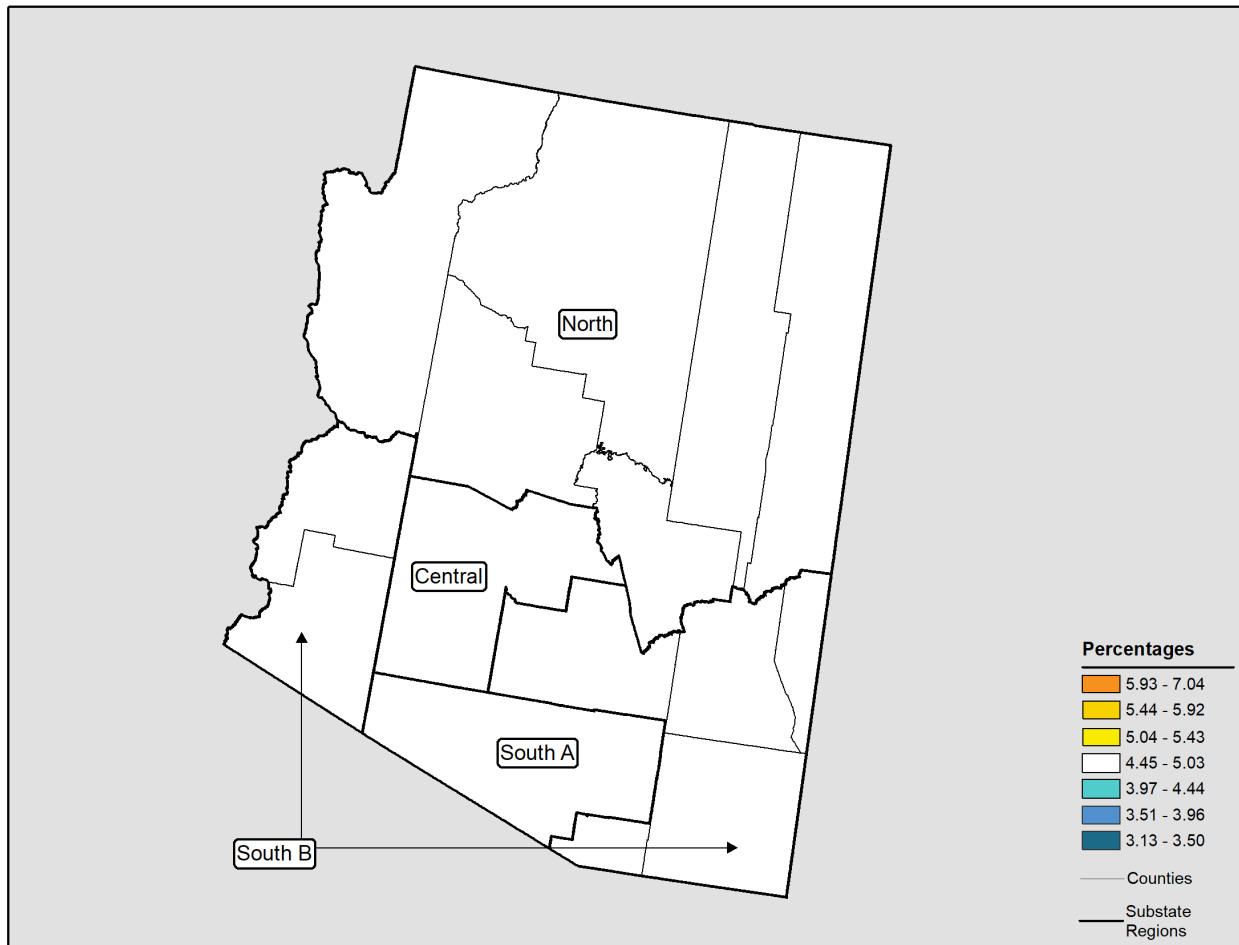
Figure 3.24 *Substance Use Disorder in the Past Year* among Individuals Aged 12 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

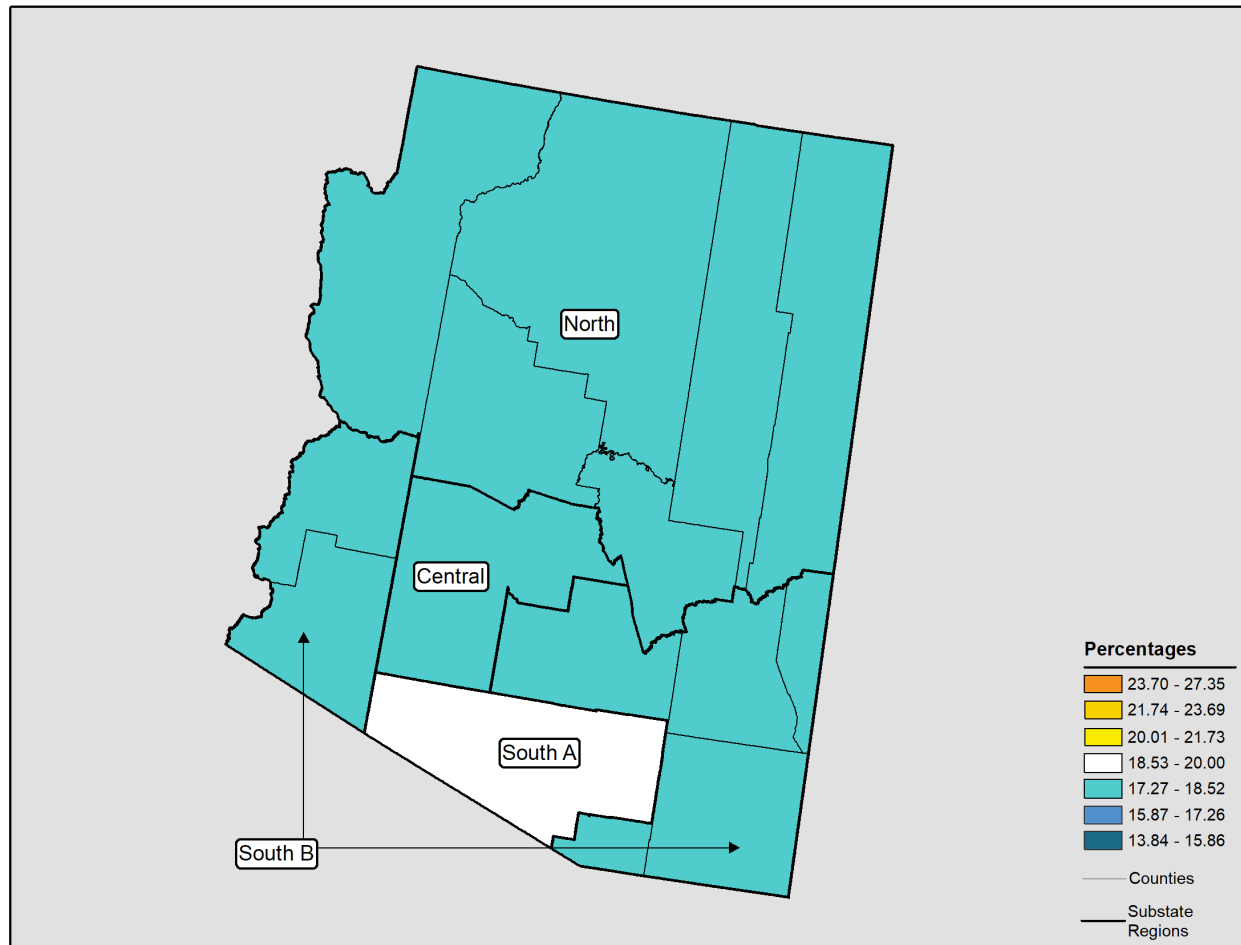
Figure 3.25 *Serious Mental Illness in the Past Year* among Adults Aged 18 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

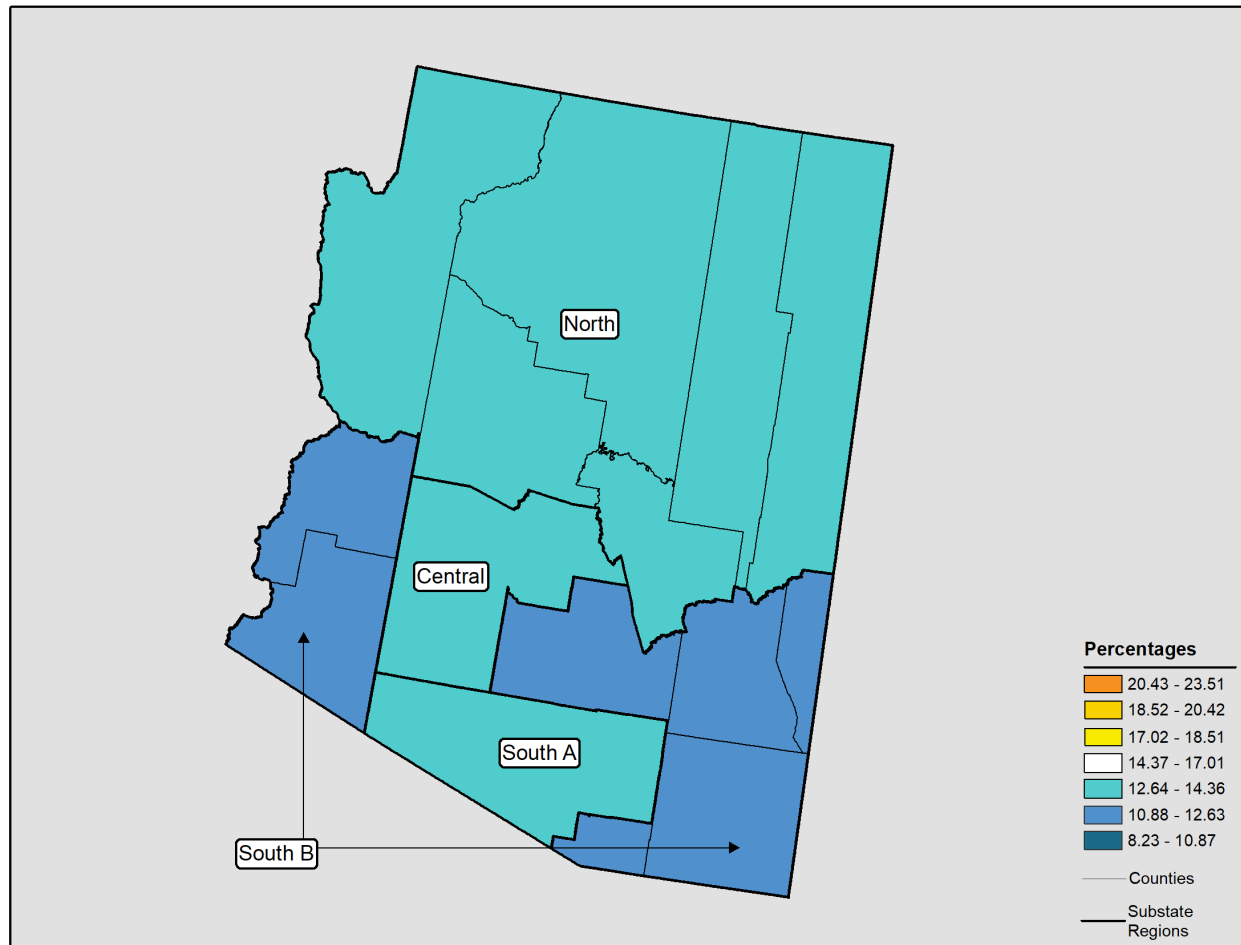
Figure 3.26 *Any Mental Illness in the Past Year* among Adults Aged 18 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs

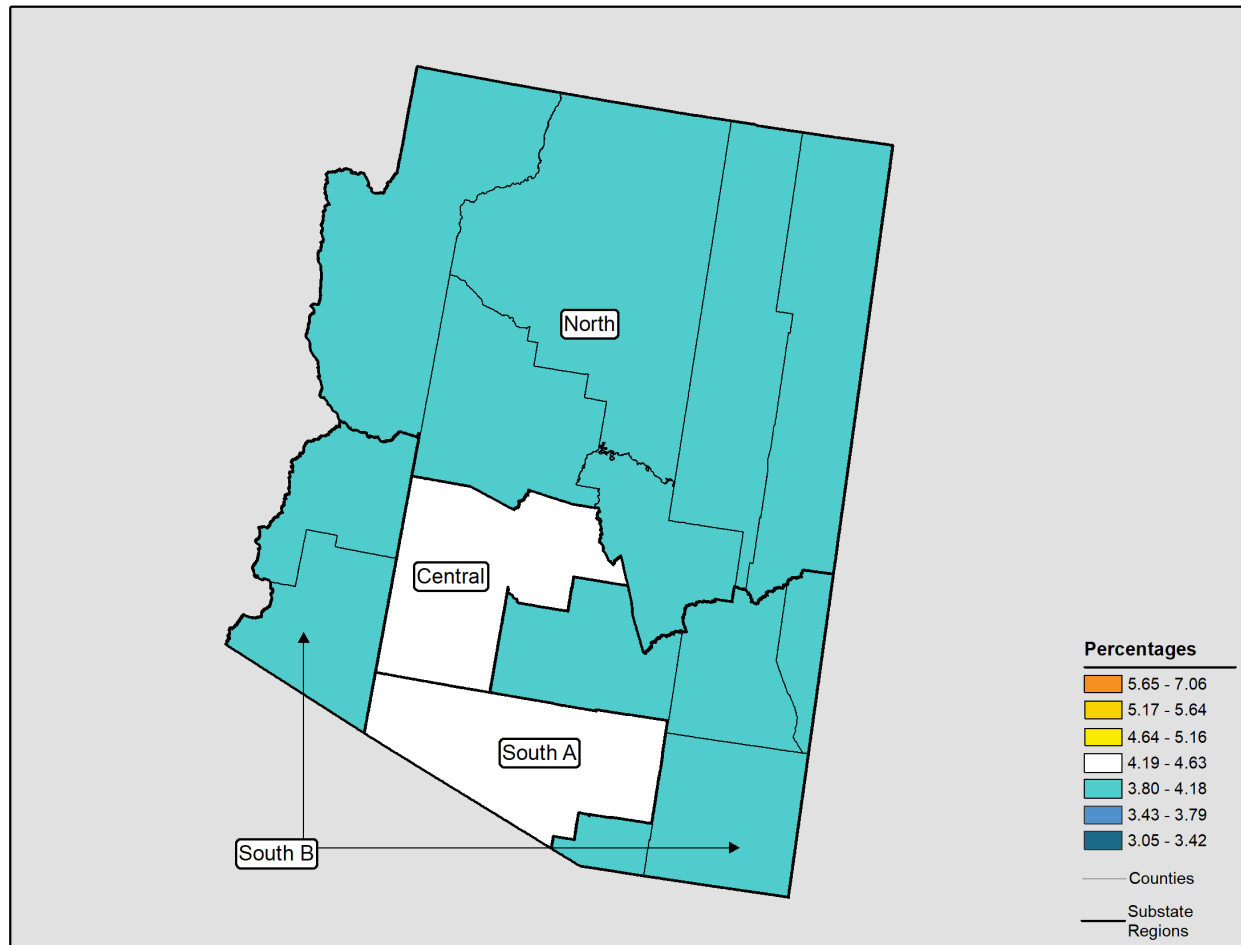
Figure 3.27 *Received Mental Health Services in the Past Year among Adults Aged 18 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

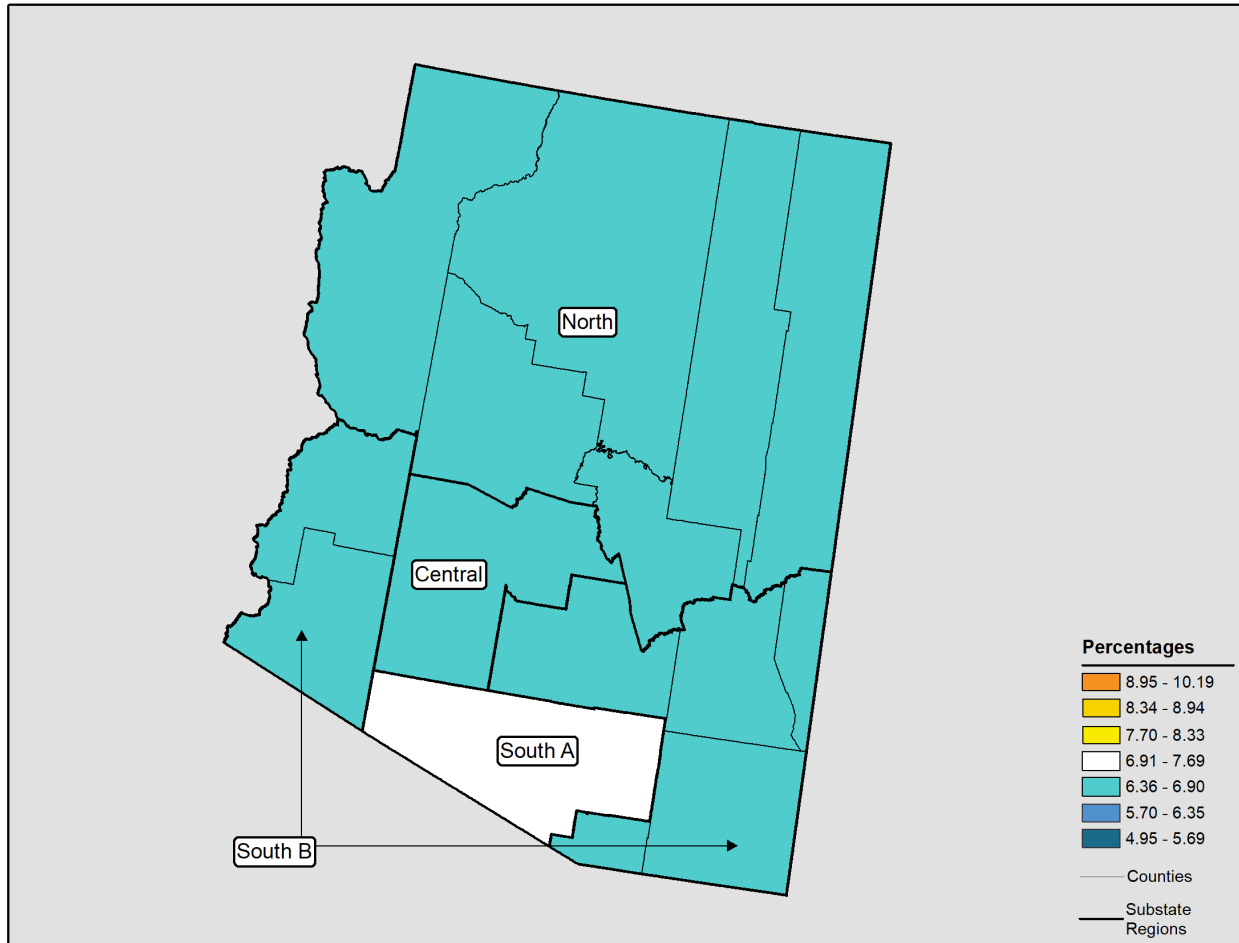
Figure 3.28 *Had Serious Thoughts of Suicide in the Past Year among Adults Aged 18 or Older in Arizona, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*
