<sup>1</sup> First Use of Marijuana is defined as follows: *Average annual initiation of marijuana (%) = 100 \* {[X<sub>1</sub> ÷ (0.5 \* X<sub>1</sub> + X<sub>2</sub>)] ÷ 2}*, where X<sub>1</sub> is the number of marijuana initiates in the past 24 months and X<sub>2</sub> is the number of individuals who never used marijuana (with the at-risk population defined as 0.5 \* X<sub>1</sub> + X<sub>2</sub>). Both of the computation components, X<sub>1</sub> and X<sub>2</sub>, are based on a survey-weighted hierarchical Bayes estimation approach. The age group is based on a respondent's age at the time of the interview, not his or her age at first use. 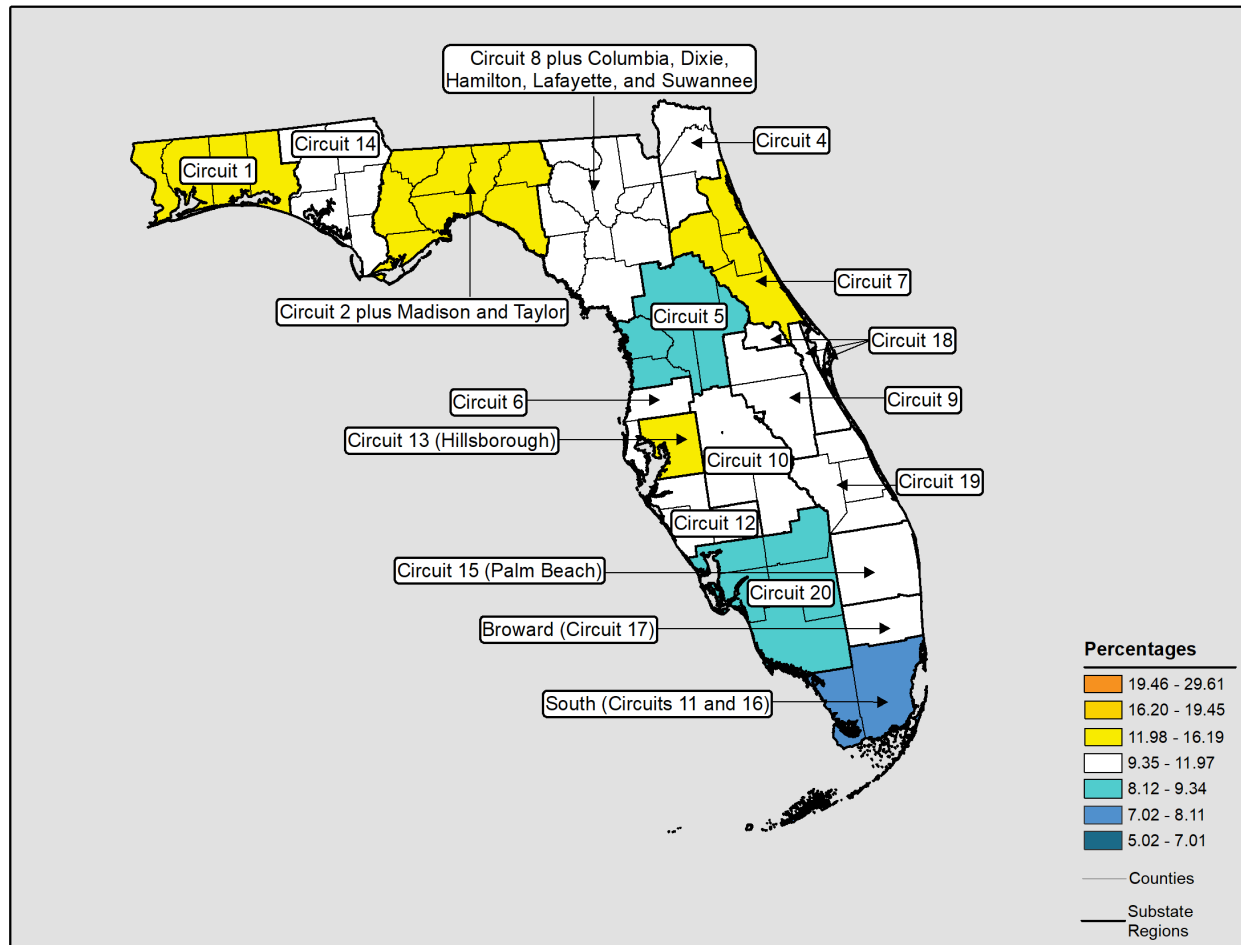

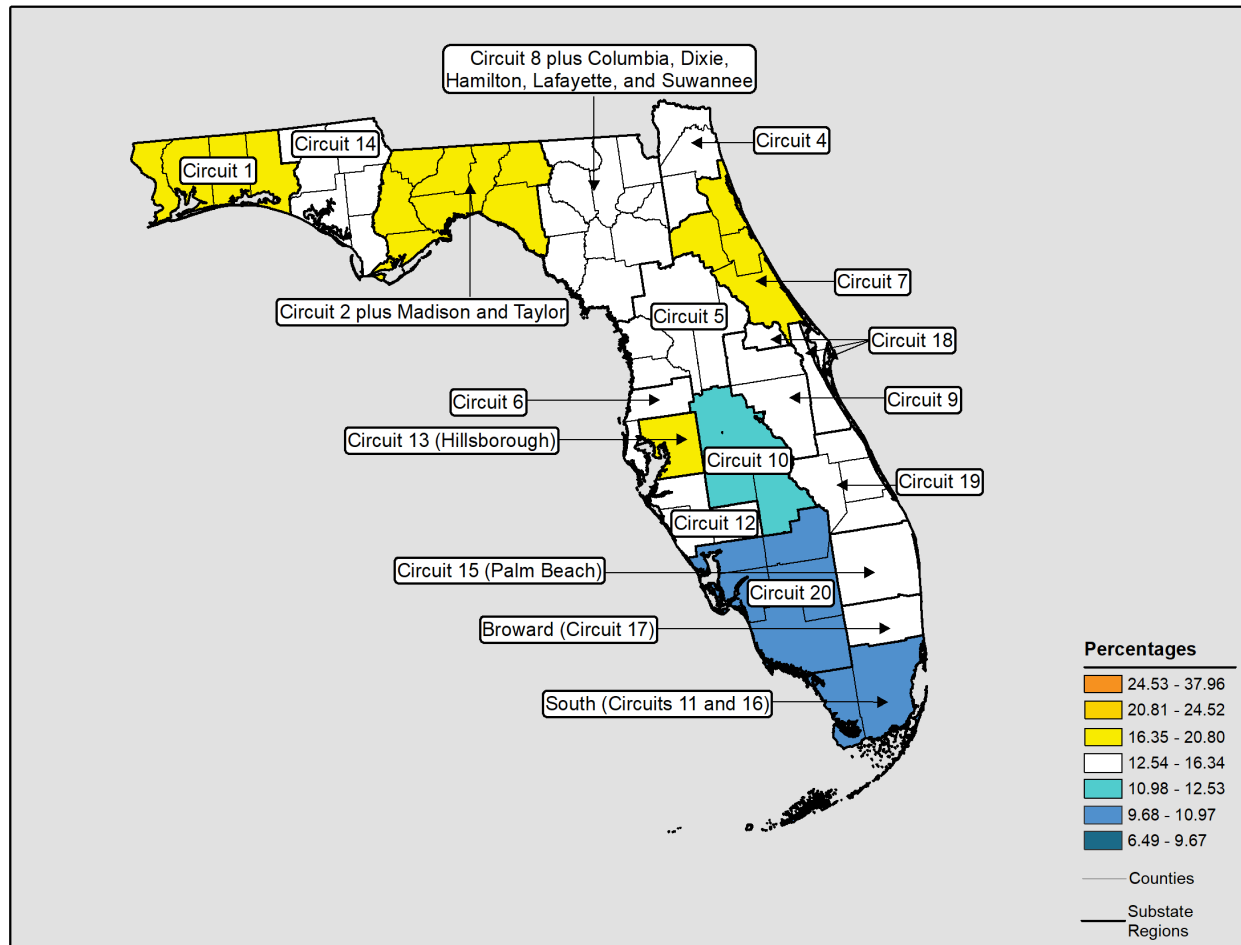
**Figure 10.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

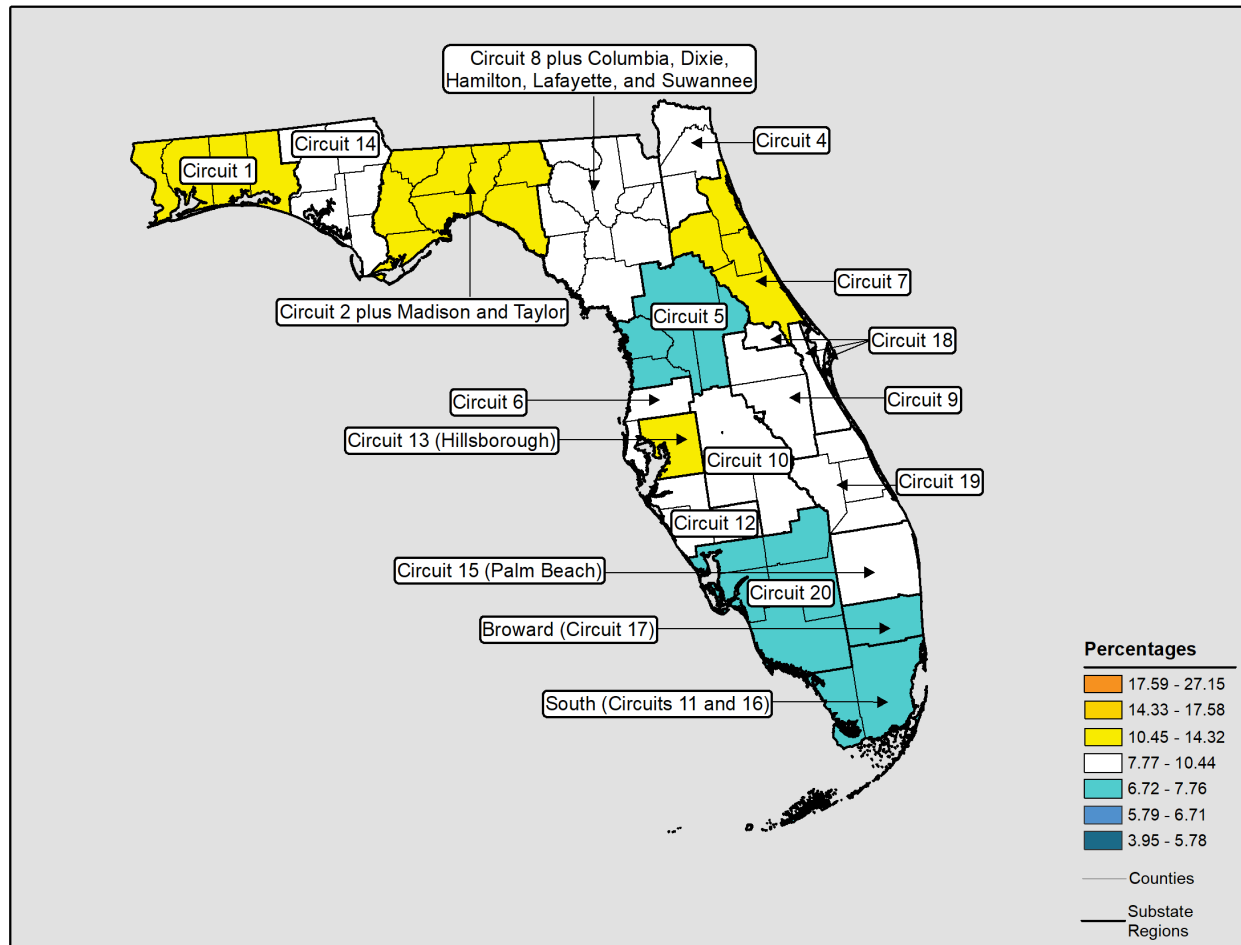
**Figure 10.2 Marijuana Use in the Past Year among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

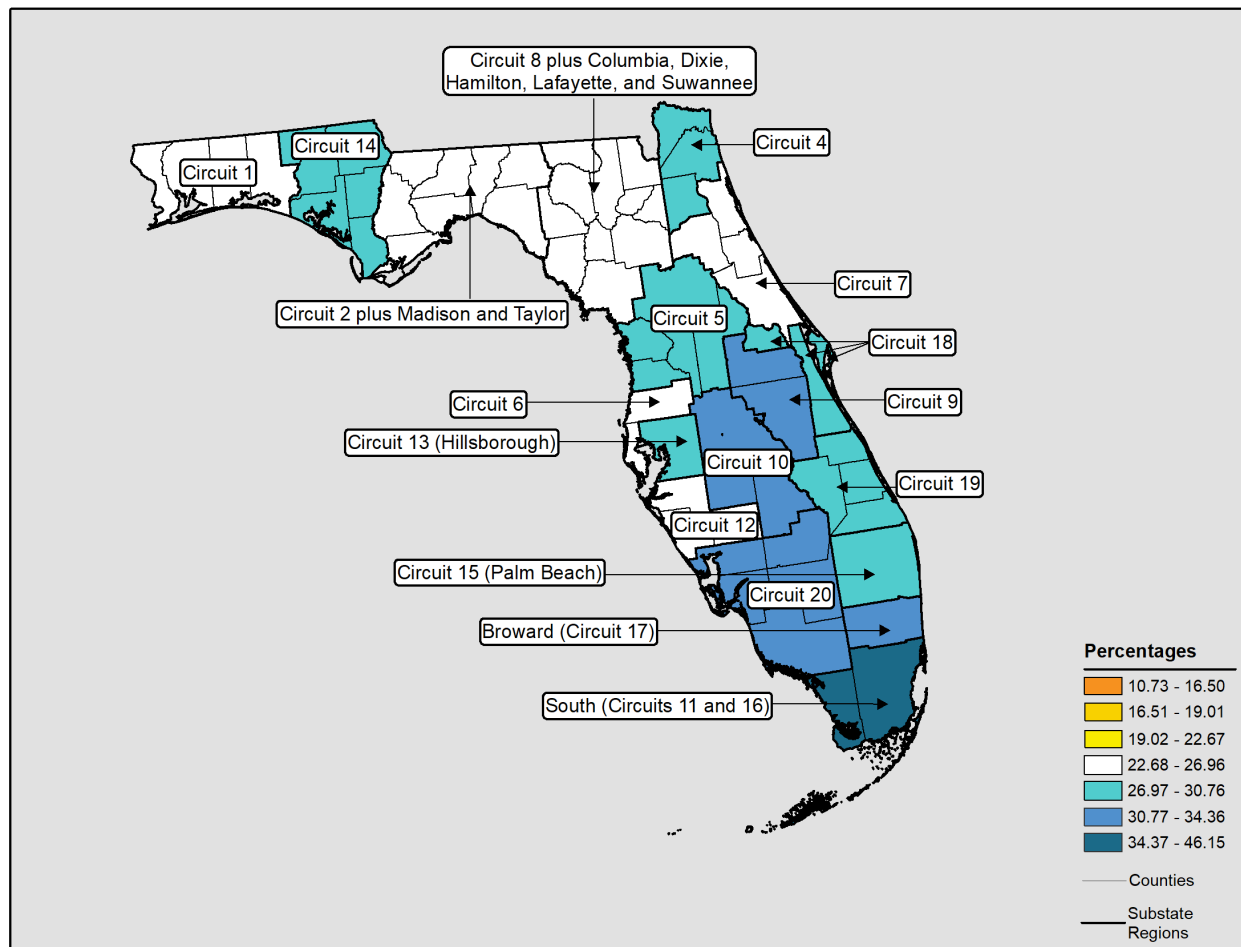
**Figure 10.3 Marijuana Use in the Past Month among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

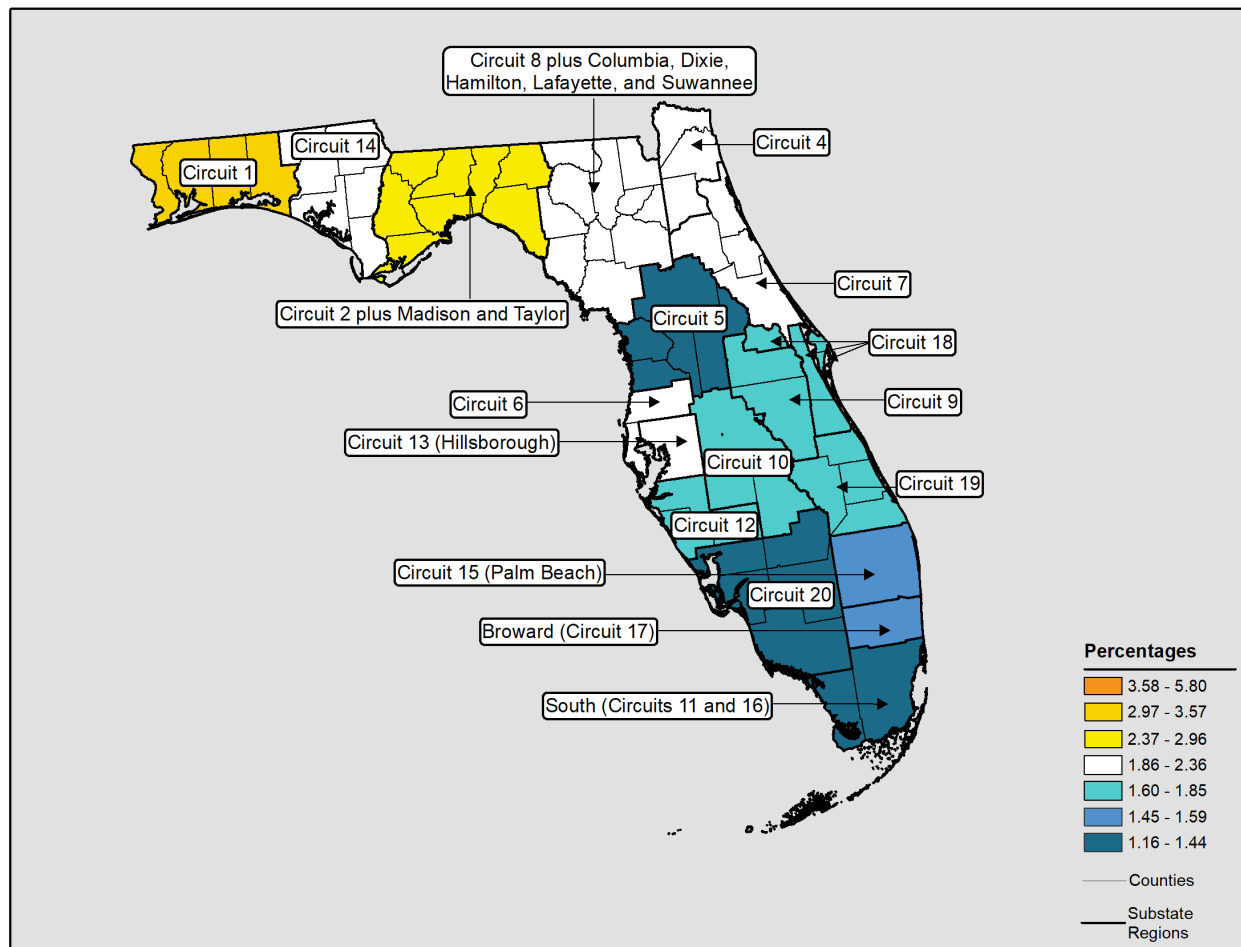
**Figure 10.4** *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

on 2016, 2017, and 2018 NSDUHs**

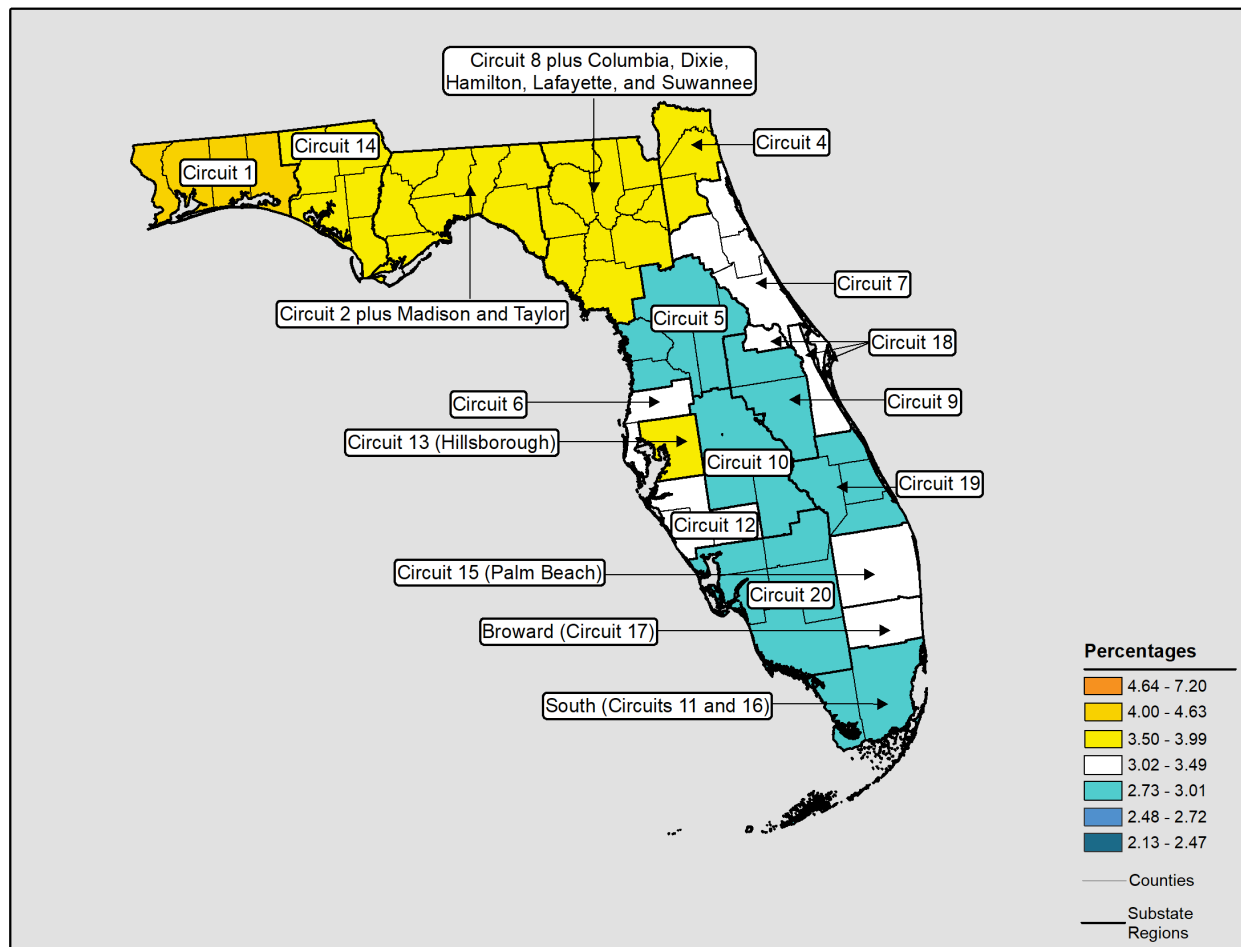

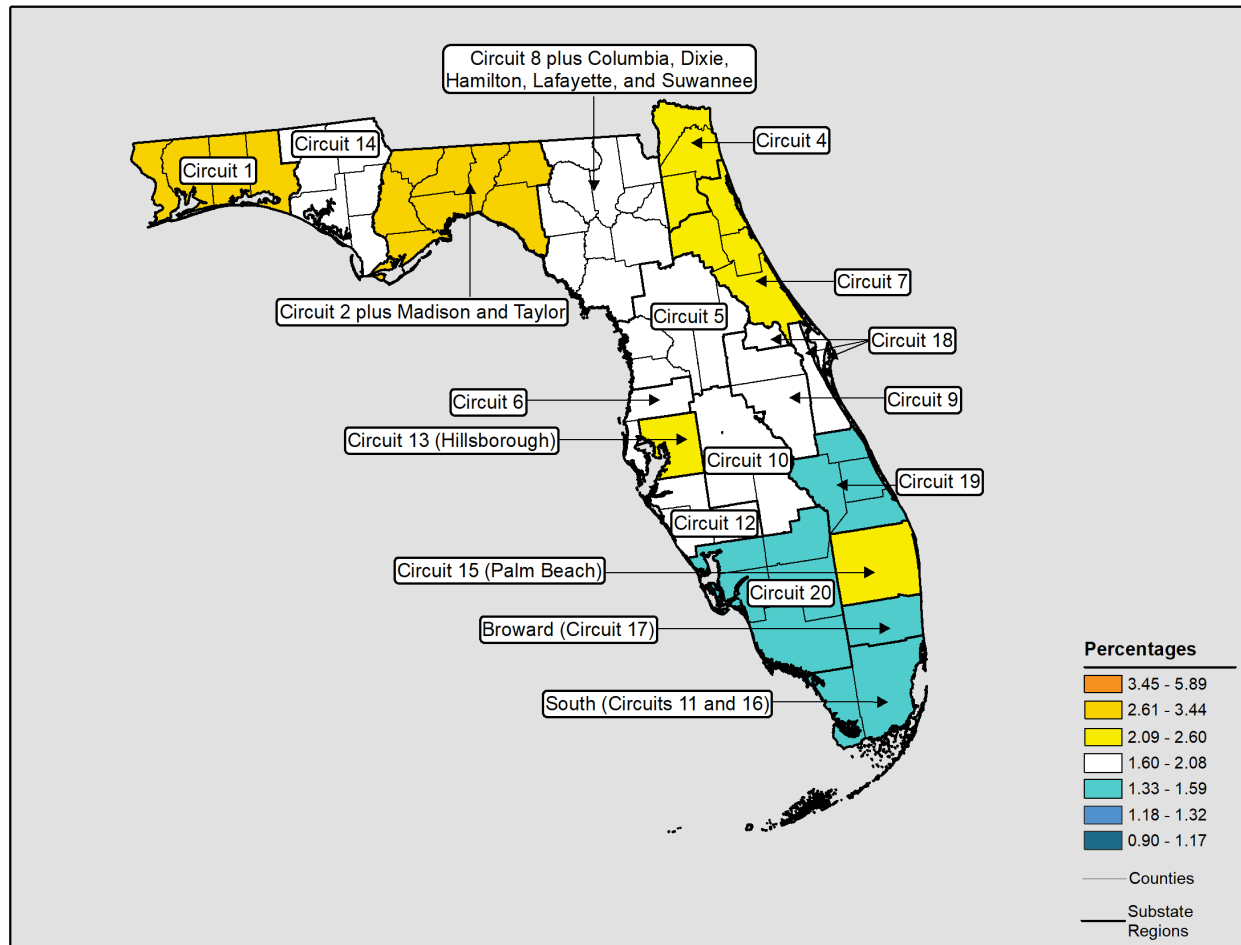
**Figure 10.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

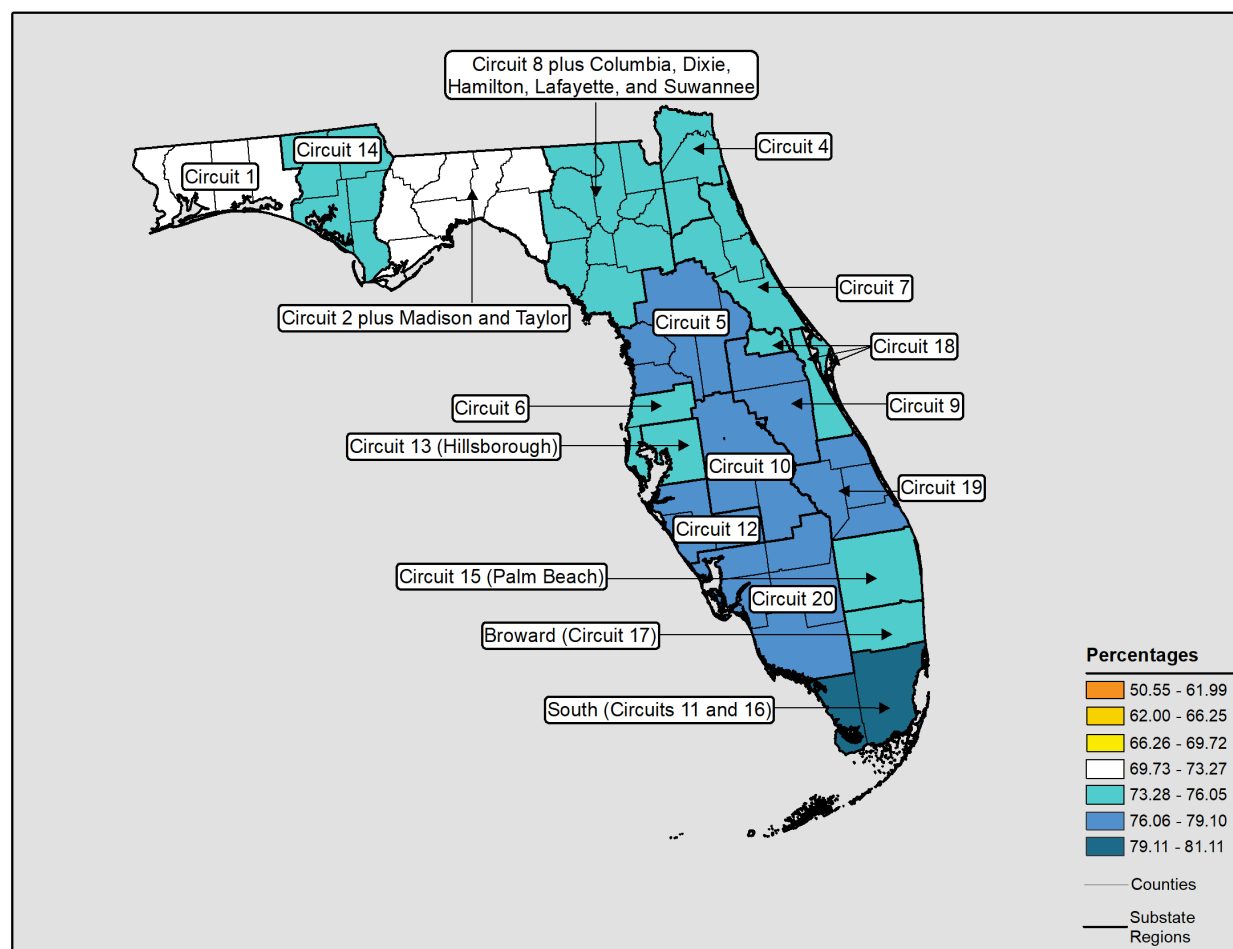
**Figure 10.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

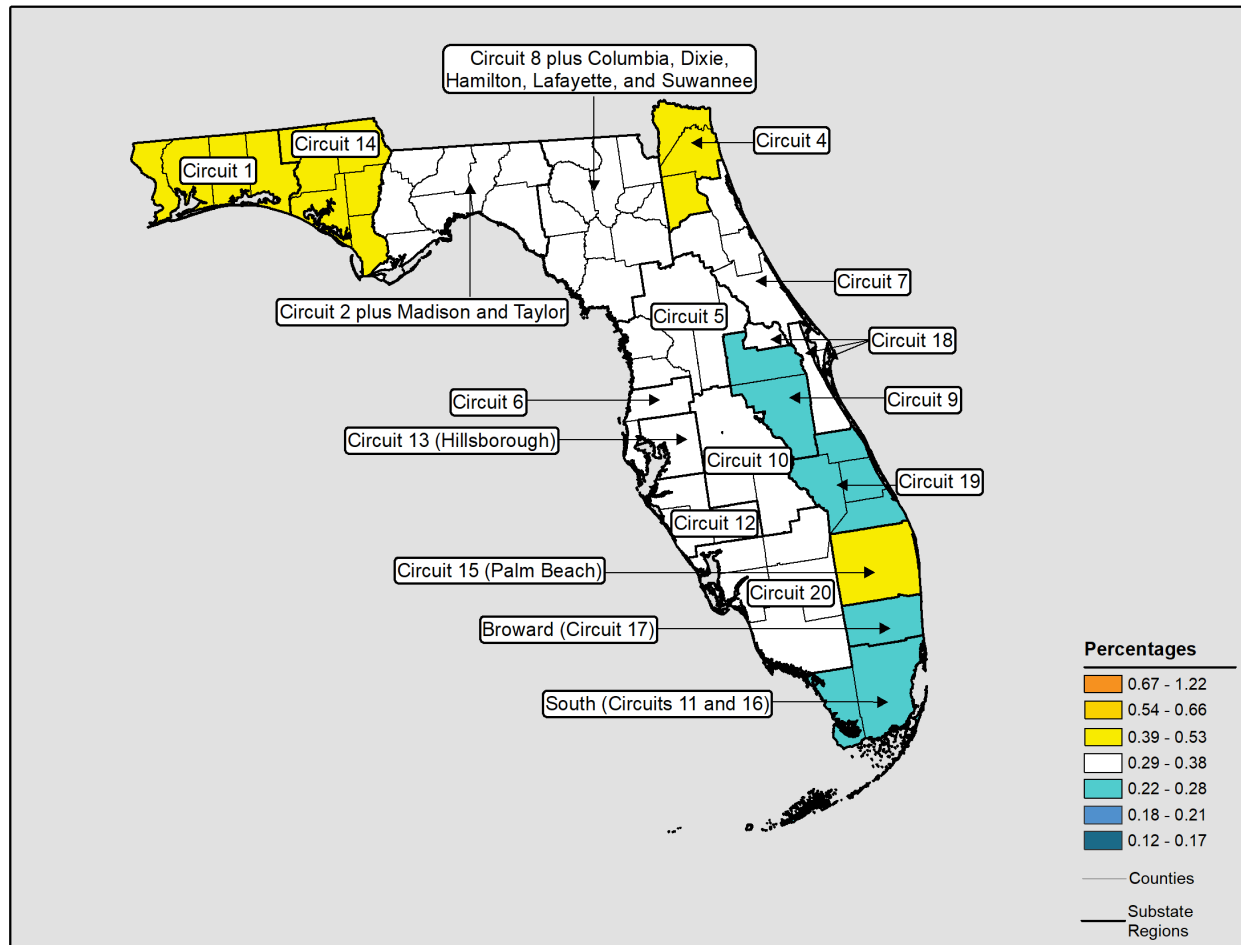
**Figure 10.8** *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

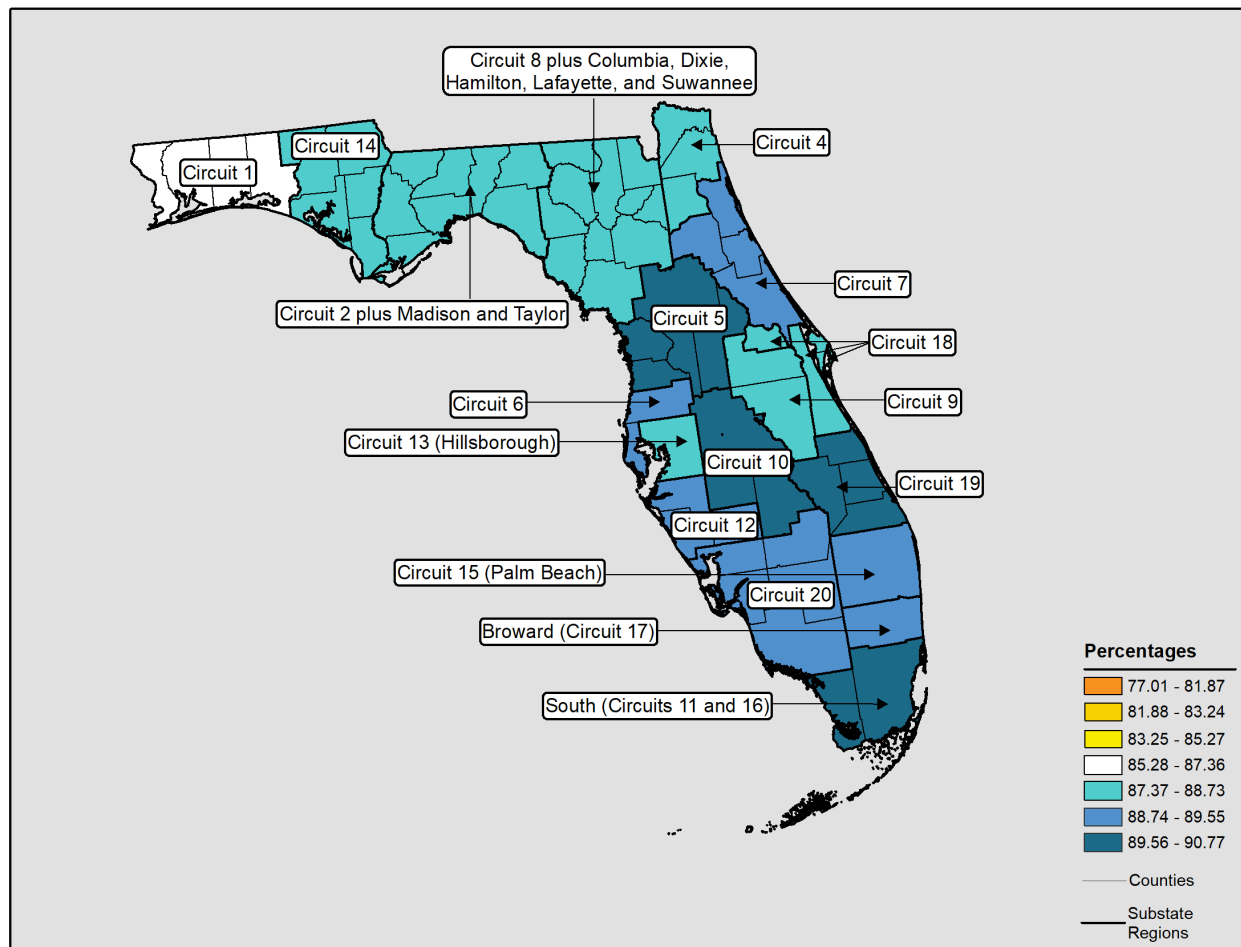
**Figure 10.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

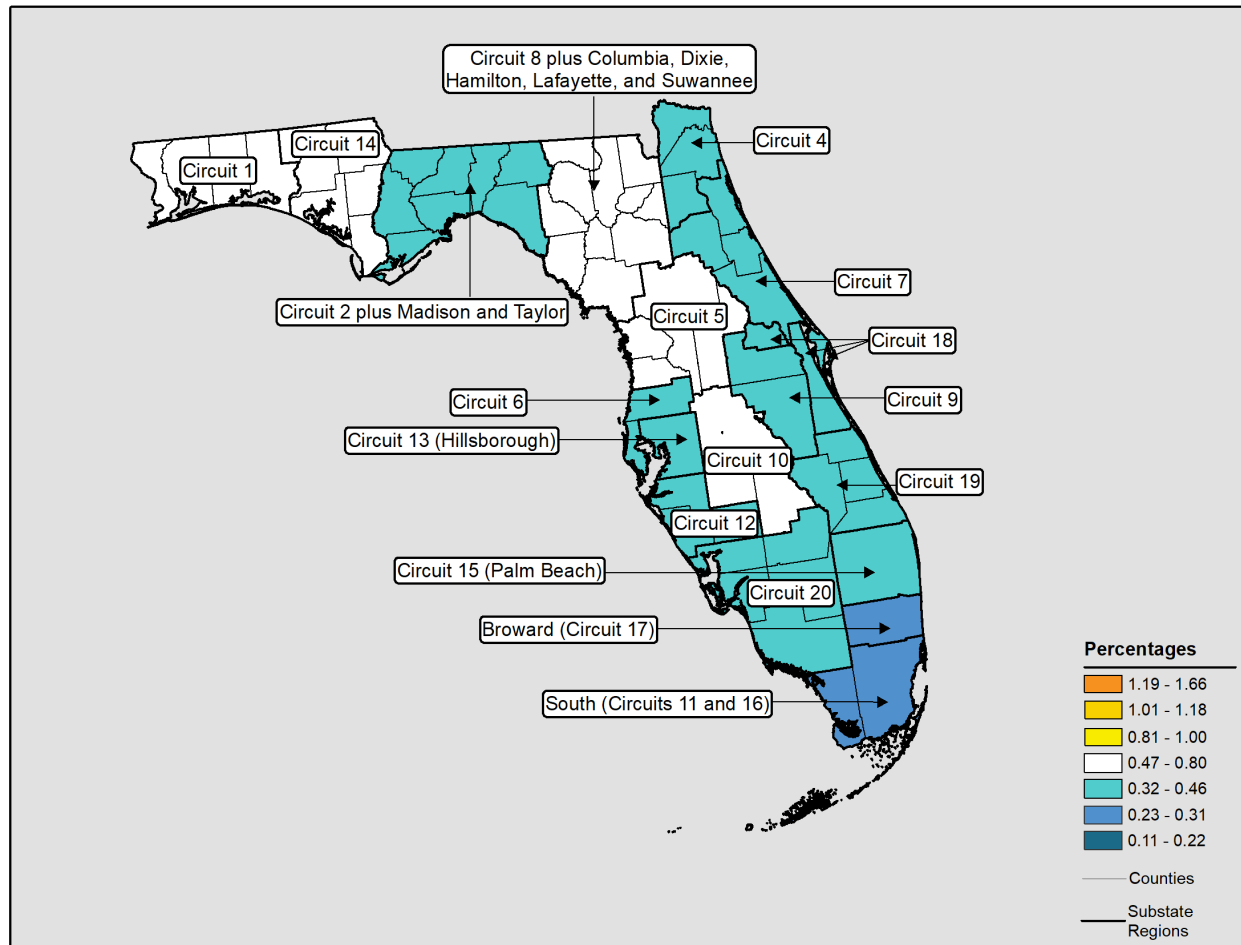
**Figure 10.10** *Perceptions of Great Risk from Trying Heroin Once or Twice among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

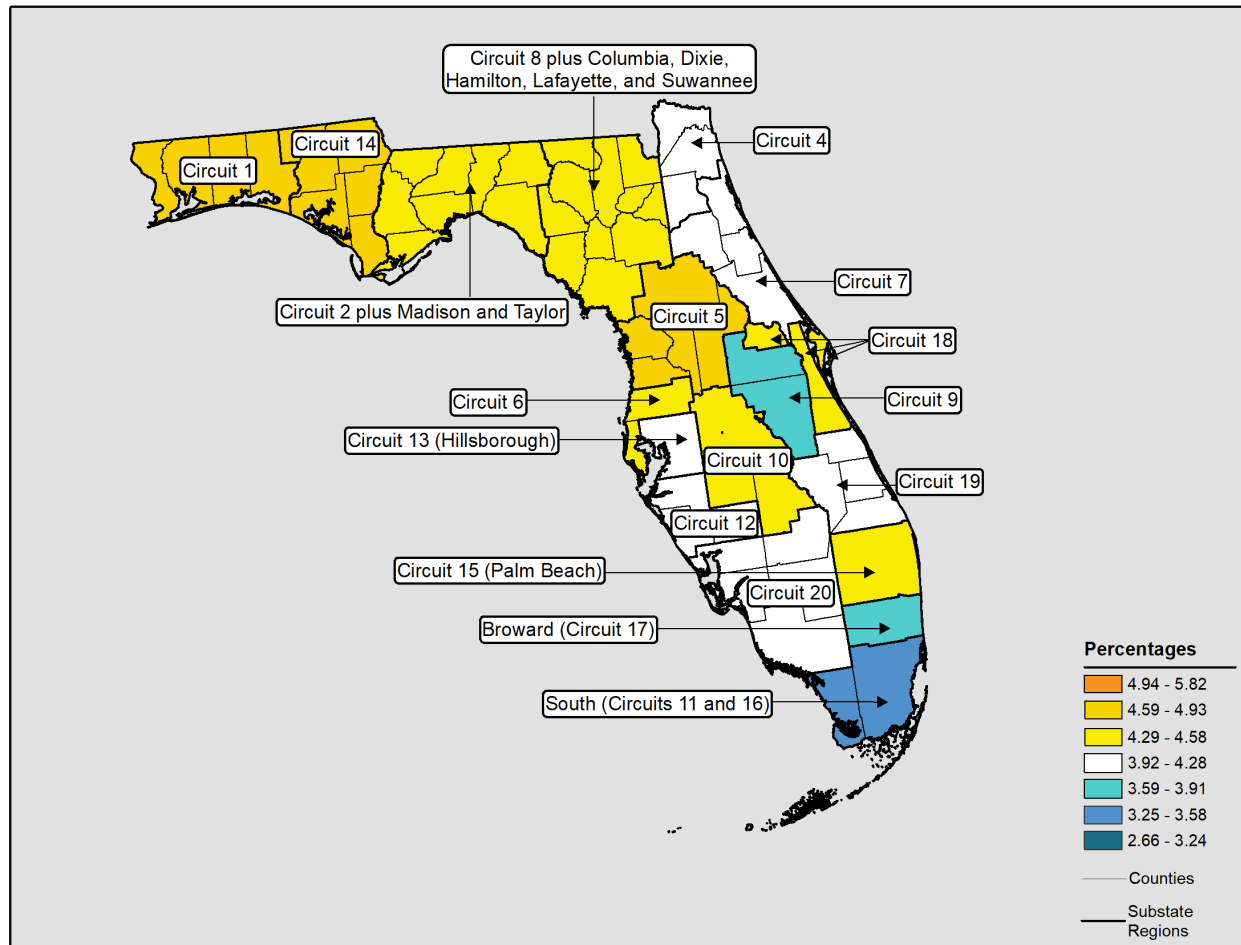
**Figure 10.11 Methamphetamine Use in the Past Year among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

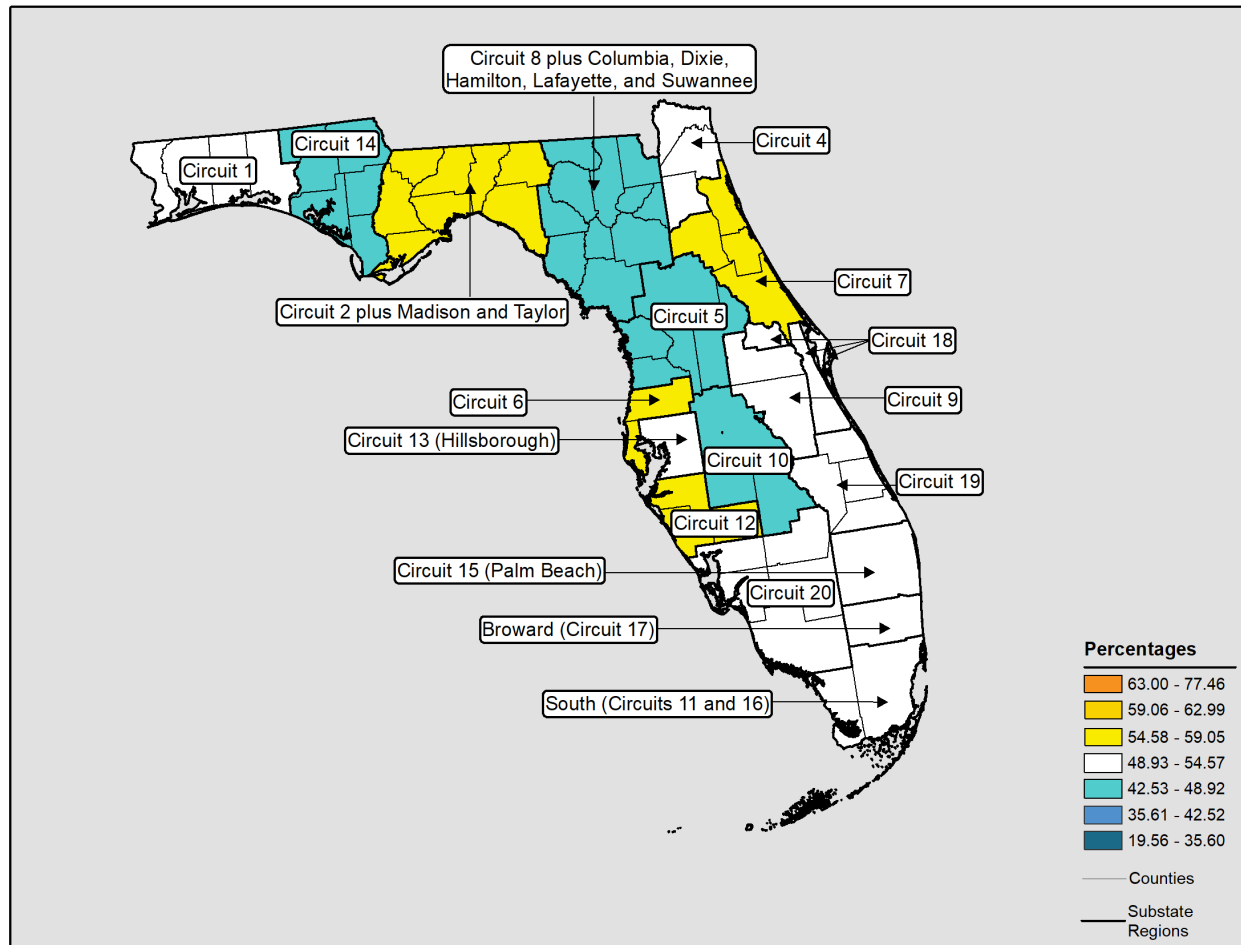
**Figure 10.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

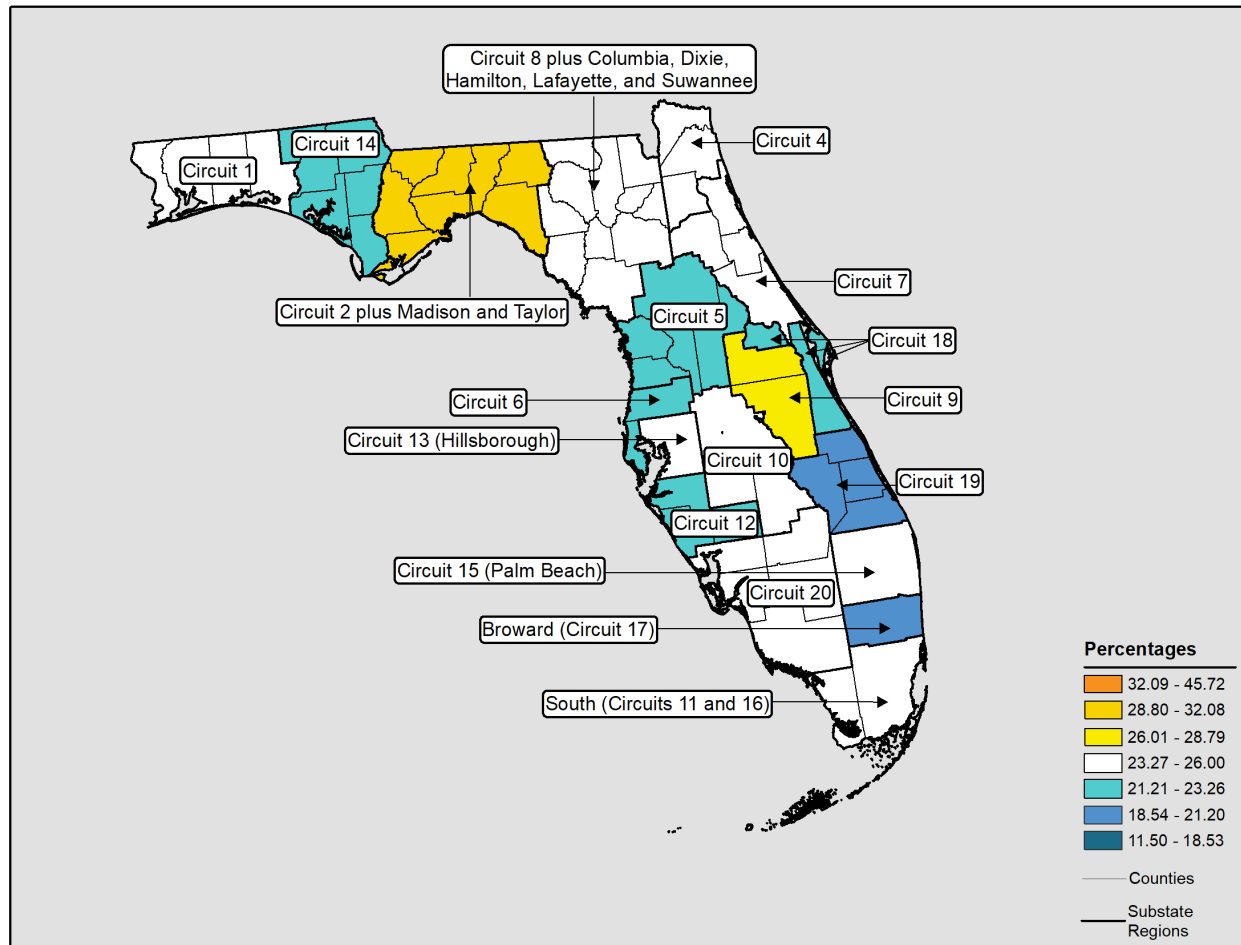

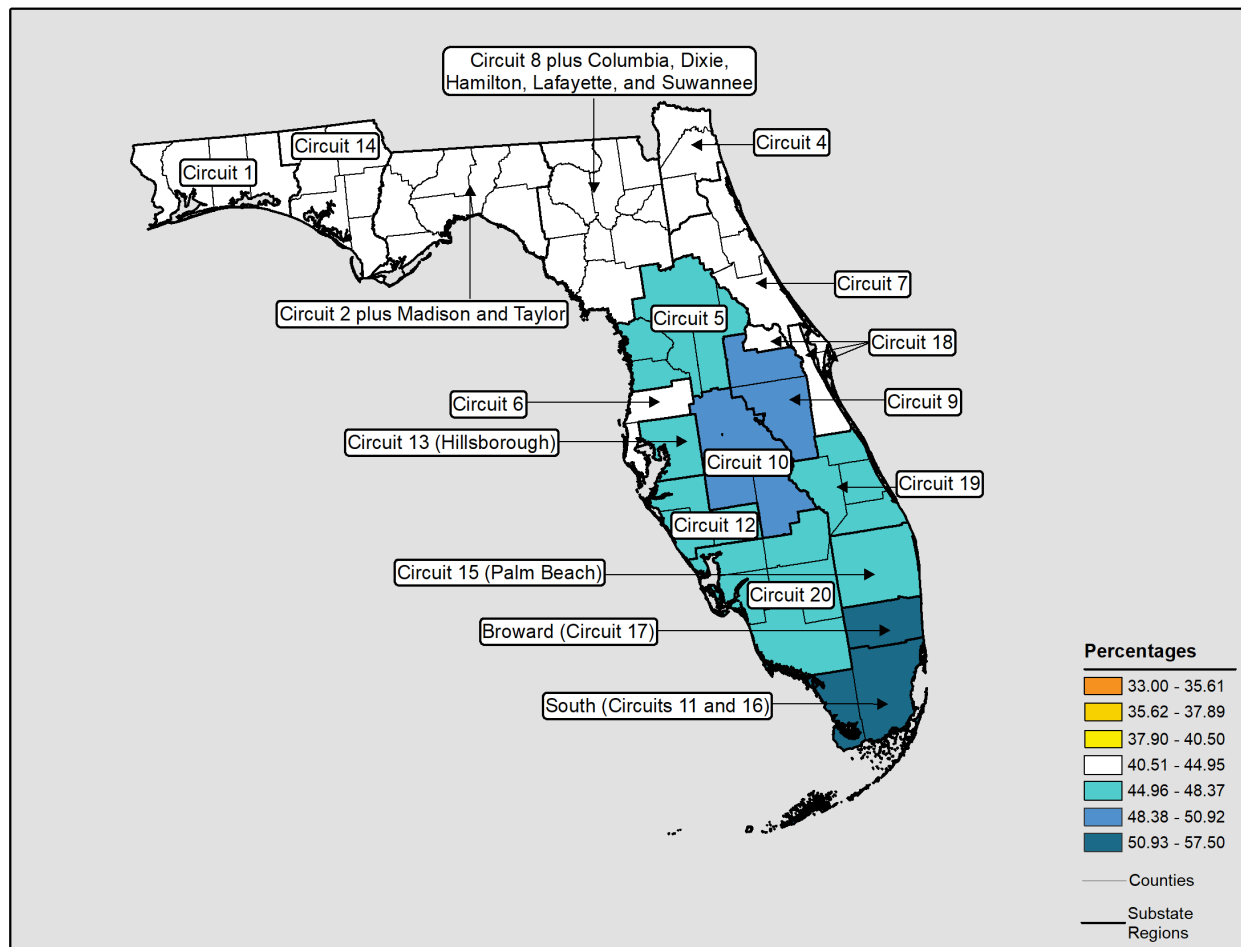
**Figure 10.14 Binge Alcohol Use in the Past Month among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

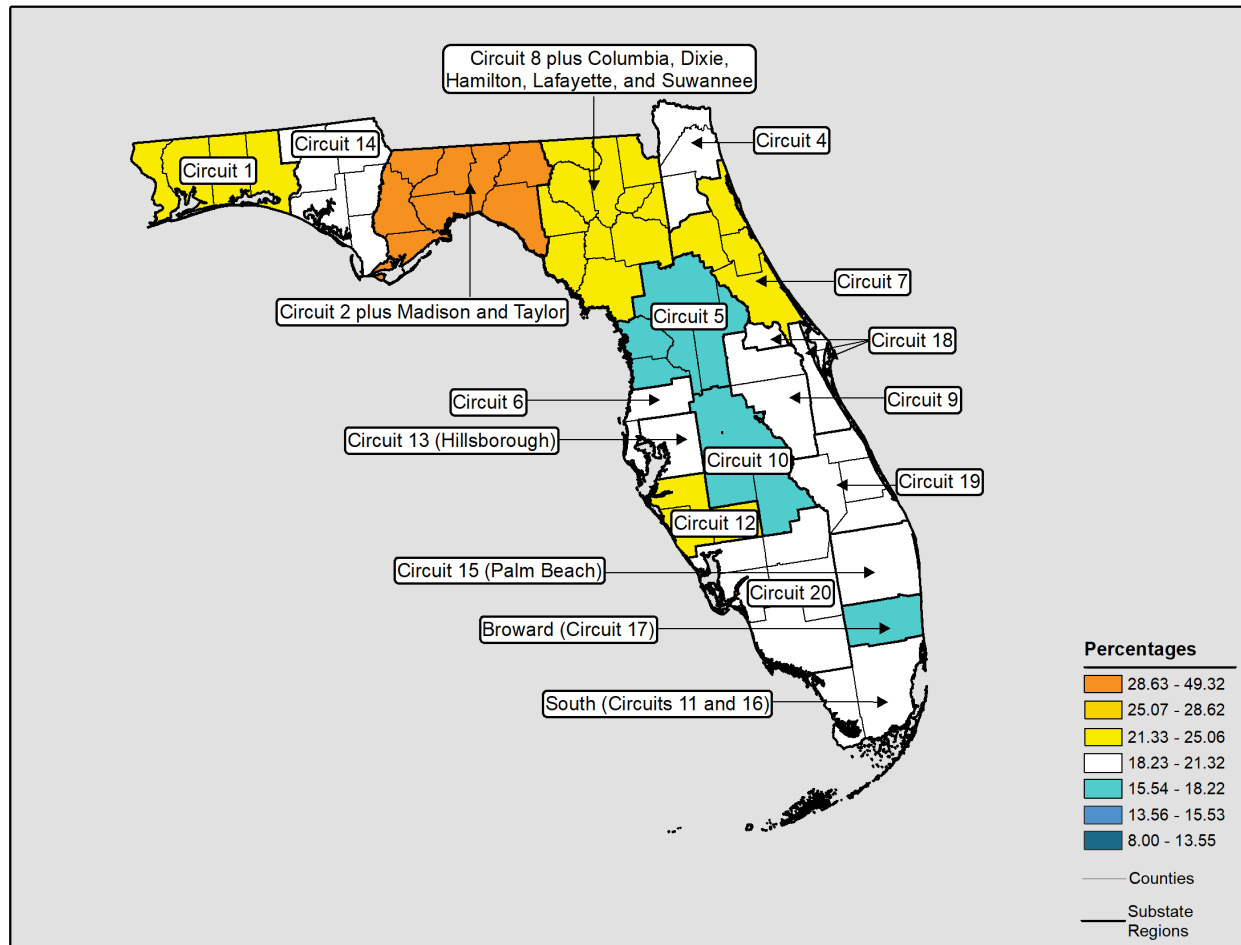
**Figure 10.15** *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

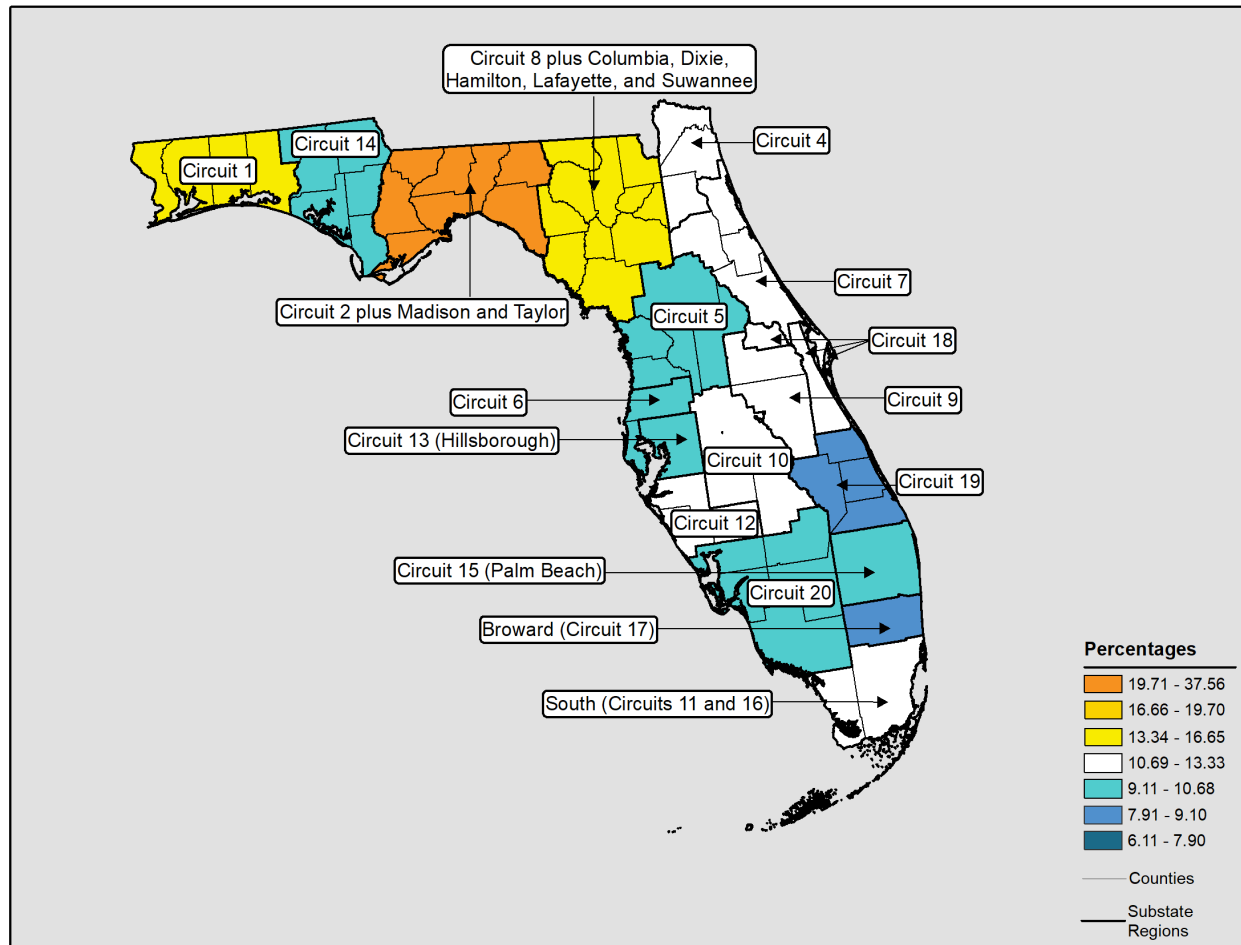
**Figure 10.16 Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

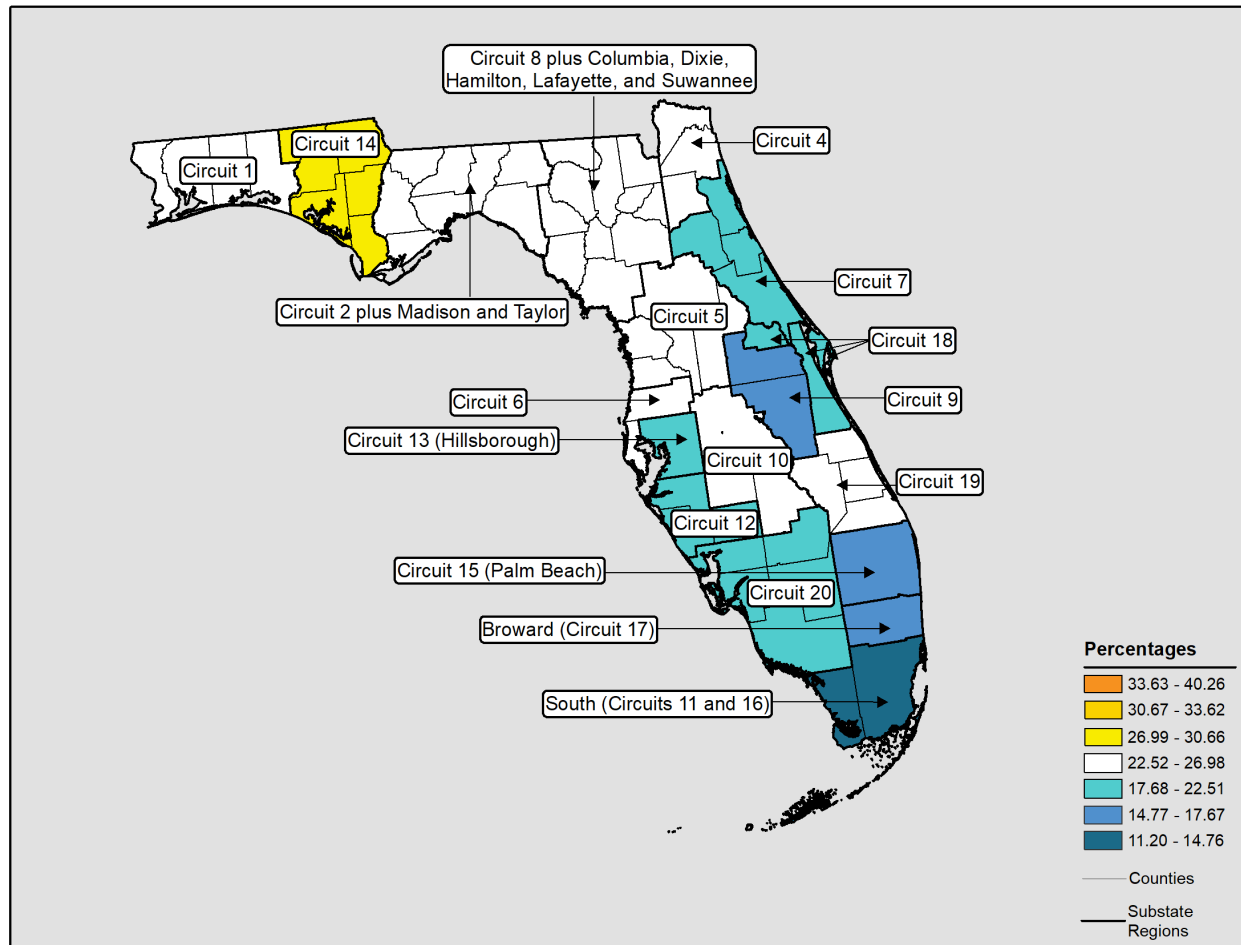
**Figure 10.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

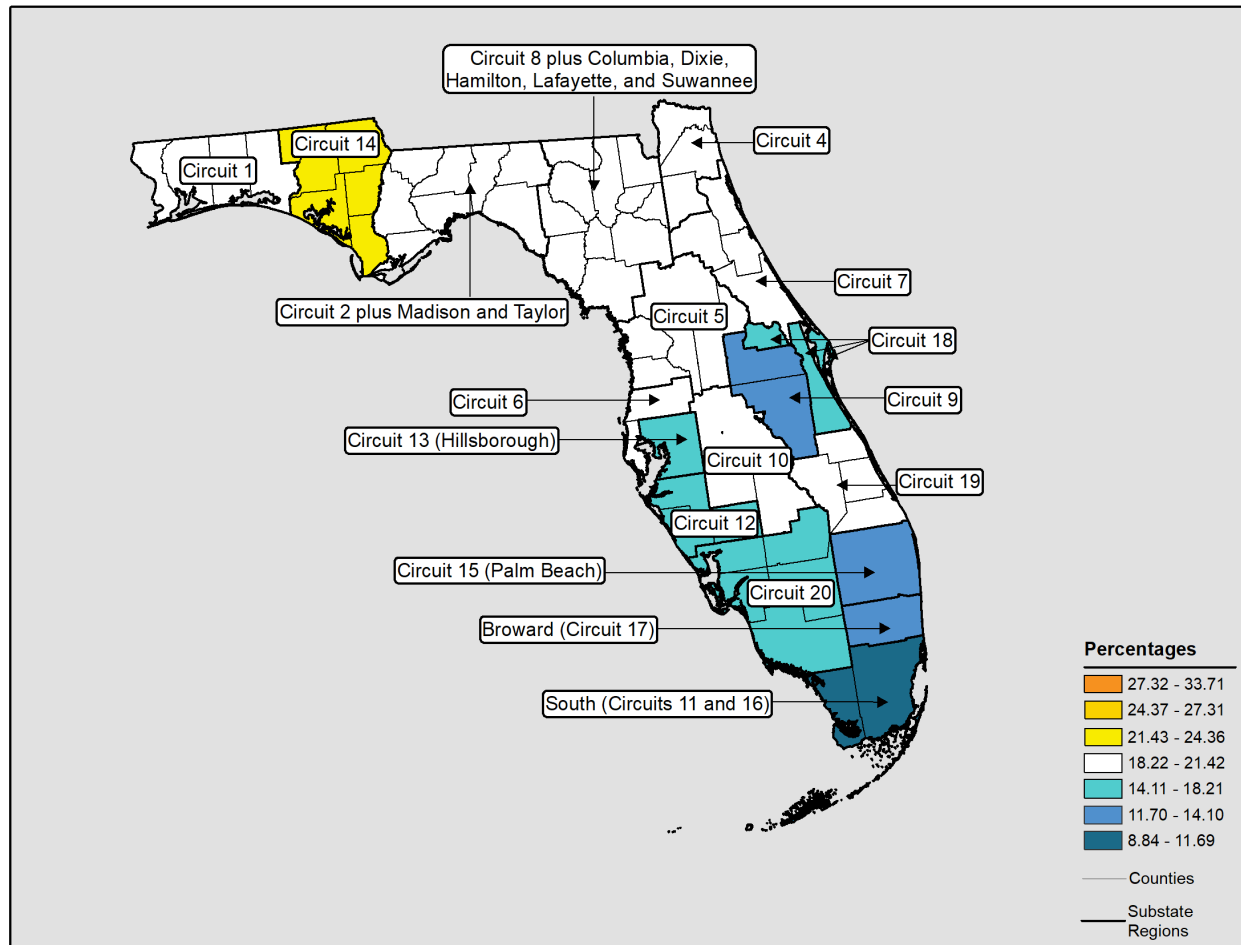
**Figure 10.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

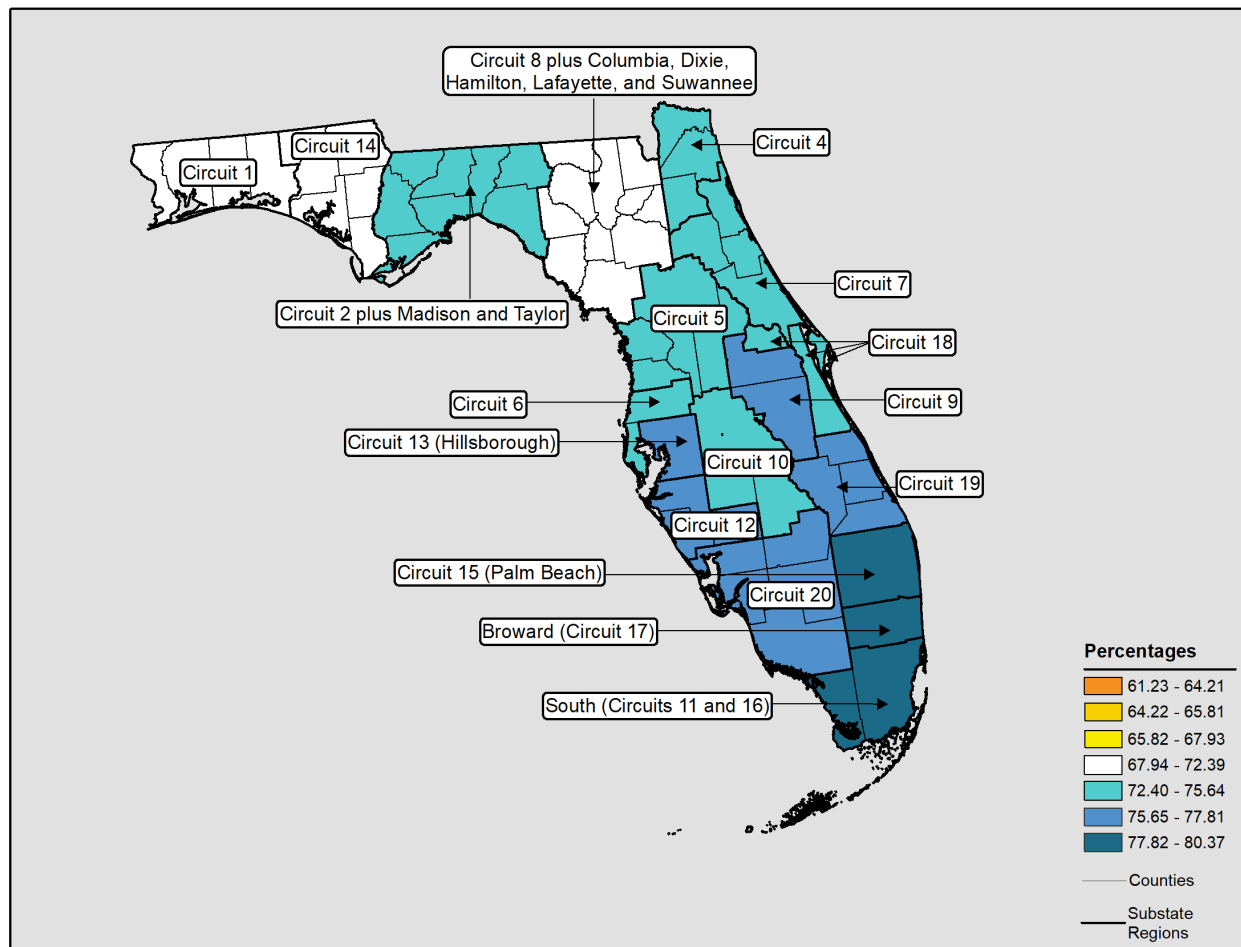
**Figure 10.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

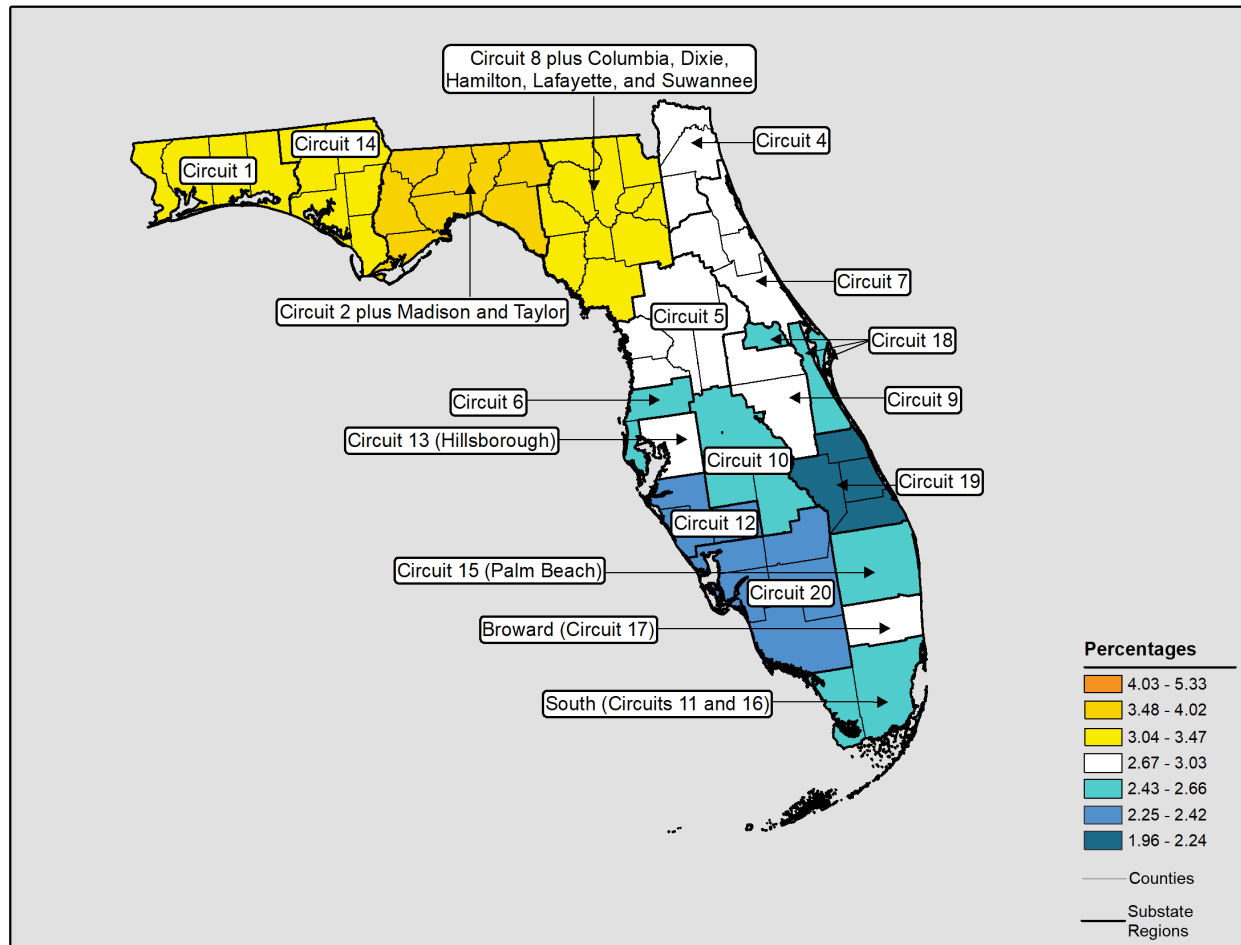
**Figure 10.20** *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

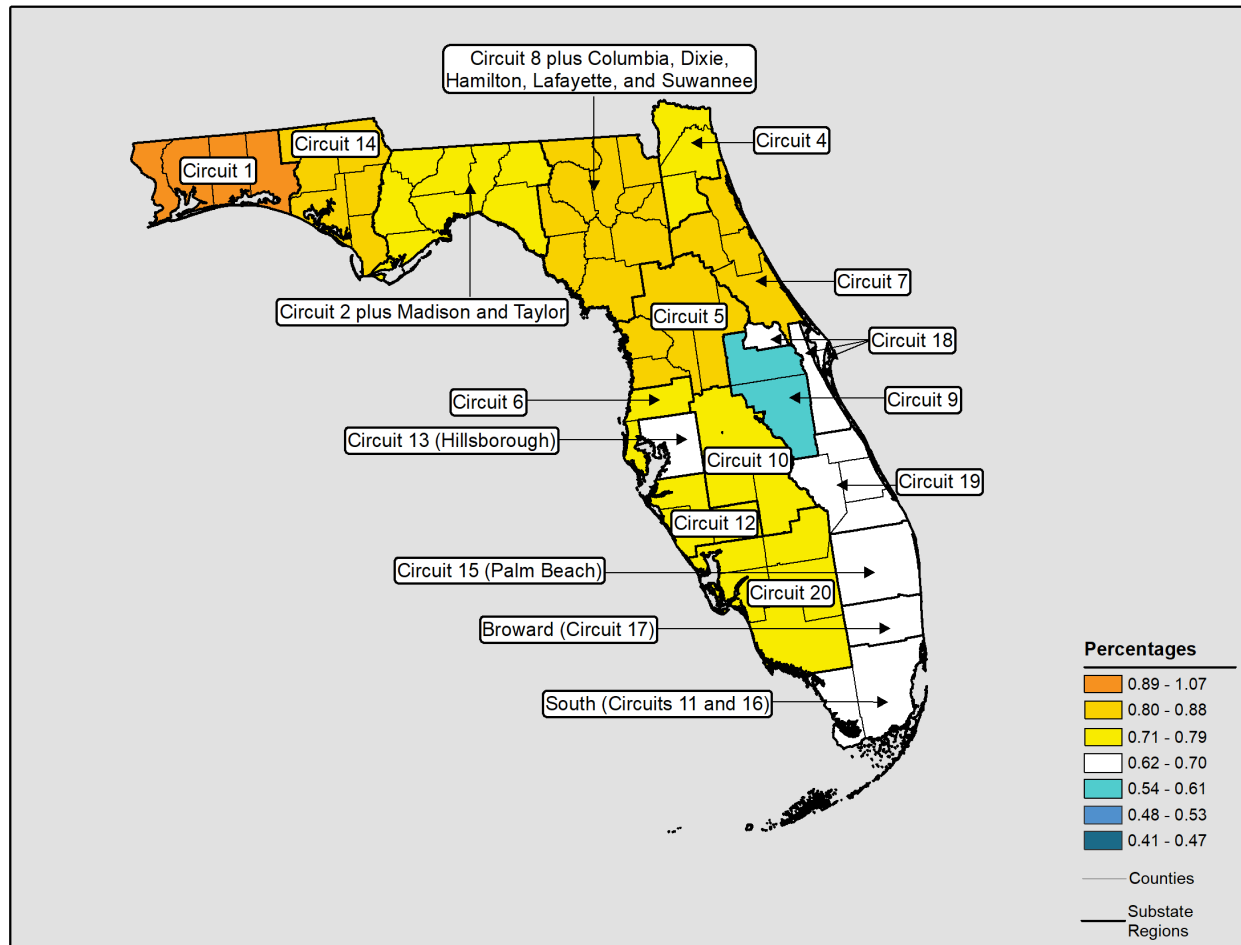

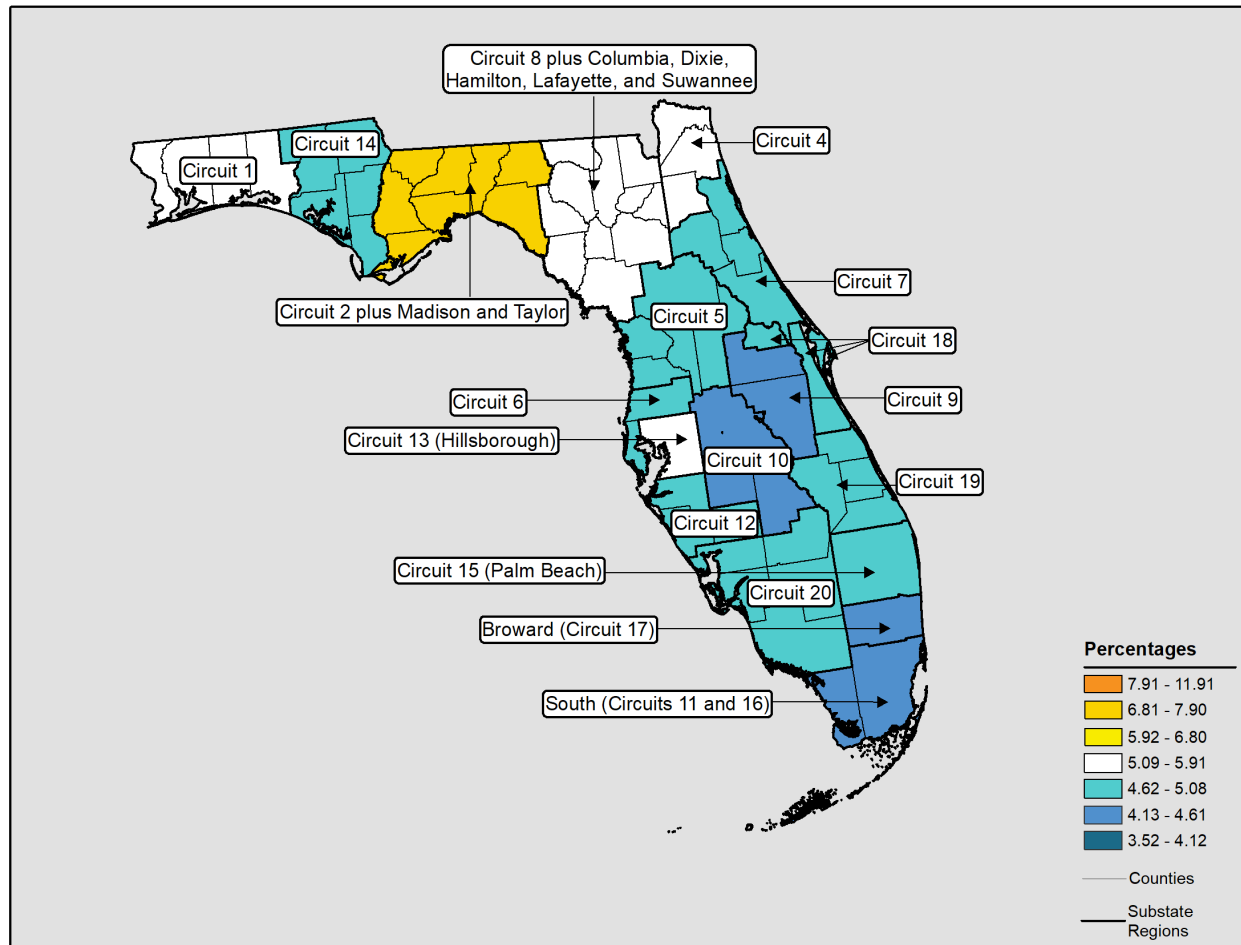
**Figure 10.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

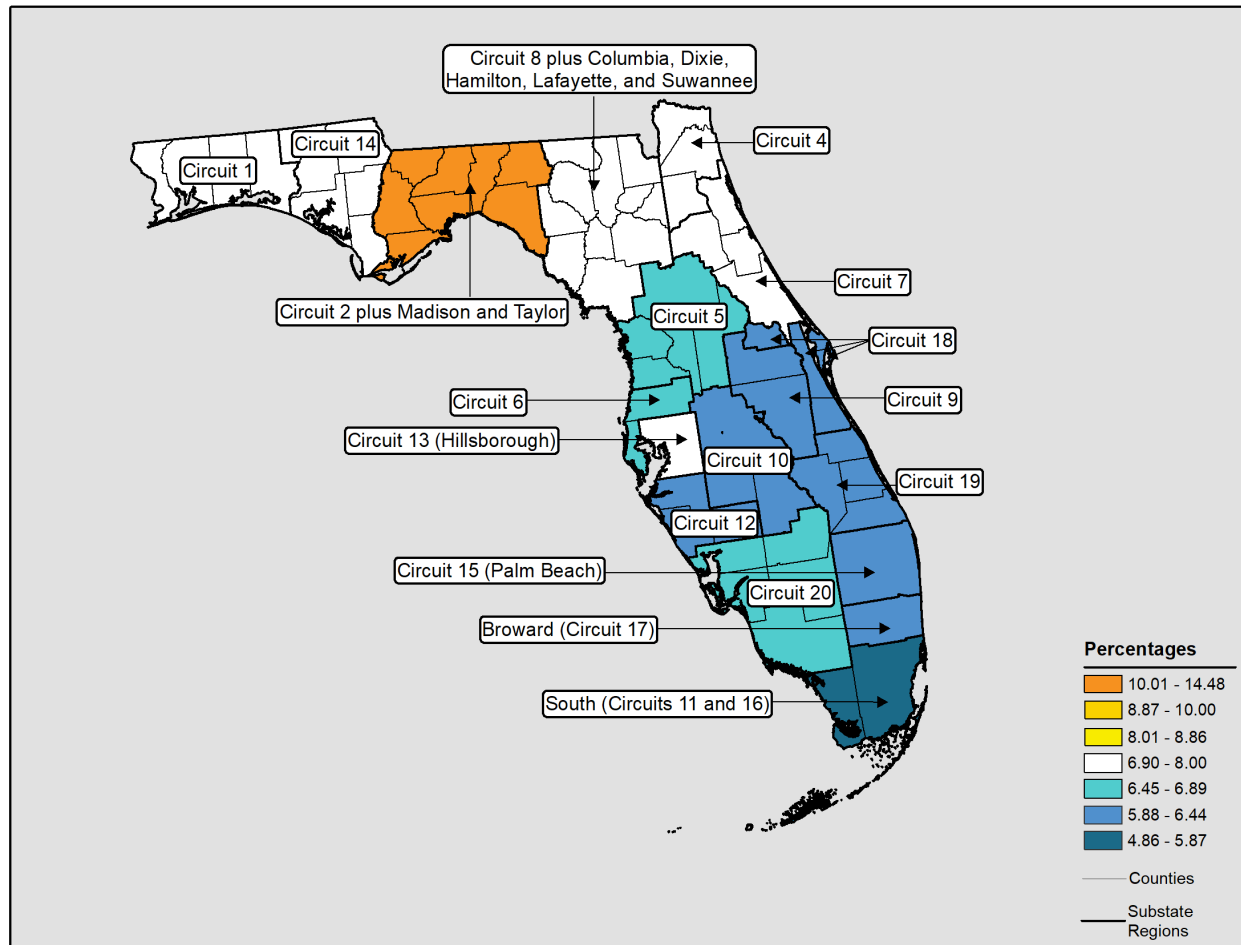
**Figure 10.23 Alcohol Use Disorder in the Past Year among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

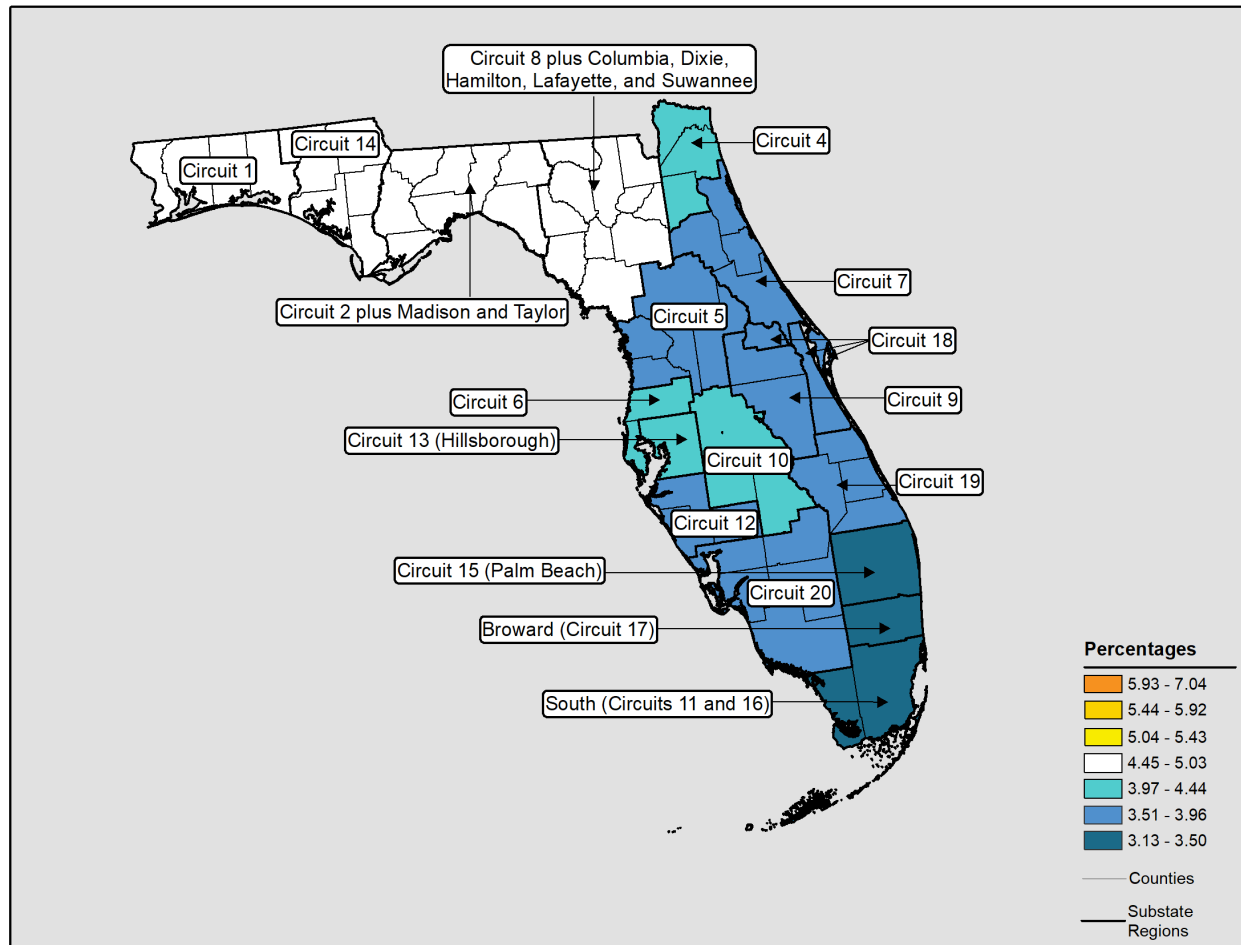
**Figure 10.24 Substance Use Disorder in the Past Year among Individuals Aged 12 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

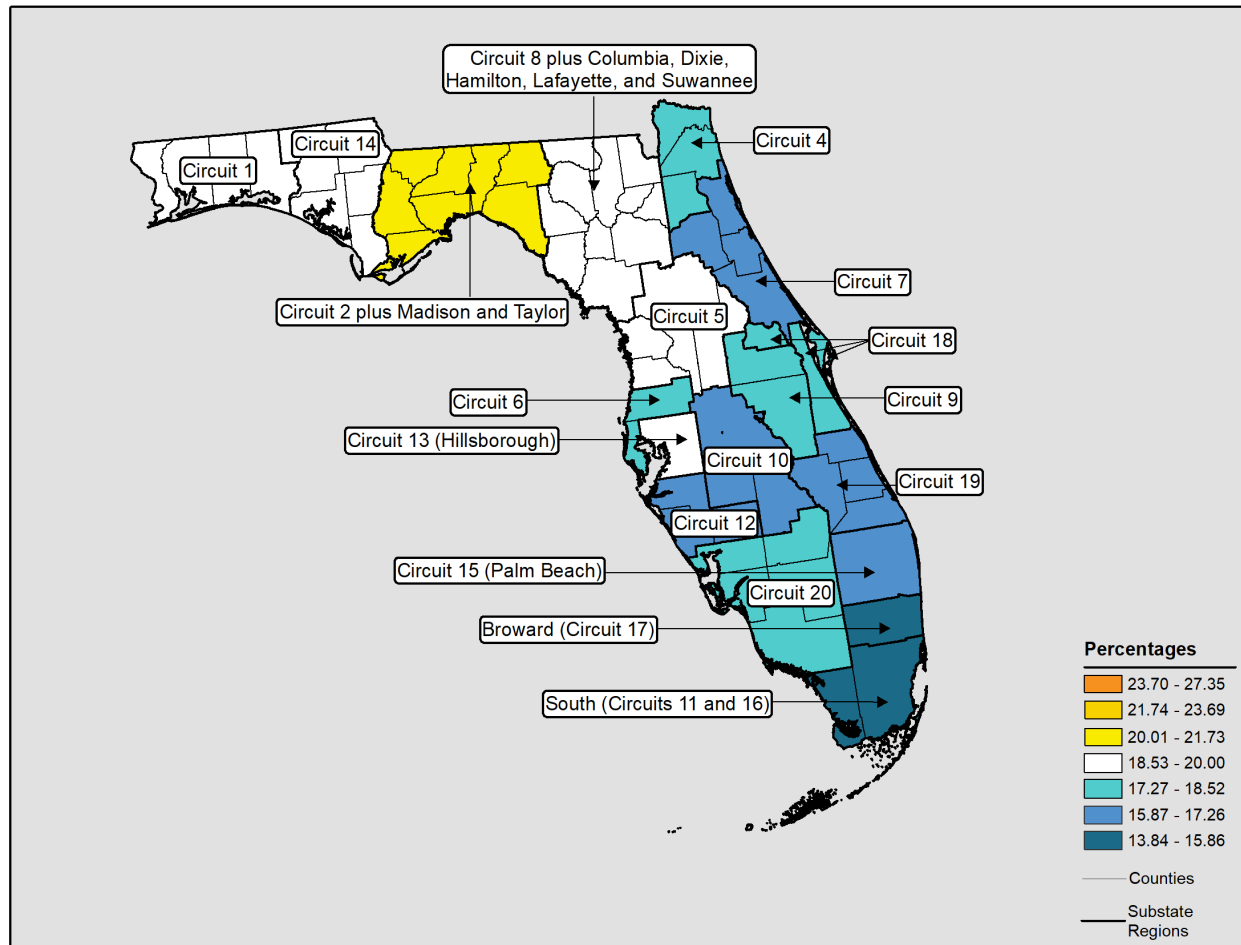
**Figure 10.25 *Serious Mental Illness in the Past Year among Adults Aged 18 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs***

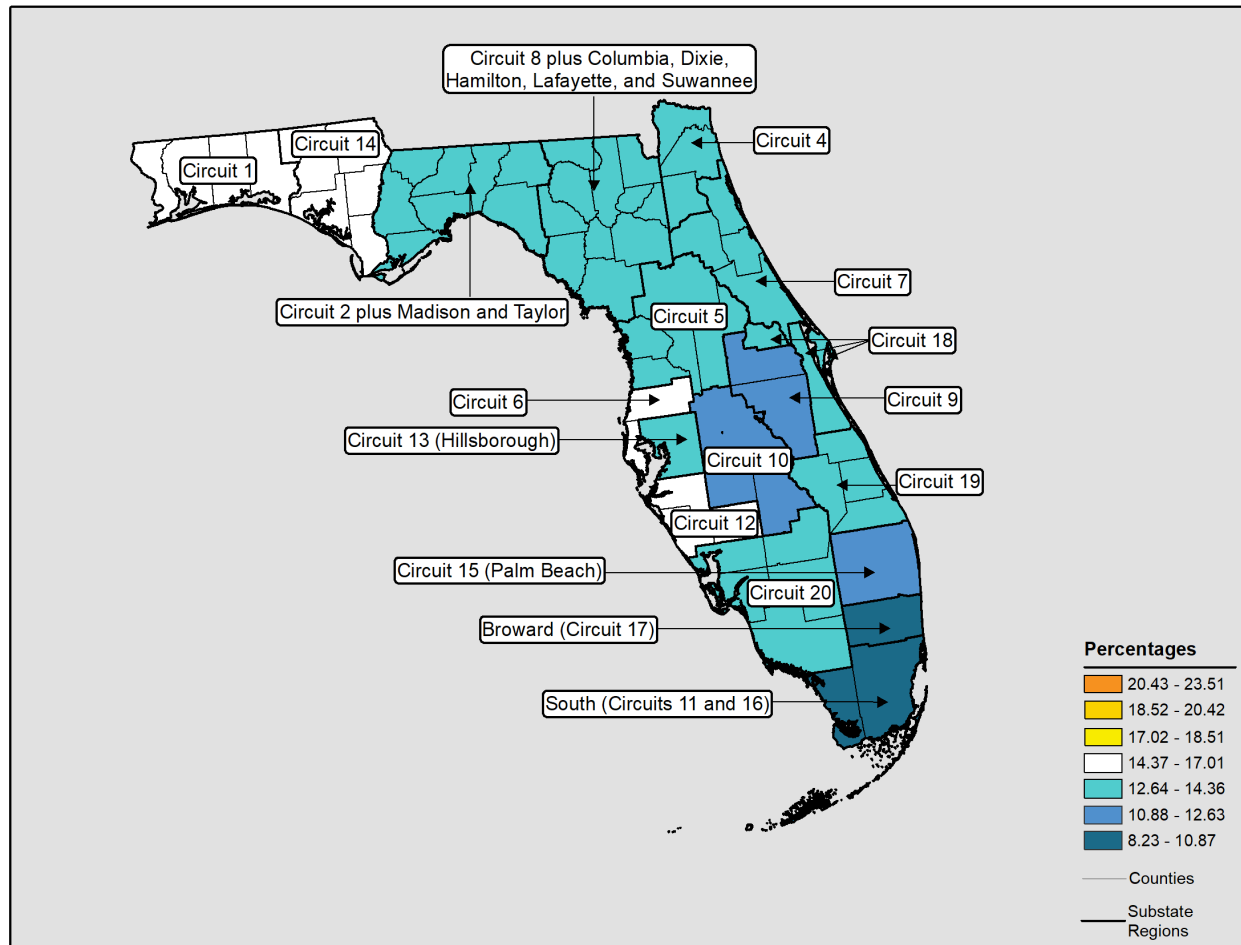
**Figure 10.26** *Any Mental Illness in the Past Year among Adults Aged 18 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

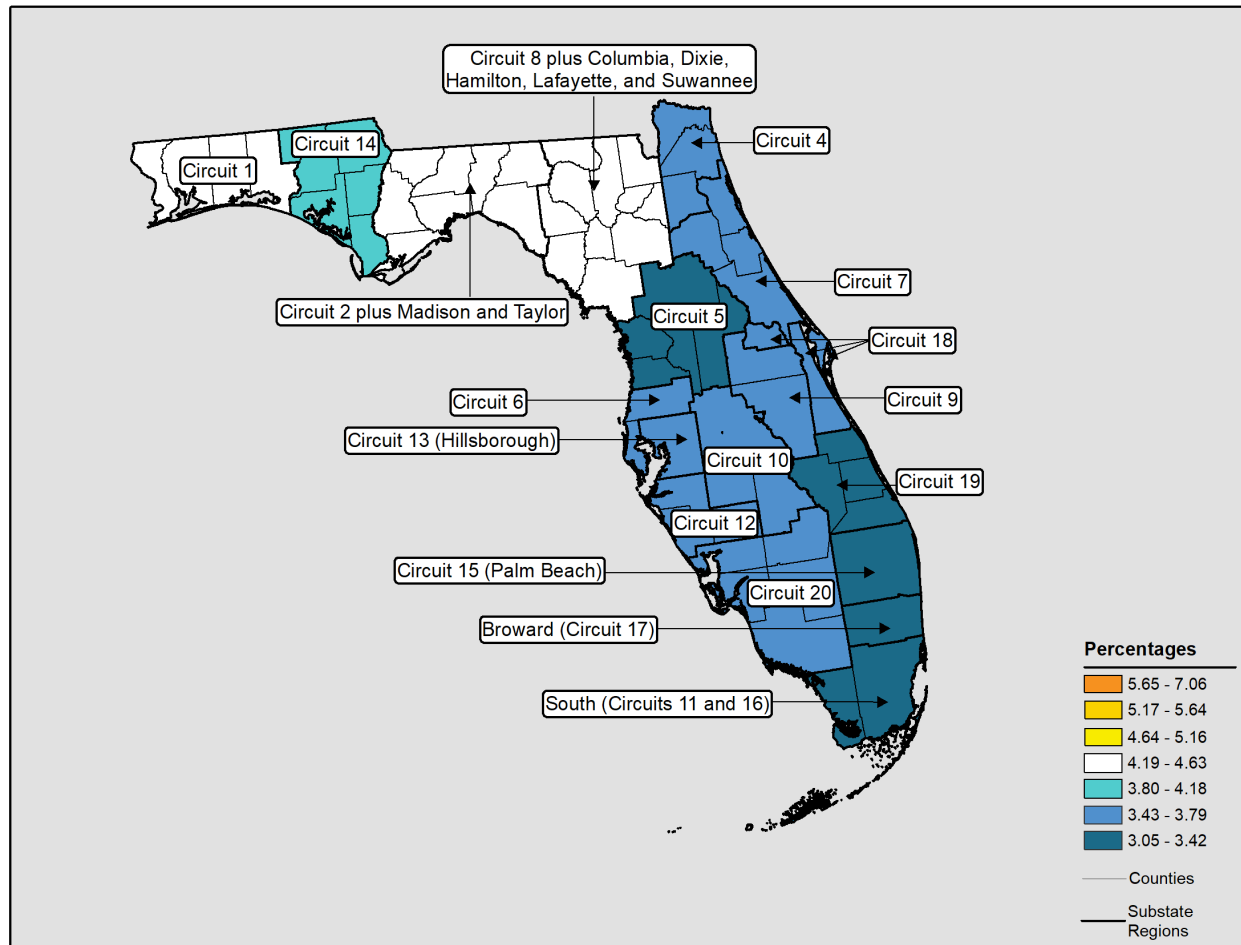
**Figure 10.27 Received Mental Health Services in the Past Year among Adults Aged 18 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

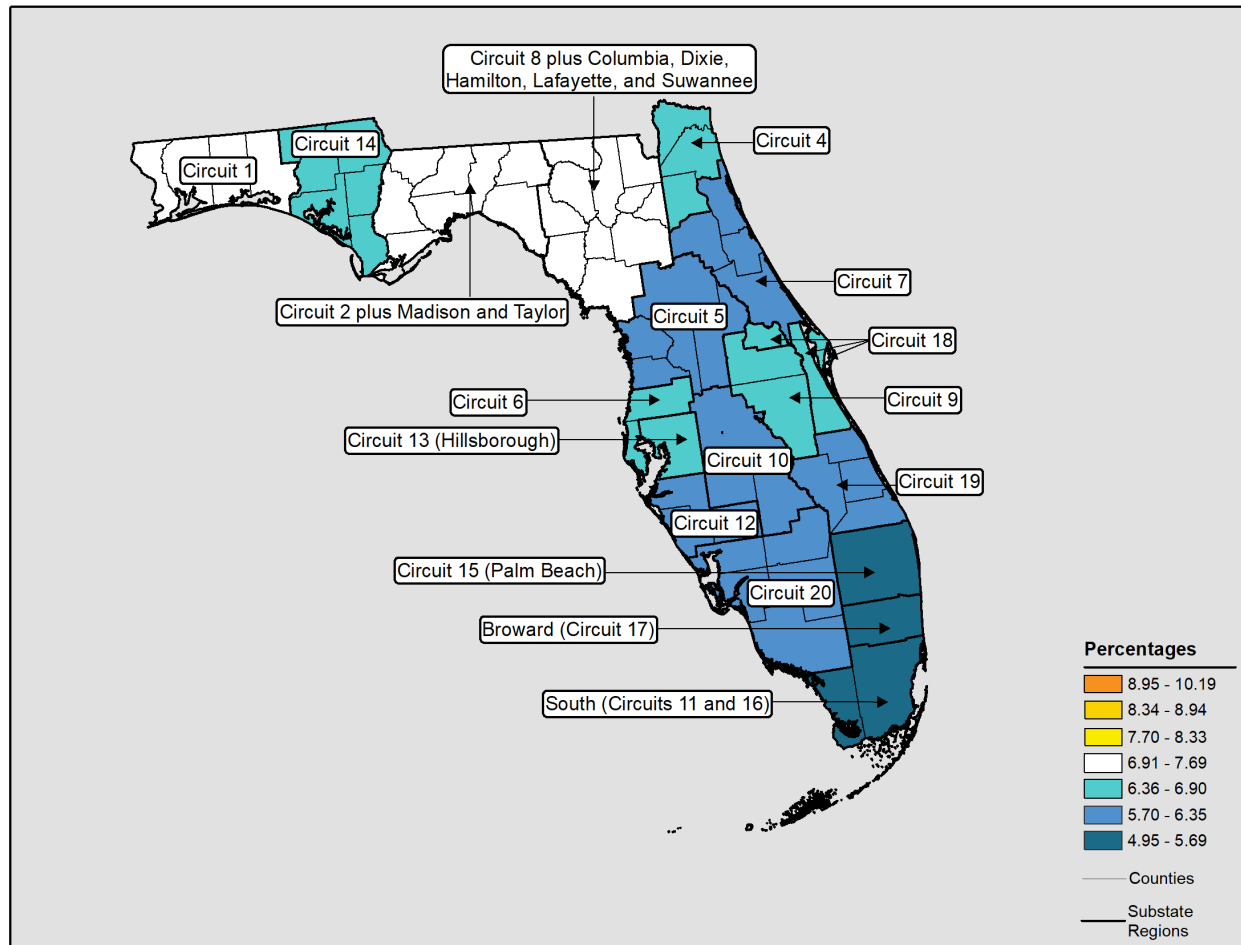
**Figure 10.28 *Had Serious Thoughts of Suicide in the Past Year* among Adults Aged 18 or Older in Florida, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**
