


Figure 29.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.2 *Marijuana Use in the Past Year* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.3 *Marijuana Use in the Past Month* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.4 *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


**Figure 29.5 *First Use of Marijuana* among Individuals Aged 12 or Older in Nevada, by Substate Region:


Figure 29.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.8 *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 29.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.10 *Perceptions of Great Risk from Trying Heroin Once or Twice* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.11 *Methamphetamine Use in the Past Year* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.13 Alcohol Use in the Past Month among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


**Figure 29.14 *Binge Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Nevada,


Figure 29.15 *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 29.16 *Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 29.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.20 *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 29.21 *Illicit Drug Use Disorder in the Past Year* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.23 *Alcohol Use Disorder in the Past Year* among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.24 Substance Use Disorder in the Past Year among Individuals Aged 12 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.25 *Serious Mental Illness in the Past Year* among Adults Aged 18 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.26 *Any Mental Illness in the Past Year* among Adults Aged 18 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.27 Received Mental Health Services in the Past Year among Adults Aged 18 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 29.28 *Had Serious Thoughts of Suicide in the Past Year* among Adults Aged 18 or Older in Nevada, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs
