


Figure 37.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.2 Marijuana Use in the Past Year among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.3 *Marijuana Use in the Past Month* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.4 *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.5 *First Use of Marijuana* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Average Annual Initiation Estimates (Expressed as Percentages of the At-Risk Population) Based on 2016, 2017, and 2018 NSDUHs


Figure 37.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.8 *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.10 *Perceptions of Great Risk from Trying Heroin Once or Twice among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.11 *Methamphetamine Use in the Past Year* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.13 *Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.14 *Binge Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.15 *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.16 *Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.20 *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.21 *Illicit Drug Use Disorder in the Past Year* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.23 Alcohol Use Disorder in the Past Year among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.24 Substance Use Disorder in the Past Year among Individuals Aged 12 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 37.25 *Serious Mental Illness in the Past Year among Adults Aged 18 or Older in Oklahoma,*


Figure 37.26 *Any Mental Illness in the Past Year among Adults Aged 18 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.27 *Received Mental Health Services in the Past Year among Adults Aged 18 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 37.28 *Had Serious Thoughts of Suicide in the Past Year* among Adults Aged 18 or Older in Oklahoma, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs
