


Figure 38.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.2 *Marijuana Use in the Past Year* among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.3 *Marijuana Use in the Past Month* among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.4 *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 38.5 *First Use of Marijuana* among Individuals Aged 12 or Older in Oregon, by Substate Region: Average Annual Initiation Estimates (Expressed as Percentages of the At-Risk Population) Based on 2016, 2017, and 2018 NSDUHs


Figure 38.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.8 *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 38.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.10 *Perceptions of Great Risk from Trying Heroin Once or Twice among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


**Figure 38.11 *Methamphetamine Use in the Past Year* among Individuals Aged 12 or Older in Oregon,


**Figure 38.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Oregon,


Figure 38.13 Alcohol Use in the Past Month among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.14 Binge Alcohol Use in the Past Month among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.15 *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 38.16 Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.20 *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 38.21 *Illicit Drug Use Disorder in the Past Year* among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


**Figure 38.23 *Alcohol Use Disorder in the Past Year* among Individuals Aged 12 or Older in Oregon,


Figure 38.24 Substance Use Disorder in the Past Year among Individuals Aged 12 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.25 *Serious Mental Illness in the Past Year among Adults Aged 18 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 38.26 *Any Mental Illness in the Past Year* among Adults Aged 18 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.27 Received Mental Health Services in the Past Year among Adults Aged 18 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 38.28 *Had Serious Thoughts of Suicide in the Past Year* among Adults Aged 18 or Older in Oregon, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs
