


Figure 45.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.2 *Marijuana Use in the Past Year* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.3 *Marijuana Use in the Past Month* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.4 *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


**Figure 45.5 *First Use of Marijuana* among Individuals Aged 12 or Older in Utah, by Substate Region:


Figure 45.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.8 *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 45.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.10 *Perceptions of Great Risk from Trying Heroin Once or Twice among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


**Figure 45.11 *Methamphetamine Use in the Past Year* among Individuals Aged 12 or Older in Utah,


Figure 45.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.13 *Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.14 *Binge Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.15 *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 45.16 *Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 45.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


**Figure 45.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Utah,


Figure 45.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.20 *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


**Figure 45.21 *Illicit Drug Use Disorder in the Past Year* among Individuals Aged 12 or Older in Utah,


Figure 45.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.23 *Alcohol Use Disorder in the Past Year* among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.24 Substance Use Disorder in the Past Year among Individuals Aged 12 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.25 *Serious Mental Illness in the Past Year* among Adults Aged 18 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.26 *Any Mental Illness in the Past Year among Adults Aged 18 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 45.27 Received Mental Health Services in the Past Year among Adults Aged 18 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 45.28 *Had Serious Thoughts of Suicide in the Past Year* among Adults Aged 18 or Older in Utah, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs
