


Figure 49.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.2 *Marijuana Use in the Past Year* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.3 *Marijuana Use in the Past Month* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.4 *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 49.5 *First Use of Marijuana* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Average Annual Initiation Estimates (Expressed as Percentages of the At-Risk Population) Based on 2016, 2017, and 2018 NSDUHs


Figure 49.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.8 *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 49.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.10 *Perceptions of Great Risk from Trying Heroin Once or Twice among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 49.11 *Methamphetamine Use in the Past Year* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


**Figure 49.13 *Alcohol Use in the Past Month* among Individuals Aged 12 or Older in West Virginia,


Figure 49.14 *Binge Alcohol Use in the Past Month* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.15 *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 49.16 *Alcohol Use in the Past Month among Individuals Aged 12 to 20 in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 49.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.20 *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*


Figure 49.21 *Illicit Drug Use Disorder in the Past Year* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.23 *Alcohol Use Disorder in the Past Year* among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.24 Substance Use Disorder in the Past Year among Individuals Aged 12 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.25 *Serious Mental Illness in the Past Year* among Adults Aged 18 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.26 *Any Mental Illness in the Past Year* among Adults Aged 18 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.27 *Received Mental Health Services in the Past Year* among Adults Aged 18 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs


Figure 49.28 *Had Serious Thoughts of Suicide in the Past Year among Adults Aged 18 or Older in West Virginia, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*
