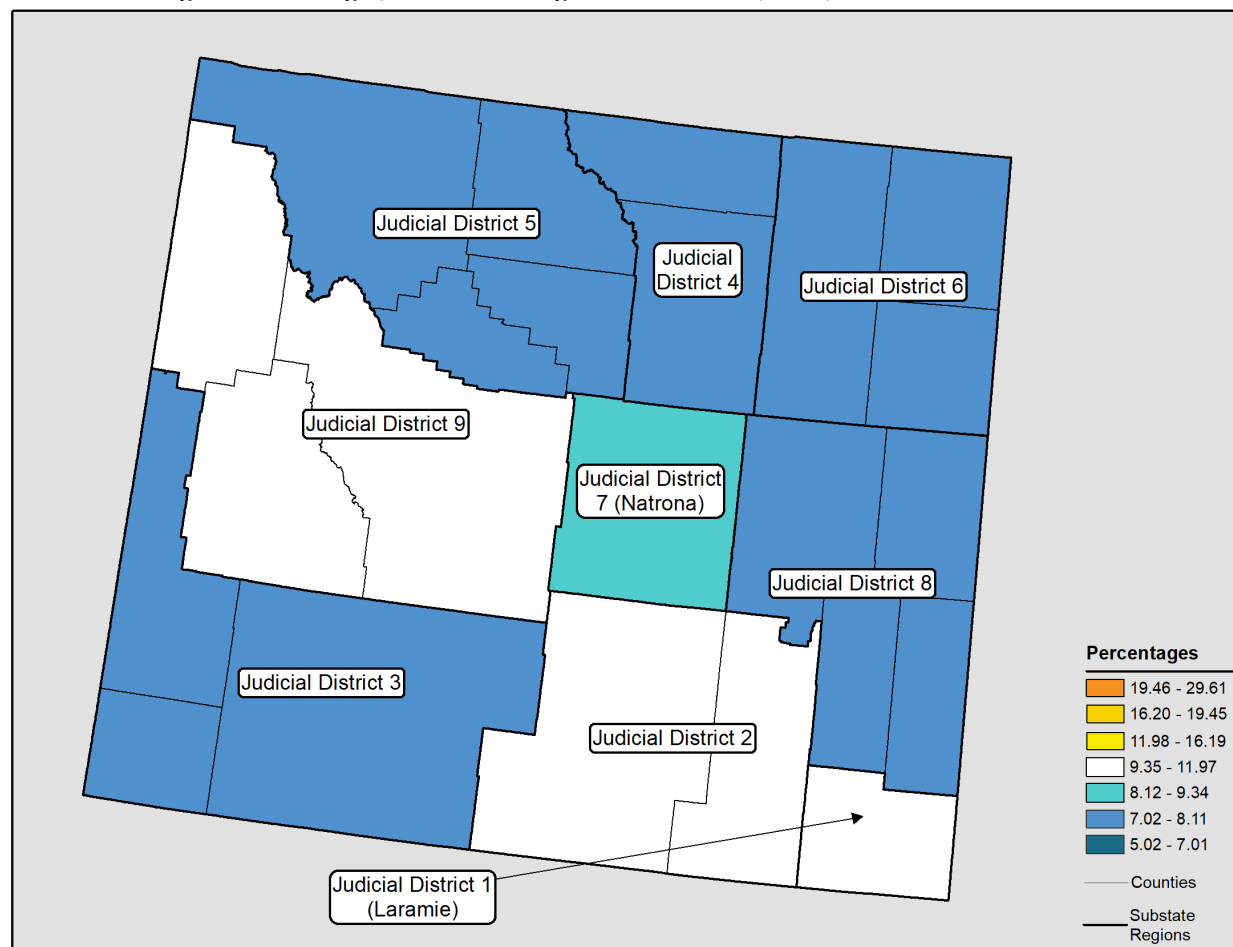

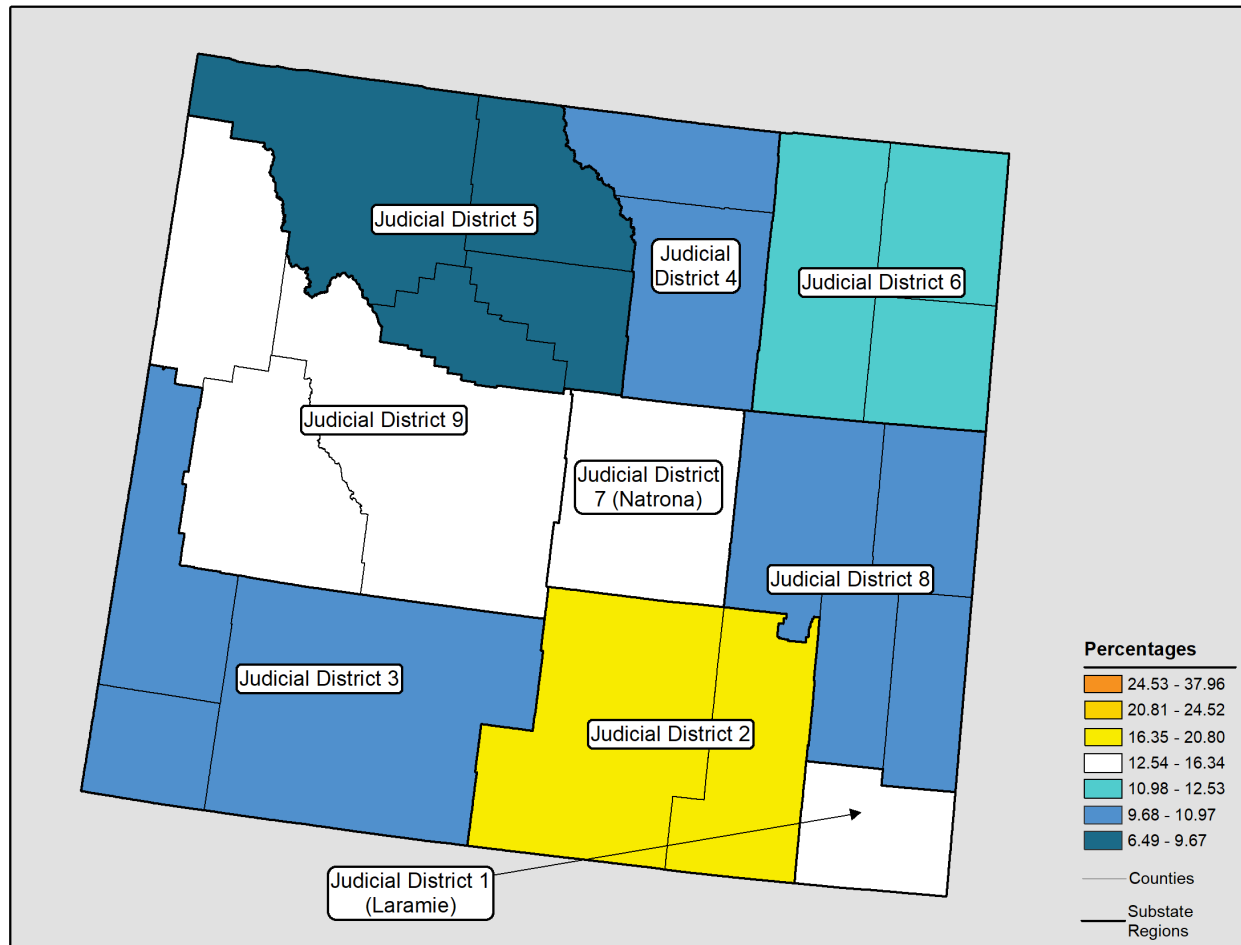
**Figure 51.1 *Illicit Drug Use in the Past Month* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

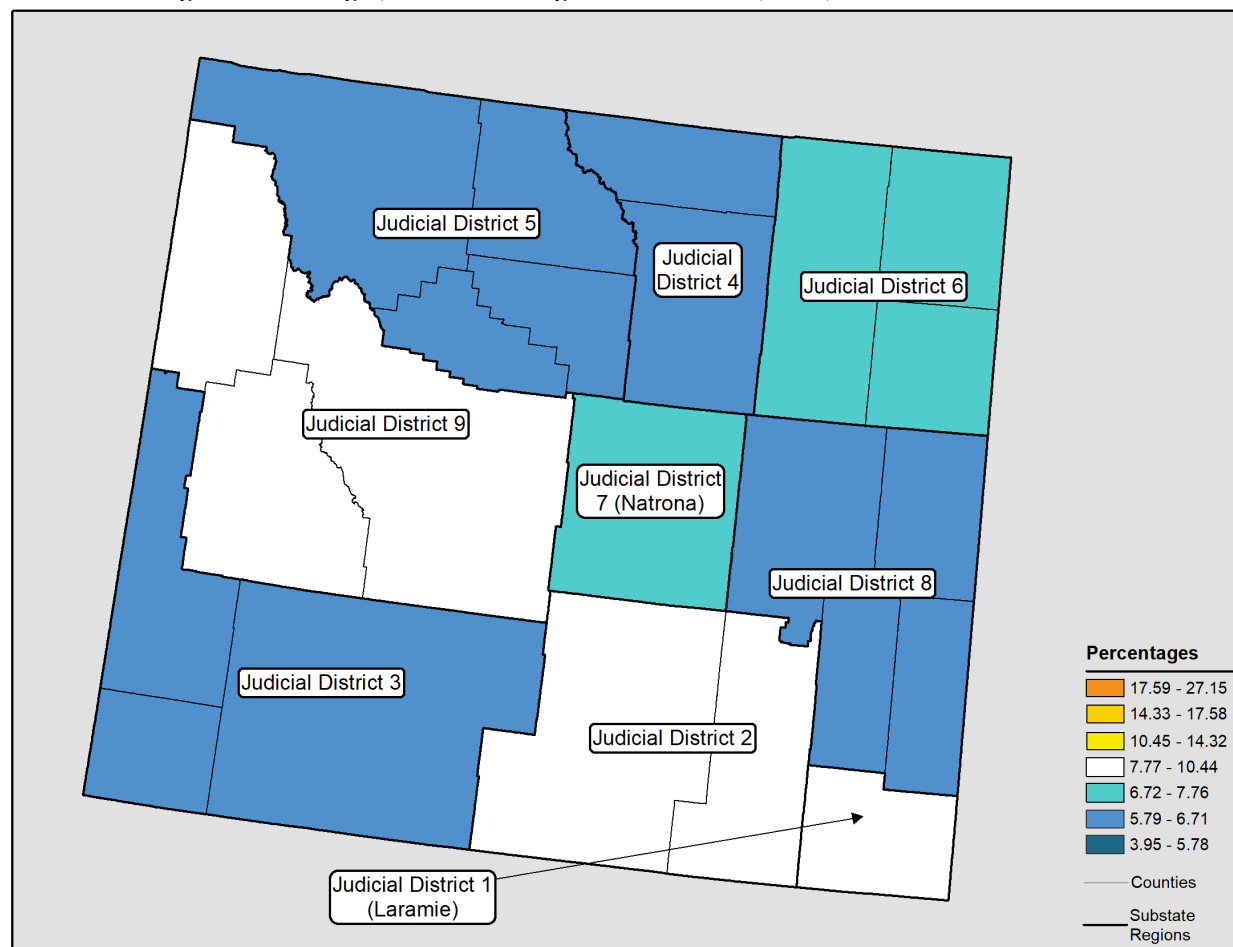
**Figure 51.2 *Marijuana Use in the Past Year* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

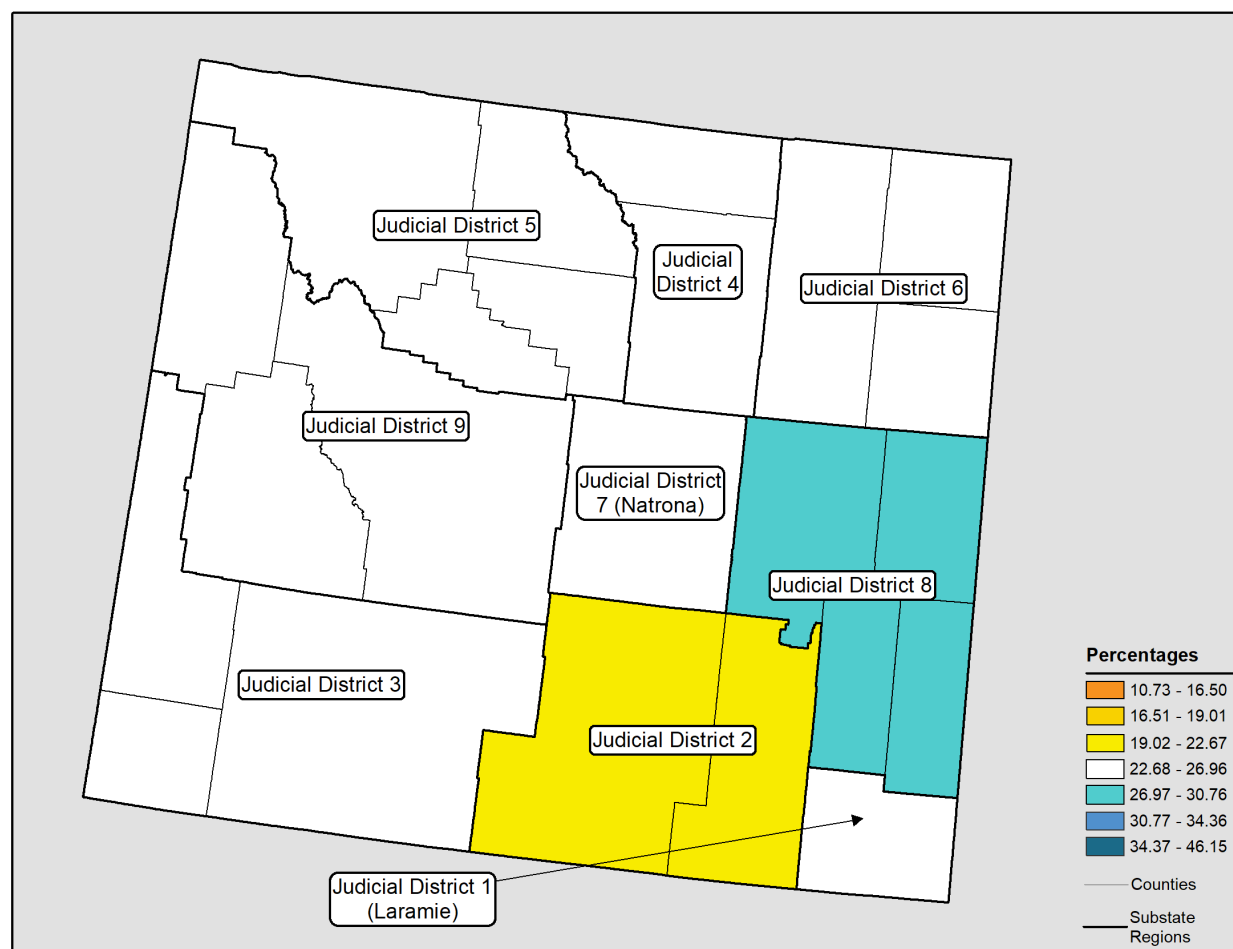
**Figure 51.3 Marijuana Use in the Past Month among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

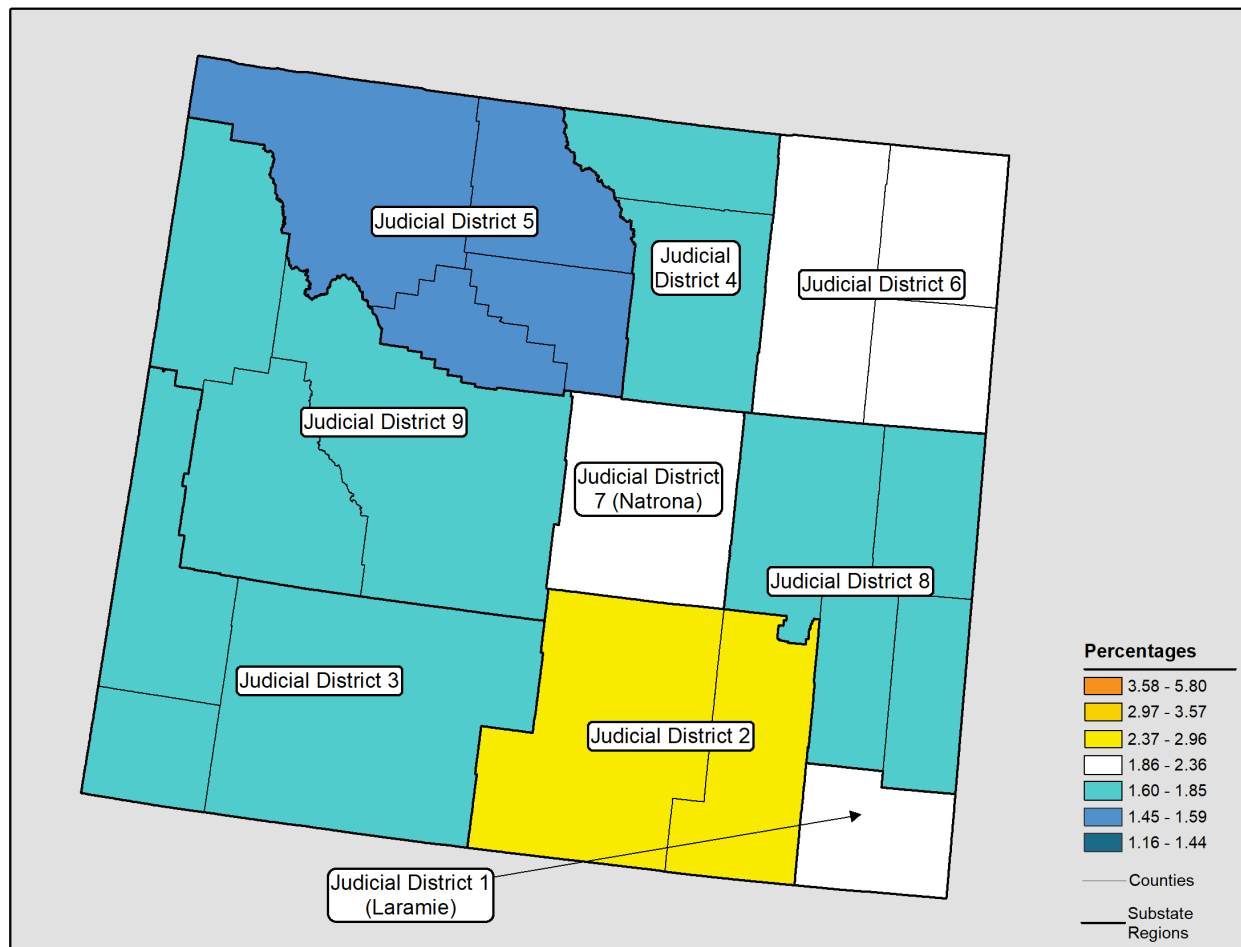
**Figure 51.4** *Perceptions of Great Risk from Smoking Marijuana Once a Month among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

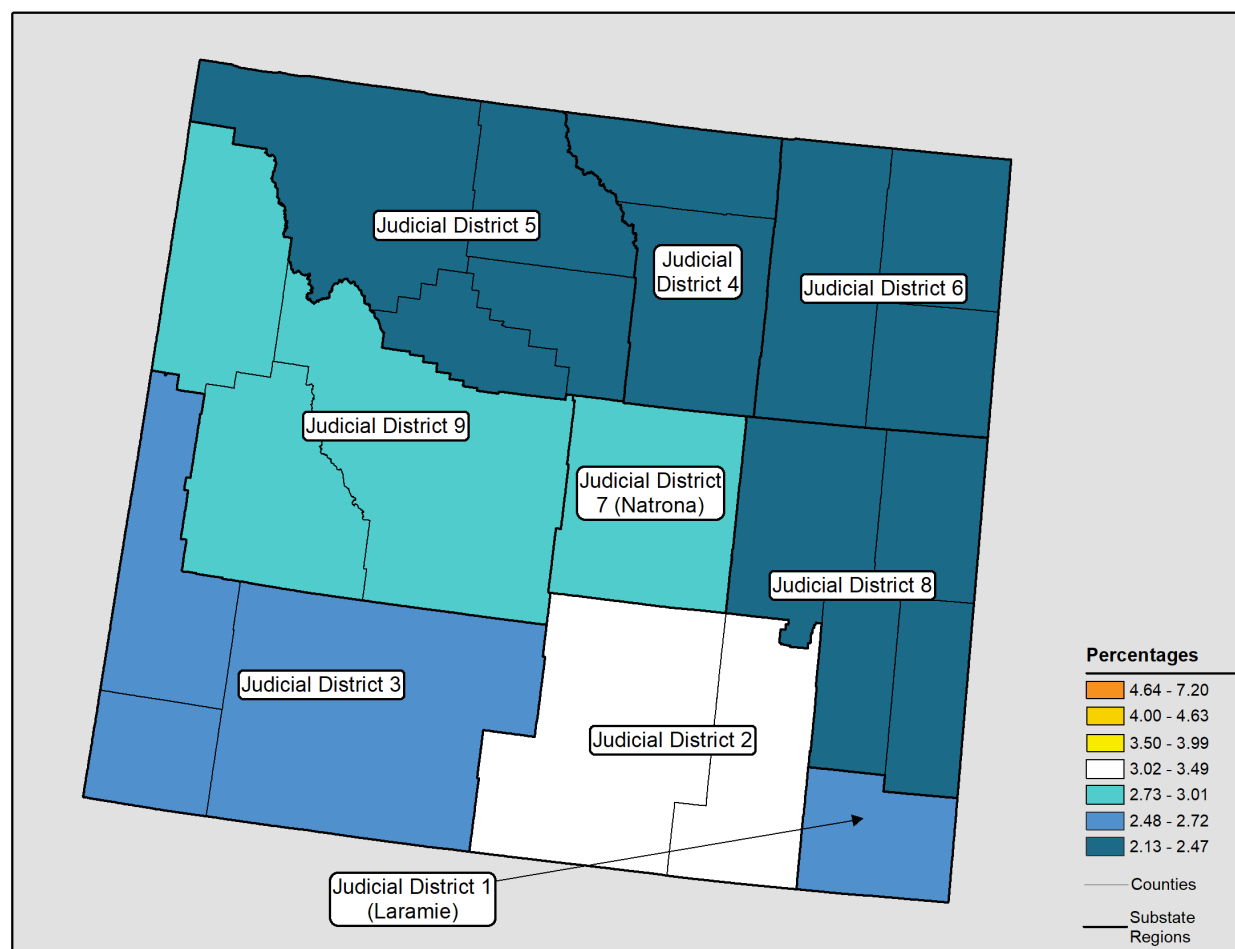

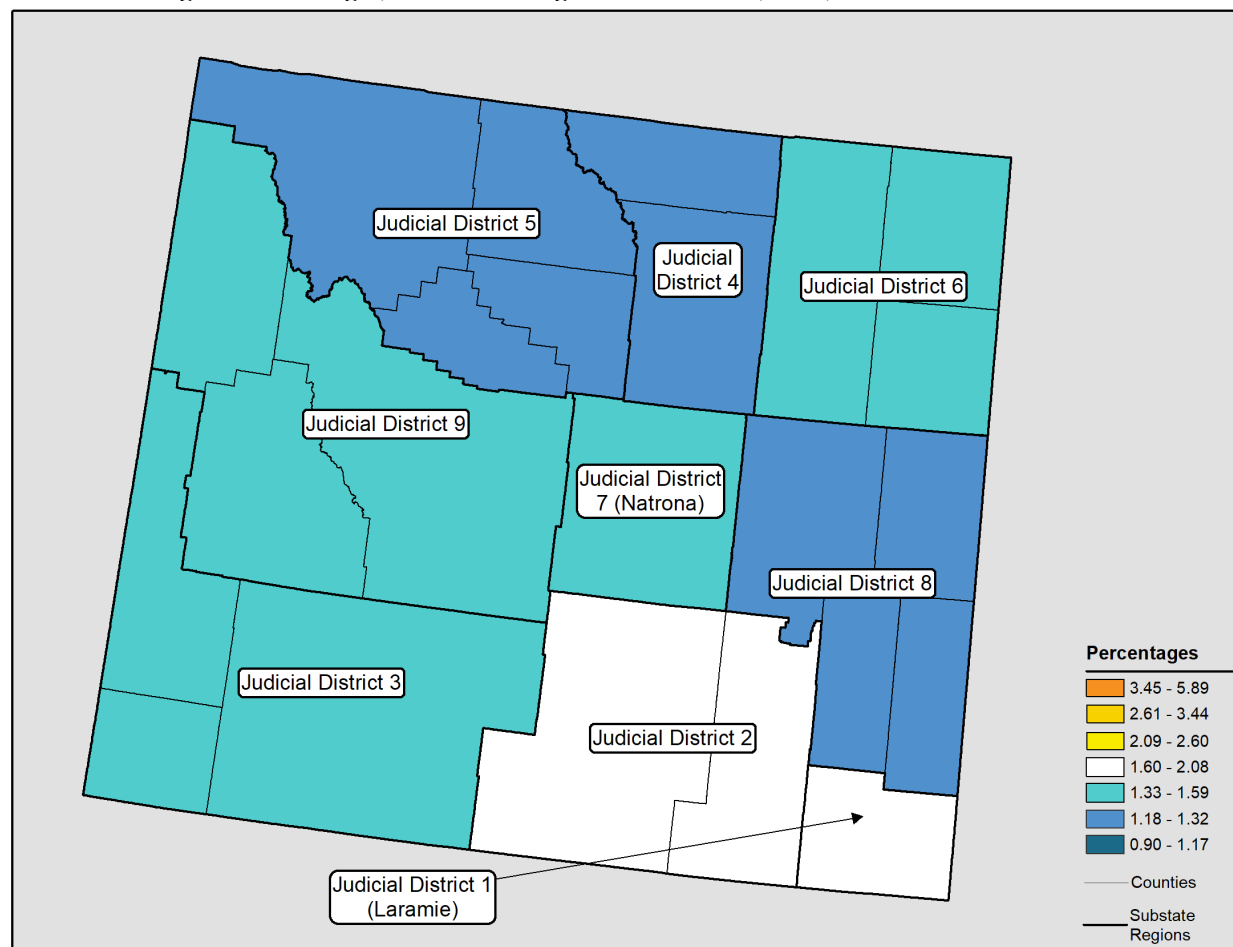
**Figure 51.6 *Illicit Drug Use Other Than Marijuana in the Past Month* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

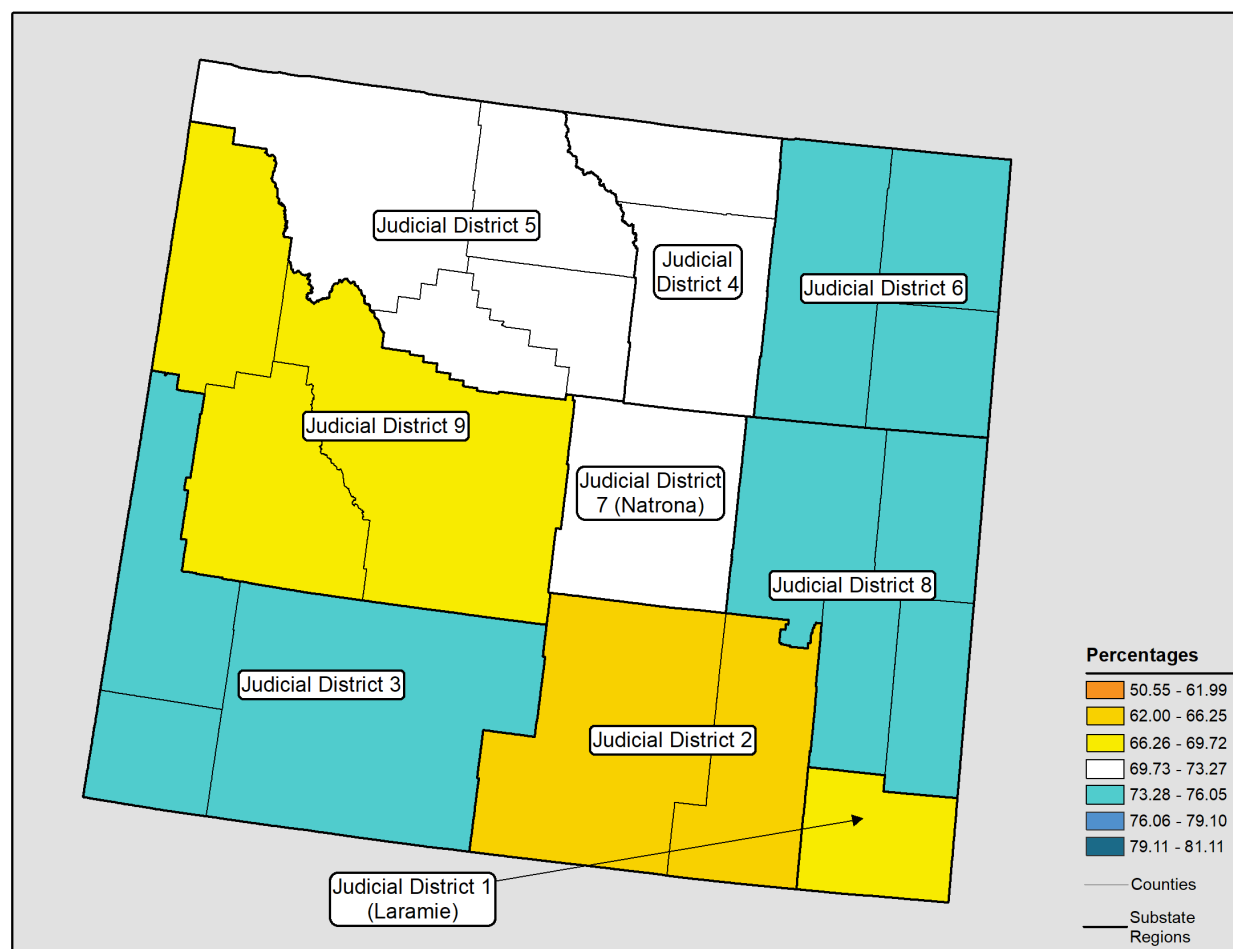
**Figure 51.7 Cocaine Use in the Past Year among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

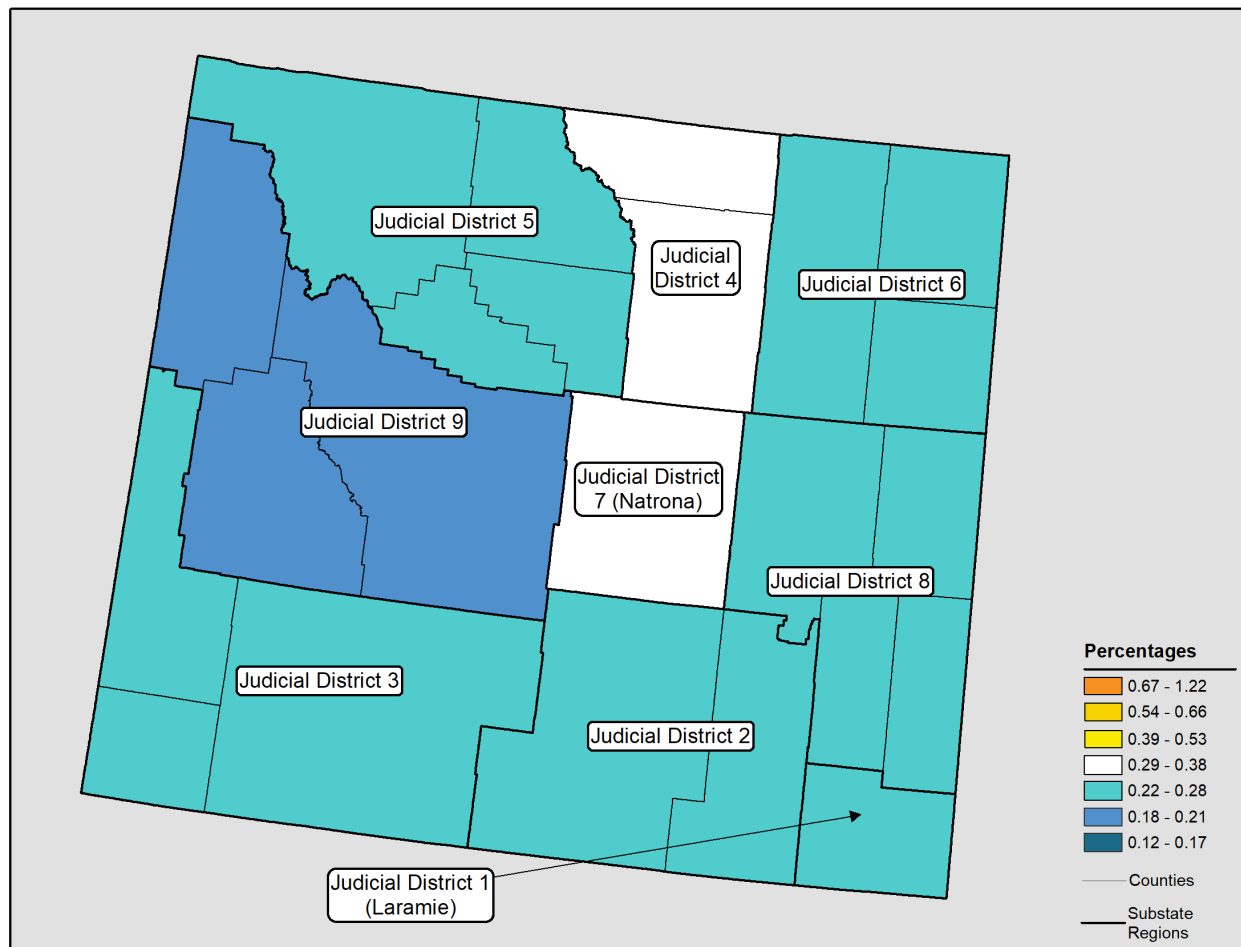
**Figure 51.8** *Perceptions of Great Risk from Using Cocaine Once a Month among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

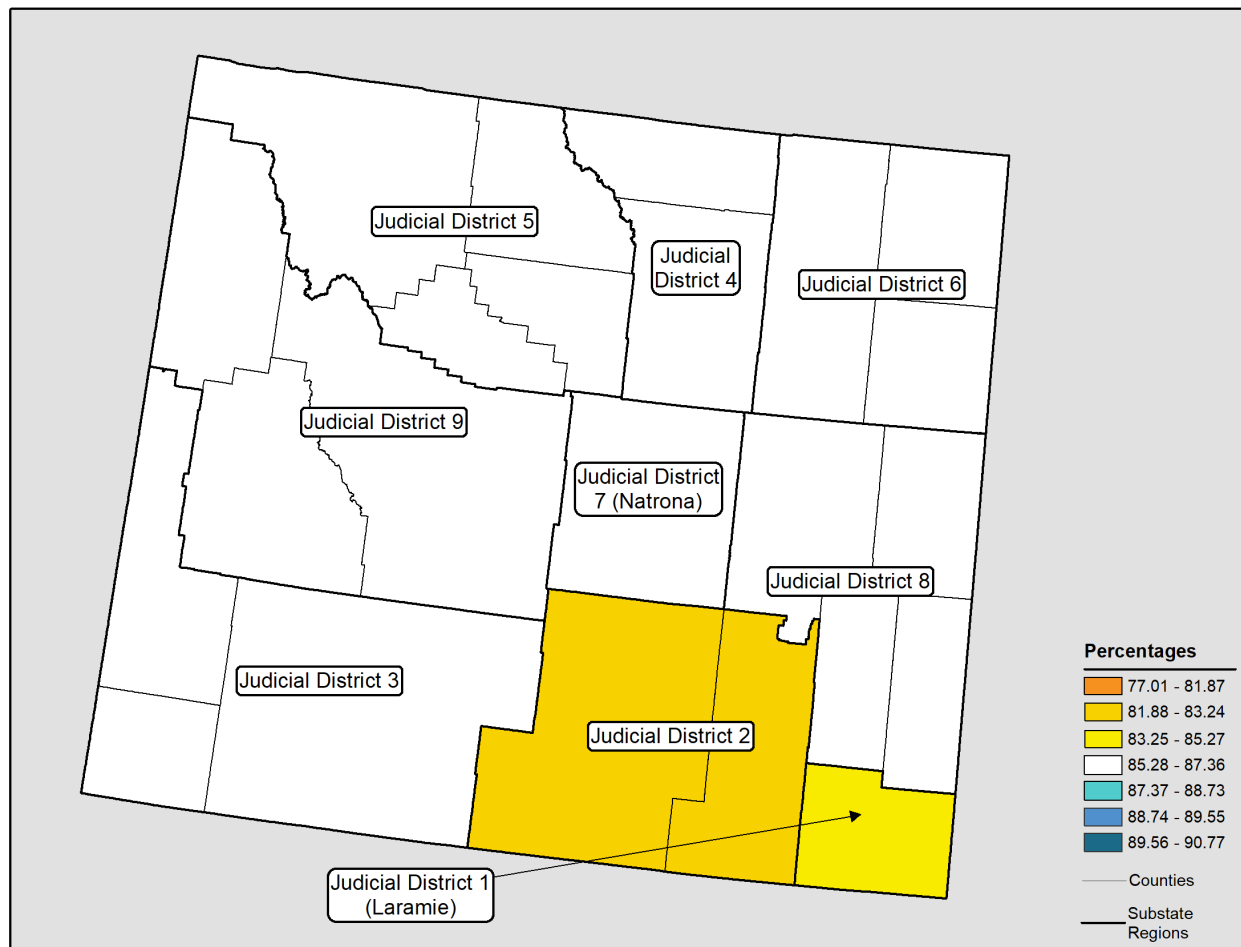
**Figure 51.9 Heroin Use in the Past Year among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

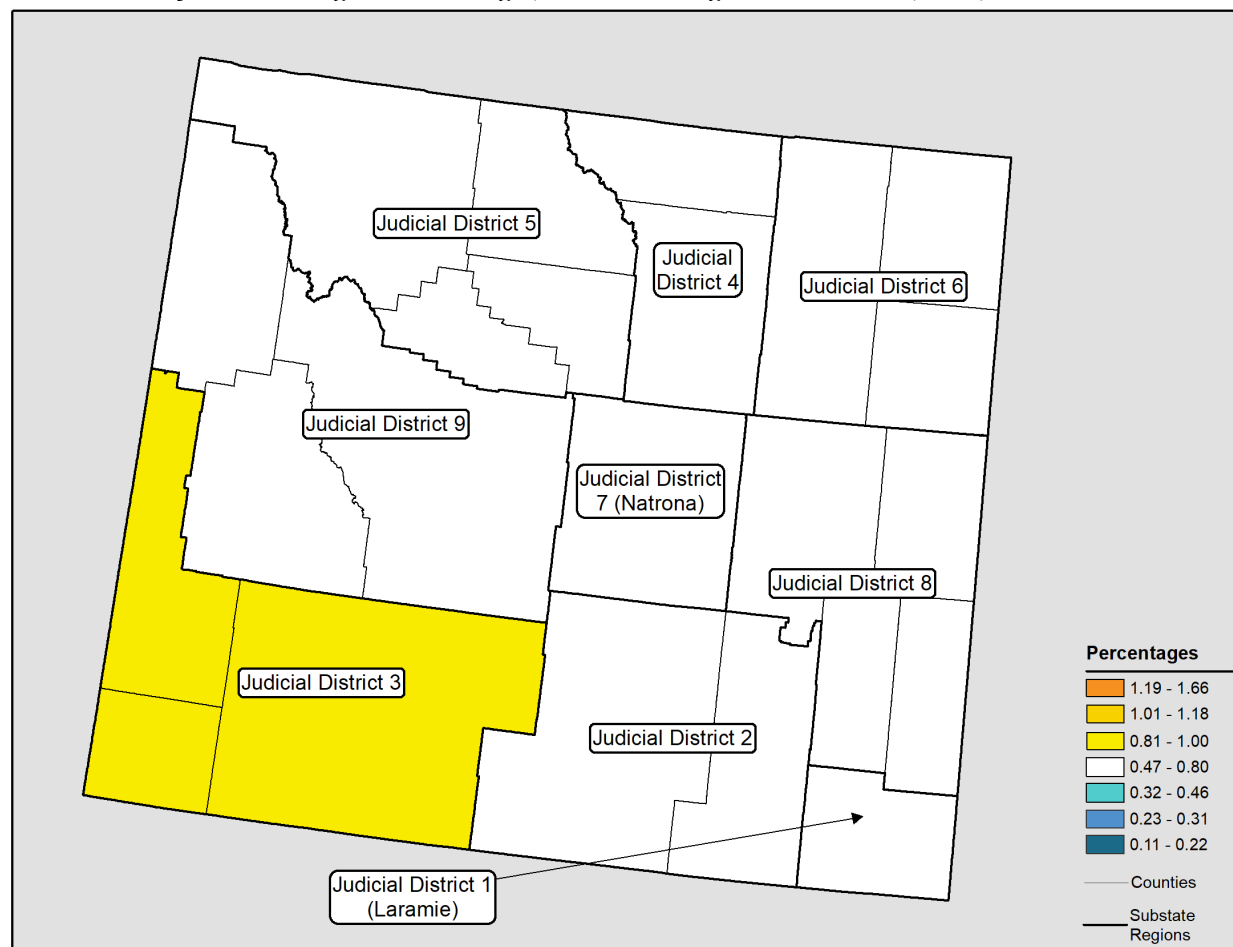
**Figure 51.10** *Perceptions of Great Risk from Trying Heroin Once or Twice among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

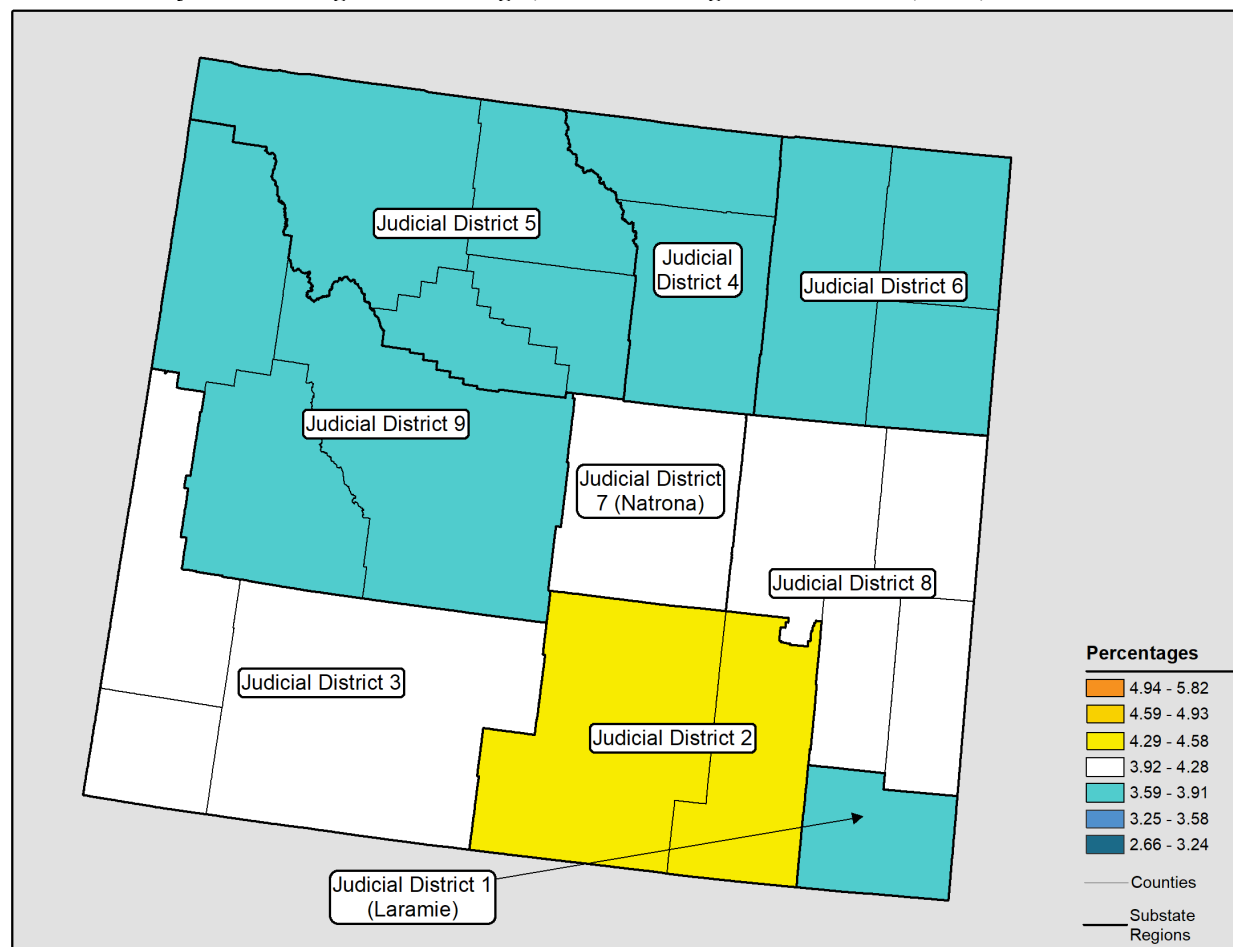
**Figure 51.11 *Methamphetamine Use in the Past Year* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

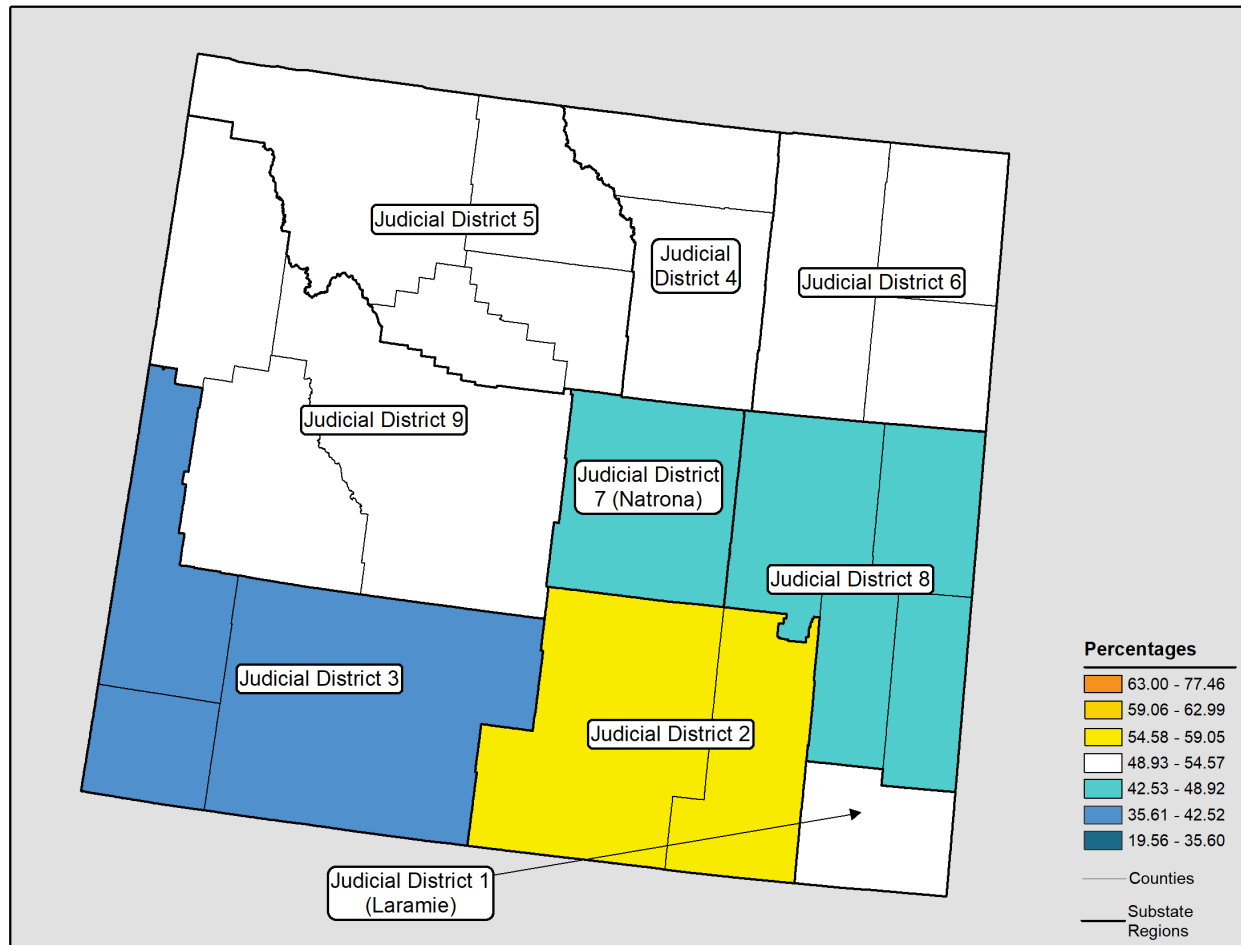
**Figure 51.12 *Pain Reliever Misuse in the Past Year* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

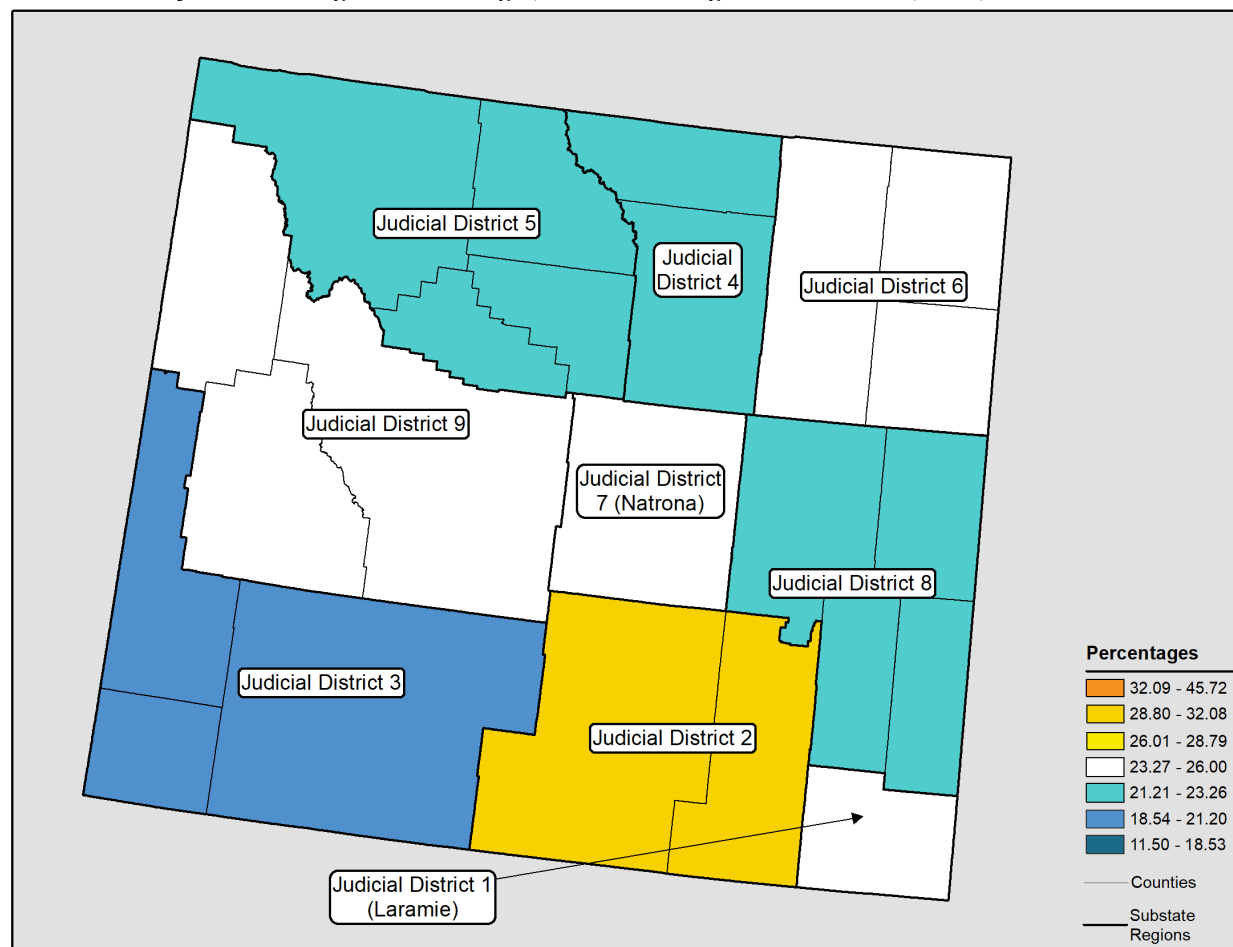

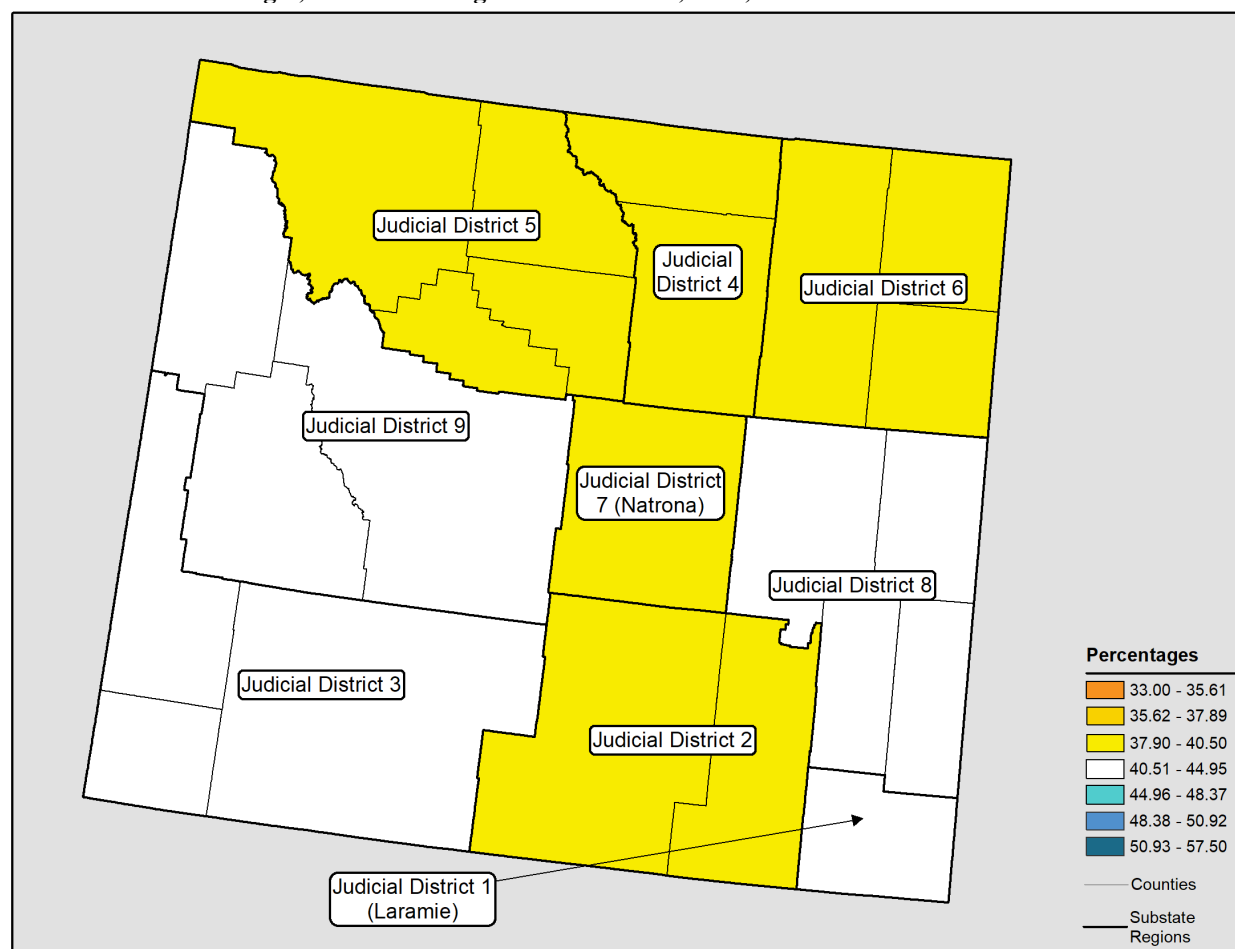
**Figure 51.14 *Binge Alcohol Use in the Past Month* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

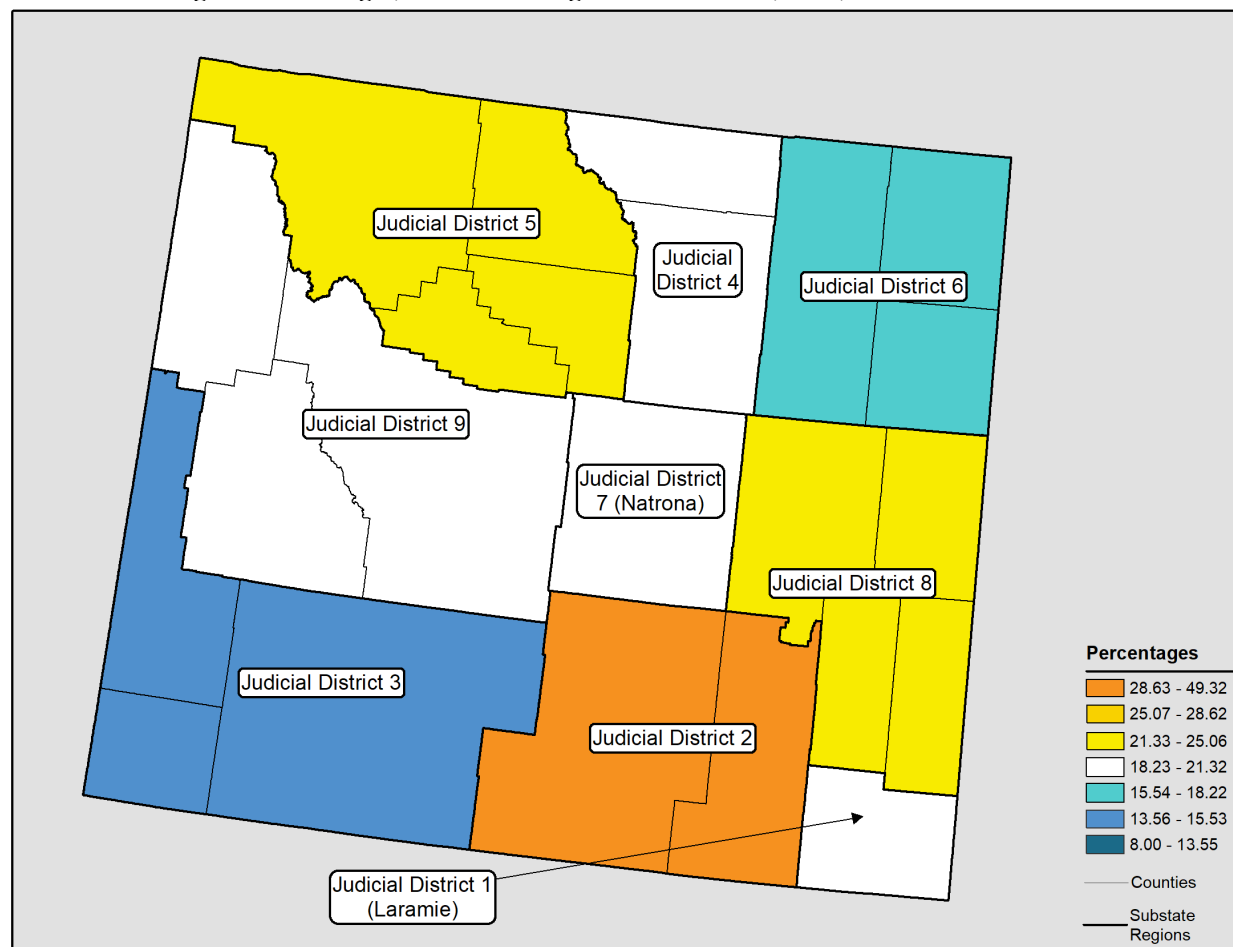
**Figure 51.15** *Perceptions of Great Risk from Having Five or More Drinks of an Alcoholic Beverage Once or Twice a Week among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

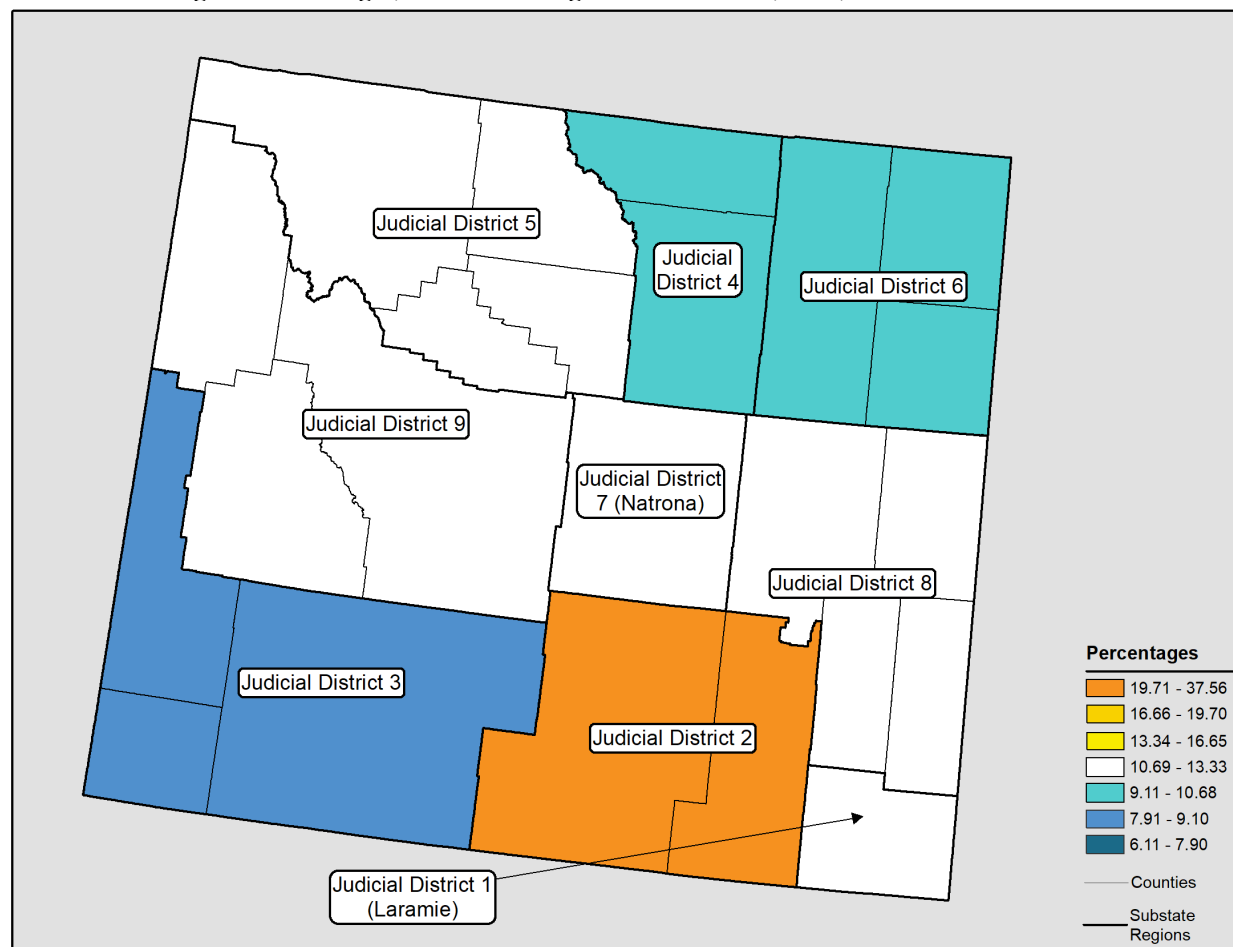
**Figure 51.16 Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

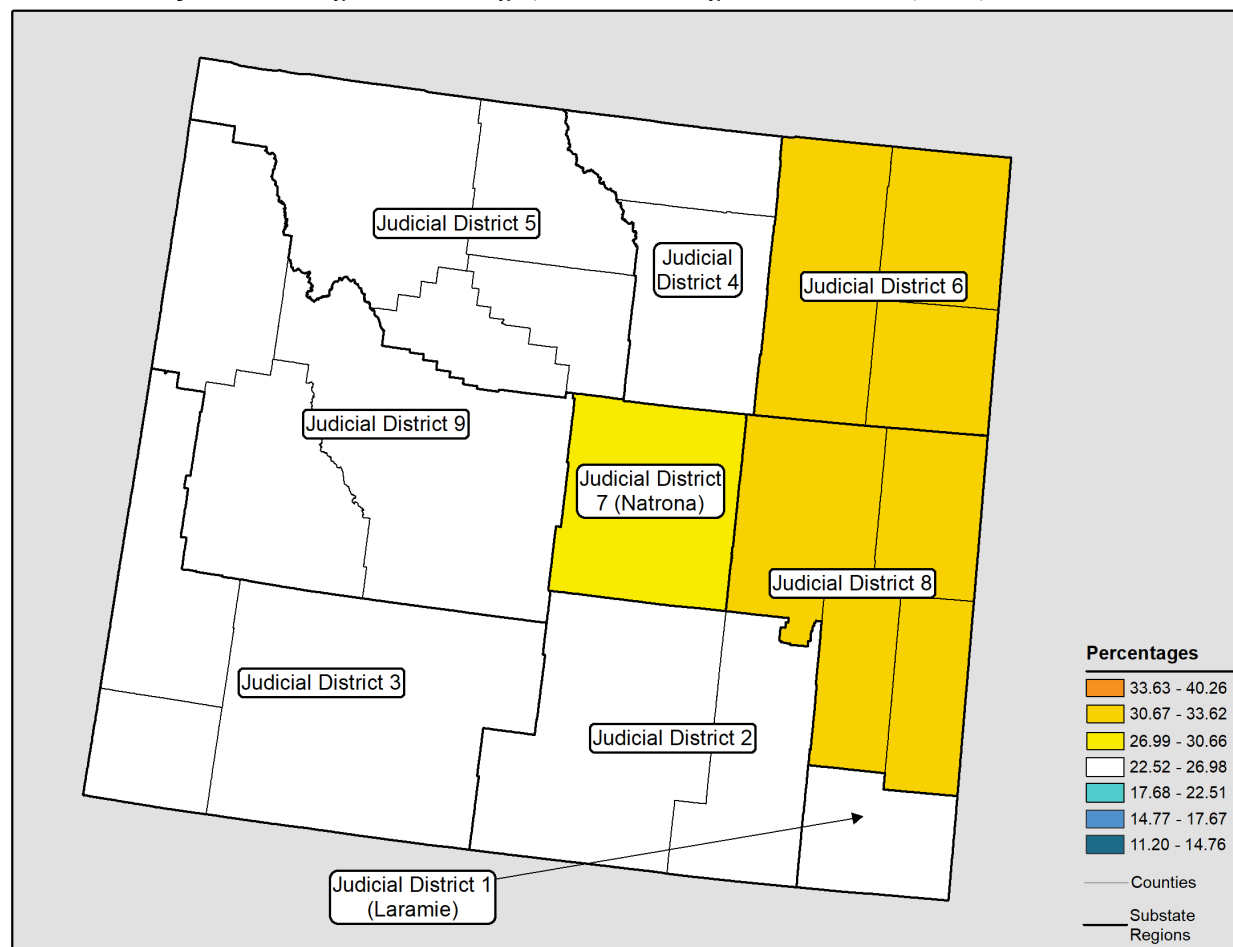
**Figure 51.17 Binge Alcohol Use in the Past Month among Individuals Aged 12 to 20 in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

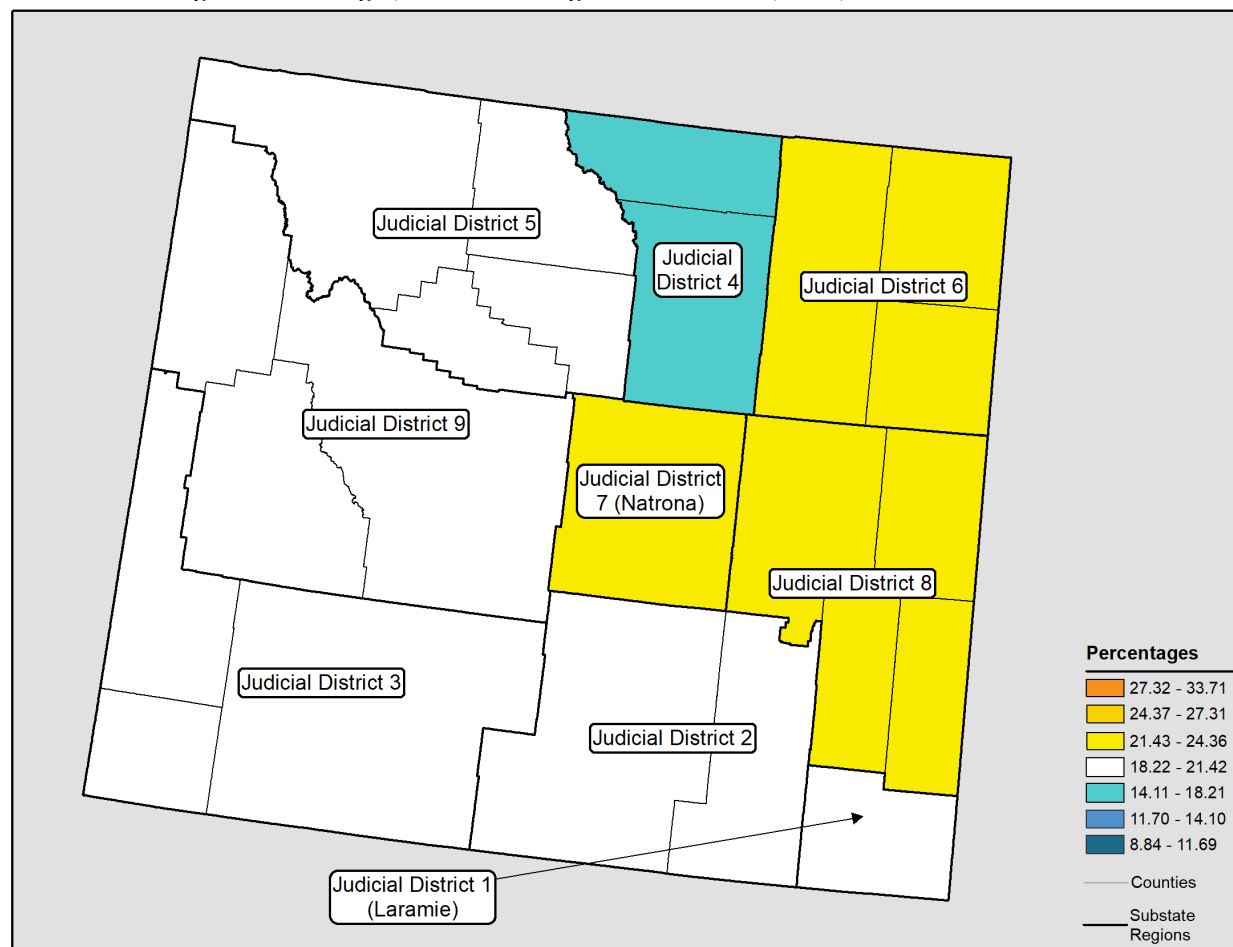
**Figure 51.18 Tobacco Product Use in the Past Month among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

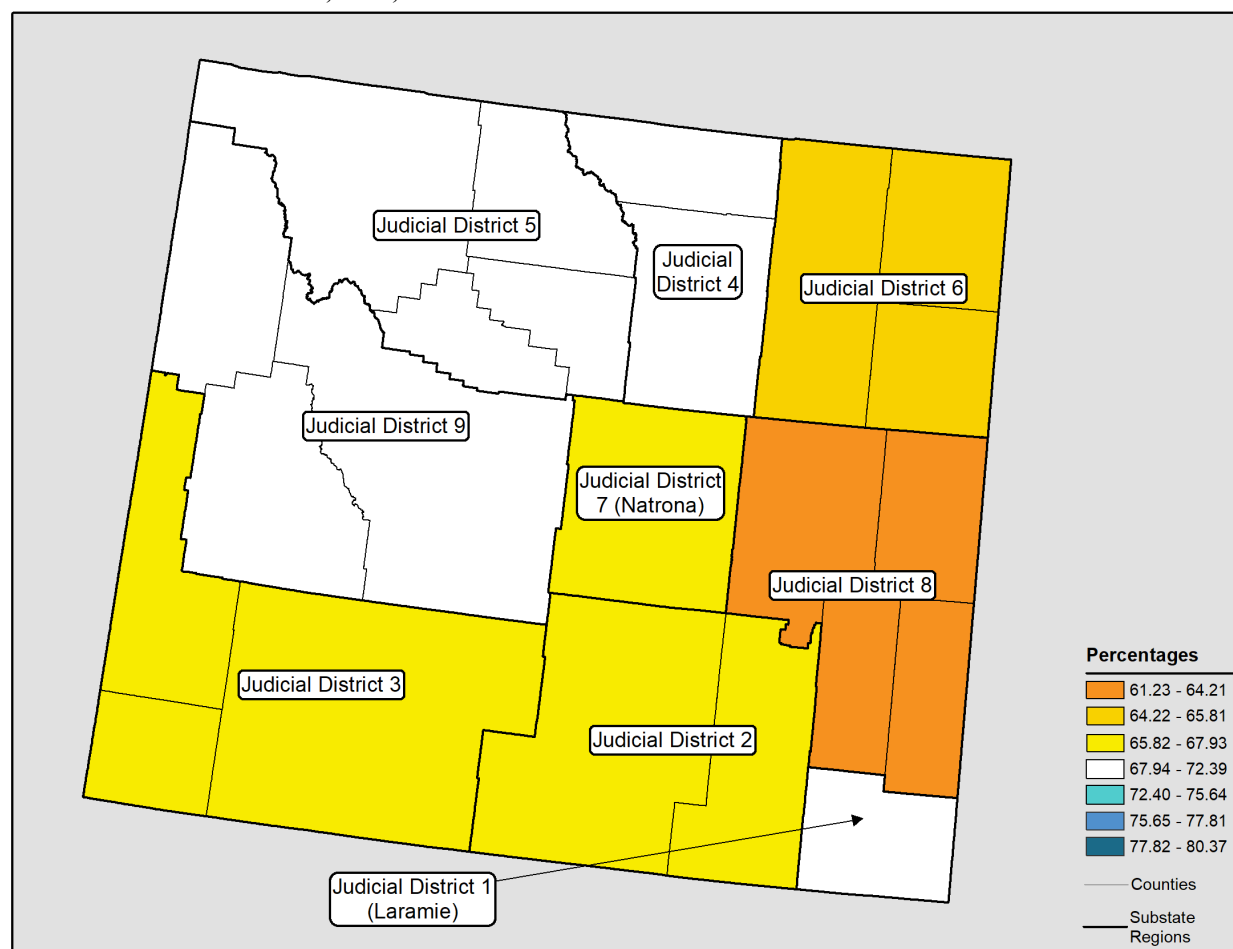
**Figure 51.19 Cigarette Use in the Past Month among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

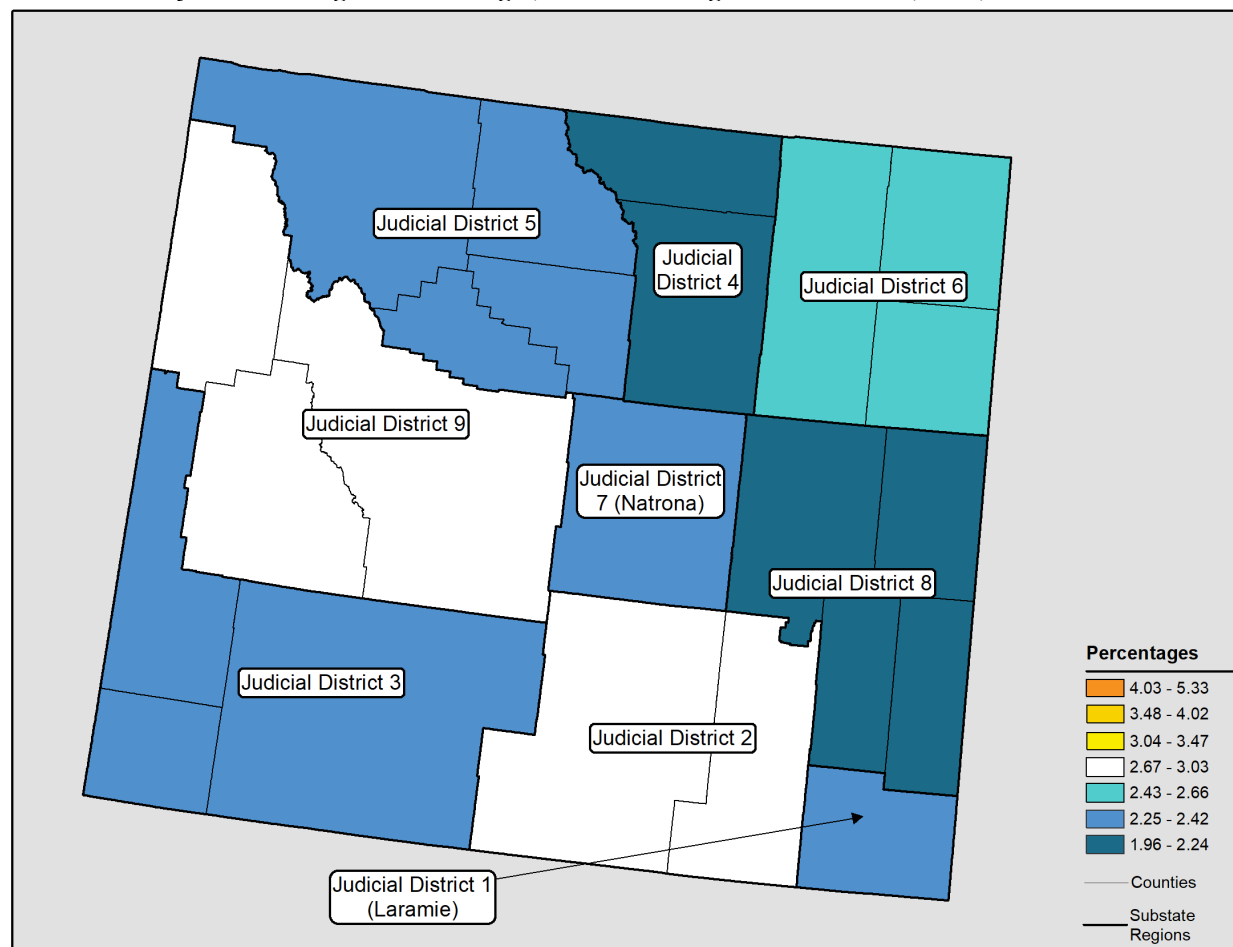
**Figure 51.20** *Perceptions of Great Risk from Smoking One or More Packs of Cigarettes per Day among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

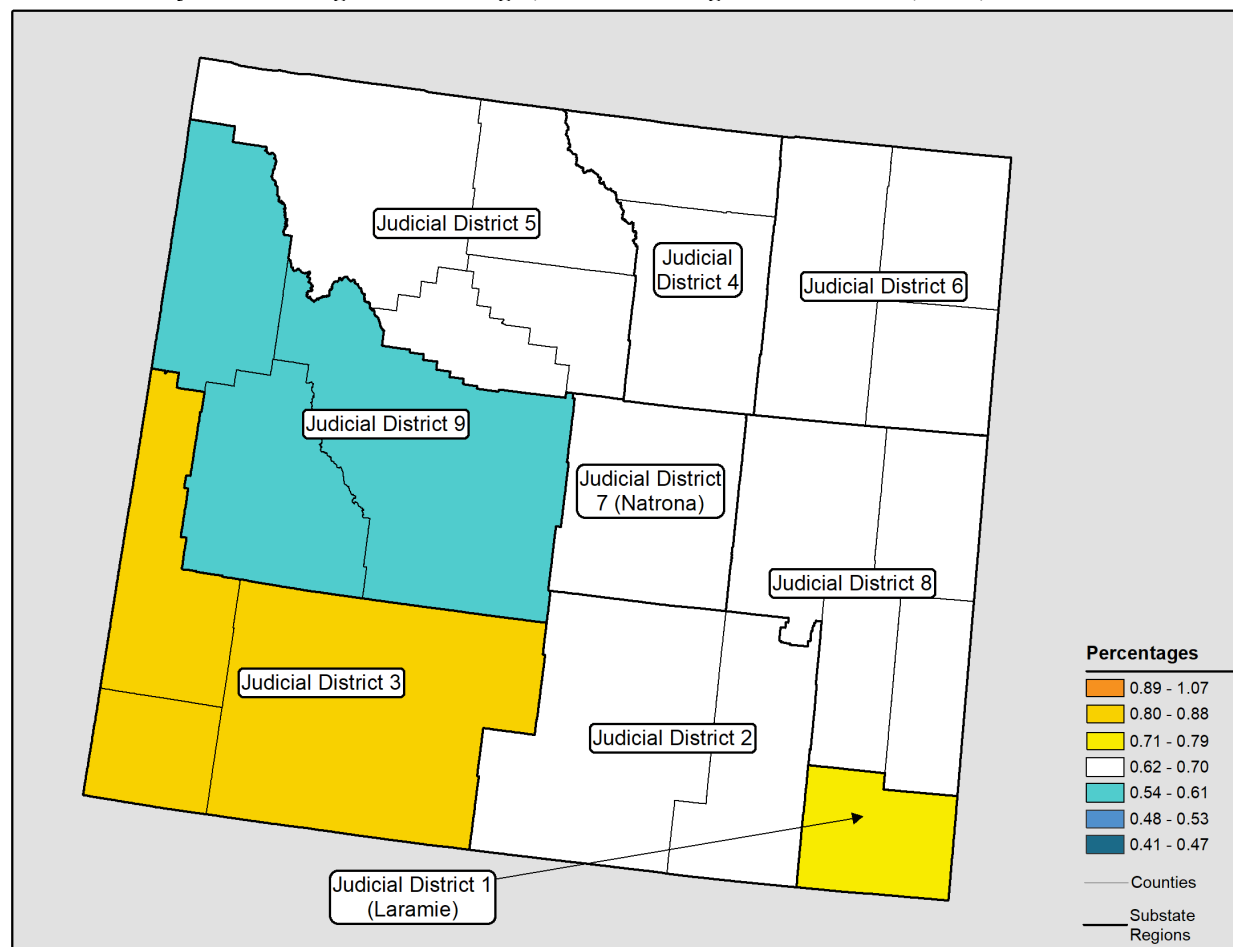

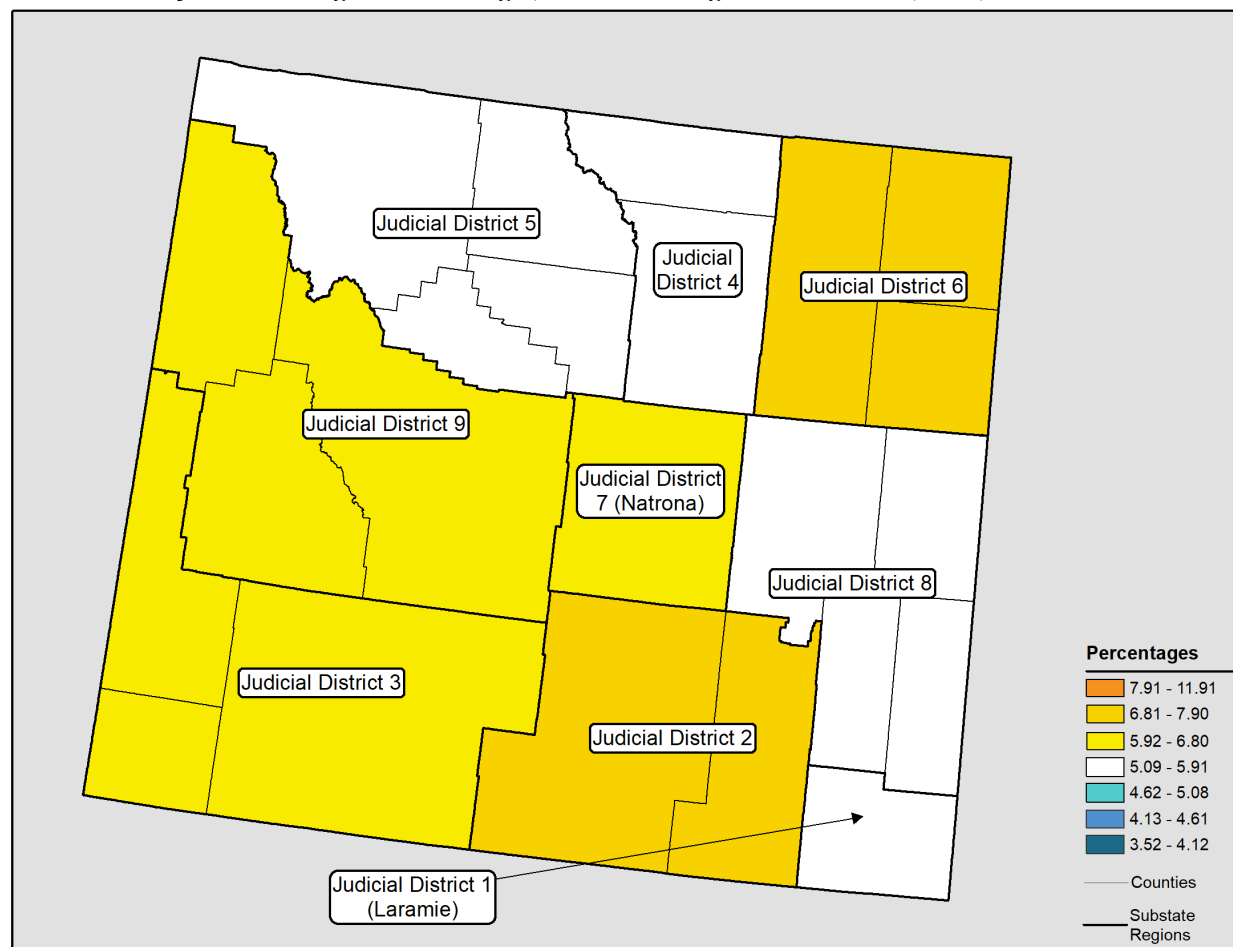
**Figure 51.22 *Pain Reliever Use Disorder in the Past Year* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

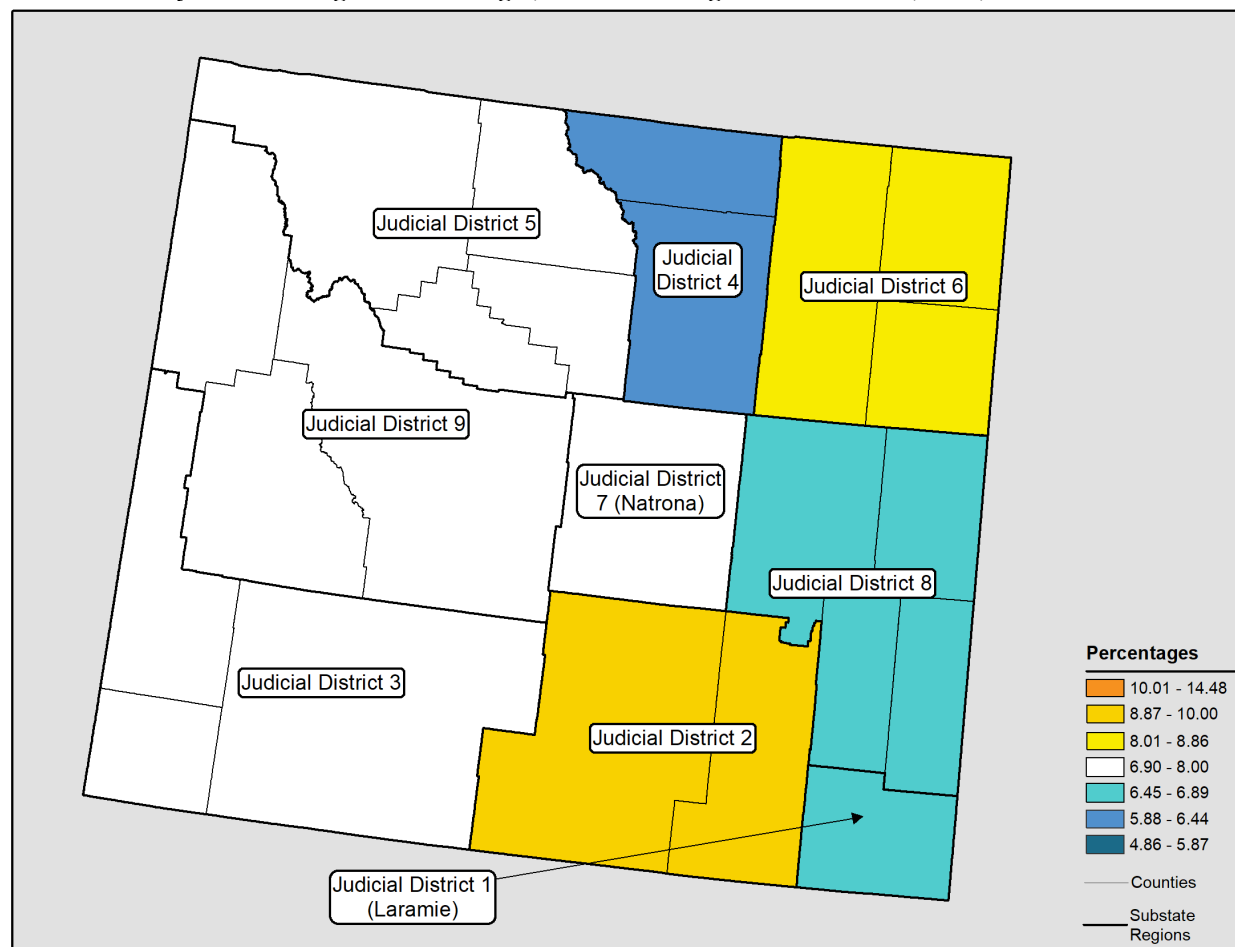
**Figure 51.23 *Alcohol Use Disorder in the Past Year* among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

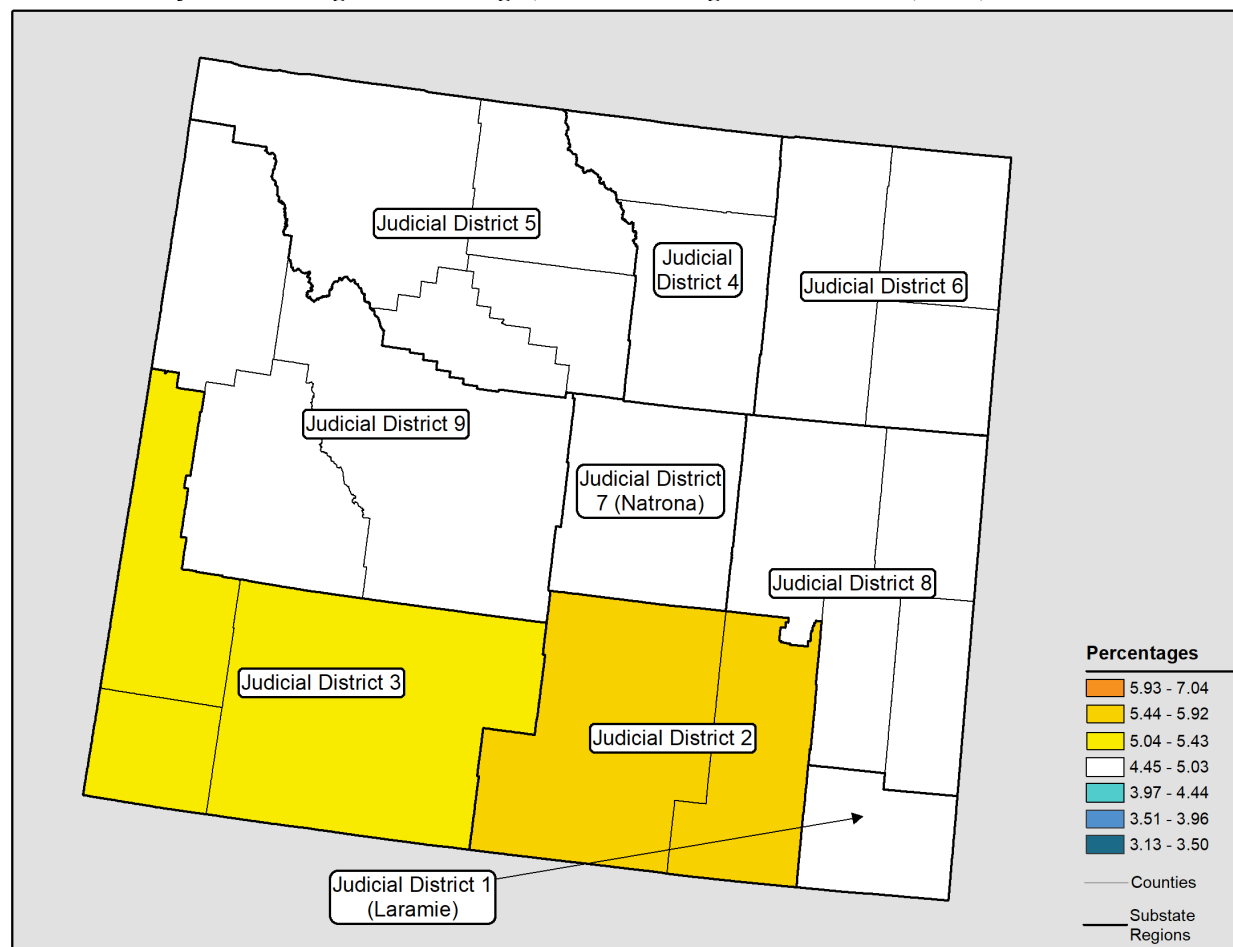
**Figure 51.24 Substance Use Disorder in the Past Year among Individuals Aged 12 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

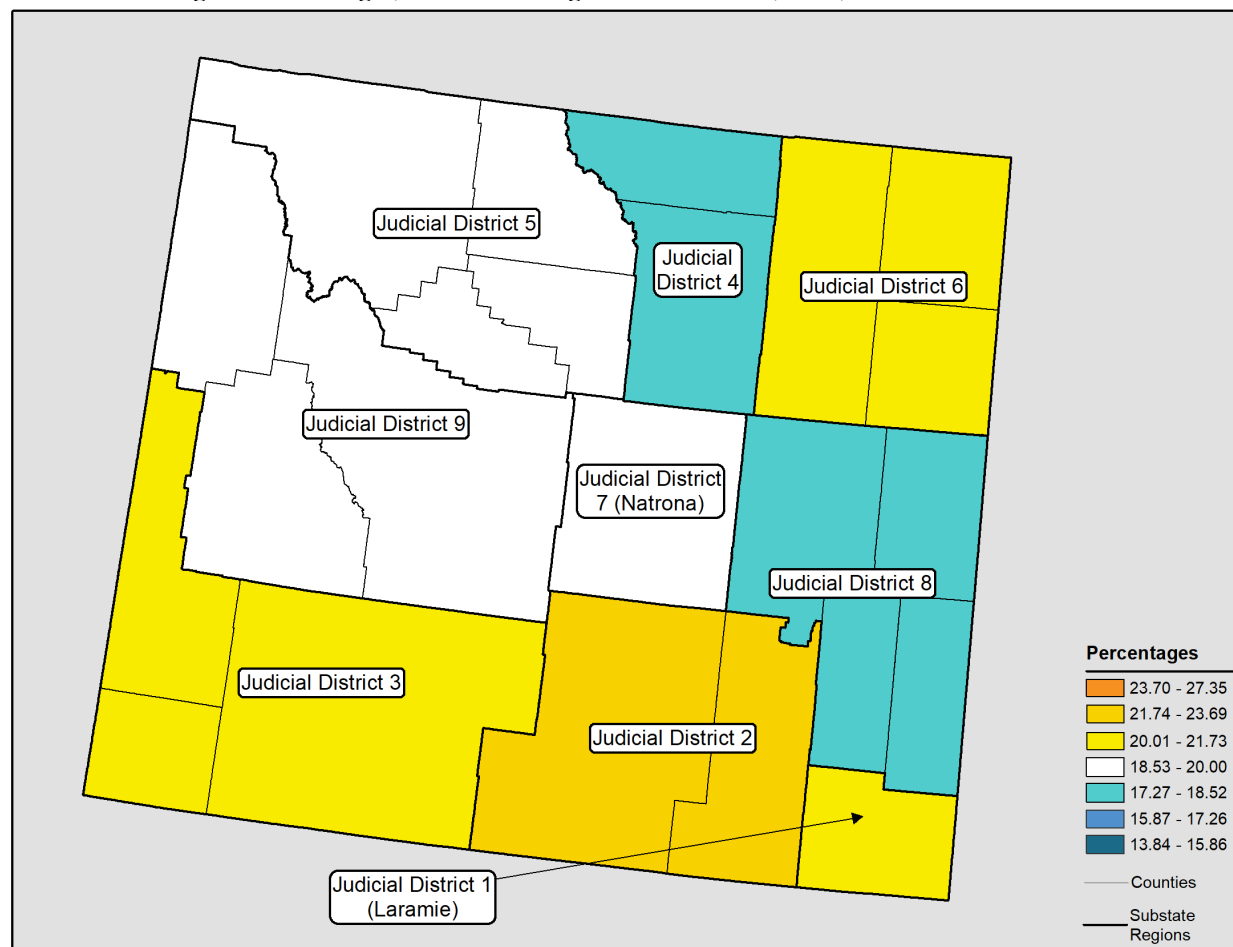
**Figure 51.25 *Serious Mental Illness in the Past Year among Adults Aged 18 or Older in Wyoming,***

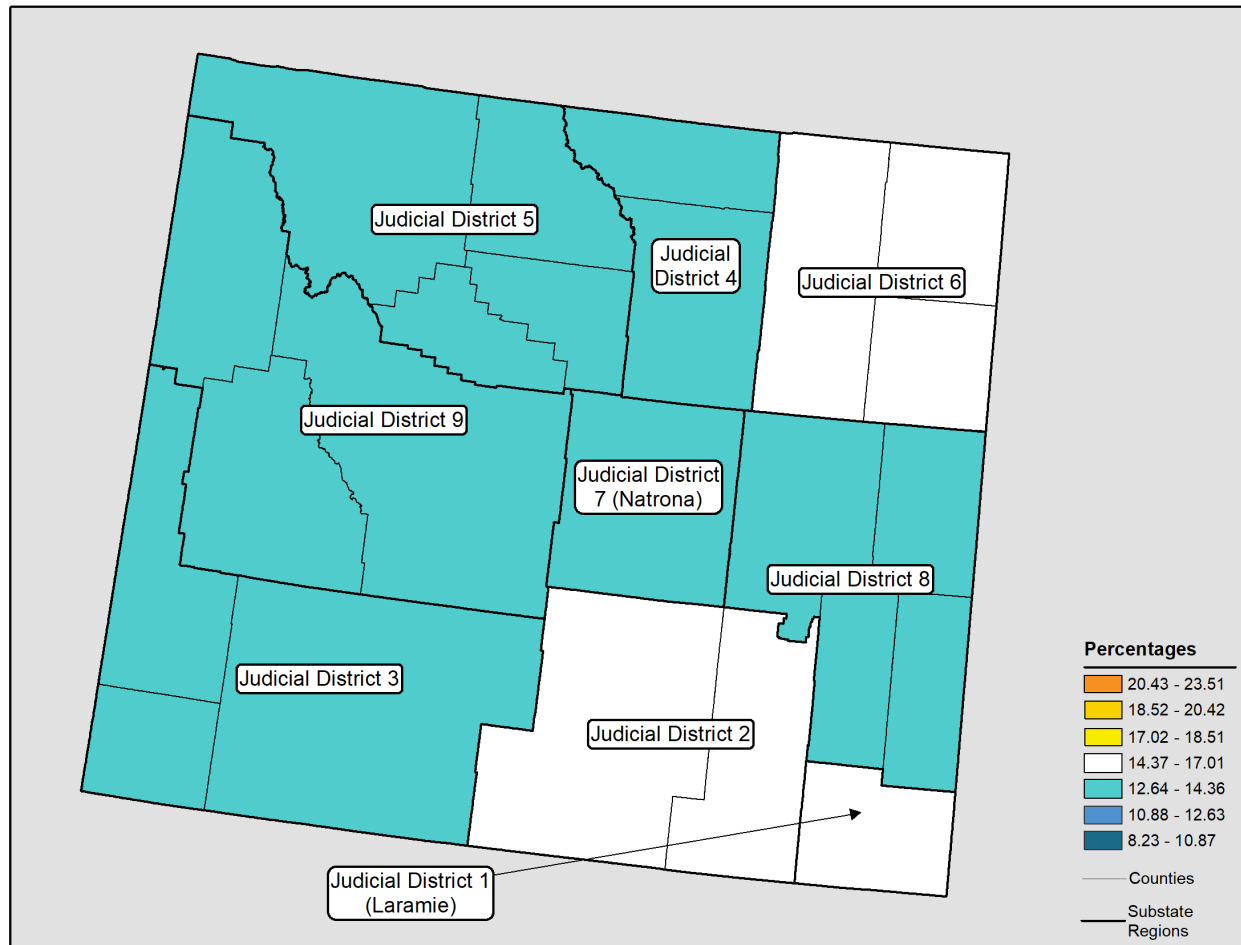
**Figure 51.26** *Any Mental Illness in the Past Year among Adults Aged 18 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs*

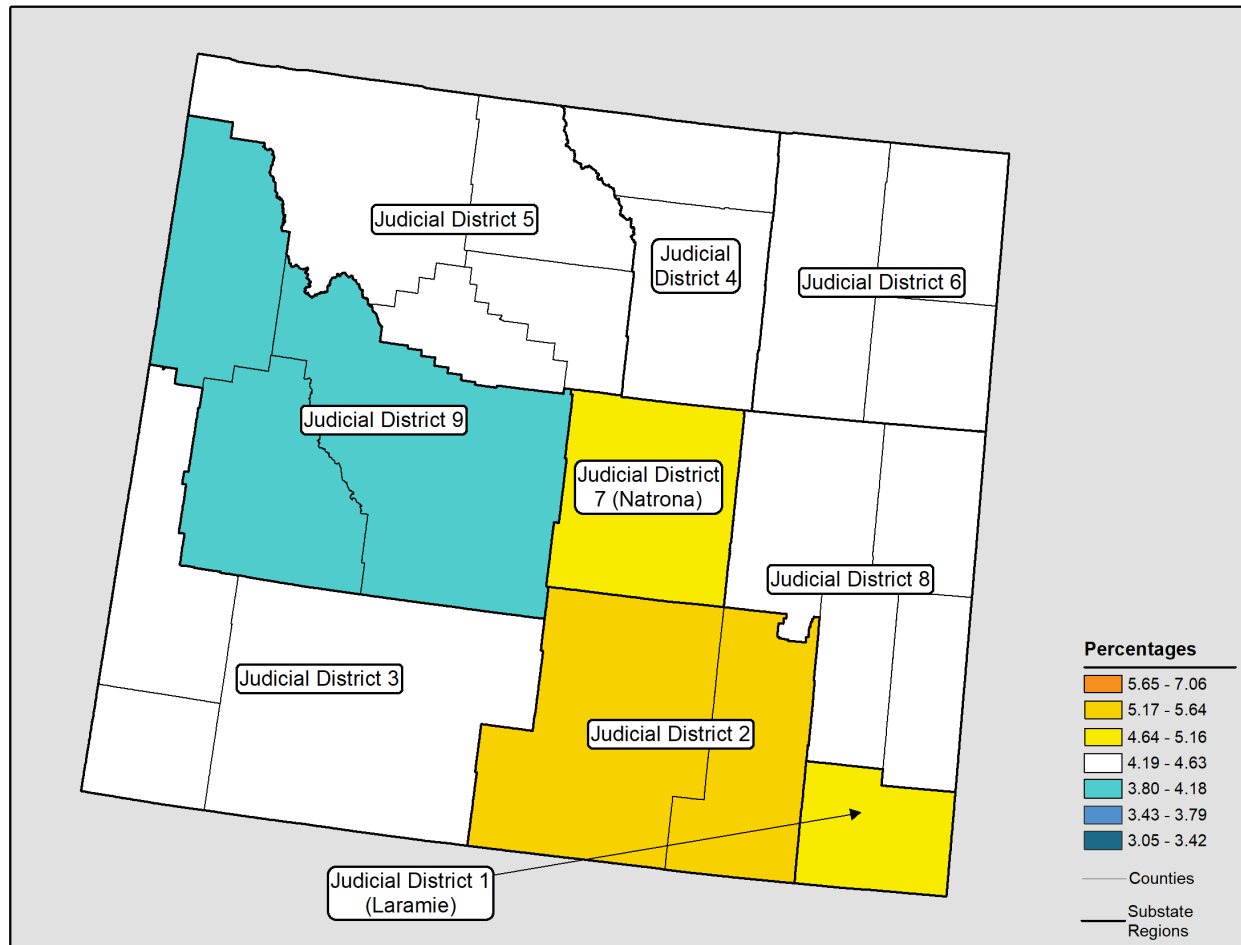
**Figure 51.27 Received Mental Health Services in the Past Year among Adults Aged 18 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**

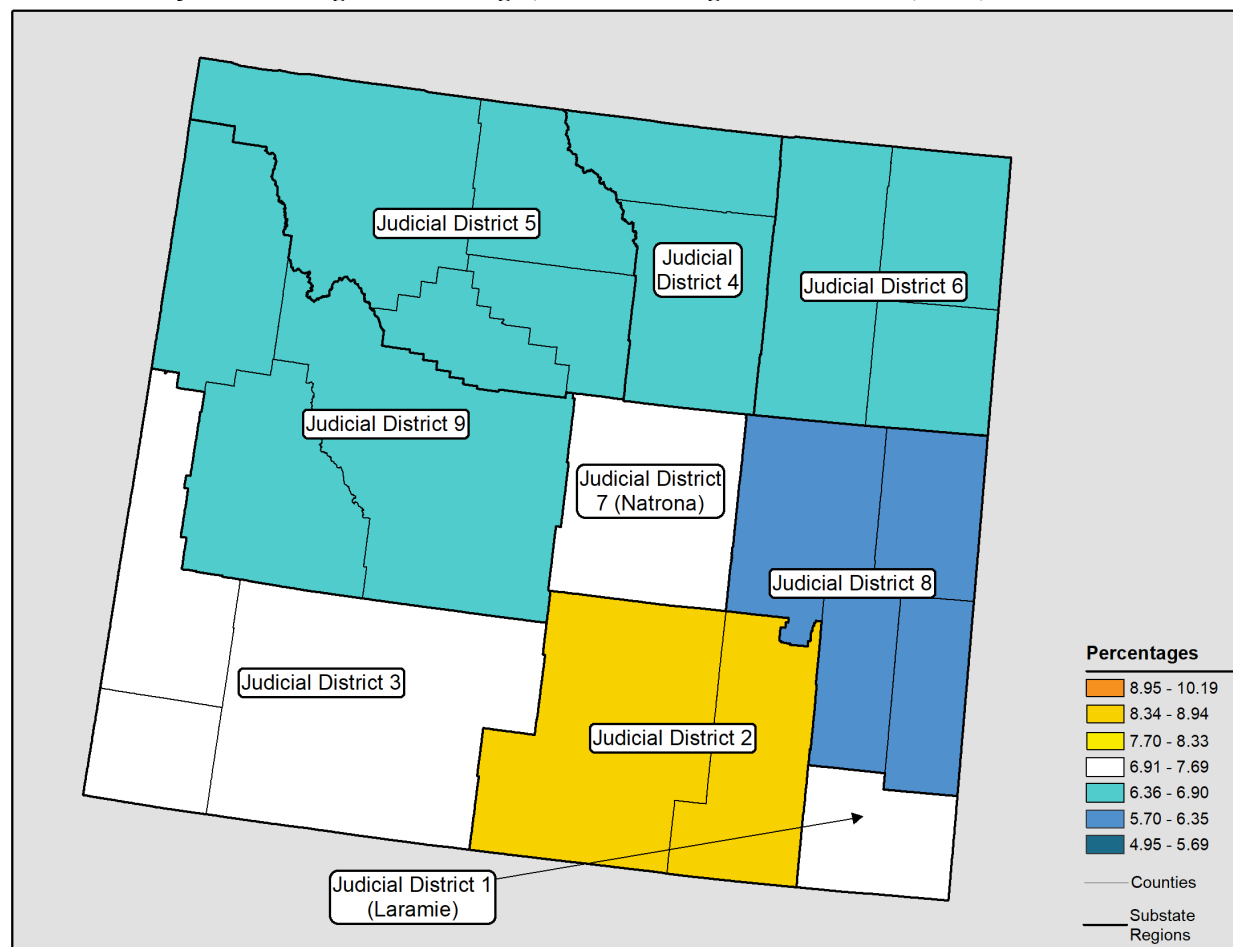
**Figure 51.28 *Had Serious Thoughts of Suicide in the Past Year* among Adults Aged 18 or Older in Wyoming, by Substate Region: Percentages, Annual Averages Based on 2016, 2017, and 2018 NSDUHs**
