5A	TennCare (Medicaid) data is provided at the aggregate level, not client level. This does not allow for the de-duplication of clients across TennCare and TDMHSAS systems. It is possible for people counted under TennCare to also be counted under TDMHSAS data systems. Clients receiving care at state hospitals may become eligible for TennCare (Medicaid) services during their stay, resulting in a reimbursement of TDMHSAS dollars.
6	The number of unduplicated clients served by TennCare (Medicaid providers) at Residential Treatment Centers was higher at the beginning of FY2019 (n=671) compared to the beginning of FY2018 (n=590). Similarly, the total number of unduplicated clients served in FY 2019 (n=5,615) was higher than the total number of unduplicated clients served in FY 2018 (n=4,529). Similar increases can be seen in FY2020. This is in part due to an increase in the number of clients with SA and SED/SMI co-occurring diagnoses in need of residential treatment. The average length of stay of adults discharged from state hospitals decreased 26% in FY2020 compared to FY2019 in part because there was a significant decrease in the number of patients with stays greater than a year. There have been concentrated efforts to discharge patients from Regional Mental Health Institutes into supportive community settings. This may have contributed to decreasing patient stays that would have been greater to less than a year.
7	There was an overall increase in FY2019 MHBG funding compared to FY2018. However, between FY2018 and FY2019, there was a slight reduction in Medicaid and Medicare patients at the state Regional Mental Health Institutes and a reduction in community-based care funded by discretionary federal grants that were phased out. "Total Other Funds Expenditure" decreased by 17% in FY2020 compared to FY2019 as a result of expiring federal discretionary grants. "Total Local Funds expenditure" decreased by 30% in FY2020 compared to FY2019 because of a reduction of county forensic services, expiring local grants, and reclassification of expenses to "Other". "Total Other Expenditures" decreased by 26% in FY2020 compared to FY2019 due to a reduction of private insurance and self-pay. There is an increase in "Total EBP for ESMI Expenditures" for FY2020 when compared to FY2019 because there was an addition of state funds for First Episode Psychosis (\$190,000). "Other Psychiatric Inpatient Care" was an added row in FY2020. Funds previously reported in "Other 24-Hour Care (Residential Care)" were divided between "Other Psychiatric Inpatient Care" and "Other 24-Hour Care (Residential Care)" resulting in an 82% decrease in "Total Other 24-Hour Care Expenditures" in FY2020 compared to FY2019.
7A	In 2019 year, the First Episode Psychosis was expanded to two ways that contributed to the change in expenses: 1) a new provider was added to cover an additional county of the state; and 2) a new contract was established to employ a statewide trainer to provide training, technical assistance, and fidelity monitoring to Coordinated Specialty Care/OnTrackTN teams across the state. "Total CSC-Evidence-Based Practices for First Episode Psychosis Expenditures" increased in FY2020 because of the addition of state funds (\$190,000).

10	In the Federal Fiscal Year 2018 appropriation, Congress increased the funding for the federal Community Mental Health Block Grant (MHBG). After soliciting input from Tennessee's Planning and Policy Council Executive Committee, leadership from community behavioral health centers, consumers, family organizations, and other key stakeholders, the Department released following funding announcements (i.e. Announcements of Funding/AOF) in FY2019 as a result of this increase: Intensive Long Term Support; School Based Behavioral Health Liaisons; First Episode Psychosis; Tennessee Move Initiative; and the Older Adults Program. Announcements for these programs have all been released and many proposals are under review at the time of this report submission. Additionally, these new funds are supporting the enhancement of the Recovery Within Reach/Housing Within Reach website, creation of an Anti-Stigma Campaign related to mental illness and crisis services, and increasing resources for targeted transitional support services. Peer support and supported employment services will also be enhanced as a result of these funds.
12	This table only include TennCare (Medicaid) data. The 33% decrease in the percent of children served by the SMHA with co-occurring MH/SA diagnoses was the result of a rounding issue. In FY2019, the actual percent of children served by the SMHA with co-occurring MH/SA diagnoses was 2.6% (rounded to 3%) while the actual percentage was 2.4% (rounded to 2%) in FY2020.
12,14A & 15A	TennCare employs an operational definition of SMI/SED based on ICD10 behavioral health diagnosis and a 15-month claims history to categorize individuals as having serious mental illness (SMI/SED). Substance abuse disorders (SUD) were based on the presence of a primary or secondary diagnosis of substance abuse disorder (ICD-10 section F10-F19: Disorders due to psychoactive substance use). Co-occurring diagnoses were based on a primary mental health diagnosis and a secondary substance use diagnosis.
14A & 15A	In March 2015, Crisis Services stopped collecting data on diagnoses. Data from TennCare (Medicaid); TDMHSAS Behavioral Health Safety Net; state psychiatric hospitals; and private psychiatric hospitals that contract with TDMHSAS, are included in these tables.
16	Multi-Systemic Therapy (MST) services for Children with SED in Tennessee increased overall by 55% in FY2020 compared to FY2019 as a result of one provider expanding these services. The large percentage increase is somewhat exaggerated by the fact that total counts for this EBP were low (FY2019 - 222, FY2020 - 343) with the change in N merely 121.
16 & 17	A computer system transition in FY2019 by a large provider resulted in improvements in identifying duplicated clients. Additionally, a switch by a few providers to EBP's not found on the URS report caused a slight decrease to select FY2020 counts. Other Evidence Based Practices reported by providers include: CBT/CBT-Insomnia/CBT- Suicide Prevention, DBT, CPT, PE, RRT, EMDR, FT, Gottman, PCIT, ARC, CPP, TF CBT, CAP.
20A	The FY20 readmission rate of 10.6% across all state hospitals continues to be less than the national 30-day hospital readmission rate for psychiatric hospitals, which is 13% according to the "Tennessee 2019 Mental Health National Outcome Measures (NOMS): SAMHSA Uniform Reporting System" report. Though there are many variables that can affect readmission rates, TDMHSAS data suggests that the primary contributing factor is non-adherence to medication and treatment regimens that are recommended after discharge. Efforts have been made to increase community support systems for people with mental illness, including the Tennessee Behavioral Health Safety Net. These supports encourage improved compliance with discharge treatment plans and in turn, reduce the potential for readmission. There is a potential that COVID-19 has impacted individuals' ability to access and comply with recommended medication and treatment regimens which may be impacting re-admission rates.
21	This table only include TennCare (Medicaid) data. The large percentage increase for TennCare180-day readmission rates in FY2018 (36%, 6,766) compared to FY2017 (29.18%, 5411) was due to a change in methods. When estimating this metric for FY2017, only claims incurred in FY2017 were considered, which is incorrect. Any claims prior to (July 1, 2016) associated with readmissions in FY2017 should have been considered. Using this correct method, the TennCare readmission rate for FY2017 should have been 34.5% which is similar to the FY2018 180-day readmission rate.
