

2024 Uniform Reporting Summary Output Tables Executive Summary

State Mental Health Agencies (SMHAs) compile and report annual data as part of SAMHSA's Community Mental Health Services Block Grant Report requirements. These compiled data constitute the Uniform Reporting System (URS).

The URS is comprised of 25 tables that are developed by SAMHSA in consultation with SMHAs. The 2024 URS Output Tables present findings from 59 states and U.S. territories.

Each output table provides summary information on the SMHA clients served in 2024: sociodemographic characteristics of clients served, outcomes of care, use of selected evidence-based practices, client assessment of care, Medicaid funding status, living situation, employment status, crisis response services, and readmission to state psychiatric hospitals within 30 and 180 days. Key data highlights are listed below:

- In 2024, 7,945,185 clients received SMHA services from 59 states and U.S. territories/jurisdictions. This is a reduction from 8,220,399 clients served by the SMHAs in 2023.*
- There were 5,730,557 adults (or 21.9 per 1,000), 2,212,116 children (or 30.4 per 1,000) served. Age data was missing for 2,512 (<0.1 percent) clients served.
- Among SMHA clients, there were 4,165,971 (52.4 percent) females served while there were 3,684,256 (46.4 percent) males served. In most states (38), more females were served than males, and in the remaining states (21), more males were served than females.
- The age distribution of SMHA clients served was the largest among ages 25-44 with 33.2 percent, followed by ages 45-64 with 21.7 percent, children ages 13-17 with 12.9 percent, and children ages 6-12 with 12.2 percent.
- Over half of SMHA clients served were White, comprising the largest racial category at 56.0 percent; Black or African American clients comprised the next largest group with 17.6 percent. Race data was missing for 12.5 percent of clients served. When looking at ethnicity, the majority of SMHA clients served were non-Hispanic (67.8 percent), while 15.1 percent were Hispanic.

This is a Medicaid data issue at the LME-MCO's for the most part. NC is down thousands of Medicaid claims due to the state's new processing system (EPS). This decrease was also reflected in NC's annual unduplicated file which was significantly smaller than the file from last year.
5A	In 2023, NC implemented a change in Medicaid processing which pulled all Medicaid claims/ encounters from being processed in the current system (NCTracks) into a separate system (EPS). When this took place, the state's annual/combined numbers greatly reduced. NC's plan and intention is to incorporate those diverted Medicaid numbers back into the typical combined reporting for the upcoming reporting cycle. Additionally, in late 2023, NC adopted Medicaid expansion which allows for more NC residents to receive services funded by Medicaid. Since that timing, NC-DMHDDSUS leadership has made it a high-priority to develop more high-value services to take advantage of this surplus in funding but it will take some time to gain traction on the service penetration. These services will also be part of NC's reporting as they are on-boarded.
7A, 7B, 7C	NC has verified the source documents and confirmed that the updated SFY24 data reconciles with the values of reported NCTracks Claims and the Grant Inventory report. The state also noted differences in some of the 2023 amounts used to calculate the changes. The largest increase in the SFY24 MHBG data was in Admin Expenditures and COVID-19 Relief funds. Adjustments were previously made to break out State Funds from Residential Care to Other Psychiatric Inpatient. The data also reflects increases in Medicaid and Crisis Expenditures in line with increases in funding. In general, the increases reflect increases in MHBG funding in 2024. The highest increases in expenditures are reported in Admin, COVID-19 and Crisis Services as a result of additional funding in these areas. The amounts reported in the 'Total' column reflect significant increases across each Activity for 2024, which is mostly driven by higher Medicaid, COVID-19, ARP and BSC spending. It's important to note, increases in Medicaid expenditures are a result of Medicaid Expansion which was implemented in North Carolina on December 1, 2023. The MHBG decreases reported for Crisis Services, Admin, State Funds and Other are also a result of higher Medicaid, COVID-19, ARP and BSC expenditures. The increases in Medicaid expenditures have an inverse impact on the use of State Funds.
8	DMHDDSUS was able to move increased funds through to our vendors/grantees as spending picked up following COVID-19 restrictions. As COVID Supplemental funds were being expended, DMHDDSUS could increase focus on shifting ARPA funds to grantees. Initial expenditures for BSCA were minimal due to the delay in executing contracts and request for applications. As these have been resolved, funding is now moving through to grantees.
12	The decrease in the percent of adults and children served by the SMHA with co-occurring disorders were likely due to more community support options available and clients who are now eligible for Medicaid due to NC's successful Medicaid expansion being able to receive Medicaid coverage instead of state plan services. In addition, more children are being served by another Division, the Division of Child and Family Wellbeing, with non-SMHA funds.
14C	The cause of multiyear changes is unknown.
